

HOUSE AMENDMENTS TO HOUSE BILL 2234

- 1 On page 1 of the printed bill, delete lines 5 through 21 and insert:
- 2 **“SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS chapter 414.**
- 3 **“SECTION 2. (1) As used in this section:**
- 4 **“(a) ‘Child abuse medical assessment’ has the meaning given that term in ORS 418.782.**
- 5 **“(b) ‘Community assessment center’ has the meaning given that term in ORS 418.782.**
- 6 **“(2) The Oregon Health Authority shall reimburse a community assessment center for**
- 7 **the services the center provides:**
- 8 **“(a) In conducting a child abuse medical assessment of a child who is eligible for medical**
- 9 **assistance; and**
- 10 **“(b) That are related to the child abuse medical assessment including, but not limited to:**
- 11 **“(A) A forensic interview; and**
- 12 **“(B) Mental health treatment.**
- 13 **“(3) The authority shall adopt billing and payment mechanisms to ensure that the re-**
- 14 **imbursement is proportionate to the scope and intensity of the services provided by the**
- 15 **community assessment center.**
- 16 **“SECTION 3. Section 4 of this 2015 Act is added to and made a part of the Insurance**
- 17 **Code.**
- 18 **“SECTION 4. (1) As used in this section:**
- 19 **“(a) ‘Child abuse medical assessment’ has the meaning given that term in ORS 418.782.**
- 20 **“(b) ‘Community assessment center’ has the meaning given that term in ORS 418.782.**
- 21 **“(c) ‘Health benefit plan’ has the meaning given that term in ORS 743.730.**
- 22 **“(2) A health benefit plan shall provide payment to or reimburse a community assess-**
- 23 **ment center for the services provided by the center:**
- 24 **“(a) In conducting a child abuse medical assessment of a child enrolled in the plan; and**
- 25 **“(b) That are related to the child abuse medical assessment including, but not limited to:**
- 26 **“(A) A forensic interview; and**
- 27 **“(B) Mental health treatment.**
- 28 **“(3) The payment or reimbursement made in accordance with this section must be**
- 29 **proportionate to the scope and intensity of the services provided by the community assess-**
- 30 **ment center.**
- 31 **“(4) This section is exempt from ORS 743A.001.”.**
- 32 In line 22, delete “4” and insert “5”.
- 33 In line 29, delete “3” and insert “4”.
- 34 On page 2, line 38, delete “5” and insert “6”.
- 35 In line 45, delete “3” and insert “4”.

- 1 On page 3, line 38, delete “6” and insert “7”.
- 2 On page 4, line 1, delete “3” and insert “4”.
- 3 In line 38, delete “7” and insert “8”.
- 4 In line 45, delete “3” and insert “4”.
