

# House Bill 2264

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Transportation and Economic Development)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes civil and criminal forfeiture of motor vehicle if person is convicted of acting as vehicle dealer without certificate.

## A BILL FOR AN ACT

2 Relating to the offense of acting as a vehicle dealer without a certificate; creating new provisions;  
3 and amending ORS 131.602.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2015 Act is added to and made a part of the Oregon Vehicle**  
6 **Code.**

7 **SECTION 2. (1) A motor vehicle may be seized for forfeiture if the motor vehicle is sold,**  
8 **offered for sale, bought, traded, brokered, exchanged, displayed or otherwise used in the**  
9 **course of conduct prohibited under ORS 822.005.**

10 **(2) All seizure and forfeiture proceedings under this section shall be conducted in ac-**  
11 **cordance with ORS chapter 131A.**
