

# B-Engrossed House Bill 2320

Ordered by the House June 29  
Including House Amendments dated April 27 and June 29

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Judiciary)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs State Board of Parole and Post-Prison Supervision to adopt sex offender risk assessment methodology to classify sex offenders into risk levels. Directs board to classify persons convicted of certain sex crimes and sentenced to imprisonment.

Directs Psychiatric Security Review Board or Oregon Health Authority to classify persons found guilty except for insanity of sex crimes.

Authorizes [*certain juveniles to report as sex offender to*] Oregon Youth Authority or county juvenile department **to register certain juvenile sex offenders.**

Requires certain sex offenders moving into state or convicted in another jurisdiction to report to Department of State Police or law enforcement agency in county of residence instead of Department of State Police in Marion County.

**Provides that failure or refusal to participate in risk assessment constitutes crime of failure to report as a sex offender.**

Prohibits Internet release of information concerning sex offender under jurisdiction of Psychiatric Security Review Board or Oregon Health Authority.

Repeals provisions relating to juvenile predatory sex offenders. Extends tenancy termination provisions and crimes related to unlawful contact with children to unclassified former predatory sex offenders and certain level three sex offenders.

Requires sharing of certain information among Psychiatric Security Review Board, Oregon Health Authority and State Board of Parole and Post-Prison Supervision for purposes of sex offender classification. Authorizes Oregon Youth Authority and juvenile department to disclose information to **Psychiatric Security Review Board, Oregon Health Authority and State Board of Parole and Post-Prison Supervision** for purposes of sex offender classification.

Extends time in which State Board of Parole and Post-Prison Supervision, or Psychiatric Security Review Board in certain circumstances, must classify existing registrants to December 1, 2018. **Provides for default classification of sex offenders who fail or refuse to participate in risk assessment.**

Requires juvenile court to hold hearing at end of jurisdiction over juvenile to determine whether juvenile must report as sex offender. Specifies procedures for holding hearings and standard of proof.

Extends permissible age difference between victim and person convicted of certain sex crime to three years and 180 days for purpose of order setting aside conviction. Requires certain court findings for orders in which age difference is between two years and 180 days and three years and 180 days.

Authorizes person living outside state to file petition for order relieving person of obligation to report as sex offender as result of adjudication in Oregon juvenile court.

**Provides that State Board of Parole and Post-Prison Supervision hearings are presumed to be panel hearings. Authorizes minimum panel of three board members to make and review certain decisions. Authorizes chairperson of board to require all voting members of board to participate in hearing or decision.**

**Appropriates moneys from General Fund to State Board of Parole and Post-Prison Supervision for purposes related to panel hearings.**

**Declares emergency, effective on passage.**

5 **SEX OFFENDER CLASSIFICATION**

6  
7 **SECTION 1.** ORS 181.800 is amended to read:

8 181.800. The *[Department of Corrections shall]* **State Board of Parole and Post-Prison Super-**  
9 **vision shall, in consultation with community corrections agencies,** adopt by rule a sex offender  
10 risk assessment *[tool]* **methodology** for use in classifying sex offenders *[based on the statistical like-*  
11 *lihood that an individual sex offender will commit another sex crime]*. Application of the risk assess-  
12 ment *[tool]* **methodology** to a sex offender must result in placing the sex offender in one of the  
13 following levels:

14 (1) A level one sex offender who presents the lowest risk of reoffending and requires a limited  
15 range of notification.

16 (2) A level two sex offender who presents a moderate risk of reoffending and requires a moder-  
17 ate range of notification.

18 (3) A level three sex offender who presents the highest risk of reoffending and requires the  
19 widest range of notification.

20 **SECTION 2.** ORS 181.801 is amended to read:

21 181.801. (1) When a person convicted of a crime described in ORS 163.355 to 163.427 is sentenced  
22 to a term of imprisonment in a Department of Corrections institution for that crime, the  
23 *[department]* **State Board of Parole and Post-Prison Supervision** shall *[conduct a risk assessment*  
24 *of]* **assess** the person utilizing the risk assessment *[tool]* **methodology** described in ORS 181.800.  
25 **The board shall apply the results of the assessment to place the person in one of the levels**  
26 **described in ORS 181.800** before the person is released from custody.

27 (2) When a person convicted of a sex crime is sentenced to a term of incarceration in a jail, or  
28 is discharged, released or placed on probation by the court, the supervisory authority as defined in  
29 ORS 144.087 shall *[conduct a risk assessment of]* **assess** the person utilizing the risk assessment  
30 *[tool]* **methodology** described in ORS 181.800 **and apply the results of the assessment to place**  
31 **the person in one of the levels described in ORS 181.800** no later than 60 days after the person  
32 is released from jail or discharged, released or placed on probation by the court.

33 (3)(a) When a person is found guilty except for insanity of a sex crime, the *[State Board of Parole*  
34 *and Post-Prison Supervision]* **Psychiatric Security Review Board or the Oregon Health Author-**  
35 **ity** shall *[conduct a risk assessment of]* **assess** the person utilizing the risk assessment *[tool]* **meth-**  
36 **odology** described in ORS 181.800 **and apply the results of the assessment to place the person**  
37 **in one of the levels described in ORS 181.800** *[within]* **no later than** 60 days after the person is:

38 (A) Placed on conditional release by the Psychiatric Security Review Board or the Oregon  
39 Health Authority;

40 (B) Discharged from the jurisdiction of the Psychiatric Security Review Board or the Oregon

5 **Authority need not complete a reassessment for an initial classification.**

11 **Psychiatric Security Review Board or the authority conditionally releases or discharges a**  
12 **person who has a prior sex crime conviction that obligates the person to report as a sex**  
13 **offender, unless the person has also been found guilty except for insanity of a sex crime that**  
14 **obligates the person to report as a sex offender.**

15 (4) Within 60 days after the event triggering the obligation to make an initial report, the State  
16 Board of Parole and Post-Prison Supervision shall [*conduct a risk assessment of*] **assess** a person  
17 utilizing the risk assessment [*tool*] **methodology** described in ORS 181.800 **and apply the results**  
18 **of the assessment to place the person in one of the levels described in ORS 181.800** if the  
19 person:

20 (a) Has been convicted in another United States court of a crime:

21 (A) That would constitute a sex crime if committed in this state; or

22 (B) For which the person would have to register as a sex offender in that court's jurisdiction,  
23 or as required under federal law, regardless of whether the crime would constitute a sex crime in  
24 this state; or

25 (b) Has been convicted of a sex crime and was sentenced to a term of imprisonment in a De-  
26 partment of Corrections institution for that sex crime, but was not subjected to a risk assessment  
27 utilizing the risk assessment [*tool*] **methodology** described in ORS 181.800 before release under  
28 subsection (1) of this section.

29 (5) When [*the Department of Corrections,*] the State Board of Parole and Post-Prison  
30 Supervision, **the Psychiatric Security Review Board, the Oregon Health Authority** or a super-  
31 visory authority [*conducts a risk assessment under this section*] **applies the results of a risk as-**  
32 **essment to place a person in one of the levels described in ORS 181.800,** the agency shall  
33 notify the Department of State Police of the results of the risk assessment **within three business**  
34 **days after the agency's classification.** Upon receipt, the Department of State Police shall enter  
35 the results of the risk assessment into the Law Enforcement Data System.

36 **SECTION 3.** ORS 181.803 is amended to read:

37 181.803. Notwithstanding any other provision of law:

38 [(1) A person required to report as a sex offender under ORS 181.806, 181.807 or 181.808 is clas-  
39 sified as a level three sex offender under ORS 181.800 (3) unless:]

40 [(a) Following a risk assessment conducted under ORS 181.801, the person is classified as a level  
41 two sex offender under ORS 181.800 (2) or as a level one sex offender under ORS 181.800 (1); or]

42 [(b) After filing a petition under ORS 181.821 (2), the person is reclassified as a level two sex  
43 offender under ORS 181.800 (2) by the State Board of Parole and Post-Prison Supervision or the  
44 Psychiatric Security Review Board.]

45 [(2)] (1) A person who is a sexually violent dangerous offender under ORS 137.765:

1 (a) Must be classified as a level three sex offender under ORS 181.800 (3); and

2 (b) Is not eligible for relief from the obligation to report as a sex offender or reclassification as  
3 a level two sex offender under ORS 181.800 (2), pursuant to a petition filed under ORS 181.821.

4 [(3)] (2) A person who has been convicted or found guilty except for insanity of one of the fol-  
5 lowing offenses is not eligible for relief from the obligation to report as a sex offender pursuant to  
6 a petition filed under ORS 181.821 (1):

7 (a) Rape in the first degree;

8 (b) Sodomy in the first degree;

9 (c) Unlawful sexual penetration in the first degree;

10 (d) Kidnapping in the first degree as described in ORS 163.235 (1)(e) or when the victim is under  
11 18 years of age; or

12 (e) Burglary in the first degree when committed with the intent to commit any of the offenses  
13 listed in ORS 181.805 (5)(a) to (t).

14 **(3) A person classified as a level three sex offender under section 7 (2)(b), chapter 708,**  
15 **Oregon Laws 2013 is not eligible for relief from the obligation to report as a sex offender**  
16 **pursuant to a petition filed under ORS 181.821 (1).**

17 **SECTION 4.** ORS 181.821 is amended to read:

18 181.821. (1)(a) A person who is required to report as a sex offender under ORS 181.806, 181.807  
19 or 181.808 due to a conviction for a sex crime and is classified as a level one sex offender under  
20 ORS 181.800 (1) may petition the State Board of Parole and Post-Prison Supervision to relieve the  
21 person from the obligation to report as a sex offender under ORS 181.806, 181.807 or 181.808.

22 (b) A person who is required to report as a sex offender under ORS 181.806, 181.807 or 181.808  
23 due to being found guilty except for insanity under ORS 161.295 for a sex crime, and is classified  
24 as a level one sex offender under ORS 181.800 (1), may petition the Psychiatric Security Review  
25 Board to relieve the person from the obligation to report as a sex offender under ORS 181.806,  
26 181.807 or 181.808.

27 (c)(A) Except as otherwise provided in subparagraph (B) of this paragraph, a person described  
28 in paragraph (a) or (b) of this subsection may file the petition no sooner than five years after the  
29 date supervision for the sex crime is terminated or, if the person was not subject to supervision for  
30 the sex crime, five years after the date the person was discharged from the jurisdiction of the court,  
31 Psychiatric Security Review Board or Oregon Health Authority.

32 (B) A person who was reclassified under subsection (2) of this section from a level two sex  
33 offender under ORS 181.800 (2) to a level one sex offender under ORS 181.800 (1) may file the peti-  
34 tion no sooner than five years after the date of reclassification.

35 (d) Notwithstanding paragraph (c) of this subsection, if a person is required to report because  
36 of a conviction or finding of guilty except for insanity from another United States court as that term  
37 is defined in ORS 181.805, the person may not petition for relief from reporting as a sex offender in  
38 Oregon unless the laws of the jurisdiction where the person was convicted or found guilty except  
39 for insanity would permit a petition for relief from reporting as a sex offender.

12 supervision for the sex crime is terminated or, if the person was not subject to supervision for the  
13 sex crime, 10 years after the date the person was discharged from the jurisdiction of the court,  
14 Psychiatric Security Review Board or Oregon Health Authority.

15 (3)(a) The State Board of Parole and Post-Prison Supervision or the Psychiatric Security Review  
16 Board shall deny a petition filed under this section if, at any time after the person is convicted or  
17 found guilty except for insanity of a sex crime, the person is convicted of or found guilty except for  
18 insanity of a person felony or a person Class A misdemeanor, as those terms are defined in the rules  
19 of the Oregon Criminal Justice Commission.

20 (b) The appropriate board shall deny a petition filed under subsection (2)(c) or (d) of this section  
21 if the board has previously reclassified the person as a level two sex offender under ORS 181.800 (2)  
22 as the result of a petition filed under subsection (2)(a) or (b) of this section.

23 (4)(a) Except as otherwise provided in subsection (3) of this section, if a person files a petition  
24 under subsection (1) of this section, the State Board of Parole and Post-Prison Supervision or the  
25 Psychiatric Security Review Board shall hold a hearing. At the hearing, the board shall enter an  
26 order relieving the person of the obligation to report as a sex offender under ORS 181.806, 181.807  
27 or 181.808 if the board determines, by clear and convincing evidence, that the person:

- 28 (A) Is statistically unlikely to reoffend; and
- 29 (B) Does not pose a threat to the safety of the public.

30 (b)(A) Except as otherwise provided in subsection (3) of this section, if a person files a petition  
31 under subsection (2)(a) or (b) of this section, the State Board of Parole and Post-Prison Supervision  
32 or the Psychiatric Security Review Board shall hold a hearing. At the hearing, the board shall enter  
33 an order reclassifying the person as a level two sex offender under ORS 181.800 (2) if, after com-  
34 pletion of a new risk assessment utilizing the risk assessment *[tool]* **methodology** described in ORS  
35 181.800, the person is classified as presenting a low or moderate risk of reoffending and the board  
36 determines that a lower level of notification is sufficient to protect public safety.

37 (B) Except as otherwise provided in subsection (3) of this section, if a person files a petition  
38 under subsection (2)(c) or (d) of this section, the State Board of Parole and Post-Prison Supervision  
39 or the Psychiatric Security Review Board shall hold a hearing. At the hearing, the board shall enter  
40 an order reclassifying the person as a level one sex offender under ORS 181.800 (1) if, after com-  
41 pletion of a new risk assessment utilizing the risk assessment *[tool]* **methodology** described in ORS  
42 181.800, the person is classified as presenting a low risk of reoffending and the board determines  
43 that a lower level of notification is sufficient to protect public safety.

44 (5) In making the determinations described in subsection (4) of this section, the State Board of  
45 Parole and Post-Prison Supervision or the Psychiatric Security Review Board shall consider:

- 1 (a) The nature of and degree of violence involved in the offense that requires reporting;
- 2 (b) The age and number of victims of the offense that requires reporting;
- 3 (c) The age of the person at the time of the offense that requires reporting;
- 4 (d) The length of time since the offense that requires reporting and the time period during which
- 5 the person has not reoffended;
- 6 (e) The person's performance on supervision for the offense that requires reporting;
- 7 (f) Whether the person has participated in or successfully completed a court-approved sex
- 8 offender treatment program or any other rehabilitative programs;
- 9 (g) The person's stability in employment and housing;
- 10 (h) The person's community and personal support system;
- 11 (i) Other criminal and relevant noncriminal behavior of the person both before and after the
- 12 offense that requires reporting; and
- 13 (j) Any other relevant factors.

14 (6)(a) The Attorney General may represent the state at a hearing conducted under this section  
15 unless the district attorney of the county in which the person was convicted or, if the conviction for  
16 which the person is required to report as a sex offender was entered in another United States court,  
17 the district attorney of the county in which the person resides, elects to represent the state.

18 (b) If a district attorney elects to represent the state, the district attorney shall give timely  
19 written notice of the election to the Attorney General, the State Board of Parole and Post-Prison  
20 Supervision or the Psychiatric Security Review Board and the person who is the subject of the  
21 hearing.

22 (c) If the district attorney declines to represent the state, the district attorney shall cooperate  
23 with the Attorney General in securing the material necessary to represent the state.

24 (7)(a) When the State Board of Parole and Post-Prison Supervision or the Psychiatric Security  
25 Review Board enters an order under this section relieving a person of the obligation to report as  
26 a sex offender under ORS 181.806, 181.807 or 181.808 or enters an order reclassifying a person as a  
27 level two sex offender under ORS 181.800 (2) or as a level one sex offender under ORS 181.800 (1),  
28 the board shall forward a copy of the order to the Department of State Police.

29 (b) Upon receipt of an order relieving a person of the obligation to report, the department shall  
30 remove from the Law Enforcement Data System the sex offender information obtained from the sex  
31 offender registration form submitted under ORS 181.806, 181.807 or 181.808.

32 (c) Upon receipt of an order reclassifying a person as a level two sex offender under ORS  
33 181.800 (2) or as a level one sex offender under ORS 181.800 (1), the department shall update the  
34 Law Enforcement Data System to reflect the reclassification.

35 (8) The State Board of Parole and Post-Prison Supervision and the Psychiatric Security Review  
36 Board shall adopt rules to carry out the provisions of this section. The rules may include a filing  
37 fee in an amount determined by the appropriate board. All fees paid under this subsection shall be  
38 deposited into the General Fund and credited to the account of the appropriate board.

39 (9) As used in this section, "supervision" means probation, parole, post-prison supervision or any  
40 other form of supervised or conditional release.

**SEX OFFENDER REPORTING**

44 **SECTION 5.** ORS 181.806 is amended to read:

45 181.806. (1) The agency to which a person reports under subsection (3) of this section shall

1 complete a sex offender registration form concerning the person when the person reports under  
2 subsection (3) of this section.

3 (2) Subsection (3) of this section applies to a person who:

4 (a) Is discharged, paroled or released on any form of supervised or conditional release from a  
5 jail, prison or other correctional facility or detention facility in this state at which the person was  
6 confined as a result of:

7 (A) Conviction of a sex crime or a crime for which the person would have to register as a sex  
8 offender under federal law; or

9 (B) Having been found guilty except for insanity of a sex crime;

10 (b) Is paroled to this state under ORS 144.610 after being convicted in another United States  
11 court of a crime:

12 (A) That would constitute a sex crime if committed in this state; or

13 (B) For which the person would have to register as a sex offender in that court's jurisdiction,  
14 or as required under federal law, regardless of whether the crime would constitute a sex crime in  
15 this state; or

16 (c) Is discharged by the court under ORS 161.329 after having been found guilty except for in-  
17 sanity of a sex crime.

18 (3)(a) A person described in subsection (2) of this section shall report, in person, to the Depart-  
19 ment of State Police, a city police department or a county sheriff's office, in the county to which the  
20 person was discharged, paroled or released or in which the person was otherwise placed:

21 (A) Within 10 days following discharge, release on parole, post-prison supervision or other  
22 supervised or conditional release;

23 (B) Within 10 days of a change of residence;

24 (C) Once each year within 10 days of the person's birth date, regardless of whether the person  
25 changed residence;

26 (D) Within 10 days of the first day the person works at, carries on a vocation at or attends an  
27 institution of higher education; and

28 (E) Within 10 days of a change in work, vocation or attendance status at an institution of higher  
29 education.

30 (b) If a person required to report under this subsection has complied with the initial reporting  
31 requirement under paragraph (a)(A) of this subsection, the person shall subsequently report, in per-  
32 son, in the circumstances specified in paragraph (a) of this subsection, as applicable, to the De-  
33 partment of State Police, a city police department or a county sheriff's office, in the county of the  
34 person's last reported residence.

35 **(c) Notwithstanding paragraphs (a) and (b) of this subsection, during the period of**  
36 **supervision or custody authorized by law, the Oregon Youth Authority may register a youth**  
37 **offender committed to its supervision and custody by order of the juvenile court or a person**  
38 **placed in its physical custody under ORS 137.124 or any other provision of law.**

39 [(c)] (d) The obligation to report under this subsection terminates if the conviction or adjudi-  
40 cation that gave rise to the obligation is reversed or vacated or if the registrant is pardoned.

41 (4) As part of the registration and reporting requirements of this section:

42 (a) The person required to report shall:

43 (A) Provide the information necessary to complete the sex offender registration form and sign  
44 the form as required; and

45 (B) Submit to the requirements described in paragraph (b) of this subsection.

1 (b) The Department of State Police, **Oregon Youth Authority**, [the] city police department or  
2 [the] county sheriff's office:

3 (A) Shall photograph the person when the person initially reports under this section and each  
4 time the person reports annually under this section;

5 (B) May photograph the person or any identifying scars, marks or tattoos located on the person  
6 when the person reports under any of the circumstances described in this section; and

7 (C) Shall fingerprint the person if the person's fingerprints are not included in the record file  
8 of the Department of State Police.

10 **SECTION 7.** ORS 181.808 is amended to read:

11 181.808. (1)(a) When a person described in subsection (6) of this section moves into this state  
12 and is not otherwise required by ORS 181.806, 181.807 or 181.809 to report, the person shall report,  
13 in person, to the Department of State Police [in Marion County, Oregon], **a city police department**  
14 **or a county sheriff's office, in the county of the person's residence:**

15 (A) No later than 10 days after moving into this state;

16 (B) Within 10 days of a change of residence;

17 (C) Once each year within 10 days of the person's birth date, regardless of whether the person  
18 changed residence;

19 (D) Within 10 days of the first day the person works at, carries on a vocation at or attends an  
20 institution of higher education; and

21 (E) Within 10 days of a change in work, vocation or attendance status at an institution of higher  
22 education.

23 (b) If a person required to report under this subsection has complied with the initial reporting  
24 requirement under paragraph (a)(A) of this subsection, the person shall subsequently report, in per-  
25 son, in the circumstances specified in paragraph (a) of this subsection, as applicable, to the De-  
26 partment of State Police, a city police department or a county sheriff's office, in the county of the  
27 person's last reported residence.

28 (2)(a) When a person described in ORS 181.806 (2) or 181.807 (2) or subsection (6) of this section

25 **SECTION 31.** (1)(a) The juvenile court shall hold a hearing on the issue of reporting as  
26 a sex offender by a person who has been found to be within the jurisdiction of the juvenile  
27 court under ORS 419C.005, or found by the juvenile court to be responsible except for insanity  
28 under ORS 419C.411, for having committed an act that if committed by an adult would con-  
29 stitute a felony sex crime.

30 **(b) The hearing described in paragraph (a) of this subsection must be held during the  
31 six-month period before:**

32 **(A) The termination of juvenile court jurisdiction over the person; or**

33 **(B) The person is discharged from the jurisdiction of the Psychiatric Security Review  
34 Board, if the person was placed under the jurisdiction of the board.**

35 **(c) The court shall notify the person of the person's right to a hearing under this section  
36 upon finding the person within the jurisdiction of the juvenile court under ORS 419C.005.**

37 **(d) The county or state agency responsible for supervising the person shall notify the  
38 person when the agency determines that termination of jurisdiction will occur within six  
39 months.**

40 **(e) A petition requesting a hearing may be filed under this section by the person within  
41 six months of the termination date if the date has been set by the court, or within six  
42 months of the projected termination date provided to the person by the supervising agency.**

43 **(2) The district attorney shall notify the victim prior to the hearing of the right to appear  
44 and the right to be heard under ORS 419C.273.**

45 **(3) At the hearing described in subsection (1) of this section:**

1 (a) The district attorney, the victim, the person and the juvenile court counselor or a  
2 representative of the Oregon Youth Authority shall have an opportunity to be heard.

3 (b) The person who is the subject of the hearing has the burden of proving by clear and  
4 convincing evidence that the person is rehabilitated and does not pose a threat to the safety  
5 of the public. If the court finds that the person has not met the burden of proof, the court  
6 shall enter an order requiring the person to report as a sex offender under ORS 181.809.

7 (4) In determining whether the person has met the burden of proof, the juvenile court  
8 may consider but need not be limited to considering:

9 (a) The extent and impact of any physical or emotional injury to the victim;

10 (b) The nature of the act that subjected the person to the duty of reporting as a sex  
11 offender;

12 (c) Whether the person used or threatened to use force in committing the act;

13 (d) Whether the act was premeditated;

14 (e) Whether the person took advantage of a position of authority or trust in committing  
15 the act;

16 (f) The age of any victim at the time of the act, the age difference between any victim  
17 and the person and the number of victims;

18 (g) The vulnerability of the victim;

19 (h) Other acts committed by the person that would be crimes if committed by an adult  
20 and criminal activities engaged in by the person before and after the adjudication;

21 (i) Statements, documents and recommendations by or on behalf of the victim or the  
22 parents of the victim;

23 (j) The person's willingness to accept personal responsibility for the act and personal  
24 accountability for the consequences of the act;

25 (k) The person's ability and efforts to pay the victim's expenses for counseling and other  
26 trauma-related expenses or other efforts to mitigate the effects of the act;

27 (L) Whether the person has participated in and satisfactorily completed a sex offender  
28 treatment program or any other intervention, and if so the juvenile court may also consider:

29 (A) The availability, duration and extent of the treatment activities;

30 (B) Reports and recommendations from the providers of the treatment;

31 (C) The person's compliance with court, board or supervision requirements regarding  
32 treatment; and

33 (D) The quality and thoroughness of the treatment program;

34 (m) The person's academic and employment history;

35 (n) The person's use of drugs or alcohol before and after the adjudication;

36 (o) The person's history of public or private indecency;

37 (p) The person's compliance with and success in completing the terms of supervision;

38 (q) The results of psychological examinations of the person;

39 (r) The protection afforded the public by the continued existence of the records; and

40 (s) Any other relevant factors.

41 (5) In a hearing under this section, the juvenile court may receive testimony, reports and  
42 other evidence, without regard to whether the evidence is admissible under ORS 40.010 to  
43 40.210 and 40.310 to 40.585, if the evidence is relevant evidence related to the determination  
44 and findings required under this section. As used in this subsection, "relevant evidence" has  
45 the meaning given that term in ORS 40.150.

2 (2)(a) A copy of the motion and a full set of the defendant's fingerprints shall be served upon  
3 the office of the prosecuting attorney who prosecuted the crime or violation, or who had authority

16 prosecuting attorney. The office of the prosecuting attorney shall forward the check with the fin-  
17 gerprint card to the Department of State Police.

18 (d) In addition to the fee established under paragraph (c) of this subsection, when a person  
19 makes a motion under subsection (1)(a) of this section the person must pay the filing fee established  
20 under ORS 21.135.

21 (3) Upon hearing the motion, the court may require the filing of such affidavits and may require  
22 the taking of such proofs as the court deems proper. The court shall allow the victim to make a  
23 statement at the hearing. Except as otherwise provided in subsection (13) of this section, if the court  
24 determines that the circumstances and behavior of the applicant from the date of conviction, or from  
25 the date of arrest as the case may be, to the date of the hearing on the motion warrant setting aside  
26 the conviction, or the arrest record as the case may be, the court shall enter an appropriate order

28 original, date of charge, submitting agency and disposition. The order shall further state that posi-  
29 tive identification has been established by the Department of State Police and further identified as  
30 to Department of State Police number or submitting agency number. Upon the entry of the order,  
31 the applicant for purposes of the law shall be deemed not to have been previously convicted, or ar-  
32 rested as the case may be, and the court shall issue an order sealing the record of conviction and  
33 other official records in the case, including the records of arrest whether or not the arrest resulted  
34 in a further criminal proceeding.

35 (4) The clerk of the court shall forward a certified copy of the order to such agencies as directed  
36 by the court. A certified copy must be sent to the Department of Corrections when the person has

16 (c) A sex crime constituting a Class C felony, if:

17 (A) The person was under 16 years of age at the time of the offense;

18 (B) The person is:

19 (i) Less than *[three years]* **two years and 180 days** older than the victim; **or**

20 (ii) **At least two years and 180 days older, but less than three years and 180 days older,**  
21 **than the victim and the court finds that setting aside the conviction is in the interests of**  
22 **justice and of benefit to the person and the community;**

23 (C) The victim's lack of consent was due solely to incapacity to consent by reason of being less  
24 than a specified age;

25 (D) The victim was at least 12 years of age at the time of the offense;

26 (E) The person has not been convicted of, found guilty except for insanity of or found to be  
27 within the jurisdiction of the juvenile court based on a crime that a court is prohibited from setting  
28 aside under this section; and

29 (F) Each conviction or finding described in this paragraph involved the same victim.

30 (9) The provisions of subsection (1)(b) of this section do not apply to:

31 (a) A person arrested within the three-year period immediately preceding the filing of the motion

38 (10) The provisions of subsection (1) of this section apply to convictions and arrests that oc-  
39 curred before, as well as those that occurred after, September 9, 1971. There is no time limit for

41 (11) For purposes of any civil action in which truth is an element of a claim for relief or affir-  
42 mative defense, the provisions of subsection (3) of this section providing that the conviction, arrest  
43 or other proceeding be deemed not to have occurred do not apply and a party may apply to the  
44 court for an order requiring disclosure of the official records in the case as may be necessary in the

23 (14) As used in this section, "sex crime" has the meaning given that term in ORS 181.805.

8 (b) When a district attorney receives notice of a hearing for expunction of a record concerning  
9 a youth or youth offender proceeding under ORS chapter 419C, if the victim of the acts that resulted  
10 in the disposition that is the subject of the application for expunction requests, the district attorney  
11 shall mail notice of the hearing to the victim's last-known address.

12 (16) The court shall conduct a hearing on a pending expunction in accord with the provisions  
13 of ORS 419B.195, 419B.198, 419B.201, 419B.205, 419B.208, 419B.310, 419B.812 to 419B.839 and  
14 419B.908. Rules of evidence shall be as in a hearing to establish juvenile court jurisdiction and as  
15 defined in ORS 419B.310 (3) and 419C.400 (2). The burden of proof shall be with the party contesting  
16 expunction.

17 (17) At the conclusion of a hearing on a pending expunction, the court shall issue judgment  
18 granting or denying expunction.

19 (18) The juvenile court or juvenile department shall send a copy of an expunction judgment to  
20 each agency subject to the judgment. Upon receipt of a copy of the judgment, the agency shall  
21 comply and, within 21 days of the date of receipt, return the copy to the juvenile court or juvenile  
22 department with an indorsement indicating compliance.

23 (19) When all agencies subject to an expunction judgment have indicated their compliance or in  
24 any event no later than six weeks following the date the judgment was delivered as required by  
25 subsection (18) of this section, the juvenile court shall provide the person who is the subject of the  
26 record with a copy of the expunction judgment, a list of complying and noncomplying agencies, and  
27 a written notice of rights and effects of expunction. The juvenile court and juvenile department then  
28 shall expunge forthwith all records which they possess and which are subject to the judgment, ex-  
29 cept the original expunction judgment and the list of complying and noncomplying agencies which  
30 must be preserved under seal.

31 (20) In addition to those agencies identified in ORS 419A.260 (1)(d), the juvenile, circuit, munic-  
32 ipal and justice courts, and the district and city attorneys of this state, are bound by an expunction  
33 judgment of any juvenile court of appropriate jurisdiction in this state issuing an expunction judg-  
34 ment.

35 (21) Upon entry of an expunction judgment, the contact that is the subject of the expunged re-  
36 cord shall not be disclosed by any agency. An agency that is subject to an expunction judgment shall  
37 respond to any inquiry about the contact by indicating that no record or reference concerning the  
38 contact exists.

39 (22) A person who is the subject of a record that has been expunged under this section may  
40 assert that the record never existed and that the contact, which was the subject of the record, never

26 in the juvenile court in which the person was adjudicated for the act that requires reporting.

27 (b) In another state and is required to report under ORS 181.809 (4), the petition must be filed  
28 in the juvenile court in the county in which the person attends school or works.

29 **(c) In another state and is required to report under the laws of the other state, the pe-**  
30 **tion must be filed in the juvenile court in which the person was adjudicated for the act that**  
31 **requires reporting.**

32 (2) If the act giving rise to the obligation to report would constitute:

33 (a) A Class A or Class B felony sex crime if committed by an adult, the petition may be filed  
34 no sooner than two years after the termination of juvenile court jurisdiction over the person or, if  
35 the person is placed under the jurisdiction of the Psychiatric Security Review Board, no sooner than  
36 two years after the person is discharged from the jurisdiction of the board.

37 (b) A Class C felony sex crime if committed by an adult, the petition may be filed no sooner than  
38 30 days before the termination of juvenile court jurisdiction over the person or, if the person is  
39 placed under the jurisdiction of the Psychiatric Security Review Board, no sooner than 30 days be-  
40 fore the person is discharged from the jurisdiction of the board.

41 (3)(a) The juvenile court in which a petition under this section is filed may transfer the matter  
42 to the juvenile court of the county that last supervised the person if the court determines that the  
43 convenience of the parties, the victim and witnesses require the transfer.

44 (b) The juvenile court has exclusive original jurisdiction in any proceeding under this section.

45 (c) The person, the district attorney and the juvenile department are parties to a hearing on a

1 petition filed under this section.

2 (4) The person filing the petition has the burden of proving by clear and convincing evidence  
3 that the person is rehabilitated and does not pose a threat to the safety of the public. In determining  
4 whether the person has met the burden of proof, the juvenile court may consider but need not be  
5 limited to considering:

6 (a) The extent and impact of any physical or emotional injury to the victim;

7 (b) The nature of the act that subjected the person to the [*duty*] **obligation** of reporting as a sex

17 (i) Statements, documents and recommendations by or on behalf of the victim or the parents of

19 (j) The person's willingness to accept personal responsibility for the act and personal account-  
20 ability for the consequences of the act;

21 (k) The person's ability and efforts to pay the victim's expenses for counseling and other  
22 trauma-related expenses or other efforts to mitigate the effects of the act;

23 (L) Whether the person has participated in and satisfactorily completed a sex offender treatment  
24 program or any other intervention, and if so the juvenile court may also consider:

25 (A) The availability, duration and extent of the treatment activities;

26 (B) Reports and recommendations from the providers of the treatment;

27 (C) The person's compliance with court, board or supervision requirements regarding treatment;

8 (B) Criminal mischief in the first degree by means of an explosive as defined in ORS 164.365;

9 (C) Burglary in the first degree as defined in ORS 164.225;

10 (D) Escape in the first degree as defined in ORS 162.165;

11 (E) Kidnapping in the second degree as defined in ORS 163.225;

12 (F) Kidnapping in the first degree as defined in ORS 163.235;

13 (G) Robbery in the first degree as defined in ORS 164.415;

14 (H) Any felony sexual offense in the first degree defined in this chapter;

15 (I) Compelling prostitution as defined in ORS 167.017; or

16 (J) Assault in the first degree, as defined in ORS 163.185, and the victim is under 14 years of  
17 age, or assault in the second degree, as defined in ORS 163.175 (1)(a) or (b), and the victim is under  
18 14 years of age; or

19 (c) By abuse when a person, recklessly under circumstances manifesting extreme indifference to  
20 the value of human life, causes the death of a child under 14 years of age or a dependent person,  
21 as defined in ORS 163.205, and:

22 (A) The person has previously engaged in a pattern or practice of assault or torture of the vic-  
23 tim or another child under 14 years of age or a dependent person; or

24 (B) The person causes the death by neglect or maltreatment.

25 (2) An accusatory instrument alleging murder by abuse under subsection (1)(c) of this section  
26 need not allege specific incidents of assault or torture.

27 (3) It is an affirmative defense to a charge of violating subsection (1)(b) of this section that the  
28 defendant:

29 (a) Was not the only participant in the underlying crime;

30 (b) Did not commit the homicidal act or in any way solicit, request, command, importune, cause  
31 or aid in the commission thereof;

32 (c) Was not armed with a dangerous or deadly weapon;

33 (d) Had no reasonable ground to believe that any other participant was armed with a dangerous  
34 or deadly weapon; and

35 (e) Had no reasonable ground to believe that any other participant intended to engage in con-  
36 duct likely to result in death.

37 (4) It is an affirmative defense to a charge of violating subsection (1)(c)(B) of this section that  
38 the victim was a dependent person who was at least 18 years of age and was under care or treat-  
39 ment solely by spiritual means pursuant to the religious beliefs or practices of the dependent person  
40 or the guardian of the dependent person.

41 [(5)(a)] **(5)** Except as otherwise provided in ORS 163.155[,]:

42 (a) A person convicted of murder, who was at least 15 years of age at the time of committing  
43 the murder, shall be punished by imprisonment for life.

44 (b) When a defendant is convicted of murder under this section, the court shall order that the  
45 defendant shall be confined for a minimum of 25 years without possibility of parole, release to

1 post-prison supervision, release on work release or any form of temporary leave or employment at  
2 a forest or work camp.

3 (c) At any time after completion of a minimum period of confinement pursuant to paragraph (b)  
4 of this subsection, the State Board of Parole and Post-Prison Supervision, upon the petition of a  
5 prisoner so confined, shall hold a hearing to determine if the prisoner is likely to be rehabilitated  
6 within a reasonable period of time. The sole issue is whether the prisoner is likely to be rehabili-  
7 tated within a reasonable period of time. At the hearing the prisoner has:

8 (A) The burden of proving by a preponderance of the evidence the likelihood of rehabilitation  
9 within a reasonable period of time;

10 (B) The right, if the prisoner is without sufficient funds to employ an attorney, to be represented  
11 by legal counsel, appointed by the board, at board expense; and

12 (C) The right to a subpoena upon a showing of the general relevance and reasonable scope of  
13 the evidence sought, provided that any subpoena issued on behalf of the prisoner must be issued by  
14 the State Board of Parole and Post-Prison Supervision pursuant to rules adopted by the board.

15 (d) If, upon hearing all of the evidence, the board, upon a unanimous vote of [*all of its*] **three**  
16 **board members or, if the chairperson requires all voting members to participate, a unani-**  
17 **mous vote of all voting** members, finds that the prisoner is capable of rehabilitation and that the  
18 terms of the prisoner's confinement should be changed to life imprisonment with the possibility of  
19 parole, release to post-prison supervision or work release, it shall enter an order to that effect and  
20 the order shall convert the terms of the prisoner's confinement to life imprisonment with the possi-  
21 bility of parole, release to post-prison supervision or work release and may set a release date. Oth-  
22 erwise, the board shall deny the relief sought in the petition.

23 (e) If the board denies the relief sought in the petition, the board shall determine the date of the  
24 subsequent hearing, and the prisoner may petition for an interim hearing, in accordance with ORS  
25 144.285.

26 (f) The board's final order shall be accompanied by findings of fact and conclusions of law. The  
27 findings of fact shall consist of a concise statement of the underlying facts supporting the findings  
28 as to each contested issue of fact and as to each ultimate fact required to support the board's order.

29 (6) As used in this section:

30 (a) "Assault" means [*to intentionally, knowingly or recklessly cause*] **the intentional, knowing**  
31 **or reckless causation of** physical injury to another person. "Assault" does not include the  
32 [*causing*] **causation** of physical injury in a motor vehicle accident that occurs by reason of the  
33 reckless conduct of a defendant.

34 (b) "Neglect or maltreatment" means a violation of ORS 163.535, 163.545 or 163.547 or a failure  
35 to provide adequate food, clothing, shelter or medical care that is likely to endanger the health or  
36 welfare of a child under 14 years of age or a dependent person. This paragraph is not intended to  
37 replace or affect the duty or standard of care required under ORS chapter 677.

38 (c) "Pattern or practice" means one or more previous episodes.

39 (d) "Torture" means [*to intentionally inflict*] **the intentional infliction of** intense physical pain  
40 upon an unwilling victim as a separate objective apart from any other purpose.

41 **SECTION 47.** ORS 163.155 is amended to read:

42 163.155. (1) When a defendant, who was at least 15 years of age at the time of committing the  
43 murder, is convicted of murdering a pregnant victim under ORS 163.115 (1)(a) and the defendant  
44 knew that the victim was pregnant, the defendant shall be sentenced to life imprisonment without  
45 the possibility of release or parole or to life imprisonment. The court shall conduct a sentencing

1 proceeding to determine whether the defendant shall be sentenced to life imprisonment without the  
2 possibility of release or parole as described in subsection (4) of this section or to life imprisonment  
3 as described in subsection (5) of this section. If the defendant waives all rights to a jury sentencing  
4 proceeding, the court shall conduct the sentencing proceeding as the trier of fact. The procedure for  
5 the sentencing proceeding, whether before a court or a jury, shall follow the procedure of ORS  
6 163.150 (1)(a), as modified by this section.

7 (2) Following the presentation of evidence and argument under subsection (1) of this section, the  
8 court shall instruct the jury that the trial court shall sentence the defendant to life imprisonment  
9 without the possibility of release or parole as described in subsection (4) of this section, unless after  
10 considering all of the evidence submitted, 10 or more members of the jury find there are sufficient  
11 mitigating circumstances to warrant life imprisonment with the possibility of release or parole as  
12 described in subsection (5) of this section. If 10 or more members of the jury do not find there are  
13 sufficient mitigating circumstances to warrant life imprisonment with the possibility of release or  
14 parole, the trial court shall sentence the defendant to life imprisonment without the possibility of  
15 release or parole as described in subsection (4) of this section. If 10 or more members of the jury  
16 find there are sufficient mitigating circumstances to warrant life imprisonment with the possibility  
17 of release or parole, the trial court shall sentence the defendant to life imprisonment as described  
18 in subsection (5) of this section.

19 (3) Nothing in this section precludes the court from sentencing the defendant to life  
20 imprisonment, as described in subsection (5) of this section, or life imprisonment without the possi-  
21 bility of release or parole, as described in subsection (4) of this section, pursuant to a stipulation  
22 of sentence or stipulation of sentencing facts agreed to and offered by both parties if the defendant  
23 waives all rights to a jury sentencing proceeding.

24 (4) A sentence of life imprisonment without the possibility of release or parole under this section  
25 may not be suspended, deferred or commuted by any judicial officer, and the State Board of Parole  
26 and Post-Prison Supervision may neither parole the prisoner nor reduce the period of confinement  
27 in any manner whatsoever. The Department of Corrections or any executive official may not permit  
28 the prisoner to participate in any sort of release or furlough program.

29 (5) If the defendant is sentenced to life imprisonment, the court shall order that the defendant  
30 be confined for a minimum of 30 years without possibility of parole, release to post-prison super-  
31 vision, release on work release or any form of temporary leave or employment at a forest or work  
32 camp.

33 (6) At any time after completion of the minimum period of confinement pursuant to subsection  
34 (5) of this section, the board, upon the petition of a prisoner so confined, shall hold a hearing to  
35 determine if the prisoner is likely to be rehabilitated within a reasonable period of time. The sole  
36 issue shall be whether the prisoner is likely to be rehabilitated within a reasonable period of time.  
37 The proceeding shall be conducted in the manner prescribed for a contested case hearing under ORS  
38 chapter 183, except that:

39 (a) The prisoner has the burden of proving by a preponderance of the evidence the likelihood  
40 of rehabilitation within a reasonable period of time;

41 (b) The prisoner has the right, if the prisoner is without sufficient funds to employ an attorney,  
42 to be represented by legal counsel, appointed by the board, at board expense; and

43 (c) The prisoner has the right to a subpoena upon a showing of the general relevance and rea-  
44 sonable scope of the evidence sought, provided that any subpoena issued on behalf of the prisoner  
45 must be issued by the board pursuant to rules adopted by the board.

1 (7) If, upon hearing all of the evidence, the board, upon a unanimous vote of [*all of its*] **three**  
2 **board members or, if the chairperson requires all voting members to participate, a unani-**  
3 **mous vote of all voting** members, finds that the prisoner is capable of rehabilitation and that the  
4 terms of the prisoner's confinement should be changed to life imprisonment with the possibility of  
5 parole, release on post-prison supervision or work release, it shall enter an order to that effect and  
6 the order shall convert the terms of the prisoner's confinement to life imprisonment with the possi-  
7 bility of parole, release on post-prison supervision or work release and may set a release date.  
8 Otherwise the board shall deny the relief sought in the petition.

9 (8) Not less than two years after the denial of the relief sought in a petition under this section,  
10 the prisoner may petition again for a change in the terms of confinement. Further petitions for a  
11 change may be filed at intervals of not less than two years thereafter.

12 **SECTION 48. In addition to and not in lieu of any other appropriation, there is appro-**  
13 **riated to the State Board of Parole and Post-Prison Supervision, for the biennium beginning**  
14 **July 1, 2015, out of the General Fund, the amount of \$3,163,183, for the purposes of carrying**  
15 **out the amendments to ORS 144.005, 144.015, 144.025, 144.035, 144.054, 144.079, 144.110, 144.783,**  
16 **163.105, 163.115 and 163.155 by sections 37 to 47 of this 2015 Act.**

26 **SECTION 50. This 2015 Act being necessary for the immediate preservation of the public**  
27 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
