ORS 181.800 is amended to read: 10 11 "181.800. The [Department of Corrections shall] State Board of Parole and Post-Prison 12 Supervision shall, in consultation with community corrections agencies, adopt by rule a sex 13 offender risk assessment [tool] methodology for use in classifying sex offenders [based on the sta-14 tistical likelihood that an individual sex offender will commit another sex crime].
