

House Bill 2338

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Judiciary for Judicial Department for Judicial Department)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies annual salaries of judges of Supreme Court, Court of Appeals, Oregon Tax Court and circuit courts.

9 for the year beginning January 1, [*2015*] **2016**, and for each year thereafter.
