House Bill 2348

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Provides honorably retired law enforcement officers with protections provided to Oregon concealed handgun license holders.

Declares emergency, effective on passage.

5 **SECTION 1.** ORS 166.173 is amended to read:

6 166.173. (1) A city or county may adopt ordinances to regulate, restrict or prohibit the pos-7 session of loaded firearms in public places as defined in ORS 161.015.

8 (2) Ordinances adopted under subsection (1) of this section do not apply to or affect:

9 (a) A law enforcement officer in the performance of official duty.

10 (b) A member of the military in the performance of official duty.

11 (c) A person licensed to carry a concealed handgun.

- (d) A person authorized to possess a loaded firearm while in or on a public building or courtfacility under ORS 166.370.
- (e) An employee of the United States Department of Agriculture, acting within the scope of
 employment, who possesses a loaded firearm in the course of the lawful taking of wildlife.

(e) Organizations which are by law authorized to purchase or receive weapons described in ORS 1 2 166.250 from the United States, or from this state. 3 (f) Duly authorized military or civil organizations while parading, or the members thereof when going to and from the places of meeting of their organization. 4 (g) A corrections officer while transporting or accompanying an individual convicted of or ar-5 rested for an offense and confined in a place of incarceration or detention while outside the confines 6 of the place of incarceration or detention. 7 (h) A person who is licensed under ORS 166.291 and 166.292 to carry a concealed handgun. 8 9 (i) An honorably retired law enforcement officer. (1) Any person who intentionally possesses a loaded or unloaded firearm or any other instrument used as a dangerous weapon, while in or on a public building, shall upon conviction be 24 guilty of a Class C felony. 25(2)(a) Except as otherwise provided in paragraph (b) of this subsection, a person who inten-2627tionally possesses: (A) A firearm in a court facility is guilty, upon conviction, of a Class C felony. A person who 28intentionally possesses a firearm in a court facility shall surrender the firearm to a law enforcement 2930 officer. 31 (B) A weapon, other than a firearm, in a court facility may be required to surrender the weapon to a law enforcement officer or to immediately remove it from the court facility.
