SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates crime of invasion of personal privacy in the first degree. Punishes by maximum of five years' imprisonment, \$125,000 fine, or both. Modifies crime of invasion of personal privacy and [*re-names*] **by renaming** crime invasion of personal privacy in the second degree.

Provides that court may designate invasion of personal privacy in the first degree as sex crime if circumstances of offense require defendant to register as sex offender.

Adds crimes of invasion of personal privacy in the first and second degrees to criminal code.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 163.700 is amended to read:

6 163.700. (1) Except as provided in ORS 163.702, a person commits the crime of invasion of per-
7 sonal privacy **in the second degree** if:

8 [(a)(A) *The person knowingly makes or records a photograph, motion picture, videotape or other*
9 *visual recording of another person in a state of nudity without the consent of the person being recorded;*
10 *and*]

11 [(B) *At the time the visual recording is made or recorded the person being recorded is in a place*
12 *and circumstances where the person has a reasonable expectation of personal privacy; or*]

13 [(b)(A) *For the purpose of arousing or gratifying the sexual desire of the person, the person is in*
14 *a location to observe another person in a state of nudity without the consent of the other person; and*]

15 [(B) *The other person is in a place and circumstances where the person has a reasonable expecta-*
16 *tion of personal privacy.*]

17 **(a) For the purpose of arousing or gratifying the sexual desire of the person, the person**
18 **is in a location to observe another person in a state of nudity without the consent of the**
19 **other person; and**

20 **(b) The other person is in a place and circumstances where the person has a reasonable**
21 **expectation of personal privacy.**

22 (2) As used in this section **and section 2 of this 2015 Act:**

23 (a) "Makes or records a photograph, motion picture, videotape or other visual recording" in-
24 cludes, but is not limited to, making or recording or employing, authorizing, permitting, compelling

1 or inducing another person to make or record a photograph, motion picture, videotape or other

3 (b) "Nudity" means any part of the uncovered or less than opaquely covered:

4 (A) Genitals;

5 (B) Pubic area; or

6 (C) Female breast below a point immediately above the top of the areola.

7 (c) "Places and circumstances where the person has a reasonable expectation of personal pri-
8 vacy" includes, but is not limited to, a bathroom, dressing room, locker room that includes an en-
9 closed area for dressing or showering, tanning booth and any area where a person undresses in an
10 enclosed space that is not open to public view.

11 (d) "Public view" means that an area can be readily seen and that a person within the area can
12 be distinguished by normal unaided vision when viewed from a public place as defined in ORS
13 161.015.

14 (3) Invasion of personal privacy **in the second degree** is a Class A misdemeanor.

15 **SECTION 2. (1) Except as provided in ORS 163.702, a person commits the crime of inva-**
16 **sion of personal privacy in the first degree if:**

17 (a)(A) **The person knowingly makes or records a photograph, motion picture, videotape**
18 **or other visual recording of another person in a state of nudity without the consent of the**
19 **other person; and**

20 (B) **At the time the visual recording is made or recorded the person being recorded is in**
21 **a place and circumstances where the person has a reasonable expectation of personal pri-**
22 **vacancy; or**

23 (b) **The person violates ORS 163.700 and, at the time of the offense, has a prior conviction**
24 **for:**

25 (A) **Invasion of personal privacy in any degree, public indecency, private indecency or a**
26 **sex crime as defined in ORS 181.805; or**

27 (B) **the statutory counterpart of an offense described in subparagraph (A) of this para-**
28 **graph in another jurisdiction.**

29 (2)(a) **Invasion of personal privacy in the first degree is a Class C felony.**

30 (b) **The Oregon Criminal Justice Commission shall classify invasion of personal privacy**
31 **in the first degree as crime category 6 of the sentencing guidelines grid of the commission.**

32 (3) **The court may designate invasion of personal privacy in the first degree as a sex**
33 **crime under ORS 181.805 if the court finds that the circumstances of the offense require the**
34 **defendant to register and report as a sex offender for the safety of the community.**

11 (B) For which the person would have to register as a sex offender in that court's jurisdiction,

15 (7) "Works" or "carries on a vocation" means full-time or part-time employment for more than
16 14 days within one calendar year whether financially compensated, volunteered or for the purpose

19 181.803. Notwithstanding any other provision of law:

20 (1) A person required to report as a sex offender under ORS 181.806, 181.807 or 181.808 is clas-
21 sified as a level three sex offender under ORS 181.800 (3) unless:

22 (a) Following a risk assessment conducted under ORS 181.801, the person is classified as a level
23 two sex offender under ORS 181.800 (2) or as a level one sex offender under ORS 181.800 (1); or

24 (b) After filing a petition under ORS 181.821 (2), the person is reclassified as a level two sex
25 offender under ORS 181.800 (2) by the State Board of Parole and Post-Prison Supervision or the
26 Psychiatric Security Review Board.

45 solicitation to commit aggravated murder or murder, or the death of the person killed.

1 (2) A prosecution for any of the following felonies may be commenced within six years after the
2 commission of the crime or, if the victim at the time of the crime was under 18 years of age, anytime
3 before the victim attains 30 years of age or within 12 years after the offense is reported to a law

1 ulation of disclosures, or portion of such showing, to be made in camera. A record shall be made
2 of such proceedings.
