

## SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2408

3 **“TRANSFER OF UNEXPENDED BALANCES**

5 **“SECTION 102. (1) The unexpended balances authorized to be expended by the Depart-**  
6 **ment of Community Colleges and Workforce Development for a one-year period beginning**  
7 **July 1, 2015, from revenues dedicated, continuously appropriated, appropriated or otherwise**  
8 **made available for the purpose of administering and enforcing the duties, functions and**  
9 **powers transferred from the Department of Community Colleges and Workforce Develop-**  
10 **ment to the Higher Education Coordinating Commission by the amendments to statutes by**  
11 **sections 1 to 99 of this 2015 Act by acquiring, constructing, improving, repairing, equipping**  
12 **and furnishing buildings, structures, land and other projects at community colleges pursuant**  
13 **to section 7 (1) and (7), chapter 904, Oregon Laws 2009, and section 4 (3), chapter \_\_\_\_\_,**  
14 **Oregon Laws 2015 (Enrolled House Bill 5006), are transferred to and are available for ex-**  
15 **penditure by the Higher Education Coordinating Commission for the one-year period specified**  
16 **for the purpose of administering and enforcing the duties, functions and powers transferred**  
17 **by the amendments to statutes by sections 1 to 99 of this 2015 Act.**

18 **“(2) The unexpended balances authorized to be expended by the Department of Commu-**  
19 **nity Colleges and Workforce Development for a two-year period beginning July 1, 2015, from**  
20 **revenues dedicated, continuously appropriated, appropriated or otherwise made available for**  
21 **the purpose of administering and enforcing the duties, functions and powers transferred**  
22 **from the Department of Community Colleges and Workforce Development to the Higher**  
23 **Education Coordinating Commission by the amendments to statutes by sections 1 to 99 of**  
24 **this 2015 Act for community college districts for capital construction, deferred maintenance**  
25 **capital renewal, code compliance and safety projects pursuant to section 2, chapter 78,**  
26 **Oregon Laws 2012, and section 11 (1), (3), (4) to (6), (8), (10), (11), (13), (14) and (17), chapter**  
27 **79, Oregon Laws 2012, are transferred to and are available for expenditure by the Higher**  
28 **Education Coordinating Commission for the two-year period specified for the purpose of ad-**  
29 **ministering and enforcing the duties, functions and powers transferred by the amendments**  
30 **to statutes by sections 1 to 99 of this 2015 Act.**

31 **“(3) The unexpended balances authorized to be expended by the Department of Commu-**  
32 **nity Colleges and Workforce Development for a period ending July 1, 2015, from revenues**  
33 **dedicated, continuously appropriated, appropriated or otherwise made available for the pur-**  
34 **pose of administering and enforcing the duties, functions and powers transferred from the**  
35 **Department of Community Colleges and Workforce Development to the Higher Education**

1 **Coordinating Commission by the amendments to statutes by sections 1 to 99 of this 2015 Act**  
2 **by acquiring, constructing, improving, repairing, equipping and furnishing buildings, struc-**  
3 **tures, land and other projects at community colleges pursuant to section 7 (9), chapter 904,**  
4 **Oregon Laws 2009, are transferred to and are available for expenditure by the Higher Edu-**  
5 **cation Coordinating Commission for the six-year period specified for the purpose of admin-**  
6 **istering and enforcing the duties, functions and powers transferred by the amendments to**  
7 **statutes by sections 1 to 99 of this 2015 Act.**

8 **“(4) The unexpended balances authorized to be expended by the Department of Commu-**  
9 **nity Colleges and Workforce Development for a four-year period beginning July 1, 2015, from**  
10 **revenues dedicated, continuously appropriated, appropriated or otherwise made available for**  
11 **the purpose of administering and enforcing the duties, functions and powers transferred**  
12 **from the Department of Community Colleges and Workforce Development to the Higher**  
13 **Education Coordinating Commission by the amendments to statutes by sections 1 to 99 of**  
14 **this 2015 Act by acquiring, constructing, improving, repairing, equipping and furnishing**  
15 **buildings, structures, land and other projects at community colleges pursuant to section 6**  
16 **(2) to (5), (8), (9), (11) and (14), chapter 727, Oregon Laws 2013, and sections 3 (1) and 4,**  
17 **chapter 120, Oregon Laws 2014, are transferred to and are available for expenditure by the**  
18 **Higher Education Coordinating Commission for the four-year period specified for the purpose**  
19 **of administering and enforcing the duties, functions and powers transferred by the amend-**  
20 **ments to statutes by sections 1 to 99 of this 2015 Act.”.**

21 In line 14, delete “102” and insert “103”.

22 In line 20, delete “103” and insert “104”.
