**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Repeals unfunded higher education loan, scholarship and grant programs.

Combines fund accounts for alternative student loan program, scholarships for foster youth[,] **and** Nursing Services Program [*and Nursing Faculty Loan Repayment Program*] to allow consolidated accounting.

Separates statute regarding scholarships for foster youth and scholarships for dependent children of deceased and disabled public safety officers into two statutes.

Declares emergency, effective on passage.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1. ORS 348.040, 348.050, 348.070, 348.090, 348.095, 348.186, 348.210, 348.230, 348.265,**  
9 **348.427, 348.429, 348.431, 348.433 and 348.436 are repealed.**

10 **SECTION 2. ORS 348.310, 348.320, 348.330, 348.340, 348.350, 348.360, 348.370 and 348.390 are**  
11 **repealed.**

12 **SECTION 3. The repeal of ORS 348.310, 348.320, 348.330, 348.340, 348.350, 348.360, 348.370**  
13 **and 348.390 by section 2 of this 2015 Act becomes operative on July 1, 2017.**

14 **SECTION 4. (1) The Community Service Voucher Fund is abolished. Any moneys re-**  
15 **maining in the Community Service Voucher Fund on the effective date of this 2015 Act that**  
16 **are unexpended, unobligated and not subject to any conditions are transferred to the General**  
17 **Fund.**

18 **(2) The Rural Medical Education Loan Fund is abolished. Any moneys remaining in the**  
19 **Rural Medical Education Loan Fund on the operative date of the repeal of ORS 348.390 by**  
20 **section 2 of this 2015 Act that are unexpended, unobligated and not subject to any conditions**  
21 **are transferred to the General Fund.**

43 *ORS 293.701 to 293.857 and for the payment of the expenses of the Higher Education Coordinating*  
44 *Commission in carrying out the purposes of ORS 348.210 to 348.250, 348.285, 348.505 to 348.615,*  
45 *348.696 and 348.992*]. Interest earned by the fund shall be credited to the fund.

1       **(b) The fund shall consist of moneys appropriated to the Higher Education Coordinating**  
2       **Commission for deposit into the fund, collections and penalties received by the Executive**  
3       **Director of the Office of Student Access and Completion under ORS 442.545 and any do-**

35       *out the provisions of ORS 348.270 (1)(b). Interest earned by the fund shall be credited to the fund.]*

36       **[(5)] (2) There is established in the State Treasury a fund, separate and distinct from the Gen-**  
37       **eral Fund, to be known as the ASPIRE Program Fund. Moneys received from donations and grants**  
38       **shall be credited to the ASPIRE Program Fund. Moneys in the fund are continuously appropriated**  
39       **to the commission for the purposes of investment, as provided by ORS 293.701 to 293.857, and for**  
40       **carrying out the provisions of ORS 348.500. Interest earned by the fund shall be credited to the fund.**

41       **[(6)(a)] (3)(a) There is established in the State Treasury the Nursing Faculty Loan Repayment**  
42       **Fund, separate and distinct from the General Fund. Interest earned on the Nursing Faculty Loan**  
43       **Repayment Fund shall be credited to the fund. Moneys in the fund are continuously appropriated to**  
44       **the commission for carrying out ORS 348.440 to 348.448. The Nursing Faculty Loan Repayment Fund**  
45       **consists of:**

1 (A) Moneys appropriated to the commission for the Nursing Faculty Loan Repayment Program

3 (B) Grants, gifts or donations received by the commission for the program.

4 (b) Any unexpended funds in the fund at the end of a biennium shall be retained in the fund and  
5 may be expended in subsequent biennia.

6 **SECTION 9. (1) The Alternative Student Loan Program Fund, Nursing Services Account  
7 and Foster Youth Scholarship Fund are abolished.**

8 **(2) Any moneys remaining in the funds or account on the effective date of this 2015 Act  
9 that are unexpended, unobligated and not subject to any conditions are transferred to the  
10 Oregon Student Assistance Fund.**

11 **SECTION 10.** ORS 327.425 is amended to read:

12 327.425. (1) All moneys belonging to the Common School Fund and not required to meet current  
13 expenses shall be loaned by the Department of State Lands at a rate of interest fixed by the de-  
14 partment [*except as otherwise specified in ORS 348.050 (3)*]. The department may consult with and  
15 obtain the recommendation of the Oregon Investment Council in fixing the interest rate.

16 (2) Common School Fund moneys may be loaned in accordance with the repayment plan con-  
17 tained in ORS 327.440 [*and in ORS 348.050 (4)*], except that loans on property within the corporate  
18 limits of towns or cities shall be payable in not more than 15 years on the amortization plan.

19 (3) If at any time there is a Common School Fund surplus over and above all loans applied for,  
20 such portion of the surplus as the department deems proper may be invested as provided in ORS  
21 293.701 to 293.857. The department may require the State Treasurer to deposit any such surplus,  
22 until it is able to loan same, in qualified state depositories, upon the same terms and conditions as  
23 other public funds are deposited therein, in which event any interest received from any such state  
24 depository shall be credited to the fund on which such interest was earned.

25 (4) [*Except as provided in ORS 348.050 (3),*] The department may reduce the rate of interest to  
26 be paid upon outstanding loans from the Common School Fund and any trust fund placed in its  
27 charge, to correspond with the rate of interest to be paid upon new loans, but no reduction in rate  
28 of interest shall be made upon any of the loans until interest at the old rate has been paid in full  
29 to date of receipt of remittance at the office of the department.

30 **SECTION 11.** ORS 327.430 is amended to read:

31 327.430. (1) The principal and interest of all loans shall be paid in lawful money of the United  
32 States.

33 (2) [*Except for loans to students authorized by ORS 348.050,*] Loans shall be secured by note  
34 specifying the fund from which the loan is made and mortgage to the Department of State Lands  
35 on improved land within this state, or upon range or grazing land therein. Except as provided in  
36 ORS 273.815, the security for a secured loan shall be not less than twice the value of the amount  
37 loaned, and, except as otherwise provided in subsection (3) of this section, shall be of unexceptional  
38 title and free from all encumbrances. A secured loan may be secured by a deposit of obligations of  
39 the United States or of bonds or warrants of this state of a face value of not less than 25 percent  
40 in excess of such loans.

41 (3) The department is not prohibited by subsection (2) of this section from making a secured loan  
42 merely because the land securing the loan is:

43 (a) Situated in an irrigation district, taking into consideration the amount of bonded indebt-  
44 edness of the district as compared with the valuation of the real property of the district.

45 (b) Subject to a reservation of mineral rights.

- 1 (c) Subject to a lease of any kind.
- 2 (d) Subject to a statutory lien for public improvements.
- 3 (e) Subject to an easement.

4 **SECTION 12.** ORS 327.482 is amended to read:

5 327.482. Out of the moneys in the General Fund, there is continuously appropriated such sums  
6 as are necessary but not to exceed \$100,000 in total to reimburse the Common School Fund for [*any*  
7 *loss which may result from the failure of any student to repay the amounts loaned to the student under*  
8 *ORS 348.050, and for*] any amount [*which*] **that** may result from the failure of loans to earn at least  
9 four percent interest. The computation required to determine the interest earned on the loans shall  
10 be made annually, and the amount required to reimburse the fund shall be paid annually.

11 **SECTION 13.** ORS 327.484 is amended to read:

12 327.484. Moneys may be withdrawn **annually on July 1** [*periodically*] from the General Fund by  
13 order of the Department of State Lands to be credited to the Common School Fund [*to reimburse the*  
14 *Common School Fund for any loss which may result from the failure of any student to repay the*  
15 *amounts loaned to the student under ORS 348.050 and annually on July 1*] to pay to the Common  
16 School Fund any amount resulting from the failure of the total student loans to earn at least four  
17 percent interest in the preceding fiscal year.

18 **SECTION 14.** ORS 348.180 is amended to read:

19 348.180. As used in this section and ORS [*348.186,*] 348.205, [*348.230,*] 348.250, 348.260 and  
20 348.285:

- 21 (1) "Cost of education" includes but is not limited to, tuition, fees and living expenses.
- 22 (2) "Eligible post-secondary institution" means:
  - 23 (a) A public university listed in ORS 352.002;
  - 24 (b) A community college operated under ORS chapter 341;
  - 25 (c) The Oregon Health and Science University; or
  - 26 (d) An Oregon-based, generally accredited, not-for-profit institution of higher education.
- 27 (3) "Qualified student" means any resident student who plans to attend an eligible post-  
28 secondary institution and who:
  - 29 (a) Has not achieved a baccalaureate or higher degree from any post-secondary institution;
  - 30 (b) Is enrolled in an eligible program as defined by rule of the Higher Education Coordinating

35 Education Coordinating Commission in the manner provided in this section.

36 (2) Persons interested in obtaining a grant established under ORS [*348.230 and*] 348.260 may  
37 apply to the Executive Director of the Office of Student Access and Completion for a grant.

38 (3) The executive director shall screen or cause to be screened the applications and shall de-  
39 termine for each available grant the person best qualified to receive that grant. A qualified appli-  
40 cant is eligible to receive a grant established under ORS [*348.230 and*] 348.260 if:

- 41 (a) The applicant's financial need is such that in the opinion of the executive director financial  
42 aid is warranted; and
- 43 (b) The applicant plans to be a student at the eligible post-secondary institution where the grant

14 **tion 7 of this 2015 Act.**

15 (b) Grant the appropriate scholarships under ORS 348.270 **and section 7 of this 2015 Act.**

16 (c) Make necessary rules for application and distribution of the benefits available under ORS  
17 348.270 and this section **and section 7 of this 2015 Act.**

18 (d) In awarding scholarships pursuant to its authority under ORS 348.520, give priority to stu-  
19 dents who are eligible to receive scholarships under ORS 348.270 **and section 7 of this 2015 Act.**

24 348.530. The Higher Education Coordinating Commission may:

25 (1) Negotiate for and contract with private and governmental agencies for the establishment of  
26 financial aid programs.

27 (2) Receive gifts of any type, including gifts of stock and real property, for the purpose of es-  
28 tablishing, continuing and increasing financial aid.

29 (3) Administer any form of financial aid submitted to and accepted for administration by the  
30 commission.

31 (4) Authorize payment from funds appropriated therefor, of costs, commissions, attorney fees and  
32 other reasonable expenses, including refund of overpayment of fees, that are related to and neces-  
33 sary for making and protecting guaranteed loans and recovering moneys and loans and management  
34 of property acquired in connection with such loans.

35 (5) Sue and be sued.

36 (6) Cooperatively coordinate all types of financial aid activities.

37 [(7) *Establish a State of Oregon scholar program to recognize students with outstanding academic*  
38 *achievement and other demonstrated attributes. The students will not necessarily receive financial*  
39 *aid.*]

40 [(8) *Guarantee loans by eligible lending institutions to student residents of the State of Oregon who*  
41 *are enrolled or accepted for enrollment at any eligible institution, nonresident students enrolled or ac-*  
42 *cepted for enrollment in an institution of higher education or community college in Oregon, and parents*  
43 *of those students, under the provisions of the Higher Education Act of 1965 as amended.*]

44 [(9)] (7) Deny financial aid to any student owing a refund or in default on financial aid previ-  
45 ously made available to that student.



1        [(10) Establish and implement any program permitted under federal law to guaranty agencies, in-  
2        cluding administrative garnishment and wage withholding under Public Law 102-164, section 605.]

3        **SECTION 18.** ORS 348.665 is amended to read:

4        348.665. Bonds authorized under ORS 348.570 and 348.625 to 348.695 shall be issued in accord-  
5        ance with the provisions of ORS chapter 286A. The State Treasurer, in consultation with the Higher  
6        Education Coordinating Commission, may establish special accounts or subaccounts in the [*Alter-*  
7        *native Student Loan Program Fund created*] **Oregon Student Assistance Fund established** by ORS  
8        348.570 and may pledge the assets or the revenues, or any portion of the assets or revenues, of the  
9        alternative student loan program.

10       **SECTION 19.** ORS 348.685 is amended to read:

11       348.685. The official action authorizing the issuance of bonds under ORS 348.570 and 348.625 to  
12       348.695 may contain covenants, notwithstanding that such covenants may limit the exercises of  
13       powers conferred by ORS 348.570 and 348.625 to 348.695 in the following respects and in such other  
14       respects as the state, acting through the State Treasurer, in consultation with the Higher Education  
15       Coordinating Commission, or the designee of the commission, may decide:

16       (1) The use and disposition of the revenues from repayment;

17       (2) The creation and maintenance of special accounts or subaccounts in the [*Alternative Student*

2 (a) Shall not be payable from nor charged upon any funds other than the revenue pledged to the  
3 payment thereof, except as provided in this section, nor shall the state be subject to any liability  
4 thereon. No holder or holders of such bonds shall ever have the right to compel any exercise of the  
5 taxing power of the state to pay any such bonds or the interest thereon, nor to enforce payment  
6 thereof against any property of the state.

7 (b) Shall not constitute a charge, lien or encumbrance, legal or equitable, upon any property of  
8 the state other than the [*Alternative Student Loan Program Fund created*] **Oregon Student Assist-**  
9 **ance Fund established** by ORS 348.570, any account or subaccount thereof or student loans, if any,

22 behalf of nurses who agree to practice in nursing critical shortage areas.
