# B-Engrossed House Bill 2419

Ordered by the Senate May 22  
Including House Amendments dated February 20 and Senate Amendments  
dated May 22 to resolve conflicts

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber, M.D., for Oregon Health Authority)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies definition of "health care interpreter" and revises membership of Oregon Council on Health Care Interpreters. Modifies health care data reporting requirements. Repeals statute requiring development of preferred drug list. Modifies qualifications for Public Health Officer. Removes obsolete references to Blue Mountain Recovery Center. Replaces references to Office for Oregon Health Policy and Research with references to Oregon Health Authority. Aligns references relating to screening interviews and treatment programs for alcohol and drug diversion programs.

## A BILL FOR AN ACT

**Be It Enacted by the People of the State of Oregon:**

## HEALTH CARE INTERPRETERS

**SECTION 1.** ORS 413.550 is amended to read:

413.550. As used in ORS 413.550 to 413.558:

*[(1) "Health care interpreter" means a person who is readily able to communicate with a person with limited English proficiency and to accurately translate the written or oral statements of the person with limited English proficiency into English, and who is readily able to translate the written or oral statements of other persons into the language of the person with limited English proficiency.]*

*[(2) "Health care" means medical, surgical or hospital care or any other remedial care recognized by state law, including mental health care.]*

**(1) "Certified health care interpreter" means an individual who has been approved and certified by the Oregon Health Authority.**

**(2) "Health care" means medical, surgical or hospital care or any other remedial care recognized by state law, including physical and behavioral health care.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1       **(3) “Health care interpreter” means an individual who is readily able to:**

2       **(a) Communicate with a person with limited English proficiency;**

3       **(b) Accurately interpret the oral statements of a person with limited English proficiency,**  
4 **or the statements of a person who communicates in sign language, into English;**

5       **(c) Sight translate documents from a person with limited English proficiency;**

6       **(d) Interpret the oral statements of other persons into the language of the person with**  
7 **limited English proficiency or into sign language; and**

8       **(e) Sight translate documents in English into the language of the person with limited**  
9 **English proficiency.**

10       [(3)] **(4) “Person with limited English proficiency” means a person who, by reason of place of**  
11 **birth or culture, speaks a language other than English and does not speak English with adequate**  
12 **ability to communicate effectively with a health care provider.**

13       **(5) “Qualified health care interpreter” means an individual who has received a valid letter**  
14 **of qualification from the authority.**

15       **(6) “Sight translate” means to translate a written document into spoken or sign lan-**  
16 **guage.**

17       **SECTION 2.** ORS 413.552 is amended to read:

18       413.552. (1) The Legislative Assembly finds that persons with limited English proficiency, **or**  
19 **who communicate in sign language**, are often unable to interact effectively with health care  
20 providers. Because of language differences, persons with limited English proficiency, **or who com-**  
21 **municate in sign language**, are often excluded from health care services, experience delays or  
22 denials of health care services or receive health care services based on inaccurate or incomplete  
23 information.

24       (2) The Legislative Assembly further finds that the lack of competent health care interpreters  
25 among health care providers impedes the free flow of communication between the health care pro-  
26 vider and patient, preventing clear and accurate communication and the development of empathy,  
27 confidence and mutual trust that is essential for an effective relationship between health care pro-  
28 vider and patient.

29       **(3) It is the policy of the Legislative Assembly to require the use of certified health care**  
30 **interpreters or qualified health care interpreters whenever possible to ensure the accurate**  
31 **and adequate provision of health care to persons with limited English proficiency and to**  
32 **persons who communicate in sign language.**

33       [(3)] **(4) It is the policy of the Legislative Assembly that health care for persons with limited**  
34 **English proficiency be provided according to the guidelines established under the policy statement**  
35 **issued August 30, 2000, by the U.S. Department of Health and Human Services, Office for Civil**  
36 **Rights, entitled, “Title VI of the Civil Rights Act of 1964; Policy Guidance on the Prohibition**  
37 **Against National Origin Discrimination As It Affects Persons With Limited English Proficiency,”**  
38 **and the 1978 Patient’s Bill of Rights.**

39       **SECTION 3.** ORS 413.554 is amended to read:

40       413.554. (1) The Oregon Council on Health Care Interpreters is created in the Oregon Health  
41 Authority. The council shall consist of [25 members appointed as follows:] **no more than 15 mem-**  
42 **bers, appointed by the Director of the Oregon Health Authority, representing:**

43       **(a) Persons with expertise and experience in the administration of or policymaking for**  
44 **programs or services related to interpreters;**

45       **(b) Employers or contractors of health care interpreters;**

1 (c) Health care interpreter training programs;

2 (d) Language access service providers; and

3 (e) Practicing certified and qualified health care interpreters.

4 [(a) The Governor shall appoint two members from each of the following groups:]

5 [(A) Consumers of medical services who are persons with limited English proficiency and who use  
6 health care interpreters;]

7 [(B) Educators who either teach interpreters or persons in related educational fields, or who train  
8 recent immigrants and persons with limited English proficiency;]

9 [(C) Persons with expertise and experience in administration or policymaking related to the devel-  
10 opment and operation of policies, programs or services related to interpreters, and who have familiarity  
11 with the rulings of the federal Office for Civil Rights concerning interpreter services for various insti-  
12 tutions;]

13 [(D) Health care providers, consisting of one physician and one registered nurse, who utilize in-  
14 terpreter services regularly in their practice;]

15 [(E) Representatives of safety net clinics that predominantly serve persons with limited English  
16 proficiency; and]

17 [(F) Representatives of hospitals, health systems and health plans predominantly serving persons  
18 with limited English proficiency.]

19 [(b) The Governor shall appoint one representative from each of the following agencies and or-  
20 ganizations after consideration of nominations by the executive authority of each:]

21 [(A) The Commission on Asian and Pacific Islander Affairs;]

22 [(B) The Commission on Black Affairs;]

23 [(C) The Commission on Hispanic Affairs;]

24 [(D) The Commission on Indian Services;]

25 [(E) The International Refugee Center of Oregon;]

26 [(F) The Oregon Judicial Department's Certified Court Interpreter program;]

27 [(G) The Commission for Women; and]

28 [(H) The Institute for Health Professionals of Portland Community College.]

29 [(c) The Director of the Oregon Health Authority shall appoint three members including:]

30 [(A) One member with responsibility for administering mental health programs;]

31 [(B) One member with responsibility for administering medical assistance programs; and]

32 [(C) One member with responsibility for administering public health programs.]

33 [(d) The Director of Human Services shall appoint:]

34 [(A) One member with responsibility for administering developmental disabilities programs; and]

35 [(B) One member with responsibility for administering programs for seniors and persons with  
36 disabilities.]

37 [(e)] (2) The membership of the council shall be appointed so as to be representative of the ra-  
38 cial, ethnic, cultural, social and economic diversity of the people of this state.

39 [(2)] (3) The term of a member shall be three years. A member may be reappointed.

40 [(3)] (4) If there is a vacancy for any cause, the [appointing authority] **director** shall make an  
41 appointment to become immediately effective for the unexpired term. The [appointing authority] **di-**  
42 **rector** may appoint a replacement for any member of the council who misses more than two con-  
43 secutive meetings of the council. The newly appointed member shall represent the same group as the  
44 vacating member.

45 [(4)] (5) The council shall select one member as chairperson and one member as vice chair-

1 person, for such terms and with duties and powers as the council determines necessary for the  
2 performance of the functions of such offices.

3 [(5)] (6) The council may establish such advisory and technical committees as it considers nec-  
4 essary to aid and advise the council in the performance of its functions. The committees may be  
5 continuing or temporary committees. The council shall determine the representation, membership,  
6 terms and organization of the committees and shall appoint committee members.

7 [(6)] (7) A majority of the members of the council shall constitute a quorum for the transaction  
8 of business.

9 [(7)] (8) Members of the council are not entitled to compensation, but at the discretion of the  
10 director [*of the Oregon Health Authority*] may be reimbursed for actual and necessary travel and  
11 other expenses incurred by them in the performance of their official duties, subject to ORS 292.495.

12 [(8)] (9) The council may accept contributions of funds and assistance from the United States  
13 Government or its agencies or from any other source, public or private, for purposes consistent with  
14 the purposes of the council.

15 [(9)] (10) The Oregon Health Authority shall provide the council with such services and em-  
16 ployees as the council requires to carry out its duties.

17 **SECTION 4.** ORS 413.556 is amended to read:

18 413.556. The Oregon Council on Health Care Interpreters shall work in cooperation with the  
19 Oregon Health Authority to:

20 (1) Develop testing, qualification and certification standards for health care interpreters for  
21 persons with limited English proficiency **and for persons who communicate in sign language.**

22 (2) Coordinate with other states, **the federal government or professional organizations** to  
23 develop and implement educational and testing programs for health care interpreters.

24 (3) Examine operational and funding issues, including but not limited to the feasibility of devel-  
25 oping a central registry and annual subscription mechanism for health care interpreters.

26 (4) Do all other acts as shall be necessary or appropriate under the provisions of ORS 413.550  
27 to 413.558.

28 **SECTION 5.** ORS 413.558 is amended to read:

29 413.558. (1) In consultation with the Oregon Council on Health Care Interpreters, the Oregon  
30 Health Authority shall by rule establish procedures for testing, qualification and certification of  
31 health care interpreters for persons with limited English proficiency **or for persons who commu-  
32 nicate in sign language**, including but not limited to:

33 (a) Minimum standards for qualification and certification as a health care interpreter, including:

34 (A) Oral and written language skills in English and in the language for which health care in-  
35 terpreter qualification or certification is granted; and

36 (B) Formal education or training in medical terminology, anatomy and physiology, [*and  
37 medical*] **medical interpreting ethics and interpreting skills;**

38 (b) Categories of expertise of health care interpreters based on the English and non-English  
39 skills, **or interpreting skills**, and the medical terminology skills of the person seeking qualification  
40 or certification;

41 (c) Procedures for receiving applications and for examining applicants for qualification or cer-  
42 tification;

43 (d) The content and administration of required examinations;

44 (e) The requirements and procedures for reciprocity of qualification and certification for health  
45 care interpreters qualified or certified in another state or territory of the United States **or by an-**

1 **other certifying body in the United States;** and

2 (f) Fees for application, examination, initial issuance, renewal and reciprocal acceptance of  
3 qualification or certification as a health care interpreter [*and for other fees*] **if** deemed necessary by  
4 the authority.

5 (2) Any person seeking qualification or certification as a health care interpreter must submit  
6 an application to the authority. If the applicant meets the requirements for qualification or certi-  
7 fication established by the authority under this section, the authority shall issue [*an annual certif-*  
8 *icate*] **a letter** of qualification or a certification to the health care interpreter. [*The authority shall*  
9 *collect a fee for the issuance of the certificate of qualification or the certification and for any required*  
10 *examinations in the amount established pursuant to subsection (1) of this section.*]

11 (3) The authority shall work with other states, **the federal government or professional or-**  
12 **ganizations** to develop educational and testing programs and procedures for the qualification and  
13 certification of health care interpreters.

14 (4) In addition to the requirements for qualification established under subsection (1) of this  
15 section, a person may be qualified as a health care interpreter only if the person:

16 (a) Is able to fluently interpret [*or translate*] the dialect, slang or specialized vocabulary of the  
17 non-English language for which qualification is sought; **and**

18 (b) Has had at least 60 hours of health care interpreter training that includes anatomy and  
19 physiology and concepts of medical interpretation[; *and*].

20 [*Has had practical experience as an intern with a practicing health care interpreter.*]

21 (5) A person may not use the title of “qualified health care interpreter” **in this state** unless the  
22 person has met the requirements for qualification established under subsections (1) and (4) of this  
23 section and has been issued a valid [*certificate*] **letter** of qualification by the authority.

24 (6) In addition to the requirements for certification established under subsection (1) of this sec-  
25 tion, a person may be certified as a health care interpreter only if:

26 (a) The person has met all the requirements established under subsection (4) of this section; and

27 (b) The person has passed written and oral examinations required by the authority in English,  
28 in [*the*] **a non-English language** [*the person wishes to translate*] **or sign language** and in medical  
29 terminology.

30 (7) A person may not use the title of “certified health care interpreter” **in this state** unless the  
31 person has met the requirements for certification established under subsections (1) and (6) of this  
32 section and has been issued a valid certification by the authority.

34 **HEALTH CARE DATA REPORTING**

35  
36 **SECTION 6.** ORS 442.120 is amended to read:

37 442.120. In order to provide data essential for health planning programs:

38 (1) The [*Office for Oregon Health Policy and Research*] **Oregon Health Authority** may request,  
39 by July 1 of each year, each general hospital to file with the [*office*] **authority** ambulatory surgery  
40 and inpatient discharge abstract records covering all patients discharged during the preceding cal-  
41 endar year. The ambulatory surgery and inpatient discharge abstract record for each patient must  
42 include the following information, and may include other information deemed necessary by the  
43 [*office*] **authority** for developing or evaluating statewide health policy:

44 (a) Date of birth;

45 (b) Sex;

- 1       **(c) Race and ethnicity;**
- 2       **(d) Primary language;**
- 3       **(e) Disability;**
- 4       [(c)] **(f) Zip code;**
- 5       [(d)] **(g) Inpatient admission date or outpatient service date;**
- 6       [(e)] **(h) Inpatient discharge date;**
- 7       [(f)] **(i) Type of discharge;**
- 8       [(g)] **(j) Diagnostic related group or diagnosis;**
- 9       [(h)] **(k) Type of procedure performed;**
- 10      [(i)] **(L) Expected source of payment, if available;**
- 11      [(j)] **(m) Hospital identification number; and**
- 12      [(k)] **(n) Total hospital charges.**

13       (2) By July 1 of each year, the [office] **authority** may request from ambulatory surgical centers  
14 licensed under ORS 441.015 ambulatory surgery discharge abstract records covering all patients  
15 admitted during the preceding year. Ambulatory surgery discharge abstract records must include  
16 information similar to that requested from general hospitals under subsection (1) of this section.

17       (3) In lieu of abstracting and compiling the records itself, the [office] **authority** may solicit the  
18 voluntary submission of such data from Oregon hospitals or other sources to enable it to carry out  
19 its responsibilities under this section. If such data are not available to the [office] **authority** on an  
20 annual and timely basis, the [office] **authority** may establish by rule a fee to be charged to each  
21 hospital.

22       (4) Subject to prior approval of the Oregon Health Policy Board and a report to the Emergency  
23 Board, if the Legislative Assembly is not in session, prior to adopting the fee, and within the budget  
24 authorized by the Legislative Assembly as the budget may be modified by the Emergency Board, the  
25 fee established under subsection (3) of this section may not exceed the cost of abstracting and  
26 compiling the records.

27       (5) The [office] **authority** may specify by rule the form in which the records are to be submitted.  
28 If the form adopted by rule requires conversion from the form regularly used by a hospital, reason-  
29 able costs of such conversion shall be paid by the [office] **authority**.

30       (6) Abstract records must include a patient identifier that allows for the statistical matching of  
31 records over time to permit public studies of issues related to clinical practices, health service  
32 utilization and health outcomes. Provision of such a patient identifier must not allow for identifica-  
33 tion of the individual patient.

34       (7) In addition to the records required in subsection (1) of this section, the [office] **authority**  
35 may obtain abstract records for each patient that identify specific services, classified by Interna-  
36 tional Classification of Disease Code, for special studies on the incidence of specific health problems  
37 or diagnostic practices. However, nothing in this subsection shall authorize the publication of spe-  
38 cific data in a form that allows identification of individual patients or licensed health care profes-  
39 sionals.

40       (8) The [office] **authority** may provide by rule for the submission of records for enrollees in a  
41 health maintenance organization from a hospital associated with such an organization in a form the  
42 [office] **authority** determines appropriate to the [office's] **authority's** needs for such data and the  
43 organization's record keeping and reporting systems for charges and services.

**QUALIFICATIONS FOR PUBLIC HEALTH OFFICER**



1 (7) "State hospital" means the Oregon State Hospital[, *Blue Mountain Recovery Center*] and any  
2 other hospital established by law for similar purposes.

3 (8) "Unauthorized departure" means the unauthorized departure of a person confined by court  
4 order in a youth correction facility or a state hospital that, because of the nature of the court order,  
5 is not a correctional facility as defined in this section, or the failure to return to custody after any  
6 form of temporary release or transitional leave from a correctional facility.

7 **SECTION 9.** ORS 179.010 is amended to read:

8 179.010. As used in this chapter, unless the context requires otherwise:

9 (1) "Institution" means the institutions designated in ORS 179.321.

10 (2) "Agency" means:

11 (a) The Department of Corrections when the institution is a Department of Corrections institu-  
12 tion, as defined in ORS 421.005;

13 (b) The Department of Human Services when the institution is the facility formerly used as the  
14 Eastern Oregon Training Center; or

15 (c) The Oregon Health Authority when the institution is [*the Blue Mountain Recovery Center*  
16 *or*] an Oregon State Hospital campus.

17 **SECTION 10.** ORS 179.321 is amended to read:

18 179.321. (1) The Oregon Health Authority shall operate, control, manage and supervise the [*Blue*  
19 *Mountain Recovery Center and the*] Oregon State Hospital campuses.

20 (2) The Department of Corrections shall operate, control, manage and supervise those insti-  
21 tutions defined as Department of Corrections institutions in ORS 421.005.

22 **SECTION 11.** ORS 179.331 is amended to read:

23 179.331. (1) The superintendents shall be appointed and, whenever the public service requires  
24 such action, may be removed, suspended or discharged, as follows:

25 (a) The [*superintendents of the Blue Mountain Recovery Center and*] **superintendent of** the  
26 Oregon State Hospital, by the Director of the Oregon Health Authority.

27 (b) The superintendents of Department of Corrections institutions as defined in ORS 421.005, by  
28 the Director of the Department of Corrections.

29 (2) For purposes of the State Personnel Relations Law, the superintendents are assigned to the  
30 unclassified service.

31 **SECTION 12.** ORS 179.505 is amended to read:

32 179.505. (1) As used in this section:

33 (a) "Disclosure" means the release of, transfer of, provision of access to or divulgence in any  
34 other manner of information outside the health care services provider holding the information.

35 (b) "Health care services provider" means:

36 (A) Medical personnel or other staff employed by or under contract with a public provider to  
37 provide health care or maintain written accounts of health care provided to individuals; or

38 (B) Units, programs or services designated, operated or maintained by a public provider to pro-  
39 vide health care or maintain written accounts of health care provided to individuals.

40 (c) "Individually identifiable health information" means any health information that is:

41 (A) Created or received by a health care services provider; and

42 (B) Identifiable to an individual, including demographic information that identifies the individual,  
43 or for which there is a reasonable basis to believe the information can be used to identify an indi-  
44 vidual, and that relates to:

45 (i) The past, present or future physical or mental health or condition of an individual;

- 1 (ii) The provision of health care to an individual; or  
2 (iii) The past, present or future payment for the provision of health care to an individual.  
3 (d) "Personal representative" includes but is not limited to:  
4 (A) A person appointed as a guardian under ORS 125.305, 419B.372, 419C.481 or 419C.555 with  
5 authority to make medical and health care decisions;  
6 (B) A person appointed as a health care representative under ORS 127.505 to 127.660 or a rep-  
7 resentative under ORS 127.700 to 127.737 to make health care decisions or mental health treatment  
8 decisions; and  
9 (C) A person appointed as a personal representative under ORS chapter 113.  
10 (e) "Psychotherapy notes" means notes recorded in any medium:  
11 (A) By a mental health professional, in the performance of the official duties of the mental  
12 health professional;  
13 (B) Documenting or analyzing the contents of conversation during a counseling session; and  
14 (C) That are maintained separately from the rest of the individual's record.  
15 (f) "Psychotherapy notes" does not mean notes documenting:  
16 (A) Medication prescription and monitoring;  
17 (B) Counseling session start and stop times;  
18 (C) Modalities and frequencies of treatment furnished;  
19 (D) Results of clinical tests; or  
20 (E) Any summary of the following items:  
21 (i) Diagnosis;  
22 (ii) Functional status;  
23 (iii) Treatment plan;  
24 (iv) Symptoms;  
25 (v) Prognosis; or  
26 (vi) Progress to date.  
27 (g) "Public provider" means:  
28 (A) [*The Blue Mountain Recovery Center and*] The Oregon State Hospital campuses;  
29 (B) Department of Corrections institutions as defined in ORS 421.005;  
30 (C) A contractor of the Department of Corrections or the Oregon Health Authority that provides  
31 health care to individuals residing in a state institution operated by the agencies;  
32 (D) A community mental health program or community developmental disabilities program as  
33 described in ORS 430.610 to 430.695 and the public and private entities with which it contracts to  
34 provide mental health or developmental disabilities programs or services;  
35 (E) A program or service provided under ORS 431.250, 431.375 to 431.385 or 431.416;  
36 (F) A program or service established or maintained under ORS 430.630 or 430.664;  
37 (G) A program or facility providing an organized full-day or part-day program of treatment that  
38 is licensed, approved, established, maintained or operated by or contracted with the Oregon Health  
39 Authority for alcoholism, drug addiction or mental or emotional disturbance;  
40 (H) A program or service providing treatment by appointment that is licensed, approved, estab-  
41 lished, maintained or operated by or contracted with the authority for alcoholism, drug addiction  
42 or mental or emotional disturbance; or  
43 (I) The impaired health professional program established under ORS 676.190.  
44 (h) "Written account" means records containing only individually identifiable health information.  
45 (2) Except as provided in subsections (3), (4), (6), (7), (8), (9), (11), (12), (14), (15), (16) and (17) of

1 this section or unless otherwise permitted or required by state or federal law or by order of the  
2 court, written accounts of the individuals served by any health care services provider maintained  
3 in or by the health care services provider by the officers or employees thereof who are authorized  
4 to maintain written accounts within the official scope of their duties are not subject to access and  
5 may not be disclosed. This subsection applies to written accounts maintained in or by facilities of  
6 the Department of Corrections only to the extent that the written accounts concern the medical,  
7 dental or psychiatric treatment as patients of those under the jurisdiction of the Department of  
8 Corrections.

9 (3) If the individual or a personal representative of the individual provides an authorization, the  
10 content of any written account referred to in subsection (2) of this section must be disclosed ac-  
11 cordingly, if the authorization is in writing and is signed and dated by the individual or the personal  
12 representative of the individual and sets forth with specificity the following:

13 (a) Name of the health care services provider authorized to make the disclosure, except when  
14 the authorization is provided by recipients of or applicants for public assistance or medical assist-  
15 ance, as defined in ORS 414.025, to a governmental entity for purposes of determining eligibility for  
16 benefits or investigating for fraud;

17 (b) Name or title of the persons or organizations to which the information is to be disclosed or  
18 that information may be disclosed to the public;

19 (c) Name of the individual;

20 (d) Extent or nature of the information to be disclosed; and

21 (e) Statement that the authorization is subject to revocation at any time except to the extent  
22 that action has been taken in reliance thereon, and a specification of the date, event or condition  
23 upon which it expires without express revocation. However, a revocation of an authorization is not  
24 valid with respect to inspection or records necessary to validate expenditures by or on behalf of  
25 governmental entities.

26 (4) The content of any written account referred to in subsection (2) of this section may be dis-  
27 closed without an authorization:

28 (a) To any person to the extent necessary to meet a medical emergency.

29 (b) At the discretion of the responsible officer of the health care services provider, which in the  
30 case of any Oregon Health Authority facility or community mental health program is the Director  
31 of the Oregon Health Authority, to persons engaged in scientific research, program evaluation, peer  
32 review and fiscal audits. However, individual identities may not be disclosed to such persons, except  
33 when the disclosure is essential to the research, evaluation, review or audit and is consistent with  
34 state and federal law.

35 (c) To governmental agencies when necessary to secure compensation for services rendered in  
36 the treatment of the individual.

37 (5) When an individual's identity is disclosed under subsection (4) of this section, a health care  
38 services provider shall prepare, and include in the permanent records of the health care services  
39 provider, a written statement indicating the reasons for the disclosure, the written accounts dis-  
40 closed and the recipients of the disclosure.

41 (6) The content of any written account referred to in subsection (2) of this section and held by  
42 a health care services provider currently engaged in the treatment of an individual may be disclosed  
43 to officers or employees of that provider, its agents or cooperating health care services providers  
44 who are currently acting within the official scope of their duties to evaluate treatment programs,  
45 to diagnose or treat or to assist in diagnosing or treating an individual when the written account

1 is to be used in the course of diagnosing or treating the individual. Nothing in this subsection  
2 prevents the transfer of written accounts referred to in subsection (2) of this section among health  
3 care services providers, the Department of Corrections, the Oregon Health Authority or a local  
4 correctional facility when the transfer is necessary or beneficial to the treatment of an individual.

5 (7) When an action, suit, claim, arbitration or proceeding is brought under ORS 34.105 to 34.240  
6 or 34.310 to 34.730 and involves a claim of constitutionally inadequate medical care, diagnosis or  
7 treatment, or is brought under ORS 30.260 to 30.300 and involves the Department of Corrections or  
8 an institution operated by the department, nothing in this section prohibits the disclosure of any  
9 written account referred to in subsection (2) of this section to the Department of Justice, Oregon  
10 Department of Administrative Services, or their agents, upon request, or the subsequent disclosure  
11 to a court, administrative hearing officer, arbitrator or other administrative decision maker.

12 (8)(a) When an action, suit, claim, arbitration or proceeding involves the Oregon Health Au-  
13 thority or an institution operated by the authority, nothing in this section prohibits the disclosure  
14 of any written account referred to in subsection (2) of this section to the Department of Justice,  
15 Oregon Department of Administrative Services, or their agents.

16 (b) Disclosure of information in an action, suit, claim, nonlabor arbitration or proceeding is  
17 limited by the relevancy restrictions of ORS 40.010 to 40.585, 183.710 to 183.725, 183.745 and 183.750  
18 and ORS chapter 183. Only written accounts of a plaintiff, claimant or petitioner shall be disclosed  
19 under this paragraph.

20 (c) Disclosure of information as part of a labor arbitration or proceeding to support a personnel  
21 action taken against staff is limited to written accounts directly relating to alleged action or in-  
22 action by staff for which the personnel action was imposed.

23 (9)(a) The copy of any written account referred to in subsection (2) of this section, upon written  
24 request of the individual or a personal representative of the individual, shall be disclosed to the  
25 individual or the personal representative of the individual within a reasonable time not to exceed  
26 five working days. The individual or the personal representative of the individual shall have the  
27 right to timely access to any written accounts.

28 (b) If the disclosure of psychiatric or psychological information contained in the written account  
29 would constitute an immediate and grave detriment to the treatment of the individual, disclosure  
30 may be denied, if medically contraindicated by the treating physician or a licensed health care  
31 professional in the written account of the individual.

32 (c) The Department of Corrections may withhold psychiatric or psychological information if:

33 (A) The information relates to an individual other than the individual seeking it.

34 (B) Disclosure of the information would constitute a danger to another individual.

35 (C) Disclosure of the information would compromise the privacy of a confidential source.

36 (d) However, a written statement of the denial under paragraph (c) of this subsection and the  
37 reasons therefor must be entered in the written account.

38 (10) A health care services provider may require a person requesting disclosure of the contents  
39 of a written account under this section to reimburse the provider for the reasonable costs incurred  
40 in searching files, abstracting if requested and copying if requested. However, an individual or a  
41 personal representative of the individual may not be denied access to written accounts concerning  
42 the individual because of inability to pay.

43 (11) A written account referred to in subsection (2) of this section may not be used to initiate  
44 or substantiate any criminal, civil, administrative, legislative or other proceedings conducted by  
45 federal, state or local authorities against the individual or to conduct any investigations of the in-

1 individual. If the individual, as a party to an action, suit or other judicial proceeding, voluntarily  
2 produces evidence regarding an issue to which a written account referred to in subsection (2) of this  
3 section would be relevant, the contents of that written account may be disclosed for use in the  
4 proceeding.

5 (12) Information obtained in the course of diagnosis, evaluation or treatment of an individual  
6 that, in the professional judgment of the health care services provider, indicates a clear and imme-  
7 diate danger to others or to society may be reported to the appropriate authority. A decision not  
8 to disclose information under this subsection does not subject the provider to any civil liability.  
9 Nothing in this subsection may be construed to alter the provisions of ORS 146.750, 146.760,  
10 419B.010, 419B.015, 419B.020, 419B.025, 419B.030, 419B.035, 419B.040 and 419B.045.

11 (13) The prohibitions of this section apply to written accounts concerning any individual who  
12 has been treated by any health care services provider irrespective of whether or when the individual  
13 ceases to receive treatment.

14 (14) Persons other than the individual or the personal representative of the individual who are  
15 granted access under this section to the contents of a written account referred to in subsection (2)  
16 of this section may not disclose the contents of the written account to any other person except in  
17 accordance with the provisions of this section.

18 (15) Nothing in this section prevents the Department of Human Services or the Oregon Health  
19 Authority from disclosing the contents of written accounts in its possession to individuals or agen-  
20 cies with whom children in its custody are placed.

21 (16) The system described in ORS 192.517 (1) shall have access to records, as defined in ORS  
22 192.515, as provided in ORS 192.517.

23 (17)(a) Except as provided in paragraph (b) of this subsection, a health care services provider  
24 must obtain an authorization from an individual or a personal representative of the individual to  
25 disclose psychotherapy notes.

26 (b) A health care services provider may use or disclose psychotherapy notes without obtaining  
27 an authorization from the individual or a personal representative of the individual to carry out the  
28 following treatment, payment and health care operations:

29 (A) Use by the originator of the psychotherapy notes for treatment;

30 (B) Disclosure by the health care services provider for its own training program in which stu-  
31 dents, trainees or practitioners in mental health learn under supervision to practice or improve their  
32 skills in group, joint, family or individual counseling; or

33 (C) Disclosure by the health care services provider to defend itself in a legal action or other  
34 proceeding brought by the individual or a personal representative of the individual.

35 (c) An authorization for the disclosure of psychotherapy notes may not be combined with an  
36 authorization for a disclosure of any other individually identifiable health information, but may be  
37 combined with another authorization for a disclosure of psychotherapy notes.

38 **SECTION 13.** ORS 314.840 is amended to read:

39 314.840. (1) The Department of Revenue may:

40 (a) Furnish any taxpayer, representative authorized to represent the taxpayer under ORS 305.230  
41 or person designated by the taxpayer under ORS 305.193, upon request of the taxpayer, represen-  
42 tative or designee, with a copy of the taxpayer's income tax return filed with the department for  
43 any year, or with a copy of any report filed by the taxpayer in connection with the return, or with  
44 any other information the department considers necessary.

45 (b) Publish lists of taxpayers who are entitled to unclaimed tax refunds.

1 (c) Publish statistics so classified as to prevent the identification of income or any particulars  
2 contained in any report or return.

3 (d) Disclose a taxpayer's name, address, telephone number, refund amount, amount due, Social  
4 Security number, employer identification number or other taxpayer identification number to the ex-  
5 tent necessary in connection with collection activities or the processing and mailing of correspond-  
6 ence or of forms for any report, return or claim required in the administration of ORS 310.630 to  
7 310.706, any local tax under ORS 305.620, or any law imposing a tax upon or measured by net in-  
8 come.

9 (2) The department also may disclose and give access to information described in ORS 314.835  
10 to:

11 (a) The Governor of the State of Oregon or the authorized representative of the Governor with  
12 respect to an individual who is designated as being under consideration for appointment or reap-  
13 pointment to an office or for employment in the office of the Governor. The information disclosed  
14 shall be confined to whether the individual:

15 (A) Has filed returns with respect to the taxes imposed by ORS chapter 316 for those of not  
16 more than the three immediately preceding years for which the individual was required to file an  
17 Oregon individual income tax return.

18 (B) Has failed to pay any tax within 30 days from the date of mailing of a deficiency notice or  
19 otherwise respond to a deficiency notice within 30 days of its mailing.

20 (C) Has been assessed any penalty under the Oregon personal income tax laws and the nature  
21 of the penalty.

22 (D) Has been or is under investigation for possible criminal offenses under the Oregon personal  
23 income tax laws. Information disclosed pursuant to this paragraph shall be used only for the purpose  
24 of making the appointment, reappointment or decision to employ or not to employ the individual in  
25 the office of the Governor.

26 (b) An officer or employee of the Oregon Department of Administrative Services duly authorized  
27 or employed to prepare revenue estimates, or a person contracting with the Oregon Department of  
28 Administrative Services to prepare revenue estimates, in the preparation of revenue estimates re-  
29 quired for the Governor's budget under ORS 291.201 to 291.226, or required for submission to the  
30 Emergency Board or the Joint Interim Committee on Ways and Means, or if the Legislative As-  
31 sembly is in session, to the Joint Committee on Ways and Means, and to the Legislative Revenue  
32 Officer or Legislative Fiscal Officer under ORS 291.342, 291.348 and 291.445. The Department of  
33 Revenue shall disclose and give access to the information described in ORS 314.835 for the purposes  
34 of this paragraph only if:

35 (A) The request for information is made in writing, specifies the purposes for which the request  
36 is made and is signed by an authorized representative of the Oregon Department of Administrative  
37 Services. The form for request for information shall be prescribed by the Oregon Department of  
38 Administrative Services and approved by the Director of the Department of Revenue.

39 (B) The officer, employee or person receiving the information does not remove from the premises  
40 of the Department of Revenue any materials that would reveal the identity of a personal or corpo-  
41 rate taxpayer.

42 (c) The Commissioner of Internal Revenue or authorized representative, for tax administration  
43 and compliance purposes only.

44 (d) For tax administration and compliance purposes, the proper officer or authorized represen-  
45 tative of any of the following entities that has or is governed by a provision of law that meets the

1 requirements of any applicable provision of the Internal Revenue Code as to confidentiality:

2 (A) A state;

3 (B) A city, county or other political subdivision of a state;

4 (C) The District of Columbia; or

5 (D) An association established exclusively to provide services to federal, state or local taxing  
6 authorities.

7 (e) The Multistate Tax Commission or its authorized representatives, for tax administration and  
8 compliance purposes only. The Multistate Tax Commission may make the information available to  
9 the Commissioner of Internal Revenue or the proper officer or authorized representative of any  
10 governmental entity described in and meeting the qualifications of paragraph (d) of this subsection.

11 (f) The Attorney General, assistants and employees in the Department of Justice, or other legal  
12 representative of the State of Oregon, to the extent the department deems disclosure or access  
13 necessary for the performance of the duties of advising or representing the department pursuant to  
14 ORS 180.010 to 180.240 and the tax laws of this state.

15 (g) Employees of the State of Oregon, other than of the Department of Revenue or Department  
16 of Justice, to the extent the department deems disclosure or access necessary for such employees  
17 to perform their duties under contracts or agreements between the department and any other de-  
18 partment, agency or subdivision of the State of Oregon, in the department's administration of the  
19 tax laws.

20 (h) Other persons, partnerships, corporations and other legal entities, and their employees, to  
21 the extent the department deems disclosure or access necessary for the performance of such others'  
22 duties under contracts or agreements between the department and such legal entities, in the  
23 department's administration of the tax laws.

24 (i) The Legislative Revenue Officer or authorized representatives upon compliance with ORS  
25 173.850. Such officer or representative shall not remove from the premises of the department any  
26 materials that would reveal the identity of any taxpayer or any other person.

27 (j) The Department of Consumer and Business Services, to the extent the department requires  
28 such information to determine whether it is appropriate to adjust those workers' compensation  
29 benefits the amount of which is based pursuant to ORS chapter 656 on the amount of wages or  
30 earned income received by an individual.

31 (k) Any agency of the State of Oregon, or any person, or any officer or employee of such agency  
32 or person to whom disclosure or access is given by state law and not otherwise referred to in this  
33 section, including but not limited to the Secretary of State as Auditor of Public Accounts under  
34 section 2, Article VI of the Oregon Constitution; the Department of Human Services pursuant to  
35 ORS 314.860 and 412.094; the Division of Child Support of the Department of Justice and district  
36 attorney regarding cases for which they are providing support enforcement services under ORS  
37 25.080; the State Board of Tax Practitioners, pursuant to ORS 673.710; and the Oregon Board of  
38 Accountancy, pursuant to ORS 673.415.

39 (L) The Director of the Department of Consumer and Business Services to determine that a  
40 person complies with ORS chapter 656 and the Director of the Employment Department to determine  
41 that a person complies with ORS chapter 657, the following employer information:

42 (A) Identification numbers.

43 (B) Names and addresses.

44 (C) Inception date as employer.

45 (D) Nature of business.

1 (E) Entity changes.

2 (F) Date of last payroll.

3 (m) The Director of the Oregon Health Authority to determine that a person has the ability to  
4 pay for care that includes services provided by [*the Blue Mountain Recovery Center or*] the Oregon  
5 State Hospital, or the Oregon Health Authority to collect any unpaid cost of care as provided by  
6 ORS chapter 179.

7 (n) Employees of the Employment Department to the extent the Department of Revenue deems  
8 disclosure or access to information on a combined tax report filed under ORS 316.168 is necessary  
9 to performance of their duties in administering the tax imposed by ORS chapter 657.

10 (o) The State Fire Marshal to assist the State Fire Marshal in carrying out duties, functions and  
11 powers under ORS 453.307 to 453.414, the employer or agent name, address, telephone number and  
12 standard industrial classification, if available.

13 (p) Employees of the Department of State Lands for the purposes of identifying, locating and  
14 publishing lists of taxpayers entitled to unclaimed refunds as required by the provisions of chapter  
15 694, Oregon Laws 1993. The information shall be limited to the taxpayer's name, address and the  
16 refund amount.

17 (q) In addition to the disclosure allowed under ORS 305.225, state or local law enforcement  
18 agencies to assist in the investigation or prosecution of the following criminal activities:

19 (A) Mail theft of a check, in which case the information that may be disclosed shall be limited  
20 to the stolen document, the name, address and taxpayer identification number of the payee, the  
21 amount of the check and the date printed on the check.

22 (B) The counterfeiting, forging or altering of a check submitted by a taxpayer to the Department  
23 of Revenue or issued by the Department of Revenue to a taxpayer, in which case the information  
24 that may be disclosed shall be limited to the counterfeit, forged or altered document, the name, ad-  
25 dress and taxpayer identification number of the payee, the amount of the check, the date printed  
26 on the check and the altered name and address.

27 (r) The United States Postal Inspection Service or a federal law enforcement agency, including

42 wages or net earnings from self-employment. Any disclosure under this paragraph may be made only  
43 pursuant to a written agreement between the Department of Revenue and the municipal corporation  
44 that ensures the confidentiality of the information disclosed.

45 (u) A consumer reporting agency, to the extent necessary to carry out the purposes of ORS

1 314.843.

2 (v) The Public Employees Retirement Board, to the extent necessary to carry out the purposes  
3 of ORS 238.372 to 238.384, and to any public employer, to the extent necessary to carry out the  
4 purposes of ORS 237.635 (3) and 237.637 (2).

5 (3)(a) Each officer or employee of the department and each person described or referred to in  
6 subsection (2)(a), (b), (f) to (L) or (n) to (q) of this section to whom disclosure or access to the tax  
7 information is given under subsection (2) of this section or any other provision of state law, prior  
8 to beginning employment or the performance of duties involving such disclosure or access, shall be  
9 advised in writing of the provisions of ORS 314.835 and 314.991, relating to penalties for the vio-

24 735.723. (1) The [*Administrator of the Office for Oregon Health Policy and Research*] **Oregon**  
25 **Health Authority** shall adopt rules for the approval of one community-based health care initiative  
26 per community that meets the requirements under subsection (2) of this section and of a  
27 community-based health care improvement program that meets the requirements under subsection

40 813.021. (1) When a court, in accordance with ORS 813.020, requires a person to complete a  
41 screening interview and a treatment program, the court shall require the person to do all of the  
42 following:

43 (a) Complete a screening interview for the purpose of determining appropriate placement of the  
44 person in a program for treatment for alcoholism, drug dependency or dependency on inhalants.

45 (b) Pay directly to the agency or organization conducting the screening interview a fee of \$150.

1 (c) Complete the treatment program to which the person is referred.

2 (d) Pay for the treatment program to which the person is referred.

3 (2) The screening interview required by this section shall be conducted by an agency or organ-  
4 ization designated by the court. The designated agency or organization must meet the standards set  
5 by the Director of the Oregon Health Authority to conduct the screening interviews. Wherever  
6 possible a court shall designate agencies or organizations to perform the screening interview that  
7 are separate from those that may be designated to carry out a treatment program.
