**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes statutory authority for technological enhancements to 9-1-1 emergency communications system.

Changes name of Enhanced 9-1-1 Subaccount to 9-1-1 Subaccount.

Declares emergency, effective on passage.

8 **Be It Enacted by the People of the State of Oregon:**

9 **SECTION 1.** ORS 403.100 is amended to read:

10 403.100. It is the policy of the State of Oregon to:

11 (1) Encourage and support **the development of public safety networks and an emergency**  
12 **communications system** and the rapid deployment of broadband [*telecommunications*] **or other**  
13 **communications** services in areas of the state in which the services do not exist;

14 (2) Support redundancy of critical [*telecommunications*] **communications** assets in order to en-  
15 sure homeland security protections in the state; and

16 (3) Ensure that a secure conduit is available for **the** emergency communications **system** and  
17 public safety networks in all Oregon communities.

18 **SECTION 2.** ORS 403.105, as amended by section 1, chapter 59, Oregon Laws 2014, is amended  
19 to read:

20 403.105. As used in ORS 305.823 and 403.105 to 403.250, unless the context requires otherwise:

21 (1) "Account" means the Emergency Communications Account.

22 (2) "Automatic location identification" means a component or capability of [*enhanced 9-1-1 tele-*  
23 *phone service*] **the emergency communications system** that provides automatic display in the  
24 designated public safety answering point of geographic information about the location of the in-  
25 strument used to originate an incoming **emergency call** [*9-1-1 call*].

4 (4) “Call-back number” means a telephone number, **or other unique number or code assigned**  
 5 **to an instrument**, used by a primary public safety answering point to contact the [*location*] **in-**  
 6 **strument** from which an incoming **emergency call to 9-1-1** [*call*] originates.

7 (5) “Central office” means a utility that houses the switching and trunking equipment serving  
 8 telephones in a defined area.

9 [(6) “Department” means the Department of Revenue.]

10 [(7)] (6) “Emergency call” means a [*telephone request that results from a situation*] **request for**  
 11 **assistance using any device capable of direct communication to the emergency communi-**  
 12 **cations system** in which prompt service is essential to preserve human life or property.

13 (7) “**Emergency communications system**” means **the network, database, servers, other**  
 14 **equipment and services that provide the means to communicate with a primary public safety**

 17 *telephone service*] **the emergency communications system** that identifies a specific emergency  
 18 response location.

19 (9) “Enhanced 9-1-1 telephone service” means 9-1-1 telephone service consisting of a network,  
 20 database and on-premises equipment that provides automatic display in the designated public safety

 44 products delivered electronically [*that must be paid for in advance, and that is sold in predetermined*  
 45 *units or dollars*].

1       **(16) “Primary public safety answering point” means a 24-hour public safety answering**  
2 **point that receives emergency calls directly from members of the public.**

3       [(16)] **(17) “Provider” means a utility, or other vendor or supplier, [of telecommunications] that**  
4 **offers communications** service or equipment that provides [telecommunications with access to the  
5 9-1-1 emergency reporting system through local exchange service, cellular service or other wired or  
6 wireless means] **access to the emergency communications system.**

7       [(17)] **(18) “Public or private safety agency” means any unit of state or local government, a**  
8 **special-purpose district or a private firm that provides, or has authority to provide, fire-fighting,**  
9 **police, ambulance or emergency medical services.**

10       [(18)] **(19) “Public safety answering point” means a [24-hour] communications facility established**  
11 **as an answering location for [9-1-1] emergency calls originating within a [given] 9-1-1 service area.**

16 **that receives emergency calls from a primary public safety answering point on a transfer or**

18       [(19)] **(21) “Subscriber” means a person [who] that has telecommunication access to [the 9-1-1**  
19 **emergency reporting] make an emergency call to the emergency communications** system through  
20 local exchange service, cellular service or other wired or wireless means.

21       [(20)] **(22) “TTY” means a telephone-typewriter used by an individual with a hearing or speech**  
22 **impairment to communicate with another device or individual.**

23       [(21)] **(23) “Utility” means a telecommunications utility, as defined in ORS 759.005, a tele-**  
24 **communications carrier, as defined in ORS 133.721, a municipality or any provider of exchange ac-**  
25 **cess services.**

26       [(22)] *“Vendor” means a person providing telephone customer premises equipment or equipment*  
27 *specific to the operation of enhanced 9-1-1 telephone service.]*

28       [(23)] **(24) “Wireless telecommunications service” means commercial mobile radio service, as**  
29 **defined in 47 C.F.R. 20.3.**

30       [(24)] **(25) “9-1-1 emergency reporting system” means a telephone service that provides the users**  
31 **of a public telephone system the ability to reach a primary public safety answering point by calling**  
32 **9-1-1.**

33       [(25)] **(26) “9-1-1 jurisdiction” means:**

34       (a) An entity created under ORS chapter 190 **to form a 9-1-1 jurisdiction;**

35       (b) A county service district established under ORS chapter 451 to provide **emergency com-**  
36 **munications services within the [an] emergency communications system;**

37       (c) [An emergency] **A 9-1-1 communications district created under ORS 403.300 to 403.380; [or]**

38       **(d) A public or private safety agency; or**

39       [(d)] **(e) A group of public or private safety agencies [who] that have agreed in writing to jointly**

27 **answering point to request and provide assistance to preserve human life or property.**

7 (16) “Multiline telephone system” means a communications system, including network,

36 **that receives emergency calls from a primary public safety answering point on a transfer or**

38 [(22)] (24) “Seller” means a person that sells prepaid wireless telecommunications service or  
39 access to prepaid wireless telecommunications service to a consumer.

40 [(23)] (25) “Subscriber” means a person, **other than a consumer**, that has telecommunication  
41 access to [the 9-1-1 emergency reporting] **the emergency communications** system through local  
42 exchange service, cellular service or other wired or wireless means. [“Subscriber” does not include  
43 a person that uses prepaid wireless telecommunications service.]

44 [(24)] (26) “TTY” means a telephone-typewriter used by an individual with a hearing or speech  
45 impairment to communicate with another device or individual.

1 [(25)] (27) "Utility" means a **telecommunications** utility, as defined in ORS 759.005, a tele-  
2 communications carrier, as defined in ORS 133.721, a municipality or any provider of exchange ac-  
3 cess services.

4 [(26)] "Vendor" means a person providing telephone customer premises equipment or equipment  
5 specific to the operation of enhanced 9-1-1 telephone service.]

6 [(27)] (28) "Wireless telecommunications service" means commercial mobile radio service, as  
7 defined in 47 C.F.R. 20.3.

8 [(28)] (29) "9-1-1 emergency reporting system" means a telephone service that provides the users  
9 of a public telephone system the ability to reach a primary public safety answering point by calling  
10 9-1-1.

11 [(29)] (30) "9-1-1 jurisdiction" means:

12 (a) An entity created under ORS chapter 190 to form a **9-1-1 jurisdiction**;

13 (b) A county service district established under ORS chapter 451 to provide **emergency com-**  
14 **munications services within the** [an] emergency communications system;

15 (c) [An emergency] **A 9-1-1** communications district created under ORS 403.300 to 403.380; [or]

16 **(d) A public or private safety agency; or**

17 [(d)] (e) A group of public or private safety agencies [who] **that** have agreed in writing to jointly  
18 plan the installation, maintenance, operation or improvement of [a 9-1-1 emergency reporting  
19 system] **components of the emergency communications system that are within a 9-1-1 service**  
20 **area.**

21 [(30)] (31) "9-1-1 service area" means the geographical area [that contains the entire central office  
22 serving area from which the primary public safety answering point will have the capability to answer  
23 calls placed to 9-1-1.] **described in an approved 9-1-1 jurisdiction plan within which a 9-1-1 ju-**  
24 **risdiction has the responsibility to answer emergency calls.**

25 **SECTION 4.** Section 5 of this 2015 Act is added to and made a part of ORS 403.105 to  
26 **403.250.**

27 **SECTION 5.** The Department of Revenue may by rule adjust the definition of "intercon-  
28 nected Voice over Internet Protocol service" given in ORS 403.105 to conform to subsequent  
29 **amendments to 47 C.F.R. 9.3.**

30 **SECTION 6.** ORS 403.110 is amended to read:

31 403.110. (1) A provider or a 9-1-1 jurisdiction, or the employees or agents of a provider or a 9-1-1  
32 jurisdiction, may be held civilly liable for the installation, performance, provision or maintenance  
33 of [a 9-1-1 emergency reporting system or enhanced 9-1-1 telephone service] **the emergency commu-**  
34 **nications system** if the provider or the 9-1-1 jurisdiction or the employees or agents of the provider  
35 or the 9-1-1 jurisdiction act with willful or wanton conduct.

36 (2) This section does not affect any liability a 9-1-1 jurisdiction may have for [operator or  
37 operator-supervisor] **employee** negligence in receiving **emergency** calls from the public and dis-  
38 patching emergency services to the public.

39 **SECTION 7.** ORS 403.110, as amended by section 2, chapter 59, Oregon Laws 2014, is amended  
40 to read:

41 403.110. (1) A provider or a 9-1-1 jurisdiction or the employees or agents of a provider or a 9-1-1  
42 jurisdiction may be held civilly liable for the installation, performance, provision or maintenance of  
43 a 9-1-1 emergency reporting system or enhanced 9-1-1 telephone service if the provider or the 9-1-1  
44 jurisdiction or the employees or agents of the provider or the 9-1-1 jurisdiction act with willful or  
45 wanton conduct. [This section does not affect any liability a 9-1-1 jurisdiction may have for operator

1 *or operator-supervisor negligence in receiving calls from the public and dispatching emergency services*  
2 *to the public.]*

3 (2) A provider or seller is not liable for damages that result from providing or failing to provide  
4 access to the [9-1-1 emergency reporting] **emergency communications** system or from identifying  
5 or failing to identify the telephone number, address, location or name associated with any person  
6 or device accessing or attempting to access the [9-1-1 emergency reporting] **emergency communi-**  
7 **cations** system.

8 **(3) This section does not affect any liability a 9-1-1 jurisdiction may have for employee**  
9 **negligence in receiving emergency calls from the public and dispatching emergency services**  
10 **to the public.**

11 **SECTION 8.** ORS 403.115 is amended to read:

12 403.115. (1) The primary emergency telephone number within [the] **this** state is 9-1-1, but a public  
13 or private safety agency shall maintain both a separate 10-digit secondary emergency number for  
14 use by [the telephone company] **a telephone operator or provider** and a separate 10-digit nonemer-  
15 gency number.

16 (2) Every public and private safety agency in this state shall [establish or] participate in [a 9-1-1  
17 emergency reporting] **the emergency communications** system.

18 (3) An emergency telephone number other than 9-1-1 may not be published on the top three-  
19 quarters of the emergency listing page of a telephone book. However, an alternative nonemergency  
20 telephone number for a 9-1-1 jurisdiction may be printed on the top three-quarters of the emergency  
21 listing page of a telephone book. The publisher may use the remainder of the page to list the Oregon  
22 Poison Center, Federal Bureau of Investigation, a designated mental health crises service and  
23 United States Coast Guard, where applicable. If there is more than one mental health crises service  
24 in a jurisdiction, the county health department shall decide which mental health crises service the  
25 publisher may list by using the criteria of a 24-hour staffed service, nonprofit organization and  
26 non-9-1-1 participating agency. The publisher shall refer to the community services section for other  
27 numbers.

28 [(4) The 9-1-1 emergency reporting system must include at a minimum:]

29 [(a) A primary public safety answering point that is automatically accessible anywhere in the 9-1-1  
30 jurisdiction service area by calling 9-1-1;]

31 [(b) Central dispatch of public and private safety services in the 9-1-1 service area or relay or  
32 transfer of 9-1-1 calls to an appropriate public or private safety agency; and]

33 [(c) Two 9-1-1 circuits from each central office to each primary public safety answering point.]

34 [(5) In addition to the requirements set forth in subsection (4) of this section, enhanced 9-1-1 tele-  
35 phone service must provide:]

36 [(a) Two call-taker stations and staffing for at least one of the stations at all times;]

37 [(b) Automatic display of the incoming telephone number and address in the designated public  
38 safety answering point at the time of receiving an incoming 9-1-1 call;]

39 [(c) A network developed to transport address and telephone number information to the designated  
40 public safety answering point automatically when a call is placed to 9-1-1; and]

41 [(d) Emergency telephone service in which one or fewer calls in 100 attempts receive a busy signal  
42 on the first attempt during the average busiest hour. A public safety answering point may not have  
43 fewer than two 9-1-1 circuits.]

44 **(4) The emergency communications system must provide:**

45 **(a) Interconnectivity between public safety answering points and interconnectivity with**

1 **providers of the same or similar emergency response services nationally;**

2 **(b) The capability, within each primary public safety answering point, to receive all**  
3 **emergency calls placed locally within each 9-1-1 service area; and**

4 **(c) The automatic location identification accurately portraying the location from which**  
5 **each emergency call originates.**

6 **SECTION 9.** ORS 403.120 is amended to read:

7 403.120. (1) The Office of Emergency Management shall:

8 (a) *[Adopt rules in accordance with ORS chapter 183 relating to the planning, administration and*  
9 *funding of 9-1-1 emergency reporting systems established pursuant to ORS 403.115.]* **Except as oth-**  
10 **erwise provided by law, adopt rules relating to the emergency communications system, as**  
11 **deemed necessary by the office.**

12 (b) *[Assist, at the request of a 9-1-1 jurisdiction, local government or governing body, in planning*  
13 *9-1-1 emergency reporting systems or may, at the request of a 9-1-1 jurisdiction, act as an agent of the*  
14 *9-1-1 jurisdiction for the purposes of purchasing and maintaining equipment and services]* **Plan, im-**  
15 **plement, administer, operate and maintain the emergency communications system** required  
16 to fulfill the requirements of ORS 403.115.

17 **(c) At the request of a 9-1-1 jurisdiction, act as an agent of the 9-1-1 jurisdiction for the**  
18 **purposes of purchasing and maintaining equipment and services required to conform to ap-**  
19 **licable laws and rules adopted by the office.**

20 *[(c)]* **(d) Report biennially to the Legislative Assembly the progress made in implementing ORS**  
21 **305.823 and 403.105 to 403.250. [including in the report:] The report must include:**

22 (A) Financial information concerning the revenues collected, distributed and expended by state  
23 agencies and 9-1-1 jurisdictions for the purposes of complying with ORS 403.105 to 403.250; and

24 (B) Account and subaccount balances.

25 **(2) The office may enter into and administer contracts for goods and services related to**  
26 **the emergency communications system.**

27 *[(2)]* **(3) The office may establish advisory committees and study groups to study and advise on:**

28 (a) The planning and administration of *[9-1-1 emergency reporting systems]* **public safety an-**  
29 **swering points; and**

30 *[(b) Multijurisdictional 9-1-1 emergency reporting systems; and]*

31 *[(c)]* **(b) Issues impacting [9-1-1 emergency reporting systems throughout the state] the emergency**  
32 **communications system or individual public safety answering points.**

33 **SECTION 10.** ORS 403.130 is amended to read:

34 403.130. (1) **A 9-1-1 jurisdiction shall create and maintain a 9-1-1 jurisdiction plan for**  
35 **emergency communications services provided within a 9-1-1 service area pursuant to ORS**

41 **(2) The 9-1-1 jurisdiction plan must describe the capital and recurring costs to provide**  
42 **the components of the emergency communications system within the 9-1-1 service area.**

43 **(3) The office shall review the 9-1-1 jurisdiction plan for compliance with the require-**  
44 **ments imposed under ORS 403.105 to 403.250 and rules adopted by the office, and if the plan**  
45 **is:**

1 (a) In compliance, the office shall approve the plan.

2 (b) Not in compliance, the office shall reject the plan.

3 (4) If the office rejects the 9-1-1 jurisdiction plan under subsection (3) of this section:

4 (a) The 9-1-1 jurisdiction shall revise and resubmit the plan within 90 days after the date  
5 the office rejects the plan; and

6 (b) The office shall review the revised plan and either approve or reject the revised plan  
7 within 90 days after the date the office receives the revised plan.

8 [(1)] (5) Each 9-1-1 jurisdiction shall submit to the Office of Emergency Management in writing  
9 within 30 days any change to [the 9-1-1 emergency telephone system] a public safety answering point

22 by an agency or agencies other than [as] the agency or agencies identified in the [final plan ap-  
23 proved by the office under ORS 401.750 (1987 Replacement Part), section 7, chapter 743, Oregon Laws  
24 1991, or the system description filed with the office under ORS 401.750 (5) (1987 Replacement Part)]  
25 approved 9-1-1 jurisdiction plan filed with the office, the 9-1-1 jurisdiction or governing body  
26 shall submit a revised 9-1-1 jurisdiction plan setting forth [these] the changes to:

27 (a) The Office of Emergency Management;

28 (b) Public and private safety agencies in the 9-1-1 service area; and

29 (c) [Utilities which provide telephone service] Any other public or private entity in the 9-1-1  
30 service area that may be affected.

31 [(3)] (7) In addition to meeting the requirements [of ORS 403.115] imposed under ORS 403.105  
32 to 403.250 and rules adopted pursuant to ORS 403.120, the revised [final] 9-1-1 jurisdiction plan  
33 must describe the capital and recurring costs for the proposed [9-1-1 emergency reporting system]  
34 components of the emergency communications system within the 9-1-1 service area.

35 [(4)] (8) The office shall review the revised [final] 9-1-1 jurisdiction plan for compliance with  
36 [this section, ORS 403.115] the requirements imposed under ORS 403.105 to 403.250 and rules  
37 adopted pursuant to ORS 403.120 and, if the office determines that the plan is in compliance, ap-  
38 prove the plan.

39 [(5)] (9) The office may not approve a revised [final] 9-1-1 jurisdiction plan submitted under  
40 subsection (6) of this section unless the revised plan is accompanied by written approval of the  
41 governing bodies of all public and private safety agencies affected by or providing service in the  
42 9-1-1 service area.

43 **SECTION 11.** ORS 403.135, as amended by section 3, chapter 29, Oregon Laws 2014, is amended

45 403.135. (1) [Each telecommunications utility that provides exchange access service or radio com-

21 (4) Subsection (3) of this section does not compel a provider to provide nonpublished and non-  
22 listed subscriber information directly to emergency services providers or law enforcement agencies

25 (5) Subscriber information acquired by a 9-1-1 jurisdiction for the purpose of [*enhancing a 9-1-1*  
26 *emergency reporting system*] **providing emergency communications services under ORS 403.105**  
27 **to 403.250** is not subject to public disclosure and may not be used by other public agencies except:

28 (a) To respond to [*a 9-1-1*] **an emergency call;**

29 (b) To respond to an emergency situation that involves the risk of death or serious physical  
30 harm to an individual, as provided in section 2, chapter 29, Oregon Laws 2014; or

31 (c) To notify the public of an emergency by utilizing an automated [*telephone*] notification system  
32 if a provider has provided subscriber information to the 9-1-1 jurisdiction or emergency services  
33 provider.

34 **SECTION 12.** ORS 403.137 is amended to read:

35 403.137. (1) As used in this section, "workplace":

36 (a) Includes hallways, lobbies, conference rooms, rest rooms, break rooms, elevators, laborato-
