

# House Bill 2426

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber, M.D., for Oregon Military Department)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes statutory authority for technological enhancements to 9-1-1 emergency communications system.

Changes name of Enhanced 9-1-1 Subaccount to 9-1-1 Subaccount.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

Relating to 9-1-1 emergency communications system; creating new provisions; amending ORS 165.570, 165.572, 181.610, 243.736, 403.100, 403.105, 403.110, 403.115, 403.120, 403.130, 403.135, 403.137, 403.140, 403.145, 403.150, 403.155, 403.160, 403.200, 403.205, 403.215, 403.235, 403.240, 403.245, 403.300, 403.360, 451.010, 451.605, 451.610, 453.322, 811.747, 811.748 and 811.750 and sections 3 and 8, chapter 753, Oregon Laws 2013, section 2, chapter 29, Oregon Laws 2014, and section 13b, chapter 59, Oregon Laws 2014; and declaring an emergency.

### Be It Enacted by the People of the State of Oregon:

**SECTION 1.** ORS 403.100 is amended to read:

403.100. It is the policy of the State of Oregon to:

(1) Encourage and support **the development of public safety networks and an emergency communications system** and the rapid deployment of broadband [*telecommunications*] **or other communications** services in areas of the state in which the services do not exist;

(2) Support redundancy of critical [*telecommunications*] **communications** assets in order to ensure homeland security protections in the state; and

(3) Ensure that a secure conduit is available for **the** emergency communications **system** and public safety networks in all Oregon communities.

**SECTION 2.** ORS 403.105, as amended by section 1, chapter 59, Oregon Laws 2014, is amended to read:

403.105. As used in ORS 305.823 and 403.105 to 403.250, unless the context requires otherwise:

(1) "Account" means the Emergency Communications Account.

(2) "Automatic location identification" means a component or capability of [*enhanced 9-1-1 telephone service*] **the emergency communications system** that provides automatic display in the designated public safety answering point of geographic information about the location of the instrument used to originate an incoming **emergency call** [*9-1-1 call*].

[(3) "*Automatic number identification*" means a component or capability of enhanced 9-1-1 telephone service that provides automatic display in the designated public safety answering point of a telephone number associated with the access line from which an incoming 9-1-1 call originates.]

[(4) (3) "Call-back number" means a telephone number, **or other unique number or code assigned to an instrument**, used by a primary public safety answering point to contact the

1 [location] **instrument** from which an incoming **emergency call to 9-1-1** [call] originates.

2 [(5)] (4) “Central office” means a utility that houses the switching and trunking equipment  
3 serving telephones in a defined area.

4 [(6) “Department” means the Department of Revenue.]

5 [(7)] (5) “Emergency call” means a [telephone request that results from a situation] **request for**  
6 **assistance that is communicated, using any mode of communication, directly to the emer-**  
7 **gency communications system** in which prompt service is essential to preserve human life or  
8 property.

9 (6) **“Emergency communications system” means the network, database, servers, other**  
10 **equipment and services that provide access to communicate with a primary public safety**  
11 **answering point to request assistance to preserve human life or property.**

12 [(8)] (7) “Emergency response location identifier” means a component or capability of [enhanced  
13 9-1-1 telephone service] **the emergency communications system** that identifies a specific emer-  
14 gency response location.

15 [(9)] (8) “Enhanced 9-1-1 telephone service” means 9-1-1 telephone service consisting of a net-  
16 work, database and on-premises equipment that provides automatic display in the designated public  
17 safety answering point of a telephone number and geographic information about the location of the  
18 instrument used to originate an incoming 9-1-1 call when the call is received.

19 [(10)] (9) “Exchange access services” means:

20 (a) Telephone exchange access lines or channels that provide [local] access by a subscriber in  
21 this state to the local telecommunications network to effect the transfer of information; and

22 (b) Unless a separate tariff rate is charged therefor, any facility or service provided in con-  
23 nection with the services described in paragraph (a) of this subsection.

24 [(11)] (10) “Governing body” means the [board of county commissioners of a county, city council  
25 of a city, other governing body of a city or county, board of directors of a special] **governing body**  
26 **of a city, county, special** district or [a] 9-1-1 jurisdiction.

27 [(12)] (11) “Key telephone system” means a type of multiline telephone system designed to pro-  
28 vide exchange access services through shared exchange access lines or channels that typically ap-  
29 pears to offer direct line termination on a particular instrument.

30 [(13)] (12) “Local government” has the meaning given that term in ORS 190.710.

31 [(14)] (13) “Multiline telephone system” means a communications system, including network,  
32 premises-based, PBX, hybrid and key telephone systems, that offers two or more telephone exchange  
33 access lines and consists of a common control unit, instruments, control hardware and software and  
34 adjunct systems installed at a subscriber’s premises to support the [9-1-1 emergency reporting]  
35 **emergency communications** system.

36 [(15)] (14) “Prepaid wireless telecommunications service” means a telecommunications service  
37 that **is sold in predetermined units or dollar amounts, must be paid for in advance and** pro-  
38 vides the [right] **purchaser with the ability** to use mobile wireless service as well as other  
39 nontelecommunications services including content, ancillary services and the download of digital  
40 products delivered electronically that must be paid for in advance, and that is sold in predetermined  
41 units or dollars.

42 (15) **“Primary public safety answering point” means a 24-hour public safety answering**  
43 **point that receives emergency calls directly from members of the public.**

44 (16) “Provider” means a utility, or other vendor or supplier, [of telecommunications] **that offers**  
45 **communications** service or equipment that provides [telecommunications with access to the 9-1-1

1 *emergency reporting system through local exchange service, cellular service or other wired or wireless*  
 2 *means*] **access to the emergency communications system.**

3 (17) “Public or private safety agency” means any unit of state or local government, a special-  
 4 purpose district or a private firm that provides, or has authority to provide, fire-fighting, police,  
 5 ambulance or emergency medical services.

6 (18) “Public safety answering point” means a [24-hour] communications facility established as  
 7 an answering location for [9-1-1] **emergency** calls originating within a [given] **9-1-1** service area.  
 8 [A “primary public safety answering point” receives all calls directly from the public. A “secondary  
 9 public safety answering point” only receives calls from a primary public safety answering point on a  
 10 transfer or relay basis.]

11 (19) **“Secondary public safety answering point” means a public safety answering point**  
 12 **that receives emergency calls from a primary public safety answering point on a transfer or**  
 13 **relay basis.**

14 [(19)] (20) “Subscriber” means a person [who] **that** has telecommunication access to [the 9-1-1  
 15 emergency reporting] **make an emergency call to the emergency communications** system through  
 16 local exchange service, cellular service or other wired or wireless means.

17 [(20)] (21) “TTY” means a telephone-typewriter used by an individual with a hearing or speech  
 18 impairment to communicate with another device or individual.

19 [(21)] (22) “Utility” means a utility, as defined in ORS 759.005, a telecommunications carrier, as  
 20 defined in ORS 133.721, a municipality or any provider of exchange access services.

21 [(22)] “Vendor” means a person providing telephone customer premises equipment or equipment  
 22 specific to the operation of enhanced 9-1-1 telephone service.]

23 (23) “Wireless telecommunications service” means commercial mobile radio service, as defined  
 24 in 47 C.F.R. 20.3.

25 (24) “9-1-1 emergency reporting system” means a telephone service that provides the users of a  
 26 public telephone system the ability to reach a primary public safety answering point by calling 9-1-1.

27 (25) “9-1-1 jurisdiction” means:

28 (a) An entity created under ORS chapter 190;

29 (b) A county service district established under ORS chapter 451 to provide **emergency com-**  
 30 **munications services within the** [an] emergency communications system;

31 (c) [An emergency] **A 9-1-1** communications district created under ORS 403.300 to 403.380; [or]

32 **(d) A public or private safety agency; or**

33 [(d)] (e) A group of public or private safety agencies [who] **that** have agreed in writing to jointly  
 34 plan the installation, maintenance, operation or improvement of [a 9-1-1 emergency reporting  
 35 system] **components of the emergency communications system that are within a 9-1-1 service**  
 36 **area.**

37 (26) “9-1-1 service area” means the geographical area [that contains the entire central office  
 38 serving area from which the primary public safety answering point will have the capability to answer  
 39 calls placed to 9-1-1] **within which a 9-1-1 jurisdiction has the responsibility to answer emer-**  
 40 **gency calls.**

41 **SECTION 3.** ORS 403.105, as amended by sections 1 and 1a, chapter 59, Oregon Laws 2014, is  
 42 amended to read:

43 403.105. As used in ORS 305.823 and 403.105 to 403.250, unless the context requires otherwise:

44 (1) “Account” means the Emergency Communications Account.

45 (2) “Automatic location identification” means a component or capability of [enhanced 9-1-1 tele-

1 *phone service*] **the emergency communications system** that provides automatic display in the  
 2 designated public safety answering point of geographic information about the location of the in-  
 3 strument used to originate an incoming **emergency call** [9-1-1 call].

12 [(6) (5) “Consumer” means a person that purchases prepaid wireless telecommunications service  
 13 in a retail transaction.

14 [(7) “Department” means the Department of Revenue.]

15 [(8) (6) “Emergency call” means a [telephone request that results from a situation] **request for**  
 16 **assistance that is communicated, using any mode of communication, directly to the emer-**  
 17 **gency communications system** in which prompt service is essential to preserve human life or  
 18 property.

19 (7) **“Emergency communications system” means the network, database, servers, other**  
 20 **equipment and services that provide access to communicate with a primary public safety**  
 21 **answering point to request assistance to preserve human life or property.**

22 [(9) (8) “Emergency response location identifier” means a component or capability of [enhanced  
 23 9-1-1 telephone service] **the emergency communications system** that identifies a specific emer-  
 24 gency response location.

25 [(10) (9) “Enhanced 9-1-1 telephone service” means 9-1-1 telephone service consisting of a net-  
 26 work, database and on-premises equipment that provides automatic display in the designated public  
 27 safety answering point of a telephone number and geographic information about the location of the  
 28 instrument used to originate an incoming 9-1-1 call when the call is received.

29 [(11) (10) “Exchange access services” means:

30 (a) Telephone exchange access lines or channels that provide [local] access by a consumer or  
 31 subscriber in this state to the local telecommunications network to effect the transfer of informa-  
 32 tion; and

33 (b) Unless a separate tariff rate is charged therefor, any facility or service provided in con-  
 34 nection with the services described in paragraph (a) of this subsection.

35 [(12) (11) “Governing body” means the [board of county commissioners of a county, city council  
 36 of a city, other governing body of a city or county, board of directors of a special] **governing body**  
 37 **of a city, county, special** district or [a] 9-1-1 jurisdiction.

38 [(13) (12) “Interconnected Voice over Internet Protocol service” has the meaning given that  
 39 term in 47 C.F.R. 9.3, as amended [on July 9, 2009] **and in effect on the effective date of this 2015**  
 40 **Act.** [The Department of Revenue may by rule adjust this definition to conform to subsequent amend-  
 41 ments to 47 C.F.R. 9.3.]

42 [(14) (13) “Key telephone system” means a type of multiline telephone system designed to pro-  
 43 vide exchange access services through shared exchange access lines or channels that typically ap-  
 44 pears to offer direct line termination on a particular instrument.

45 [(15) (14) “Local government” has the meaning given that term in ORS 190.710.

1 [(16)] (15) "Multiline telephone system" means a communications system, including network,  
2 premises-based, PBX, hybrid and key telephone systems, that offers two or more telephone exchange  
3 access lines and consists of a common control unit, instruments, control hardware and software and  
4 adjunct systems installed at a subscriber's premises to support the [9-1-1 emergency reporting]  
5 **emergency communications** system.

6 [(17)] (16) "Prepaid wireless telecommunications service" means a telecommunications service

30 **that receives emergency calls from a primary public safety answering point on a transfer or**  
31 **relay basis.**

32 [(22)] (23) "Seller" means a person that sells prepaid wireless telecommunications service or  
33 access to prepaid wireless telecommunications service to a consumer.

34 [(23)] (24) "Subscriber" means a person, **other than a consumer**, that has telecommunication  
35 access to [the 9-1-1 emergency reporting] **the emergency communications** system through local  
36 exchange service, cellular service or other wired or wireless means. ["Subscriber" does not include  
37 a person that uses prepaid wireless telecommunications service.]

38 [(24)] (25) "TTY" means a telephone-typewriter used by an individual with a hearing or speech  
39 impairment to communicate with another device or individual.

40 [(25)] (26) "Utility" means a utility, as defined in ORS 759.005, a telecommunications carrier, as  
41 defined in ORS 133.721, a municipality or any provider of exchange access services.

42 [(26)] "Vendor" means a person providing telephone customer premises equipment or equipment  
43 specific to the operation of enhanced 9-1-1 telephone service.]

44 (27) "Wireless telecommunications service" means commercial mobile radio service, as defined  
45 in 47 C.F.R. 20.3.

1 (28) “9-1-1 emergency reporting system” means a telephone service that provides the users of a  
 2 public telephone system the ability to reach a primary public safety answering point by calling 9-1-1.

3 (29) “9-1-1 jurisdiction” means:

4 (a) An entity created under ORS chapter 190;

5 (b) A county service district established under ORS chapter 451 to provide **emergency com-**  
 6 **munications services within the** *[an]* emergency communications system;

7 (c) *[An emergency]* **A 9-1-1** communications district created under ORS 403.300 to 403.380; *[or]*

8 **(d) A public or private safety agency; or**

9 *[(d)]* **(e)** A group of public or private safety agencies *[who]* **that** have agreed in writing to jointly  
 10 plan the installation, maintenance, operation or improvement of *[a 9-1-1 emergency reporting*  
 11 *system]* **components of the emergency communications system that are within a 9-1-1 service**  
 12 **area.**

13 (30) “9-1-1 service area” means the geographical area *[that contains the entire central office*  
 14 *servicing area from which the primary public safety answering point will have the capability to answer*  
 15 *calls placed to 9-1-1.]* **within which a 9-1-1 jurisdiction has the responsibility to answer emer-**  
 16 **gency calls.**

17 **SECTION 4. Section 5 of this 2015 Act is added to and made a part of ORS 403.105 to**  
 18 **403.250.**

19 **SECTION 5. The Department of Revenue may by rule adjust the definition of “intercon-**  
 20 **connected Voice over Internet Protocol service” given in ORS 403.105 to conform to subsequent**  
 21 **amendments to 47 C.F.R. 9.3.**

22 **SECTION 6.** ORS 403.110 is amended to read:

23 403.110. (1) A provider or a 9-1-1 jurisdiction, or the employees or agents of a provider or a 9-1-1  
 24 jurisdiction, may be held civilly liable for the installation, performance, provision or maintenance  
 25 of *[a 9-1-1 emergency reporting system or enhanced 9-1-1 telephone service]* **the emergency commu-**  
 26 **nications system** if the provider or the 9-1-1 jurisdiction or the employees or agents of the provider  
 27 or the 9-1-1 jurisdiction act with willful or wanton conduct.

28 (2) This section does not affect any liability a 9-1-1 jurisdiction may have for *[operator or*  
 29 *operator-supervisor]* **employee** negligence in receiving **emergency** calls from the public and dis-  
 30 patching emergency services to the public.

31 **SECTION 7.** ORS 403.110, as amended by section 2, chapter 59, Oregon Laws 2014, is amended  
 32 to read:

33 403.110. (1) A provider or a 9-1-1 jurisdiction or the employees or agents of a provider or a 9-1-1  
 34 jurisdiction may be held civilly liable for the installation, performance, provision or maintenance of  
 35 a 9-1-1 emergency reporting system or enhanced 9-1-1 telephone service if the provider or the 9-1-1  
 36 jurisdiction or the employees or agents of the provider or the 9-1-1 jurisdiction act with willful or  
 37 wanton conduct. *[This section does not affect any liability a 9-1-1 jurisdiction may have for operator*  
 38 *or operator-supervisor negligence in receiving calls from the public and dispatching emergency services*  
 39 *to the public.]*

40 (2) A provider or seller is not liable for damages that result from providing or failing to provide  
 41 access to the *[9-1-1 emergency reporting]* **emergency communications** system or from identifying  
 42 or failing to identify the telephone number, address, location or name associated with any person  
 43 or device accessing or attempting to access the *[9-1-1 emergency reporting]* **emergency communi-**  
 44 **cations** system.

45 **(3) This section does not affect any liability a 9-1-1 jurisdiction may have for employee**

1 **negligence in receiving emergency calls from the public and dispatching emergency services**  
 2 **to the public.**

3 **SECTION 8.** ORS 403.115 is amended to read:

4 403.115. (1) The primary emergency telephone number within *[the]* **this** state is 9-1-1, but a public  
 5 or private safety agency shall maintain both a separate 10-digit secondary emergency number for  
 6 use by *[the telephone company]* **a telephone operator or provider** and a separate 10-digit nonemer-  
 7 gency number.

8 (2) Every public and private safety agency in this state shall *[establish or]* participate in *[a 9-1-1*  
 9 *emergency reporting]* **the emergency communications** system.

10 (3) An emergency telephone number other than 9-1-1 may not be published on the top three-  
 11 quarters of the emergency listing page of a telephone book. However, an alternative nonemergency  
 12 telephone number for a 9-1-1 jurisdiction may be printed on the top three-quarters of the emergency  
 13 listing page of a telephone book. The publisher may use the remainder of the page to list the Oregon  
 14 Poison Center, Federal Bureau of Investigation, a designated mental health crises service and  
 15 United States Coast Guard, where applicable. If there is more than one mental health crises service  
 16 in a jurisdiction, the county health department shall decide which mental health crises service the  
 17 publisher may list by using the criteria of a 24-hour staffed service, nonprofit organization and  
 18 non-9-1-1 participating agency. The publisher shall refer to the community services section for other  
 19 numbers.

20 *[(4) The 9-1-1 emergency reporting system must include at a minimum:]*

21 *[(a) A primary public safety answering point that is automatically accessible anywhere in the 9-1-1*  
 22 *jurisdiction service area by calling 9-1-1;]*

23 *[(b) Central dispatch of public and private safety services in the 9-1-1 service area or relay or*  
 24 *transfer of 9-1-1 calls to an appropriate public or private safety agency; and]*

25 *[(c) Two 9-1-1 circuits from each central office to each primary public safety answering point.]*

26 *[(5) In addition to the requirements set forth in subsection (4) of this section, enhanced 9-1-1 tele-*  
 27 *phone service must provide:]*

28 *[(a) Two call-taker stations and staffing for at least one of the stations at all times;]*

29 *[(b) Automatic display of the incoming telephone number and address in the designated public*  
 30 *safety answering point at the time of receiving an incoming 9-1-1 call;]*

31 *[(c) A network developed to transport address and telephone number information to the designated*  
 32 *public safety answering point automatically when a call is placed to 9-1-1; and]*

33 *[(d) Emergency telephone service in which one or fewer calls in 100 attempts receive a busy signal*  
 34 *on the first attempt during the average busiest hour. A public safety answering point may not have*  
 35 *fewer than two 9-1-1 circuits.]*

36 **(4) The emergency communications system must provide:**

37 **(a) Interconnectivity between public safety answering points and interconnectivity with**  
 38 **providers of the same or similar emergency response services nationally and internationally;**

39 **(b) The capability, within each primary public safety answering point, to receive all**  
 40 **emergency calls placed locally within each 9-1-1 service area; and**

41 **(c) The automatic location identification accurately portraying the location from which**  
 42 **each emergency call originates.**

43 **SECTION 9.** ORS 403.120 is amended to read:

44 403.120. (1) The Office of Emergency Management shall:

45 (a) Adopt rules in accordance with ORS chapter 183 *[relating to the planning, administration and*

1 *funding of 9-1-1 emergency reporting systems established pursuant to ORS 403.115.] to carry out the*  
 2 **intent and scope of ORS 403.105 to 403.250.**

3 **(b) Plan, implement, administer and maintain the emergency communications system and**  
 4 **may:**

5 *[(b)] (A) [Assist,] At the request of a 9-1-1 jurisdiction, local government or governing body, [in*  
 6 *planning 9-1-1 emergency reporting systems or may,] assist in planning, implementing, adminis-*  
 7 **tering and maintaining the emergency communications system within a 9-1-1 service area;**  
 8 **or**

9 **(B)** At the request of a 9-1-1 jurisdiction, act as an agent of the 9-1-1 jurisdiction for the pur-  
 10 poses of purchasing and maintaining equipment and services required to fulfill the requirements of  
 11 ORS 403.115.

12 (c) Report biennially to the Legislative Assembly the progress made in implementing ORS  
 13 305.823 and 403.105 to 403.250. *[including in the report:]* **The report must include:**

14 (A) Financial information concerning the revenues collected, distributed and expended by state  
 15 agencies and 9-1-1 jurisdictions for the purposes of complying with ORS 403.105 to 403.250; and

16 (B) Account and subaccount balances.

17 **(2) The office may enter into and administer contracts for goods and services related to**  
 18 **the emergency communications system.**

19 *[(2)] (3)* The office may establish advisory committees and study groups to study and advise on:

20 (a) The planning and administration of *[9-1-1 emergency reporting systems]* **public safety an-**  
 21 **swering points; and**

22 *[(b)] Multijurisdictional 9-1-1 emergency reporting systems; and]*

23 *[(c)] (b)* Issues impacting *[9-1-1 emergency reporting systems throughout the state]* **the emergency**  
 24 **communications system or individual public safety answering points.**

25 **SECTION 10.** ORS 403.130 is amended to read:

26 403.130. (1) A 9-1-1 jurisdiction shall submit and maintain a 9-1-1 jurisdiction plan for  
 27 emergency communications services provided within a 9-1-1 service area pursuant to ORS  
 28 403.105 to 403.250, to:

29 (a) The Office of Emergency Management;

30 (b) Public and private safety agencies within the 9-1-1 service area; and

31 (c) Any other public or private entity within the 9-1-1 service area that may be affected.

32 (2) The 9-1-1 jurisdiction plan must describe the capital and recurring costs to provide  
 33 the components of the emergency communications system within the 9-1-1 service area.

34 (3) The Office of Emergency Management shall review the 9-1-1 jurisdiction plan for  
 35 compliance with the requirements imposed under ORS 403.105 to 403.250, and if the plan is:

36 (a) In compliance, the office shall approve the plan.

37 (b) Not in compliance, the office shall reject the plan.

38 (4) If the office rejects the 9-1-1 jurisdiction plan under subsection (3) of this section:

39 (a) The 9-1-1 jurisdiction shall revise and resubmit the plan within 90 days after the date  
 40 the office rejects the plan; and

41 (b) The office shall review the revised plan and either approve or reject the revised plan  
 42 within 90 days after the date the office receives the revised plan.

43 *[(1)] (5)* Each 9-1-1 jurisdiction shall submit to the Office of Emergency Management in writing  
 44 within 30 days any change to *[the 9-1-1 emergency telephone system]* a **public safety answering point**  
 45 that alters the *[final plan or system description]* **approved 9-1-1 jurisdiction plan** on file with the



1 office. The changes may include, but are not limited to:

- 2 (a) The address of the public safety answering point;
- 3 (b) Telephone numbers used to satisfy requirements set forth in ORS 403.115;
- 4 (c) Director changes;
- 5 (d) Agencies served by the 9-1-1 jurisdiction; and
- 6 (e) The method used to direct [*the 9-1-1*] **an emergency** call once received by the primary public

8 [(2)] (6) If an established 9-1-1 jurisdiction proposes to move [*its 9-1-1 emergency reporting system*  
 9 *from one*] a public safety answering point to another **location** or a governing body proposes to es-  
 10 tablish a new 9-1-1 jurisdiction with a new primary public safety answering point, and if either of  
 11 these proposals will result in control of the [*9-1-1 emergency reporting system*] **9-1-1 service area**  
 12 by an agency or agencies other than [*as*] **the agency or agencies** identified in the [*final plan ap-*  
 13 *proved by the office under ORS 401.750 (1987 Replacement Part), section 7, chapter 743, Oregon Laws*  
 14 *1991, or the system description filed with the office under ORS 401.750 (5) (1987 Replacement Part)*]  
 15 **approved 9-1-1 jurisdiction plan filed with the office**, the 9-1-1 jurisdiction or governing body  
 16 shall submit a **revised 9-1-1 jurisdiction** plan setting forth [*these*] **the** changes to:

- 17 (a) The Office of Emergency Management;
- 18 (b) Public and private safety agencies in the 9-1-1 service area; and
- 19 (c) [*Utilities which provide telephone service*] **Any other public or private entity** in the 9-1-1
- 20 service area **that may be affected**.

21 [(3)] (7) In addition to meeting the requirements [*of ORS 403.115 and rules adopted pursuant to*  
 22 *ORS 403.120*] **imposed under ORS 403.105 to 403.250**, the revised [*final*] **9-1-1 jurisdiction** plan  
 23 must describe the capital and recurring costs for the proposed [*9-1-1 emergency reporting system*]  
 24 **components of the emergency communications system within the 9-1-1 service area**.

25 [(4)] (8) The office shall review the revised [*final*] **9-1-1 jurisdiction** plan for compliance with  
 26 [*this section, ORS 403.115 and rules adopted pursuant to ORS 403.120*] **the requirements imposed**  
 27 **under ORS 403.105 to 403.250** and, if the office determines that the plan is in compliance, approve  
 28 the plan.

29 [(5)] (9) The office may not approve a revised [*final*] **9-1-1 jurisdiction** plan submitted under  
 30 **subsection (6) of this section** unless the **revised** plan is accompanied by written approval of the  
 31 governing bodies of all public and private safety agencies affected by or providing service in the  
 32 9-1-1 service area.

33 **SECTION 11.** ORS 403.135, as amended by section 3, chapter 29, Oregon Laws 2014, is amended

3 (3) A provider is not subject to an action for civil damages for providing in good faith confi-  
4 dential or nonpublic information, including nonpublished and nonlisted subscriber information, to  
5 emergency services providers who are:

6 (a) Responding to [*emergency calls placed to a 9-1-1 emergency reporting system;*] **an emergency**  
7 **call;**

8 (b) Responding to emergency situations that involve the risk of death or serious physical harm  
9 to an individual, as provided in section 2, chapter 29, Oregon Laws 2014; or

10 (c) Notifying the public of an emergency.

11 (4) Subsection (3) of this section does not compel a provider to provide nonpublished and non-  
12 listed subscriber information directly to emergency services providers or law enforcement agencies  
13 prior to placement of an emergency call [*to a 9-1-1 emergency reporting system*] without process of  
14 law.

15 (5) Subscriber information acquired by a 9-1-1 jurisdiction for the purpose of [*enhancing a 9-1-1*  
16 *emergency reporting system*] **providing emergency communications services under ORS 403.105**  
17 **to 403.250** is not subject to public disclosure and may not be used by other public agencies except:

18 (a) To respond to [*a 9-1-1*] **an emergency call;**

19 (b) To respond to an emergency situation that involves the risk of death or serious physical  
20 harm to an individual, as provided in section 2, chapter 29, Oregon Laws 2014; or

21 (c) To notify the public of an emergency by utilizing an automated [*telephone*] notification system  
22 if a provider has provided subscriber information to the 9-1-1 jurisdiction or emergency services  
23 provider.

24 **SECTION 12.** ORS 403.137 is amended to read:

25 403.137. (1) As used in this section, "workplace":

26 (a) Includes hallways, lobbies, conference rooms, rest rooms, break rooms, elevators, laborato-  
27 ries, warehouse space and other areas of a building in which employees or volunteers perform work  
28 or that are accessible on a regular basis by employees, volunteers or members of the public; and

29 (b) Does not include wall thickness, shafts, heating or ventilation spaces, mechanical or elec-

- 19 (e) A 9-1-1 jurisdiction.

20 **SECTION 13.** ORS 403.140 is amended to read:

21 403.140. A person that provides telephone service through a coin or credit card operated pay  
 22 station telephone in an area served by [*a 9-1-1 emergency reporting*] **the emergency communi-**  
 23 **cations** system [*established pursuant to ORS 403.115*] shall convert every coin or credit pay station  
 24 telephone to permit calling 9-1-1 and "O"-operator without depositing a coin or charging the caller.

25 **SECTION 14.** ORS 403.145 is amended to read:

26 403.145. All public safety answering points must be capable of receiving [*9-1-1*] emergency calls  
 27 **to 9-1-1** from individuals with hearing or speech impairments through a TTY.

29 403.150. [*Each*] **A** 9-1-1 jurisdiction must have a disaster recovery plan for [*its 9-1-1 emergency*

 27 service, shall be collected by the seller from the consumer with respect to each retail transaction

 2 tified pursuant to ORS 759.020, [radio] common carriers and interexchange carriers.

3 **SECTION 21.** ORS 403.215 is amended to read:

4 403.215. (1) The provider is responsible for collecting the tax under ORS 403.200 and shall file  
 5 a return with the Department of Revenue on or before the last day of the month following the end  
 6 of each calendar quarter, reporting the amount of tax due for access to the [9-1-1 emergency report-  
 7 ing] **emergency communications** system during the quarter. The department shall prescribe the  
 8 form of the return required by this section and ORS 403.210. The rules of the department must re-

 28 mation to public or private safety agencies or dispatching emergency equipment or personnel in
