House Bill 2580

Sponsored by Representative BARNHART (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Prohibits merchant from requiring statement of account as condition for cardholder to obtain refund of amount in payment card transaction.

Makes violation of prohibition unlawful practice that is subject to action under Unlawful Trade Practices Act.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> (1) As used in this section:

6 (a) "Cardholder" means a person to which a payment card is issued or a person that is 7 authorized to use a payment card.

8 (b) "Merchant" means a person that, in the ordinary course of the person's business,

9 accepts another person's use of a payment card to obtain goods or services from the person
10 by purchase or through an extension of credit.

(c) "Payment card" means a credit card, charge card, debit card, stored value card or
 other device that enables a cardholder to obtain goods or services from a merchant by pre senting the card or device as payment.

(d) "Payment card transaction" means an exchange in which a cardholder presents and
 a merchant accepts a payment card as a method by which the cardholder obtains and the
 merchant provides goods or services.

(e) "Person" means an individual, corporation, limited liability company, partnership or
 other association or entity.

(f) "Statement of account" means a record or document that a person that issues a
 payment card maintains, in any form or format, as evidence of and information about a
 cardholder's payment card transactions.

(2) (a) A merchant may not require a cardholder to present a statement of account to the merchant in order for the cardholder to obtain a refund of all or a portion of the amount of a payment card transaction, whether or not a receipt, a sales draft or any other record or evidence of the payment card transaction exists, if the cardholder is otherwise entitled to the refund.

(b) Paragraph (a) of this subsection does not relieve the cardholder of the requirement to comply with any other terms and conditions a merchant may lawfully impose on a cardholder's right to obtain a refund for all or a portion of the amount of a payment card transaction between the cardholder and the merchant.

HB 2580 (3) A merchant's violation of a provision of this section is an unlawful practice under 1 2 ORS 646.608 that is subject to an action under ORS 646.638. **SECTION 2.** ORS 646.608, as amended by section 3, chapter 19, Oregon Laws 2014, is amended 3 4 to read: 646.608. (1) A person engages in an unlawful practice if in the course of the person's business, 5 vocation or occupation the person does any of the following: 6 7 (a) Passes off real estate, goods or services as the real estate, goods or services of another. (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-8 9 proval, or certification of real estate, goods or services. 10 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or association with, or certification by, another. 11 12(d) Uses deceptive representations or designations of geographic origin in connection with real 13 estate, goods or services. (e) Represents that real estate, goods or services have sponsorship, approval, characteristics, 14 15 ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the 16 person does not have. 17 18 (f) Represents that real estate or goods are original or new if the real estate or goods are deteriorated, altered, reconditioned, reclaimed, used or secondhand. 19 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade, 20or that real estate or goods are of a particular style or model, if the real estate, goods or services 2122are of another. 23(h) Disparages the real estate, goods, services, property or business of a customer or another by false or misleading representations of fact. 24 (i) Advertises real estate, goods or services with intent not to provide the real estate, goods or 25services as advertised, or with intent not to supply reasonably expectable public demand, unless the 2627advertisement discloses a limitation of quantity. (j) Makes false or misleading representations of fact concerning the reasons for, existence of, 2829or amounts of price reductions. 30 (k) Makes false or misleading representations concerning credit availability or the nature of the 31 transaction or obligation incurred. 32(L) Makes false or misleading representations relating to commissions or other compensation to be paid in exchange for permitting real estate, goods or services to be used for model or demon-33 34 stration purposes or in exchange for submitting names of potential customers. 35(m) Performs service on or dismantles any goods or real estate if the owner or apparent owner of the goods or real estate does not authorize the service or dismantling. 36 37 (n) Solicits potential customers by telephone or door to door as a seller unless the person provides the information required under ORS 646.611. 38 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give 39 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of 40 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or 41 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, 42 discount or other value is contingent upon an event occurring after the time the customer enters 43 into the transaction. 44

cize a product, business or service. 1 2 (q) Promises to deliver real estate, goods or services within a certain period of time with intent not to deliver the real estate, goods or services as promised. 3 (r) Organizes or induces or attempts to induce membership in a pyramid club. 4 (s) Makes false or misleading representations of fact concerning the offering price of, or the 5 person's cost for real estate, goods or services. 6 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any 7 known material defect or material nonconformity. 8 9 (u) Engages in any other unfair or deceptive conduct in trade or commerce. (v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers, 10 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situ-11 12 ation. 13 (w) Manufactures mercury fever thermometers. - 1 declaring the conduct to be unfair or deceptive in trade or commerce.
- 2 (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought
- 3 under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is lim-
- 4 ited to an injunction and the prevailing party may be awarded reasonable attorney fees.
