SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes designation of enterprise zone and zone and city for electronic commerce, addition of zone cosponsor and change of enterprise zone boundary without application process, subject to determination by Oregon Business Development Department that certain statutory requirements met.

Requires [*notification of*] **submission of documentation** to department [*at least 60 days*] before designation, addition or change, and consultation with department.

Eliminates numeric limit on number of enterprise zones that may be designated at any time.

Lowers minimum cost requirement for qualified property used in electronic commerce outside zone for electronic commerce.

Takes effect on 91st day following adjournment sine die.

2 Relating to enterprise zones; creating new provisions; amending ORS 285C.050, 285C.060, 285C.065,
3 285C.066, 285C.067, 285C.068, 285C.070, 285C.090, 285C.095, 285C.100, 285C.105, 285C.115,
4 285C.120, 285C.135, 285C.175, 285C.180, 285C.185, 285C.245, 285C.250 and 315.507; repealing ORS
5 285C.075, 285C.080 and 285C.195; and prescribing an effective date.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 285C.050 is amended to read:

8 285C.050. As used in ORS 285C.050 to 285C.250, unless the context requires otherwise:

9 (1) "Assessment date" and "assessment year" have the meanings given those terms in ORS
10 308.007.

11 (2) "Authorized business firm" means an eligible business firm that has been authorized under
12 ORS 285C.140.

13 (3) "Business firm" means a person operating or conducting one or more trades or businesses,
14 a people's utility district organized under ORS chapter 261 or a joint operating agency formed under
15 ORS chapter 262, but does not include any other governmental agency, municipal corporation or
16 nonprofit corporation.

17 (4) "County average annual wage" means:

18 (a) The most recently available average annual covered payroll for the county in which the en-
19 terprise zone is located, as determined by the Employment Department; or

20 (b) If the enterprise zone is located in more than one county, the highest county average annual
21 wage as determined under paragraph (a) of this subsection.

22 (5) "Electronic commerce" means engaging in commercial or retail transactions predominantly
23 over the Internet or a computer network, utilizing the Internet as a platform for transacting busi-

1 ness, or facilitating the use of the Internet by other persons for business transactions, and may be
2 further defined by the Oregon Business Development Department by rule.

3 (6) "Eligible business firm" means a firm engaged in an activity described under ORS 285C.135
4 that may file an application for authorization under ORS 285C.140.

5 (7) "Employee" means a person who works more than 32 hours per week, but does not include
6 a person with a temporary or seasonal job or a person hired solely to construct qualified property.

7 (8) "Enterprise zone" means one of the 30 areas designated or terminated and redesignated by
8 order of the Governor under ORS 284.160 (1987 Replacement Part) before October 3, 1989, one of the
9 areas designated by the Director of the Oregon Business Development Department under ORS
10 285C.080 **before the effective date of this 2015 Act, an area designated under ORS 285C.065**, a
11 federal enterprise zone area designated under ORS 285C.085, an area designated under ORS 285C.250
12 or a reservation enterprise zone designated, or a reservation partnership zone cosponsored, under
13 ORS 285C.306.

14 (9) "Federal enterprise zone" means any discrete area wholly or partially within this state that
15 is designated as an empowerment zone, an enterprise community, a renewal community or some
16 similar designation for purposes of improving the economic and community development of the area.

17 (10) "First-source hiring agreement" means an agreement between an authorized business firm
18 and a publicly funded job training provider whereby the provider refers qualified candidates to the
19 firm for new jobs and job openings in the firm.

20 (11) "In service" means being used or occupied or fully ready for use or occupancy for com-
21 mercial purposes consistent with the intended operations of the business firm as described in the
22 application for authorization.

23 (12) "Modification" means modernization, renovation or remodeling of an existing building,
24 structure or real property machinery or equipment.

25 (13) "New employees hired by the firm":

26 (a) Includes only those employees of an authorized business firm engaged for a majority of their
27 time in eligible operations.

28 (b) Does not include individuals employed in a job or position that:

29 (A) Is created and first filled after December 31 of the first tax year in which qualified property
30 of the firm is exempt under ORS 285C.175;

31 (B) Existed prior to the submission of the relevant application for authorization; or

32 (C) Is performed primarily at a location outside of the enterprise zone.

33 (14) "Publicly funded job training provider" includes but is not limited to a community college,
34 a service provider under the federal Workforce Investment Act Title I-B (29 U.S.C. 2801 et seq.), or
35 a similar program.

36 (15) "Qualified business firm" means a business firm described in ORS 285C.200, the qualified
37 property of which is exempt from property tax under ORS 285C.175.

38 (16) "Qualified property" means property described under ORS 285C.180.

39 (17) "Rural enterprise zone" means:

40 (a) An enterprise zone located in an area of this state in which an urban enterprise zone could
41 not be located; or

42 (b) A reservation enterprise zone designated, or a reservation partnership zone cosponsored,
43 under ORS 285C.306.

44 (18) "Sparsely populated county" means a county with a density of 100 or fewer persons per
45 square mile, based on the most recently available population figure for the county from the Portland

1 State University Population Research Center.

2 (19) "Sponsor" means:

3 (a) The city, county or port, or any combination of cities, counties or ports, that received ap-
4 proval of an enterprise zone under ORS 284.150 and 284.160 (1987 Replacement Part), [*under ORS*
5 *285C.065 and 285C.075,*] **under ORS 285C.080 before the effective date of this 2015 Act or under**
6 **ORS 285C.085 or 285C.250 or that designated an enterprise zone under ORS 285C.065 or**
7 **285C.250;**

8 (b) The tribal government, in the case of a reservation enterprise zone;

9 (c) The tribal government and the cosponsoring city, county or port, in the case of a reservation
10 partnership zone; or

11 (d) A city, county or port that joined the enterprise zone through a boundary change under ORS
12 285C.115 [(7)] (6) or a port that joined the enterprise zone under ORS 285C.068.

13 (20) "Tax year" has the meaning given that term in ORS 308.007.

14 (21) "Urban enterprise zone" means an enterprise zone in a metropolitan statistical area, as
15 defined by the most recent federal decennial census, that is located inside a regional or metropolitan
16 urban growth boundary.

17 (22) "Year" has the meaning given that term in ORS 308.007.

18 **SECTION 2.** ORS 285C.060 is amended to read:

19 285C.060. In addition to any other powers granted by law, for the purpose of administering ORS
20 285C.050 to 285C.250, the Oregon Business Development Department shall:

21 (1) Adopt any rules the department considers necessary to administer ORS 285C.050 to 285C.250.

22 (2) Assist a sponsor of an enterprise zone in its efforts to retain, expand, start or recruit eligible
23 business firms.

24 (3) Assist an eligible business firm doing business within an enterprise zone to obtain the bene-
25 fits of applicable incentive or inducement programs authorized by Oregon law.

26 (4) Take action necessary to participate in the federal enterprise zone program pursuant to ORS
27 285C.085.

28 [(5) *Process sponsor requests for boundary amendments under ORS 285C.115.*]

29 [(6)] (5) Take action necessary to [*terminate or designate zones under ORS 285C.245 or*
30 *285C.250*] **ensure that zones designated by sponsors comply with statutory requirements.**

31 [(7)] (6) Assist in implementing first-source hiring agreements by publicly funded job training
32 providers with authorized business firms and in ensuring compliance with business firm eligibility
33 requirements and with provisions addressing the avoidance of job losses outside of enterprise zones.

34 **SECTION 3.** ORS 285C.065 is amended to read:

35 285C.065. (1) Any city, county or port may [*apply to the Director of the Oregon Business Devel-*
36 *opment Department for designation of*] **designate** an area within [*that*] **the** city, county or port as
37 an enterprise zone. A port shall obtain the consent of the governing body of the county prior to
38 [*applying to the Oregon Business Development Department for designation of*] **designating** an area
39 as an enterprise zone. With the prior consent of the governing body of the city or port, a county
40 may [*apply to the department*], on behalf of a city or port [*for designation of*], **designate** any area
41 within [*that*] **the** city or port as an enterprise zone. With the prior consent of the governing body
42 of a city, a port may [*apply to the department*], on behalf of a city [*for designation of*], **designate** any
43 area that is wholly or partially shared territory of both the port and city as an enterprise zone.
44 With the prior consent of the governing body of a port, a city may [*apply to the department*], on
45 behalf of a port [*for designation of*], **designate** any area that is wholly or partially shared territory

1 of both the city and port as an enterprise zone.

2 (2) One or more cities, counties and ports may *[apply to the director for designation of]* **designate**
3 an area situated partly within each city and partly in unincorporated territory within the counties
4 or ports as an enterprise zone.

5 *[(3) An application for designation of an enterprise zone shall be in the form and contain such*
6 *information as the department, by rule, may require. However, the application shall:]*

7 *[(a) Be submitted on behalf of one or more local government units as described in subsections (1)*
8 *and (2) of this section by resolution of the governing body of each applicant;]*

9 *[(b) Contain a description of the area sought to be designated as an enterprise zone;]*

10 *[(c) Contain information sufficient to allow the department to determine if the criteria established*
11 *in ORS 285C.090 are met;]*

12 *[(d) State that the applicant will give priority to the use in the proposed enterprise zone of any*
13 *economic development or job training funds received from the federal government; and]*

14 *[(e) Declare that the applicant will comply with ORS 285C.105 and perform any other duties of the*
15 *sponsor under ORS 285C.050 to 285C.250.]*

16 *[(4) When applying for designation of an enterprise zone within its boundaries under this section,*
17 *the applicant may include in the application:]*

18 *[(a) Proposals to enhance the level or efficiency of local public services within the proposed enter-*
19 *prise zone including, but not limited to, fire-fighting and police services; and]*

20 *[(b) Proposals for local incentives and local regulatory flexibility to authorized business firms.]*

21 *[(5) In the case of joint applications by more than one local government unit, each city, county or*
22 *port joining in the application may include proposals for enhanced local public services, local incentives*
23 *or local regulatory flexibility to be effective within the boundaries of that local government unit.]*

24 *[(6) Proposals under subsection (4) or (5) of this section for enhanced local public services, local*
25 *incentives or local regulatory flexibility included in the application by a city, county or port for an*
26 *enterprise zone are binding upon the city, county or port if an enterprise zone is designated wholly or*
27 *partly within its boundaries.]*

28 **(3) Designation of an enterprise zone under this section shall be made by resolution of**
29 **the governing body of the city, county or port and is not final until a positive determination**
30 **in favor of the zone has been made by the Oregon Business Development Department under**
31 **section 10 of this 2015 Act.**

32 **SECTION 4.** ORS 285C.066 is amended to read:

33 285C.066. The Oregon Business Development Department may adopt rules related to:

34 (1) The consent required *[from]* **by resolution of the governing body of** a city, county or port
35 under ORS 285C.065 (1) in order for a city, county or port to *[apply for]* **designate an** enterprise
36 zone *[designation under ORS 285C.065]*.

37 **(2) The number of enterprise zones that may be designated within a city or other juris-**
38 **diction.**

39 **SECTION 5.** ORS 285C.067 is amended to read:

40 285C.067. (1) A city, county or port that seeks to *[apply to the Director of the Oregon Business*
41 *Development Department for]* **designate an** enterprise zone *[designation]* under ORS 285C.065 **or**
42 **285C.250** shall consult with all local taxing districts with territory in the *[proposed]* zone prior to
43 *[filing the application]* **designating the zone.**

44 (2) The Oregon Business Development Department may adopt rules on the consultations re-
45 quired under subsection (1) of this section and procedures related to the consultations.

1 **SECTION 6.** ORS 285C.068 is amended to read:

2 285C.068. (1) A port located in whole or in part within an existing enterprise zone may [*submit*
3 *a request to the Oregon Business Development Department to*] be **added as** a cosponsor of the enter-
4 prise zone **by resolution of the governing body of the port, subject to the consent of the ex-**
5 **isting zone sponsor and with notice to the Oregon Business Development Department.** [*The*
6 *request shall include:*]

7 [(a) *A copy of the resolution of the governing body of the port approving the request for designation*
8 *as cosponsor of the enterprise zone;*]

9 [(b) *A copy of the resolution of the governing body of each current sponsor of the enterprise zone*
10 *approving the addition of the port as a cosponsor; and*]

11 [(c) *Other information required by the department.*]

12 [(2) *The department shall review the request for addition of the port as a cosponsor of the enter-*
13 *prise zone. If the request is incomplete or does not satisfy the requirements of this section, the depart-*
14 *ment shall seek additional information as necessary or shall return the request to the port. If the*
15 *request is returned, the port may submit a revised request at any time. If the request is complete and*
16 *does satisfy the requirements of this section, the Director of the Oregon Business Development De-*
17 *partment shall approve the request.*]

18 [(3)] (2) The addition of a port as a cosponsor of an existing enterprise zone under this section
19 does not change the termination date of the enterprise zone under ORS 285C.245 (2).

20 **SECTION 7.** ORS 285C.070 is amended to read:

21 285C.070. (1) The governing body of a city or county that is [*seeking*] **designating an** enterprise
22 zone [*designation*] under ORS 285C.065 **or 285C.250** may elect to permit a business firm operating
23 a hotel, motel or destination resort to be an eligible business firm with respect to those operations.

24 (2) The election must be made at the time the [*application for zone designation under ORS*
25 *285C.065 is made*] **zone is designated** or any time thereafter and before the expiration of six months
26 following the date the zone is designated.

27 (3) The election shall be made by a resolution adopted by the city or county governing body. In
28 order for the election to be effective, the resolution must be submitted to the Oregon Business De-
29 velopment Department and acknowledged by the department.

30 (4)(a) If more than one city or county is to be the sponsor, the resolution making the election
31 may restrict the area in which a hotel, motel or destination resort may be located in order for the
32 firm to be an eligible business firm with respect to those operations.

33 (b) The resolution making the restriction described in paragraph (a) of this subsection may only
34 restrict the area of the zone in which a hotel, motel or destination resort may be located to that
35 area of the zone that is located:

36 (A) Within the boundaries of one or more cities in favor of hotel, motel and destination resort
37 exemption, if the county is not in favor of hotel, motel and destination resort exemption;

38 (B) Within the unincorporated territory of a county in favor of hotel, motel and destination re-
39 sort exemption, if one or more cities are not in favor of hotel, motel and destination resort ex-
40 emption; or

41 (C) Within the shared territory of a city and county in favor of hotel, motel and destination re-
42 sort exemption and the unincorporated territory of the county, if one or more other cities are not
43 in favor of hotel, motel and destination resort exemption.

44 (c) If a restriction is made under this subsection, the restriction may be modified at any time
45 within six months of the date the zone is designated, but may not be modified at any time thereafter.

1 (5) The sponsor may by resolution revoke an election made under this section. If an election is
2 revoked, the sponsor may not make another election under this section.

3 **SECTION 8.** ORS 285C.090 is amended to read:

4 285C.090. (1) [A *proposed*] **An** enterprise zone must be located in a local area in which:

5 (a) Fifty percent or more of the households have incomes below 80 percent of the median income
6 of this state, as defined by the most recent federal decennial census;

7 (b) The unemployment rate is at least 2.0 percentage points greater than the comparable unem-
8 ployment rate for this entire state, as defined by the most recently available data published or offi-
9 cially provided and verified by the United States Government, the Employment Department, the
10 Portland State University Population Research Center or special studies conducted under a contract
11 with a regional academic institution; or

12 (c) The Oregon Business Development Department determines on a case-by-case basis using ev-
13 idence provided by the cities, counties or ports [*applying for designation of*] **designating** the [*pro-*
14 *posed*] enterprise zone that there exists a level of economic hardship at least as severe as that
15 described in paragraph (a) or (b) of this subsection. The evidence must be based on the most recently
16 available data from official sources and may include a contemporary decline of the population in the
17 [*proposed*] enterprise zone, the percentage of persons in the [*proposed*] enterprise zone below the
18 poverty level relative to the percentage of the entire population of this state below the poverty level
19 or the unemployment rate for the county or counties in which the [*proposed*] enterprise zone is lo-
20 cated.

21 (2)(a) An urban enterprise zone may consist of a total area of not more than 12 square miles in
22 size.

23 (b) A rural enterprise zone may consist of a total area of not more than 15 square miles in size.

24 (c) For purposes of this subsection, the area of the zone must be calculated by excluding that
25 portion of the zone that lies below the ordinary high water mark of a navigable body of water.

26 (3) Except as provided in subsection (4) of this section:

27 (a) An urban enterprise zone must have 12 miles or less, and a rural enterprise zone must have
28 15 miles or less, as the greatest distance between any two points within the zone; and

29 (b) Unconnected areas of an enterprise zone may not be more than five miles apart.

30 (4) Unconnected areas of a rural enterprise zone may not be more than 15 miles apart when an
31 unconnected area is entirely within a sparsely populated county, and the zone:

32 (a) Must have 20 miles or less as the greatest distance between any two points within the zone,
33 if only a portion of the zone is contained within a sparsely populated county; or

34 (b) Must have 25 miles or less as the greatest distance between any two points within the zone,
35 if the zone is entirely contained within a sparsely populated county.

36 (5) This section does not apply to the designation or redesignation of a reservation enterprise
37 zone or a reservation partnership zone.

38 **SECTION 9.** Section 10 of this 2015 Act is added to and made a part of ORS 285C.050 to
39 285C.250.

40 **SECTION 10.** (1)(a) No sooner than the 45th day following compliance with section 29 (1)
41 of this 2015 Act, a zone sponsor shall submit to the Oregon Business Development Depart-
42 ment documentation of the sponsor's designation of an enterprise zone under ORS 285C.065
43 or 285C.250.

44 (b) For purposes of this subsection, the documentation submitted to the department
45 must include:

1 (A) A map clearly indicating the designated zone boundary;

2 (B) A description and geographic information system data for the area inside the zone;
3 and

4 (C) Any other information required by the department for the purposes of making a de-
5 termination under this section.

6 (2) As soon as practicable after receipt of the documentation required under subsection
7 (1) of this section, the department shall notify the zone sponsor of the department's deter-
8 mination.

9 (3)(a) The department's determination shall be positive and final if the requirements of
10 this section and ORS 285C.065, 285C.067 and 285C.090 are met.

11 (b) The designation shall take effect on the date on which the latest resolution of the
12 sponsoring or consenting city, county or port was adopted.

13 (4)(a) If the department's determination is negative, the notice required under subsection
14 (2) of this section must state the reasons for the negative determination.

15 (b) The zone sponsor may resubmit documentation for a determination under this section
16 and the sponsor and the department may discuss changes in the documentation necessary
17 for a positive determination under this section.

18 (c) If the sponsor resubmits documentation and the department makes a positive deter-
19 mination, the designation shall take effect on the date on which the latest resolution of the
20 sponsoring or consenting city, county or port was adopted, or the date on which any out-
21 standing requirement for designation is satisfied, as stipulated in the department's determi-
22 nation.

23 **SECTION 11.** ORS 285C.095, as amended by section 1, chapter 53, Oregon Laws 2014, is
24 amended to read:

25 285C.095. (1) A sponsor of an existing enterprise zone may [*seek to have*] **designate** the zone
26 [*designated*] for electronic commerce under this section **by resolution of the governing body of**
27 **the sponsor.**

28 [*(2) The sponsor shall file an application to have the zone designated for electronic commerce with*
29 *the Oregon Business Development Department. The application shall be in the form and contain the*
30 *information that the department by rule may require.*]

31 [*(3) The application shall be accompanied by a copy of a resolution, adopted by the governing body*
32 *of the sponsor, requesting that the zone be designated for electronic commerce.*]

33 [(4)] (2) [*The department shall review applications for electronic commerce designation and shall*
34 *approve*] **There may be designated at any time** no more than 15 zones for electronic commerce
35 [*designation*].

36 [(5)] (3) The sponsor may by resolution revoke an electronic commerce designation made under
37 this section. If an election is revoked, the sponsor may not subsequently seek reinstatement of
38 electronic commerce designation.

39 (4) **Designation of a zone for electronic commerce under this section is not final until a**
40 **positive determination has been made in favor of the zone by the Oregon Business Develop-**
41 **ment Department under section 14 of this 2015 Act.**

42 **SECTION 12.** ORS 285C.100 is amended to read:

43 285C.100. (1) Notwithstanding ORS 285C.095, a city shall be designated for electronic commerce
44 if the city:

45 (a) By resolution of the governing body of the city, declares itself a city designated for elec-

1 tronic commerce;

2 (b) As of January 1, 2002, has a population of more than 1,500 but less than 2,000;

3 (c) Is located less than 25 miles from a city with a population of more than 500,000; and

4 (d) Is located less than 10 miles from a city with a high concentration of high technology firms
5 and with a population that, as of January 1, 2002, does not exceed 85,000.

6 (2) Only one city may be designated for electronic commerce under this section, and that des-
7 ignation shall be made without consideration of the numeric *[limitations]* **limits** imposed by ORS
8 285C.095.

9 (3)(a) A city does not need to sponsor an enterprise zone to be designated for electronic com-
10 merce under this section.

11 (b) The governing body of a city designated for electronic commerce under this section does not
12 *[have]* **need** to comply with the requirements of ORS **285C.067 or** 285C.090, but the governing body
13 must take all actions that are required of a sponsor of a rural enterprise zone under ORS 285C.050
14 to 285C.250 with respect to business firms seeking exemption under ORS 285C.175.

15 (c) A business firm that is engaged in electronic commerce at a location inside a city designated
16 for electronic commerce under this section and that seeks an exemption under ORS 285C.175 must
17 take all actions required of a qualified business firm under ORS 285C.050 to 285C.250, except that
18 the business firm does not need to be located within an enterprise zone.

19 (d) A business firm described in paragraph (c) of this subsection:

20 (A) Shall be an eligible business firm, the qualified property of which is exempt from taxation
21 under ORS 285C.175 as if the qualified property were located in an enterprise zone under ORS
22 285C.095; and

23 (B) May claim the tax credit under ORS 315.507.

24 **(4) Designation of a city for electronic commerce under this section is not final until a**
25 **positive determination in favor of the city has been made by the Oregon Business Develop-**
26 **ment Department under section 14 of this 2015 Act.**

27 *[(4)]* **(5)** For the purpose of determining the boundaries of a city designated for electronic com-
28 merce, “city” includes:

29 (a) Territory that is annexed into the city, as of the date of the annexation;

30 (b) Land within the urban growth boundary of the city; and

31 (c) Territory that is added to the urban growth boundary described in paragraph (b) of this
32 subsection, as of the date the urban growth boundary is extended to such territory.

33 **SECTION 13. Section 14 of this 2015 Act is added to and made a part of ORS 285C.050 to**
34 **285C.250.**

35 **SECTION 14. (1) No sooner than the 31st day following compliance with section 29 (1) of**
36 **this 2015 Act, the sponsor of an enterprise zone or the governing body of a city shall submit**
37 **to the Oregon Business Development Department documentation of the sponsor’s or city’s**
38 **designation of the zone or city for electronic commerce under ORS 285C.095 or 285C.100, re-**
39 **spectively, with sufficient information for the department to make a determination under**
40 **this section.**

41 **(2)(a) As soon as practicable after receipt of the documentation required under sub-**
42 **section (1) of this section, the department shall notify the zone sponsor or governing body**
43 **of the city of the department’s determination.**

44 **(b) The department’s determination shall be positive and final if the designation meets**
45 **applicable requirements, including, but not limited to, any numeric limitation under ORS**

1 **285C.095 or 285C.100.**

2 (c) **If the department's determination is negative, the notice required under paragraph**
3 **(a) of this subsection must state the reasons for the negative determination.**

4 (d) **A zone sponsor or the governing body of a city that receives a negative determination**
5 **under this subsection may resubmit documentation of the sponsor's or city's designation of**
6 **the zone or city for electronic commerce for a determination under this section.**

7 (3)(a) **For purposes of complying with the numeric limits of ORS 285C.095 or 285C.100, the**
8 **department shall make determinations under this section in the order in which documenta-**
9 **tion submitted under subsection (1) of this section is received.**

10 (b) **For purposes of this subsection, documentation that is resubmitted after a negative**
11 **determination shall be considered received on the date of the resubmission.**

12 (c) **The department shall adopt rules necessary to administer this subsection.**

13 **SECTION 15.** ORS 285C.105 is amended to read:

19 public services, local incentives and local regulatory flexibility [*included in the application for des-*

21 *business firms and assist authorized or qualified business firms in using enhanced local public ser-*
22 *vices, local incentives and local regulatory flexibility*] **that a sponsor has elected, by policy, to**

24 (c) Review and approve or deny applications for authorization under ORS 285C.140.

25 (d) Assist the county assessor in administering the property tax exemption and in performing
26 other duties assigned to the assessor under ORS 285C.050 to 285C.250.

27 (e) Maintain, implement and periodically update a plan for marketing the enterprise zone in-
28 cluding strategies for retention, expansion, start-up and recruitment of eligible business firms.

29 (f) Manage the enterprise zone in accordance with ORS 285C.050 to 285C.250.

30 (g) Identify property available for sale or lease to eligible business firms under ORS 285C.110.

31 (h) Prepare indices of street addresses, tax lot numbers or other information to facilitate the

6 (c) The property was constructed, added, modified or installed to further the production of in-
7 come;

8 (d) The property is owned or leased by an authorized business firm;

15 **designation shall take effect no sooner than the date of termination.**

16 (b) The sponsor of an enterprise zone terminated under ORS 285C.245 (4) or (5) is not eligible
17 to *[apply for]* **redesignate an enterprise zone or designate** a new enterprise zone for a period not
18 to exceed 10 years after the zone is terminated.

19 (c) Paragraph (b) of this subsection does not apply to a county government *[when]* **if** the termi-
20 nated zone was also jointly sponsored by one or more cities or ports.

21 *[(3) Sponsors of existing enterprise zones that are due to terminate may reapply for designation*
22 *under subsection (1) of this section.]*

23 *[(4) Any city, county or port may apply to the director for designation of an enterprise zone in*
24 *accordance with the criteria set forth in ORS 285C.065 and 285C.090. In addition, the Oregon Business*
25 *Development Department by rule shall determine the minimum level of economic hardship in any area*
26 *to be included within an enterprise zone, any other criteria necessary to evaluate the need for the en-*
27 *terprise zone and the potential for accomplishing the purposes of ORS 285C.050 to 285C.250.]*

28 *[(5)]* **(2) [All enterprise zones designated under this section shall terminate in accordance with ORS**
29 **285C.245 (2)] Enterprise zones redesignated under this section are subject to ORS 285C.245.**

30 *[(6) When the director designates enterprise zones under this section, there is no limit on the rela-*
31 *tive number of urban or rural enterprise zones designated.]*

32 *[(7) The director may determine when to accept applications for any enterprise zone that terminates*
33 *under subsection (2) of this section or is not designated under subsection (1) of this section for lack of*
34 *qualified applicants.]*

35 **SECTION 25. ORS 285C.075, 285C.080 and 285C.195 are repealed.**

36 **SECTION 26.** ORS 285C.185 is amended to read:

37 285C.185. (1) In order for property to be qualified property under ORS 285C.180, the property
38 must cost:

39 (a) \$50,000 or more, in the case of:

40 (A) All real property that is concurrently exempt at the location; or

41 (B) An item of personal property that is not described in paragraph (b) of this subsection.

42 (b) \$1,000 or more, in the case of an item of personal property that is used:

43 (A) Exclusively in the production of tangible goods; or

44 (B) In electronic commerce *[in an enterprise zone approved for electronic commerce designation*
45 *under ORS 285C.095].*

1 (2) The estimated cost of property set forth in an application for authorization under ORS
2 285C.140 shall be disregarded for purposes of determining if property is qualified property.

3 (3) Property that is leased by the authorized business firm may be qualified property under ORS
4 285C.180 only if the terms of the lease provide:

5 (a) During the term of the lease, that the authorized business firm is to compensate the owner
6 of the leased property for all property taxes assessed against the leased property or that the firm
7 is to pay these taxes; and

8 (b) That the term of the lease begins on or before the start of the first tax year for which the
9 property is exempt and ends on or after the last day of the last tax year for which the property is
10 exempt.

11 (4) In order for property that is owned or leased by an authorized business firm operating a
12 hotel, motel or destination resort to be qualified property under ORS 285C.180, the property must
13 be:

14 (a) Located and in service in an enterprise zone for which the sponsor has elected under ORS
15 285C.070 to treat a business firm engaged in hotel, motel or destination resort operations as an eli-
16 gible business firm;

17 (b) Located at the same site as the hotel, motel or destination resort or in close proximity to
18 that site; and

19 (c) Used primarily to serve overnight guests of the hotel, motel or destination resort. Property
20 is used primarily to serve overnight guests if at least 50 percent of any receipts from use of the
21 property are paid by overnight guests.

22 (5) In order for property owned or leased and operated by a business firm engaged in electronic
23 commerce in a city designated for electronic commerce under ORS 285C.100 to be qualified property,
24 the property otherwise qualified under this section and the applicable electronic commerce oper-
25 ations of the firm must be located in that city.

26 (6)(a) As used in this section, "item of personal property" includes an integrated system con-
27 sisting of various components.

28 (b) Consistent with paragraph (a) of this subsection, the Department of Revenue may by rule
29 further define what constitutes an item of personal property for purposes of this section.

30 **SECTION 27.** ORS 315.507 is amended to read:

31 315.507. (1) A credit against the taxes that are otherwise due under ORS chapter 316 or, if the
32 taxpayer is a corporation, under ORS chapter 317 or 318, shall be allowed to a taxpayer that is:

33 (a) A business firm engaged or preparing to engage in electronic commerce in an enterprise zone
34 that has been [*approved*] **designated** for electronic commerce [*designation*] under ORS 285C.095; or

35 (b) A business firm engaged or preparing to engage in electronic commerce in a city that has
36 been designated for electronic commerce under ORS 285C.100.

37 (2) The credit shall equal 25 percent of the investments made by the business firm in capital
38 assets:

39 (a) Located in the area designated for electronic commerce;

40 (b) Used or constructed, installed or otherwise prepared for use in electronic commerce oper-
41 ations within the area designated for electronic commerce that are related to electronic commerce
42 sales, customer service, order fulfillment, broadband infrastructure or other electronic commerce
43 operations; and

44 (c)(A) During the period that commences [*when the firm becomes*] **with the income or corpo-**
45 **rate excise tax year in which the firm applied to be** an authorized business firm under ORS

1 285C.140 and ends on the last day of the income or corporate excise tax year in which begins the
2 first property tax year in which qualified property of the firm used in eligible electronic commerce
3 activities is exempt from property taxation under ORS 285C.175; or

4 (B) During any income or corporate excise tax year in which begins a property tax year in
5 which qualified property of the firm used in eligible electronic commerce operations is exempt from
6 property taxation under ORS 285C.175.

7 (3) Except as provided in subsection (5) of this section, the credit must be claimed for the income
8 or corporate excise tax year that is:

9 (a) The year in which the investment for which a credit is being claimed is made; and

10 (b) A year, all or part of which is described in subsection (2)(c) of this section.

11 (4) A credit allowed under this section for any one tax year may not exceed the lesser of \$2
12 million or the tax liability of the taxpayer.

13 (5) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a
14 particular year may be carried forward and offset against the taxpayer's tax liability for the next
15 succeeding tax year. Any credit remaining unused in the next succeeding tax year may be carried
16 forward and used in the second succeeding tax year, and likewise any credit not used in that second
17 succeeding tax year may be carried forward and used in the third succeeding tax year, and any
18 credit not used in that third succeeding tax year may be carried forward and used in the fourth
19 succeeding tax year, and any credit not used in that fourth succeeding tax year may be carried
20 forward and used in the fifth succeeding tax year, but may not be carried forward for any tax year

22 (6) The credit allowed under this section is not in lieu of any depreciation or amortization de-
23 duction to which the taxpayer otherwise may be entitled under ORS chapter 316, 317 or 318 for the
24 tax year.

25 (7) The taxpayer's adjusted basis for determining gain or loss may not be further decreased by
26 any amount of credit allowed under this section.

27 (8)(a) A nonresident shall be allowed the credit under this section in the proportion provided in
28 ORS 316.117.

29 (b) If a change in the status of a taxpayer from resident to nonresident or from nonresident to
30 resident occurs, the credit allowed under this section shall be determined in a manner consistent
31 with ORS 316.117.

32 (c) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or if the
33 Department of Revenue terminates the taxpayer's taxable year under ORS 314.440, the credit al-
34 lowed under this section shall be prorated or computed in a manner consistent with ORS 314.085.

35 (9) As used in this section, "authorized business firm," "business firm," "electronic commerce"
36 and "qualified property" have the meanings given those terms in ORS 285C.050.

37 **SECTION 28. Section 29 of this 2015 Act is added to and made a part of ORS 285C.050 to**
38 **285C.250.**

39 **SECTION 29. (1) Before submitting documentation, as required under section 10 or 14 of**
40 **this 2015 Act, as applicable, of the designation of an enterprise zone under ORS 285C.065 or**
41 **285C.250 or a zone or city for electronic commerce under ORS 285C.095 or 285C.100, respec-**
42 **tively, the zone sponsor or the governing body of the city shall formally advise the Oregon**
43 **Business Development Department of the zone sponsor's or the city's intent to make the**
44 **designation.**

45 (2)(a) As soon as practicable after receipt of a formal advisory required under subsection

1 (1) of this section, the department shall contact the zone sponsor or the governing body of
2 the city to arrange a consultation about the designation.

3 (b) After the consultation required under this subsection, the zone sponsor or the gov-
4 erning body of the city may submit to the department documentation of the designation, at
5 the time and in the manner required under section 10 or 14 of this 2015 Act, as applicable.

6 (3) A formal advisory submitted pursuant to subsection (1) of this section does not obli-
7 gate the zone sponsor or the governing body of the city to make the designation.
