

SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2696

1 Delete lines 4 through 24 of the printed A-engrossed bill and insert:

2 **“SECTION 1. (1) As used in this section:**

3 **“(a) ‘Coordinated care organization’ has the meaning given that term in ORS 414.025.**

4 **“(b) ‘Subcontractor’ means an entity that contracts with a coordinated care organization**
5 **to provide health care, dental care, behavioral health care or other services to medical as-**
6 **sistance recipients enrolled in the coordinated care organization.**

7 **“(2) The Oregon Health Authority shall conduct one external quality review of each co-**
8 **ordinated care organization annually. The authority may contract with an external quality**
9 **review organization to conduct the review.**

10 **“(3) The authority shall compile a standard list of documents that the authority or con-**
11 **tracted review organization collects from coordinated care organizations and subcontractors.**
12 **When requesting information from a coordinated care organization about its subcontractors,**
13 **the authority or contracted review organization shall inform the coordinated care organiza-**
14 **tion of the documents on the standard list that have been collected from the coordinated**
15 **care organization’s subcontractors in the preceding 12-month period.**

16 **“(4) The authority or a contracted review organization may not request information from**
17 **a coordinated care organization that is duplicative of or redundant with information previ-**
18 **ously provided by the coordinated care organization or a subcontractor if the information**
19 **was provided within the preceding 12-month period and the relevant content of the informa-**
20 **tion has not changed.**

21 **“(5) The authority shall provide a contracted review organization with all information**
22 **about a coordinated care organization in the authority’s possession as necessary for the**
23 **contracted review organization to conduct the external quality review. A contracted review**
24 **organization may not seek information from a coordinated care organization before first re-**
25 **questing the information from the authority.**

26 **“(6) This section does not apply to documents requested, submitted or collected in con-**
27 **nection with an audit for or an investigation of fraud, waste or abuse and does not:**

28 **“(a) Prohibit a coordinated care organization from requesting from a subcontractor in-**
29 **formation required by law or contract;**

30 **“(b) Require the authority or a contracted review organization to disclose to a coordi-**
31 **nated care organization any information described in this section collected from a coordi-**
32 **nated care organization or a subcontractor; or**

33 **“(c) Permit the authority or a contracted review organization to disclose to a coordinated**
34 **care organization confidential or proprietary information reported to the authority or con-**
35 **tracted review organization by another coordinated care organization or a subcontractor.”.**
