SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Brings Oregon law into compliance with federal Preventing Sex Trafficking and Strengthening Families Act of 2014.

Requires Department of Human Services to ensure that providers of care for wards in substitute care follow reasonable and prudent parent standard and that wards have regular, ongoing opportunities to engage in age-appropriate or developmentally appropriate activities.

When court decides to continue child or ward in substitute care, requires court to make certain findings for ward 16 years of age or older with permanency plan of another planned permanent living arrangement.

Requires that court review comprehensive plan for ward's transition to successful adulthood and make certain findings when ward is 14 years of age or older.

Changes term "independent living" to "successful adulthood" in permanency plan hearings and determinations.

Limits permanency placements in another planned permanent living arrangements to children or wards 16 years of age or older.

Declares emergency, effective October 1, 2015.

SECTION 1. ORS 419A.004 is amended to read:

7 419A.004. As used in this chapter and ORS chapters 419B and 419C, unless the context requires 8 otherwise:

(1) "Age-appropriate or developmentally appropriate activities" means:

10 (a) Activities or items that are generally accepted as suitable for children of the same 11 chronological age or level of maturity or that are determined to be developmentally appro-12priate for a child, based on the development of cognitive, emotional, physical and behavioral 13 capacities that are typical for an age or age group; and

(b) In the case of a specific child, activities or items that are suitable for the child based 14 on the developmental stages attained by the child with respect to the cognitive, emotional, 15 16 physical and behavioral capacities of the child.

17(2) "Another planned permanent living arrangement" means an out-of-home placement for a ward 16 years of age or older that is consistent with the case plan and in the best in-18

19 terests of the ward other than placement:

20(a) By adoption;

(b) With a legal guardian; or 1 2 (c) With a fit and willing relative. [(1)] (3) "CASA Volunteer Program" means a program that is approved or sanctioned by a ju-3 venile court, has received accreditation from the National CASA Association and has entered into 4 a contract with the Oregon Volunteers Commission for Voluntary Action and Service under ORS 5 458.581 to recruit, train and supervise volunteers to serve as court appointed special advocates. 6 [(2)] (4) "Child care center" means a residential facility for wards or youth offenders that is li-7 censed under the provisions of ORS 418.240. 8 9 [(3)] (5) "Community service" has the meaning given that term in ORS 137.126. [(4)] (6) "Conflict of interest" means a person appointed to a local citizen review board who has 10 a personal or pecuniary interest in a case being reviewed by that board. 11 12[(5)] (7) "Counselor" means a juvenile department counselor or a county juvenile probation of-13 ficer. 2 (21) "Reasonable and prudent parent standard" means the standard, characterized by 3 careful and sensible parental decisions that maintain the health, safety and best interests 4 of a child or ward while encouraging the emotional and developmental growth of the child 5 or ward, that a substitute care provider shall use when determining whether to allow a child 6 or ward in substitute care to participate in extracurricular, enrichment, cultural and social 7 activities.

8 [(20)] (22) "Reasonable time" means a period of time that is reasonable given a child or ward's 9 emotional and developmental needs and ability to form and maintain lasting attachments.

[(21)] (23) "Records" means any information in written form, pictures, photographs, charts,
 graphs, recordings or documents pertaining to a case.

12 [(22)] (24) "Resides" or "residence," when used in reference to the residence of a child, ward, 13 youth or youth offender, means the place where the child, ward, youth or youth offender is actually 14 living or the jurisdiction in which wardship or jurisdiction has been established.

15 [(23)] (25) "Restitution" has the meaning given that term in ORS 137.103.

16 [(24)] (26) "Serious physical injury" means:

17 (a) A serious physical injury as defined in ORS 161.015; or

18 (b) A physical injury that:

19 (A) Has a permanent or protracted significant effect on a child's daily activities;

20 (B) Results in substantial and recurring pain; or

21 (C) In the case of a child under 10 years of age, is a broken bone.

22 [(25)] (27) "Shelter care" means a home or other facility suitable for the safekeeping of a child,

ward, youth or youth offender who is taken into temporary custody pending investigation and dis-position.

[(26)] (28) "Short-term detention facility" means a facility established under ORS 419A.050 (3) for
 holding children, youths and youth offenders pending further placement.

27 [(27)] (29) "Sibling" means one of two or more children or wards related:

28 (a) By blood or adoption through a common legal parent; or

29 (b) Through the marriage of the children's or wards' legal or biological parents.

30 [(28)] (30) "Substitute care" means an out-of-home placement directly supervised by the depart-31 ment or other agency, including placement in a foster family home, group home or other child caring 32 institution or facility. "Substitute care" does not include care in:

(b) A family home that the court has approved as a ward's permanent placement, when a private

[(29)] (31) "Surrogate" means a person appointed by the court to protect the right of the child,
 ward, youth or youth offender to receive procedural safeguards with respect to the provision of free

41 [(30)] (32) "Tribal court" means a court with jurisdiction over child custody proceedings and 42 that is either a Court of Indian Offenses, a court established and operated under the code of custom 43 of an Indian tribe or any other administrative body of a tribe that is vested with authority over child 44 custody proceedings.

[(31)] (33) "Victim" means any person determined by the district attorney, the juvenile depart-
