

## HOUSE AMENDMENTS TO HOUSE BILL 2912

1 On page 1 of the printed bill, line 3, after “806.020,” insert “807.100.”

2 On page 21, after line 31, insert:

3 “**SECTION 43.** ORS 807.100 is amended to read:

4 “807.100. *[(1) A vehicle that may be operated only by the holder of a commercial driver license or*  
5 *permit may be operated only when proof of medical qualification, in a form approved by the Department*  
6 *of Transportation, is in the person’s immediate possession. The holder of a commercial driver license*  
7 *or permit who does not have proof of medical qualification as required by this section may exercise*  
8 *driving privileges granted by a Class C license.]*

9 “[~~(2)~~] (1) The Department **of Transportation** may not issue or renew a commercial driver li-  
10 cense or permit and may cancel a commercial driver license or permit if the person does not submit  
11 to the department, in a form approved by rule, proof of medical qualification to operate a commer-  
12 cial motor vehicle by such a date as required by rule by the department.

13 “[~~(3)~~] (2) A person is entitled to administrative review under ORS 809.440 when the department  
14 does not issue or renew a commercial driver license or permit under this section or cancels a com-  
15 mercial driver license or permit under this section.

16 “[~~(4)~~] (3) To the extent possible, rules adopted by the department under this section should be  
17 uniform with any applicable federal regulations related to commercial driver license medical quali-  
18 fications.

19 “**NOTE:** Deletes duplicative requirement that person who holds commercial driver license carry  
20 separate medical qualification card.

21 “**SECTION 44.** ORS 807.100, as amended by section 42, chapter 237, Oregon Laws 2013, is  
22 amended to read:

23 “807.100. *[(1) A vehicle that may be operated only by the holder of a commercial driver license or*  
24 *commercial learner driver permit may be operated only when proof of medical qualification, in a form*  
25 *approved by the Department of Transportation, is in the person’s immediate possession. The holder of*  
26 *a commercial driver license or commercial learner driver permit who does not have proof of medical*  
27 *qualification as required by this section may exercise driving privileges granted by a Class C license.]*

28 “[~~(2)~~] (1) The Department **of Transportation** may not issue or renew commercial driving privi-  
29 leges and may cancel commercial driving privileges if the person does not submit to the department,  
30 in a form approved by rule, proof of medical qualification to operate a commercial motor vehicle by  
31 such a date as required by rule by the department.

32 “[~~(3)~~] (2) A person is entitled to administrative review under ORS 809.440 when the department  
33 does not issue or renew commercial driving privileges under this section or cancels commercial  
34 driving privileges under this section.

35 “[~~(4)~~] (3) To the extent possible, rules adopted by the department under this section should be

1 uniform with any applicable federal regulations related to commercial driver license medical quali-  
2 fications.

5 In line 32, delete “43” and insert “45”.
