

## HOUSE AMENDMENTS TO HOUSE BILL 2930

- 1 On page 1 of the printed bill, line 2, delete “and 441.055”.
- 2 Delete lines 4 through 29 and delete pages 2 and 3 and insert:
- 3 “**SECTION 1.** ORS 441.064 is amended to read:
- 4 “441.064. (1) **As used in this section, ‘physician’ has the meaning given that term in ORS**
- 5 **677.010.**
- 6 “[*(1)*] (2) The rules of any hospital in this state may grant [*admitting*] privileges to nurse prac-
- 7 titioners licensed and certified under ORS 678.375 for purposes of patient care[, *subject to hospital*
- 8 *and medical staff bylaws, rules and regulations governing admissions and staff privileges*].
- 9 “[*(2)*] (3) Rules shall be in writing and may include, but need not be limited to:
- 10 “(a) Limitations on the scope of privileges;
- 11 “(b) Monitoring and supervision of nurse practitioners in the hospital by physicians who are
- 12 members of the medical staff;
- 13 “(c) A requirement that a nurse practitioner co-admit patients with a physician who is a member
- 14 of the medical staff; and
- 15 “(d) Qualifications of nurse practitioners to be eligible for privileges including but not limited
- 16 to requirements of prior clinical and hospital experience.
- 17 “[*(3)*] (4) The rules may also regulate [*the admissions*] **credentialing** and the conduct of nurse
- 18 practitioners while using the facilities of the hospital and may prescribe procedures whereby a nurse
- 19 practitioner’s privileges may be suspended or terminated. The hospital may refuse such privileges
- 20 to nurse practitioners only upon the same basis that privileges are refused to other medical pro-
- 21 viders.
- 22 “[*(4)* For purposes of this section, ‘physician’ has the meaning given the term in ORS 677.010.]
- 23 “(5) **Notwithstanding subsection (3) of this section, rules adopted by a hospital that grant**
- 24 **privileges to licensed registered nurses who are certified by the Oregon State Board of**
- 25 **Nursing as nurse midwife nurse practitioners must:**
- 26 “(a) **Include admitting privileges;**
- 27 “(b) **Be consistent with the privileges of the other medical staff; and**
- 28 “(c) **Permit the nurse midwife nurse practitioner to exercise the voting rights of the**
- 29 **other members of the medical staff.**
- 30 “(6) **Rules described in this section are subject to hospital and medical staff bylaws and**
- 31 **rules governing credentialing and staff privileges.”.**
