## House Bill 2949

Sponsored by Representatives EVANS, GOMBERG

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Creates subtraction from taxable income for start-up expenditures. Applies to tax years beginning on or after January 1, 2016, and before January 1, 2022. Takes effect on 91st day following adjournment sine die.

Sections 2 and 4 of this 2015 Act apply to tax years beginning on or after 23January 1, 2016, and before January 1, 2022. SECTION 6. This 2015 Act takes effect on the 91st day after the date on which the 2015 24 regular session of the Seventy-eighth Legislative Assembly adjourns sine die. 2526
