SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows establishment of wildlife food plots on small tract forestland subject to reforestation requirements without affecting small tract forestland assessment.

A BILL FOR AN ACT

2 Relating to wildlife food plots.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) As used in this section:**

5 (a) **"Forest tree species" has the meaning given that term in ORS 527.620.**

6 (b) **"Small tract forestland" has the meaning given that term in ORS 321.700.**

7 (c) **"Wildlife food plots" means a small tract forestland area that, instead of being used**
8 **for growing and harvesting a forest tree species, is planted in vegetation capable of sub-**
9 **stantially contributing to wildlife nutrition.**

10 (2) **The owner of a small tract forestland that is subject to reforestation requirements**
11 **under ORS 527.610 to 527.770 may, notwithstanding any contrary provision of the**
12 **reforestation requirements, establish wildlife food plots within the boundaries of the**
13 **forestland without affecting the small tract forestland assessment of the forestland. The**
14 **combined size of the wildlife food plots described in this subsection may not exceed:**

15 (a) **2.5 percent of the small tract forestland, if the forestland is 500 acres or less in size;**

16 (b) **2.0 percent of the small tract forestland, if the forestland is more than 500 acres but**
17 **not more than 1,000 acres in size; or**

18 (c) **1.0 percent of the small tract forestland, if the forestland is more than 1,000 acres in**
19 **size.**

20 (3)(a) **The State Board of Forestry shall adopt rules for carrying out this section. The**
21 **board shall consult with the State Department of Fish and Wildlife to identify vegetation**
22 **capable of substantially contributing to wildlife nutrition. The board rules shall require that**
23 **any forestland established as a wildlife food plot remain in use as a wildlife food plot for as**
24 **long as the forestland remains in small tract forestland assessment.**

25 (b) **The establishment of a wildlife food plot as provided by board rules is a forest practice**
26 **providing for the overall maintenance of forestland resources as described in ORS 527.710 and**
27 **supersedes any contrary reforestation requirement under ORS 527.610 to 527.770 for the**
28 **wildlife food plot.**

29 **SECTION 2. Section 1 of this 2015 Act applies to the establishment of wildlife food plots**
30 **in small tract forestland assessment years beginning on or after the effective date of this**
