Sponsored by Representative GOMBERG, Senator ROBLAN, Representative MCKEOWN (at the request of Lincoln County Board of Commissioners)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes creation of sand control districts for purpose of controlling drifting sand. Authorizes districts to raise revenue.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to a principal Act for sand control districts; creating new provisions; amending ORS
3 174.116, 198.010, 198.115, 198.210, 198.310, 198.335, 198.510 and 255.012; and declaring an emer-
4 gency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. (1) Contiguous territory that is not within the corporate boundaries of a city**
7 **may be formed into, or included in, a sand control district as provided by sections 1 to 6 of**
8 **this 2015 Act and provisions of ORS 198.705 to 198.955 that are not inconsistent with sections**
9 **1 to 6 of this 2015 Act.**

10 **(2) A sand control district may be created for the purpose of controlling or moving**
11 **drifting sand within the district or removing drifting sand from within the district. The sand**
12 **control district may:**

13 **(a) Make contracts.**

14 **(b) Acquire, hold, receive and dispose of real and personal property.**

15 **(c) Sue and be sued.**

16 **(d) Exercise the power of eminent domain.**

17 **(e) Raise revenue by levying, assessing and collecting taxes on taxable real property**
18 **within the district under ordinances adopted, amended or repealed under ORS 198.510 to**
19 **198.600.**

20 **(f) Take action necessary to carry out the purposes and perform the duties of the dis-**
21 **trict.**

22 **(3) Plans and actions of the district must comply with the requirements of county ordi-**
23 **nances.**

24 **SECTION 2. (1) The authority of a sand control district is vested in a district board**
25 **consisting of three members. Upon taking office, a board member shall take, and subscribe**
26 **to, an oath of office to support the Constitution and laws of the United States and of the**
27 **State of Oregon and to honestly and faithfully perform the duties imposed upon the member**

1 under the laws of Oregon.

2 (2) The district board:

3 (a) Shall hold at least one regular meeting in each calendar month, on a day fixed by the
4 board, and may hold special meetings as the board determines.

5 (b) Shall hold meetings at times and places within the district as the board determines.

6 (c) Shall, at the time of its organization, choose from the members a president, a secre-
7 tary and a treasurer, who hold those offices until the first regular meeting in January, or
8 until their successors are chosen and qualified.

9 (d) May call a special election at any regular meeting of the district.

10 (3) A majority of the members constitutes a quorum to conduct business and, in the ab-
11 sence of the member serving as president, another member may preside at a meeting.

12 (4) The secretary of the district shall:

13 (a) Assign position numbers one to three to the offices of board members;

14 (b) Certify the assigned position numbers to the member holding the office; and

15 (c) File a copy of the certification with the district elections officer.

16 (5) Except as provided in section 3 of this 2015 Act, the term of office of a board member
17 is four years.

18 (6) The district board shall fill a vacancy on the board as provided in ORS 198.320.

19 **SECTION 3.** (1) If a sand control district contains 100 or more electors residing within
20 its boundaries, electors of the district are qualified to serve as board members. Otherwise,
21 an individual who owns taxable real property within the district and is an elector registered
22 in this state is qualified to serve as a member.

23 (2) Within 10 days after the creation of the district or the election of the first board
24 members, whichever occurs later, the district board shall:

25 (a) Meet and organize; and

26 (b) Determine by lot the length of term of each board member.

27 (3) The term of one of the members determined under subsection (2) of this section ex-
28 pires June 30 next following the first regular district election. The term of two members
29 determined under subsection (2) of this section expires June 30 next following the second
30 regular district election.

31 **SECTION 4.** (1) A sand control district shall deposit moneys of the district in a deposi-
32 tory, as defined in ORS 295.001, designated by the district board.

33 (2) The moneys may be withdrawn or paid out pursuant to an order of the board upon a
34 check signed by the treasurer or by a person authorized to serve as custodian of district
35 funds by a resolution of the board.

36 (3) The district board shall keep on file receipts or vouchers that show the nature and
37 items covered by each check drawn.

38 (4) The district board shall:

39 (a) Cause all proceedings of the board to be entered at large in a record book.

40 (b) Preserve, and make available for inspection, public records pertaining to the authority
41 and duties of the district, as required by ORS 192.410 to 192.505.

42 **SECTION 5.** (1) Upon approval of the electors of a sand control district, the district may
43 issue general obligation bonds, as prescribed in ORS 287A.300 to 287A.380, from time to time
44 to finance purposes and duties of the district.

45 (2) The district may not issue, or have outstanding at any time, general obligation bonds

1 **in a principal amount that exceeds:**

2 (a) **Five percent of the real market value of the taxable property in the district, calcu-**
3 **lated as provided in ORS 308.207, if the district has a population of less than 100 individuals**
4 **within its boundaries; or**

5 (b) **10 percent of the real market value of the taxable property in the district, calculated**
6 **as provided in ORS 308.207, if the district has a population of 100 or more individuals within**
7 **its boundaries.**

8 (3) **Bonds issued under this section must mature within 30 years from the date of issu-**
9 **ance.**

10 **SECTION 6. (1) ORS chapter 255 governs:**

11 (a) **The nomination and election of district board members of a sand control district.**

12 (b) **The conduct of sand control district elections.**

13 (2) **The electors of the district may exercise the initiative and referendum powers for a**
14 **district measure as provided in ORS 255.135 to 255.205.**

15 **SECTION 7. ORS 198.010 is amended to read:**
