House Bill 3058

Sponsored by Representative KOMP

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits Public Employee Retirement System member who is retired to be employed by school district or education service district as teacher of career and technical education without loss of retirement benefits.

Sunsets June 30, 2018.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to pensions; and declaring an emergency.

3 Be It Enacted by the People of the State of Oregon:

4 <u>SECTION 1.</u> Section 2 of this 2015 Act is added to and made a part of ORS chapter 238.

5 <u>SECTION 2.</u> (1) The limitations on employment imposed by ORS 238.082 (2) and (3) do not

6 apply to a retired member who is employed by a school district or an education service dis-

7 trict as a teacher of career and technical education. A retired member who is employed un-

8 der this subsection by the same public employer that employed the member at the time of 9 retirement remains in the same collective bargaining unit that included the member before

10 retirement.

(2) This section applies to a person who retires under the provisions of ORS 238.280 (1),
(2) or (3) as long as the person's date of retirement is more than six months before the date
the person is employed under this section.

(3) Employment under this section does not affect the status of a person as a retired
 member of the Public Employees Retirement System and a recipient of retirement benefits
 under this chapter.

(4) Hours worked by a person employed under subsection (1) of this section shall not be
 counted for the purpose of the limitations on employment imposed by ORS 238.082 (2) and (3).

19 SECTION 3. Section 2 of this 2015 Act is repealed on June 30, 2018.

20 SECTION 4. Section 5 of this 2015 Act is added to and made a part of ORS chapter 238A. SECTION 5. (1) Notwithstanding ORS 238A.245, a retired member of the pension program 21 may be employed in a qualifying position by a school district or an education service district 22 as a teacher of career and technical education without loss of pension and without limitation 2324 on the number of hours employed. A retired member who is employed under this section by the same participating public employer that employed the member at the time of retirement 2526 remains in the same collective bargaining unit that included the member before retirement. 27(2) This section does not apply to any member who retires under the provisions of ORS

29 SECTION 6. Section 5 of this 2015 Act is repealed on June 30, 2018.
