**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Transfers certain duties, functions and powers related to enterprise information technology and telecommunications from Oregon Department of Administrative Services to State Chief Information Officer.

Provides that State Chief Information Officer is primary information technology and telecommunications advisor to Governor and specifies duties, functions and powers of officer.

Becomes operative January 1, 2016.

Declares emergency, effective on passage.

10 **Be It Enacted by the People of the State of Oregon:**

11 **SECTION 1. (1) As used in this section and sections 2 to 8 of this 2015 Act, "enterprise**  
12 **information technology and telecommunications" means:**

13 **(a) Technologies, resources, systems and services that state agencies use to generate,**  
14 **process, store and secure information for governmental purposes, including geographic in-**  
15 **formation;**

16 **(b) Technologies, resources, systems and services that state agencies use to send, re-**  
17 **ceive, process or otherwise facilitate telecommunications for governmental purposes; and**

18 **(c) Technologies, resources, systems and services that state agencies use to install,**  
19 **maintain, repair, update, replace, remove or otherwise support the technologies, resources,**  
20 **systems or services described in paragraphs (a) and (b) of this subsection.**

21 **(2)(a) Except as otherwise provided in this section, sections 2 to 8 of this 2015 Act and**  
22 **the amendments to ORS 84.064, 181.715, 181.725, 182.122, 182.124, 182.126, 182.128, 182.132,**  
23 **184.305, 184.473, 184.475, 184.477, 184.483, 184.484, 184.486, 279A.050, 279A.075, 279B.075, 283.100,**

7 munications are imposed upon, transferred to and vested in the State Chief Information  
8 Officer.

9 (b) The duties, functions and powers described in paragraph (a) of this subsection include,  
10 but are not limited to:

11 (A) The duty and function to plan and set standards for, coordinate and oversee enter-  
12 prise information technology and telecommunications among state agencies; and

13 (B) The power to specify policies, goals and directives and adopt rules related to enter-  
14 prise information technology and telecommunications among state agencies.

15 **SECTION 2.** (1) The Director of the Oregon Department of Administrative Services shall:

16 (a) Manage and organize the Oregon Department of Administrative Services to ensure  
17 that the department fulfills the duties, implements the functions and exercises the powers  
18 that remain to the department with respect to enterprise information technology and tele-  
19 communications in a manner that is consistent with the manner in which the State Chief  
20 Information Officer fulfills the duties, implements the functions and exercises the powers  
21 that are imposed upon, transferred to and vested in the State Chief Information Officer un-  
22 der section 1 of this 2015 Act;

23 (b) Deliver to the State Chief Information Officer all records and property within the  
24 jurisdiction of the director that relate to the duties, functions and powers transferred by  
25 section 1 of this 2015 Act; and

26 (c) Transfer to the State Chief Information Officer those employees engaged primarily in  
27 fulfilling the duties, implementing the functions and exercising the powers transferred by  
28 section 1 of this 2015 Act.

29 (2) The State Chief Information Officer shall take possession of the records and property  
30 and shall take charge of the employees and employ the employees in fulfilling the duties,  
31 implementing the functions and exercising the powers transferred under section 1 of this  
32 2015 Act without a reduction in the employees' compensation but subject to change or ter-  
33 mination of employment or compensation as provided by law.

34 (3) The Governor shall resolve any dispute between the State Chief Information Officer  
35 and the department that relates to transfers of records, property and employees, or the ap-  
36 portionment of duties, functions and powers under section 1 of this 2015 Act, and with re-  
37 spect to the director's management of the department in accordance with subsection (1)(a)  
38 of this section. The Governor's decision under this subsection is final.

39 **SECTION 3.** (1) The unexpended balances of amounts the Oregon Department of Admin-  
40 istrative Services is authorized to expend during the biennium beginning July 1, 2015, from  
41 revenues dedicated, continuously appropriated, appropriated or otherwise made available for  
42 the purpose of administering and enforcing the duties, functions and powers transferred by  
43 section 1 of this 2015 Act are transferred to and are available for the State Chief Information  
44 Officer to expend during the biennium beginning July 1, 2015, for the purpose of administer-  
45 ing and enforcing the duties, functions and powers transferred by section 1 of this 2015 Act.

1           (2) The expenditure classifications, if any, established by Acts that authorize or limit  
2 expenditures by the department remain applicable to expenditures that the State Chief In-  
3 formation Officer directs or oversees under this section.

4           **SECTION 4.** The transfer of duties, functions and powers to the State Chief Information  
5 Officer by section 1 of this 2015 Act does not affect any action, proceeding or prosecution  
6 involving or with respect to duties, functions and powers that began before and was pending  
7 at the time of the transfer, except that the State Chief Information Officer is substituted for  
8 the Oregon Department of Administrative Services in the action, proceeding or prosecution.

9           **SECTION 5.** (1) Sections 1 to 8 of this 2015 Act and the amendments to ORS 84.064,  
10 181.715, 181.725, 182.122, 182.124, 182.126, 182.128, 182.132, 184.305, 184.473, 184.475, 184.477,  
11 184.483, 184.484, 184.486, 279A.050, 279A.075, 279B.075, 283.100, 283.120, 283.140, 283.143, 283.505,  
12 283.510, 283.515, 283.520, 283.524, 291.016, 291.018, 291.032, 291.034, 291.038, 291.039, 291.042,  
13 291.047, 291.055, 291.990, 403.450, 403.455 and 403.460 and sections 1, 4 and 5, chapter 782,  
14 Oregon Laws 2009, section 1, chapter 77, Oregon Laws 2014, and sections 8, 9, 10, 11, 12, 13,  
15 14, 15 and 17, chapter 87, Oregon Laws 2014, by sections 9 to 60 of this 2015 Act do not relieve  
16 a person of a liability, duty or obligation accruing under or with respect to the duties, func-  
17 tions and powers transferred by section 1 of this 2015 Act. The State Chief Information Of-  
18 ficer may collect or enforce any such liability, duty or obligation.

19           (2)(a) The rights and obligations that the Oregon Department of Administrative Services  
20 legally incurred under contracts, leases and business transactions the department executed,  
21 entered into or began before the operative date of section 1 of this 2015 Act and that accrued  
22 under or with respect to the duties, functions and powers transferred by section 1 of this  
23 2015 Act remain with the department unless the Director of the Oregon Department of Ad-  
24 ministrative Services delegates or transfers the rights and obligations to the State Chief  
25 Information Officer. For the purpose of succession to rights or obligations that the director  
26 delegates or transfers to the State Chief Information Officer, the State Chief Information  
27 Officer is a continuation of the department and not a new authority.

28           (b) The rights and obligations that the State Chief Information Officer or the department  
29 legally incurs under contracts, leases or business transactions related to enterprise infor-  
30 mation technology and telecommunications after the operative date of section 1 of this 2015  
31 Act belong to the State Chief Information Officer.

32           **SECTION 6.** Notwithstanding the State Chief Information Officer's assumption of duties,  
33 functions and powers in accordance with section 1 of this 2015 Act, the rules of the Oregon  
34 Department of Administrative Services, with respect to duties, functions or powers, that are  
35 in effect on the operative date of section 1 of this 2015 Act continue in effect until the State  
36 Chief Information Officer supersedes or repeals the rules.

37           **SECTION 7.** If an uncodified law or resolution of the Legislative Assembly, or a rule,  
38 document, record or proceeding that the Legislative Assembly authorizes, refers to the  
39 Oregon Department of Administrative Services in the context of a duty, function or power  
40 the State Chief Information Officer assumes under section 1 of this 2015 Act, the reference  
41 is a reference to the State Chief Information Officer or an officer or employee of the office  
42 of the State Chief Information Officer who by sections 1 to 7 of this 2015 Act is charged with  
43 carrying out the duties, functions and powers.

44           **SECTION 8.** (1) There is established the State Information Technology Operating Fund  
45 in the State Treasury, separate and distinct from the General Fund. The moneys in the State

1 **Information Technology Operating Fund may be invested as provided in ORS 293.701 to**  
2 **293.857. Interest earnings on the fund assets must be credited to the fund.**

3 **(2) The Director of the Oregon Department of Administrative Services shall deposit into**  
4 **the State Information Technology Operating Fund moneys for enterprise information tech-**  
5 **nology and telecommunications that are appropriated to the Oregon Department of Admin-**  
6 **istrative Services and that are necessary for the State Chief Information Officer to fulfill the**  
7 **duties, implement the functions and exercise the powers imposed upon, transferred to and**  
8 **vested in the State Chief Information Officer under section 1 of this 2015 Act. Amounts in**  
9 **the fund are continuously appropriated to the State Chief Information Officer for the pur-**  
10 **poses authorized by law.**

11 **SECTION 9.** ORS 84.064 is amended to read:

12 84.064. (1) For purposes of ORS 84.049, 84.052 and 84.055, the [*Oregon Department of Adminis-*  
13 *trative Services*] **State Chief Information Officer** shall make determinations and adopt standards  
14 for state agencies.

15 (2) The [*department*] **State Chief Information Officer** shall adopt rules [*for the*] **to govern**  
16 **state agency** use of electronic signatures [*by state agencies*]. The rules [*shall*] **must** include control  
17 processes and procedures to ensure adequate integrity, security and confidentiality [*of state agency*]  
18 **for business transactions** [*conducted*] **that state agencies conduct** using electronic commerce and  
19 to ensure that [*those*] **the** transactions can be audited as [*may be*] **is** necessary for the normal con-  
20 duct of business.

21 (3) As used in this section, “state agency” means every state officer and board, commission,  
22 department, institution, branch and agency of the state government [*whose*], **the costs of which** are  
23 paid wholly or in part from funds held in the State Treasury, except:

24 (a) The Legislative Assembly, the courts, the district attorney for each county and [*their*] **the**  
25 officers and committees **of the Legislative Assembly, the courts and the district attorney;** and

26 (b) The Public Defense Services Commission.

27 **SECTION 10.** ORS 181.715 is amended to read:

28 181.715. (1) The Department of State Police or another criminal justice agency [*designated by the*  
29 *Director of the Oregon Department of Administrative Services*] **that the State Chief Information**  
30 **Officer designates** shall operate a Criminal Justice Information Standards program that coordinates  
31 information among state criminal justice agencies. The program [*shall*] **must:**

32 (a) Ensure that in developing new information systems, data can be retrieved to support [*evalu-*  
33 *ation of*] **evaluating** criminal justice planning and programs, including, but not limited to, **evaluat-**  
34 **ing** the ability of the programs to reduce future criminal conduct;

35 (b) Ensure that maximum effort is made for the safety of public safety officers;

36 (c) Establish methods and standards for data interchange and information access between crim-  
37 inal justice information systems, in compliance with [*the*] **information** technology **rules, policies**  
38 **and** standards [*and policies of the Oregon Department of Administrative Services*] **that the State**  
39 **Chief Information Officer adopts;**

40 (d) Design and implement improved applications for exchange of agency information; and

41 (e) Implement the capability to exchange images between criminal justice agencies.

42 (2) The program shall develop a plan to accelerate data sharing and information integration  
43 among criminal justice agencies. The plan [*shall*] **must** include, but is not limited to **including,**  
44 priorities, timelines, development costs, resources needed, the projected ongoing cost of support,  
45 critical success factors and any known barriers to accomplishing the plan. **The plan must align**

1 **with and support the Enterprise Information Resources Management Strategy described in**  
2 **ORS 291.039.** Representatives of criminal justice agencies and public safety agencies, including but  
3 not limited to local law enforcement agencies, courts of criminal jurisdiction, district attorneys, city  
4 attorneys with criminal prosecutive functions, public defender organizations established under ORS  
5 chapter 151, community corrections directors, jail managers and county juvenile departments, shall  
6 be invited to participate in the planning process. The program shall present the plan to the [*Director*  
7 *of the Oregon Department of Administrative Services*] **State Chief Information Officer** no later than  
8 May 30 of each even-numbered year for development of the Governor's budget report. The program  
9 shall submit the plan to the Joint Legislative Committee on Information Management and Technol-  
10 ogy no later than December 31 of each even-numbered year.

11 (3) Notwithstanding the meaning given "criminal justice agency" in ORS 181.010, as used in this  
12 section and ORS 181.720, "criminal justice agency" includes, but is not limited to:

- 13 (a) The Judicial Department;
- 14 (b) The Attorney General;
- 15 (c) The Department of Corrections;
- 16 (d) The Department of State Police;
- 17 (e) Any other state agency with law enforcement authority designated by order of the Governor;
- 18 (f) The Department of Transportation;
- 19 (g) The State Board of Parole and Post-Prison Supervision;
- 20 (h) The Department of Public Safety Standards and Training;
- 21 (i) The State Department of Fish and Wildlife;
- 22 (j) The Oregon Liquor Control Commission;
- 23 (k) The Oregon Youth Authority;
- 24 (L) The Youth Development Division; and
- 25 (m) A university that has established a police department under ORS 352.383 or 353.125.

26 **SECTION 11.** ORS 181.725 is amended to read:

27 181.725. (1) There is established a Criminal Justice Information Standards Advisory Board to  
28 advise the Department of State Police or the criminal justice agency [*designated by the Director of*  
29 *the Oregon Department of Administrative Services*] **that the State Chief Information Officer des-**  
30 **ignates** under ORS 181.715 (1) about the department's or the agency's duties under ORS 181.715.  
31 The board consists of the following members:

- 32 (a) The State Court Administrator or the administrator's designee;
- 33 (b) The Director of the Department of Corrections or the director's designee;
- 34 (c) The Superintendent of State Police or the superintendent's designee;
- 35 (d) The executive director of the Oregon Criminal Justice Commission or the executive  
36 director's designee;
- 37 (e) The Director of Transportation or the director's designee;
- 38 (f) The chairperson of the State Board of Parole and Post-Prison Supervision or the  
39 chairperson's designee;
- 40 (g) The Director of the Department of Public Safety Standards and Training or the director's

- 43 (i) A sheriff designated by the Oregon State Sheriffs' Association;
- 44 (j) A jail manager designated by the Oregon Sheriff's Jail Command Council;

1 Directors' Association;

2 (L) A community corrections agency director designated by the Oregon Association of Commu-  
3 nity Corrections Directors;

4 (m) A district attorney designated by the Oregon District Attorneys Association;

5 (n) The *[administrator of the Enterprise Information Strategy and Policy Division of the Oregon*  
6 *Department of Administrative Services or the administrator's]* **State Chief Information Officer or**  
7 **the State Chief Information Officer's** designee;

8 (o) The Director of the Oregon Youth Authority or the director's designee;

9 (p) The State Fish and Wildlife Director or the director's designee;

10 (q) The administrator of the Oregon Liquor Control Commission or the administrator's designee;  
11 and

12 (r) The Youth Development Director or the director's designee.

13 (2) The board shall meet at such times and places as the board deems necessary.

14 (3) The members of the board are not entitled to compensation but are entitled to expenses as  
15 provided in ORS 292.495.

16 **SECTION 12.** ORS 182.122 is amended to read:

17 182.122. (1) As used in this section:

18 (a) "Executive department" has the meaning given that term in ORS 174.112.

19 (b) "Information systems" means computers, hardware, software, storage media, networks, oper-  
20 ational procedures and processes used in *[the collection]* **collecting**, processing, *[storage]* **storing**,  
21 sharing or *[distribution of]* **distributing** information within, or with any access beyond ordinary  
22 public access to, the state's shared computing and network infrastructure.

23 (2) The *[Oregon Department of Administrative Services]* **State Chief Information Officer** has  
24 responsibility for and authority over information systems security in the executive department, in-  
25 cluding **responsibility for** taking all measures **that are** reasonably necessary to protect the avail-  
26 ability, integrity or confidentiality of information systems or the information stored in information  
27 systems. The *[Oregon Department of Administrative Services]* **State Chief Information Officer** shall,  
28 after consultation and collaborative development with agencies, establish a state information sys-  
29 tems security plan and associated standards, policies and procedures. **The plan must align with**  
30 **and support the Enterprise Information Resources Management Strategy described in ORS**  
31 **291.039.**

32 (3) The *[Oregon Department of Administrative Services, in its sole discretion, shall]* **State Chief**  
33 **Information Officer may coordinate with the Oregon Department of Administrative Services**  
34 **to:**

35 (a) Review and verify the security of information systems operated by or on behalf of **state**  
36 agencies;

37 (b) Monitor state network traffic to identify and react to security threats; and

38 (c) Conduct vulnerability assessments of **state** agency information systems for the purpose of  
39 evaluating and responding to the susceptibility of information systems to attack, disruption or any  
40 other event that threatens the availability, integrity or confidentiality of information systems or the  
41 information stored in information systems.

42 (4) The *[Oregon Department of Administrative Services]* **State Chief Information Officer** shall  
43 contract with qualified, independent consultants for the purpose of conducting vulnerability assess-  
44 ments under subsection (3) of this section.

45 (5) In collaboration with **appropriate** agencies, the *[Oregon Department of Administrative Ser-*

1 *vices*] **State Chief Information Officer** shall develop and implement policies for responding to  
 2 events that damage or threaten the availability, integrity or confidentiality of information systems  
 3 or the information stored in information systems, whether those systems are within, interoperable  
 4 with or outside the state's shared computing and network infrastructure. In the policies, the [*de-*  
 5 *partment*] **State Chief Information Officer** shall prescribe actions reasonably necessary to:

6 (a) Promptly assemble and deploy in a coordinated manner the expertise, tools and methodol-  
 7 ogies required to prevent or mitigate the damage caused or threatened by an event;

8 (b) Promptly alert other persons of the event and of the actions reasonably necessary to prevent  
 9 or mitigate the damage caused or threatened by the event;

10 (c) Implement forensic techniques and controls developed under subsection (6) of this section;

11 (d) Evaluate the event for the purpose of possible improvements to the security of information  
 12 systems; and

13 (e) Communicate and share information with **appropriate** agencies, using preexisting incident  
 14 response capabilities.

15 (6) After consultation and collaborative development with **appropriate** agencies[,] **and** the  
 16 Oregon Department of Administrative Services, **the State Chief Information Officer** shall imple-  
 17 ment forensic techniques and controls for the security of information systems, whether those systems  
 18 are within, interoperable with or outside the state's shared computing and network infrastructure.  
 19 The techniques and controls must include [*the use of*] **using** specialized expertise, tools and  
 20 methodologies[,] to investigate events that damage or threaten the availability, integrity or  
 21 confidentiality of information systems or the information stored in information systems. The [*de-*  
 22 *partment*] **State Chief Information Officer** shall consult with the Oregon State Police, the Office  
 23 of Emergency Management, the Governor and others as necessary in developing forensic techniques  
 24 and controls under this section.

25 (7) The [*Oregon Department of Administrative Services*] **State Chief Information Officer** shall  
 26 ensure that reasonably appropriate remedial actions are undertaken when the [*department*] **State**  
 27 **Chief Information Officer** finds that such actions are reasonably necessary by reason of vulner-  
 28 ability assessments of information systems under subsection (3) of this section, evaluation of events  
 29 under subsection (5) of this section and other evaluations and audits.

30 (8)(a) **State** agencies are responsible for [*the security of*] **securing** computers, hardware, soft-  
 31 ware, storage media, networks, operational procedures and processes used in [*the collection*] **col-**  
 32 **lecting**, processing, [*storage*] **storing**, sharing or [*distribution of*] **distributing** information outside  
 33 the state's shared computing and network infrastructure, following information security standards,  
 34 policies and procedures established by the [*Oregon Department of Administrative Services*] **State**  
 35 **Chief Information Officer** and developed collaboratively with **the** agencies. Agencies may establish  
 36 plans, standards and measures that are more stringent than the standards established by the [*de-*  
 37 *partment*] **State Chief Information Officer** to address specific agency needs if [*those*] **the** plans,  
 38 standards and measures do not contradict or contravene the state information systems security plan.  
 39 Independent agency security plans [*shall*] **must** be developed within the framework of the state in-  
 40 formation systems security plan.

41 (b) [*An*] **A state** agency shall report the results of any vulnerability assessment, evaluation or  
 42 audit conducted by the agency to the [*department*] **State Chief Information Officer** for the pur-  
 43 poses of consolidating statewide security reporting and, when appropriate, to prompt a state incident  
 44 response.

45 (9) This section does not apply to:

1 (a) Research and student computer systems used by or in conjunction with the State Board of  
2 Higher Education or any public university listed in ORS 352.002; and

3 (b)(A) Gaming systems and networks operated by the Oregon State Lottery or *[its]* contractors  
4 **of the State Lottery**; or

5 (B) The results of Oregon State Lottery reviews, evaluations and vulnerability assessments of  
6 computer systems outside the state's shared computing and network infrastructure.

7 (10) The *[Oregon Department of Administrative Services]* **State Chief Information Officer** shall  
8 adopt rules to *[carry out its responsibilities under]* **implement the provisions of** this section.

9 **SECTION 13.** ORS 182.124 is amended to read:

10 182.124. (1) Notwithstanding ORS 182.122, the Secretary of State, the State Treasurer and the  
11 Attorney General have sole discretion and authority over information systems security in their re-  
12 spective agencies, including *[taking]* **the discretion and authority to take** all measures **that are**  
13 reasonably necessary to protect the availability, integrity or confidentiality of information systems  
14 or the information stored in information systems.

15 (2) The Secretary of State, the State Treasurer and the Attorney General shall each establish  
16 an information systems security plan and associated standards, policies and procedures in collab-  
17 oration with the *[Oregon Department of Administrative Services]* **State Chief Information Officer**  
18 as provided in ORS 182.122.

19 (3) The plan established under subsection (2) of this section, at a minimum, must:

20 (a) Be compatible with the state information systems security plan and associated standards,  
21 policies and procedures established by the *[department]* **State Chief Information Officer** under  
22 ORS 182.122 (2);

23 (b) Assign responsibility for:

24 (A) Reviewing, monitoring and verifying the security of the *[agency's]* **Secretary of State's, the**  
25 **State Treasurer's and the Attorney General's** information systems; and

26 (B) Conducting vulnerability assessments of information systems for the purpose of evaluating  
27 and responding to the susceptibility of information systems to attack, disruption or any other event  
28 that threatens the availability, integrity or confidentiality of information systems or the information  
29 stored in information systems;

30 (c) Contain policies for responding to events that damage or threaten the availability, integrity  
31 or confidentiality of information systems or the information stored in information systems, whether

16 (3) To the extent practicable and subject to laws relating to confidentiality, when at no addi-  
17 tional cost, using existing data and existing resources of the state agency or education service dis-  
18 trict and without reallocation of resources, the Oregon transparency website must contain  
19 information about each state agency and education service district, including but not limited to:

20 (a) Annual revenues of state agencies and education service districts;

21 (b) Annual expenditures of state agencies and education service districts;

22 (c) Annual human resources expenses, including compensation, of state agencies and education  
23 service districts;

24 (d) Annual tax expenditures of state agencies, including, when possible, the identity of the re-  
25 cipients of each tax expenditure;

26 (e) For each state agency, a description of the percentage of expenditures made in this state and  
27 the percentage of expenditures made outside this state under all contracts for goods or services the  
28 state agency enters into during each biennium;

29 (f) A prominently placed graphic representation of the primary funding categories and approxi-  
30 mate number of individuals that the state agency or the education service district serves;

31 (g) A description of the mission, function and program categories of the state agency or educa-  
32 tion service district;

33 (h) A copy of any audit report that the Secretary of State issues for the state agency or the  
34 education service district;

35 (i) The local service plans of the education service districts;

36 (j) A copy of each report required by statute for education service districts; and

37 (k) A copy of all notices of public meetings of the education service districts.

38 (4) In addition to the information described in subsection (3) of this section:

39 (a) The State Chief Information Officer shall post on the Oregon transparency website notices

17 **opment programs. The section shall include, but not be limited to, the following information,**  
18 **if it is already collected or available within an existing database maintained by the state**  
19 **agency in the course of administering the economic development program:**

20 (A) **The names of filmmakers or companies that have received reimbursements from the**  
21 **Oregon Production Investment Fund under ORS 284.368 and the amount of each reimburse-**

23 (B) **The amount of revenue bonds issued under ORS 285A.430 for the Beginning and Ex-**  
24 **anding Farmer Loan Program, the names of persons who received loans under the program**  
25 **and the amount of the loan;**

26 (C) **The names of persons who received grants or loans from the Oregon Innovation**  
27 **Council under ORS 284.735 or 284.742 and the purpose and amount of the grant or loan;**

28 (D) **Copies of, or links to, annual reports required to be filed under ORS 285C.615 under**  
29 **the strategic investment program;**

30 (E) **Copies of, or links to, annual certifications required to be filed under ORS 285C.506**  
31 **for the business development income tax exemption; and**

32 (F) **Information required to be posted on the Oregon transparency website under ORS**  
33 **184.484.**

34 (e) **The information reported under paragraph (d) of this subsection:**

35 (A) **May not include proprietary information; and**

36 (B) **Shall be provided to the State Chief Information Officer by the state agency in the**  
37 **format and manner required by the State Chief Information Officer.**

38 (f) **The State Chief Information Officer shall post on the Oregon transparency website**  
39 **information describing the process for requesting copies of public records from a public body,**  
40 **including a link to the public records section of the Department of Justice webpage. At the**  
41 **request of a state agency or education service district, the State Chief Information Officer**  
42 **shall include a link to a location on the webpage of the agency or district that describes the**  
43 **process for requesting public records from the agency or district.**

44 (5) In operating, refining and recommending enhancements to the Oregon transparency website,

45 (d) ORS 316.116, if the allowed credit exceeds \$2,000.

1 (3) The following information, if *[it]* **the information** is already available in an existing database  
2 *[maintained by]* the **state** agency **maintains**, must be included in the report required under this  
3 section:

4 (a) The name of each taxpayer or applicant approved for the allowance of a tax expenditure or  
5 a grant award under ORS 469B.256.

6 (b) The address of each taxpayer or applicant.

7 (c) The total amount of credit against tax liability, reduction in taxable income or exemption

19 (3) A majority of the members of the commission constitutes a quorum for [*the transaction of*]

21 (4) [*Official action by the commission requires the approval of*] A majority of the members of the  
22 commission **must approve official action by the commission.**

23 (5) The commission shall elect one of [*its*] **the commission's** members to serve as  
24 chairperson[. *The chairperson shall be selected*] not later than October 1 of each odd-numbered year.

25 (6) If there is a vacancy for any cause, the appointing authority shall make an appointment [*to*  
26 *become*] **that becomes** immediately effective.

27 (7) The commission shall meet at times and places [*specified by the call of*] **that** the chairperson

29 (8) The commission may adopt rules necessary [*for the operation of*] **to operate** the commission.

30 (9) The commission shall use the services of permanent staff of the Legislative Fiscal Office to  
31 the greatest extent practicable to staff the commission. The [*Oregon Department of Administrative*  
32 *Services*] **State Chief Information Officer** may provide additional assistance.

33 (10) Notwithstanding ORS 171.072, members of the commission who are members of the Legis-  
34 lative Assembly are not entitled to mileage expenses or a per diem and serve as volunteers on the  
35 commission.

36 (11) Members of the commission who are not members of the Legislative Assembly are not en-  
37 titled to compensation or reimbursement for expenses and serve as volunteers on the commission.

38 (12) All agencies of state government, as defined in ORS 174.111, [*are directed to*] **shall** assist  
39 the commission in [*the performance of its*] **performing the commission's** duties and, to the extent  
40 permitted by laws relating to confidentiality, to furnish such information and advice as the members  
41 of the commission consider necessary to perform [*their*] **the members'** duties.

42 (13) The commission shall report to the Legislative Assembly not later than February 15 of each  
43 odd-numbered year. The report [*shall*] **must** describe:

44 (a) Enhancements made to the Oregon transparency website during the previous two calendar  
45 years;

1 (b) Possible future enhancements to the website, including but not limited to *[the inclusion of]*  
2 **including** information *[relating]* **that relates** to:

3 (A) Performance outcomes that measure the success of state agency programs in achieving  
4 goals;

5 (B) State agency bond debt;

6 (C) State agency expenses for capital improvements;

7 (D) Numbers and descriptions of jobs created through state agency contracts and subcontracts;

8 (E) Lists of businesses and individuals *[receiving]* **that receive** tax credits, deductions, refunds,  
9 rebates and other subsidies from a state agency;

10 (F) Lists of the names of contractors *[who]* **that** received a contract from a state agency, in-  
11 cluding the number of contracts and compensation **the contractors** received; and

12 (G) Lists *[by contracting state agency]* of the number of contracts **that each state agency** en-  
13 tered into during a biennium and the amount of moneys **each state agency** spent on the contracts;  
14 and

15 (c) The feasibility of including an interactive application where citizens can simulate balancing  
16 a biennial budget for the state.

17 (14) The term of office of each member is four years, but a member serves at the pleasure of the  
18 appointing authority. Before *[the expiration of the term of a member]* **a member's term expires**, the  
19 appointing authority shall appoint a successor whose term begins on January 1 next following. A  
20 member is eligible for reappointment. If there is a vacancy for any cause, the appointing authority  
21 shall make an appointment *[to become]* **that becomes** immediately effective for the unexpired term.

39 **apply to contracts under which the contractor delivers to the state agency information**  
40 **technology products or services incidentally in performing a personal services contract de-**  
41 **scribed in ORS chapter 279C or a construction contract described in ORS chapter 279C.**

42 (3) Except as otherwise provided in the Public Contracting Code, the Director of Transportation  
43 has all the authority **available** to:

44 (a) Procure or supervise the procurement of all services and personal services to construct, ac-  
45 quire, plan, design, maintain and operate passenger terminal facilities and motor vehicle parking

1 facilities in connection with any public transportation system in accordance with ORS 184.689 (5);

2 (b) Procure or supervise the procurement of all goods, services, public improvements and per-  
3 sonal services that relate to operating, maintaining or constructing highways, bridges and other  
4 transportation facilities that are subject to the authority of the Department of Transportation; and

5 (c) Establish standards for, prescribe forms for and conduct the prequalification of prospective  
6 bidders on public improvement contracts that relate to operating, maintaining or constructing  
7 highways, bridges and other transportation facilities that are subject to the authority of the De-  
8 partment of Transportation.

9 (4) Except as otherwise provided in the Public Contracting Code, the Secretary of State has all  
10 the authority to procure or supervise the procurement of goods, services and personal services re-  
11 lated to programs under the authority of the Secretary of State.

12 (5) Except as otherwise provided in the Public Contracting Code, the State Treasurer has all the  
13 authority to procure or supervise the procurement of goods, services and personal services related  
14 to programs under the authority of the State Treasurer.

15 (6) The state agencies listed in this subsection have all the authority to do the following in ac-  
16 cordance with the Public Contracting Code:

17 (a) The Department of Human Services to procure or supervise the procurement of goods, ser-  
18 vices and personal services under ORS 179.040 for the department's institutions and the procurement  
19 of goods, services and personal services for constructing, demolishing, exchanging, maintaining, op-  
20 erating and equipping housing for the purpose of providing care to individuals with intellectual  
21 disabilities or other developmental disabilities, subject to applicable provisions of ORS 427.335;

22 (b) The Oregon Health Authority to procure or supervise the procurement of goods, services and  
23 personal services under ORS 179.040 and construction materials, equipment and supplies for the  
24 authority's institutions and the procurement of goods, services, personal services, construction ma-  
25 terials, equipment and supplies for constructing, demolishing, exchanging, maintaining, operating  
26 and equipping housing for individuals with chronic mental illness, subject to applicable provisions  
27 of ORS 426.504;

28 (c) The State Department of Fish and Wildlife to procure or supervise the procurement of con-  
29 struction materials, equipment, supplies, services and personal services for public improvements,  
30 public works or ordinary construction described in ORS 279C.320 that is subject to the authority  
31 of the State Department of Fish and Wildlife;

32 (d) The State Parks and Recreation Department to procure or supervise the procurement of all  
33 goods, services, public improvements and personal services related to state parks;

34 (e) The Oregon Department of Aviation to procure or supervise the procurement of construction  
35 materials, equipment, supplies, services and personal services for public improvements, public works  
36 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Oregon  
37 Department of Aviation;

38 (f) The Oregon Business Development Department to procure or supervise the procurement of  
39 all goods, services, personal services and public improvements related to its foreign trade offices  
40 operating outside the state;

41 (g) The Housing and Community Services Department to procure or supervise the procurement  
42 of goods, services and personal services as provided in ORS 279A.025 (2)(n);

43 (h) The Department of Corrections to procure or supervise the procurement of construction  
44 materials, equipment, supplies, services and personal services for public improvements, public works  
45 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Depart-

1 ment of Corrections;

2 (i) The Department of Corrections, subject to any applicable provisions of ORS 279A.120,  
3 279A.125, 279A.145 and 283.110 to 283.395, to procure or supervise the procurement of goods, ser-  
4 vices and personal services under ORS 179.040 for its institutions;

5 (j) The Department of Veterans' Affairs to procure or supervise the procurement of real estate  
6 broker and principal real estate broker services related to programs under the department's au-  
7 thority;

8 (k) The Oregon Military Department to procure or supervise the procurement of construction  
9 materials, equipment, supplies, services and personal services for public improvements, public works  
10 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Oregon  
11 Military Department;

12 (L) The Department of Education, subject to any applicable provisions of ORS 329.075, 329.085  
13 and 329.485 and the federal No Child Left Behind Act of 2001 (P.L. 107-110, 115 Stat. 1425), to pro-  
14 cure or supervise the procurement of goods, services, personal services and information technology  
15 related to student assessment; and

16 (m) Any state agency to conduct a procurement when the agency is specifically authorized by  
17 any provision of law other than the Public Contracting Code to enter into a contract.

18 *[(7)(a) Notwithstanding this section and ORS 279A.140 (1), the Director of the Oregon Department*  
19 *of Administrative Services has exclusive authority, unless the director delegates this authority, to pro-*  
20 *curate or supervise the procurement of:]*

21 *[(A) All price agreements on behalf of the state agencies identified in subsection (6)(a) to (k) of this*  
22 *section under which more than one state agency may order goods, services or personal services; and]*

23 *[(B) All state agency information technology contracts.]*

24 *[(b) This subsection does not apply to contracts under which the contractor delivers to the state*  
25 *agency information technology products or services incidental to the performance of personal services*  
26 *contracts described in ORS chapter 279C or construction contracts described in ORS chapter 279C. ]*

27 *[(c) If the director has established a price agreement for goods, services or personal services, a state*  
28 *agency identified in subsection (3) or (6)(a) to (k) of this section may not establish a price agreement*  
29 *or enter into a contract for the goods, services or personal services without the approval of the*  
30 *director.]*

31 **(7)(a) Notwithstanding this section and ORS 279A.140 (1), the Director of the Oregon**  
32 **Department of Administrative Services has exclusive authority, unless the director delegates**  
33 **the authority, to procure or supervise the procurement of all price agreements on behalf of**  
34 **the state agencies identified in subsection (6) of this section under which more than one**  
35 **state agency may order goods, services or personal services.**

36 **(b) The director may delegate to the State Chief Information Officer the exclusive au-**  
37 **thority to procure or supervise the procurement of all price agreements related to informa-**  
38 **tion technology and telecommunications on behalf of the state agencies identified in**
