SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes governmental framework for conducting public health activities in this state and for providing public health services to residents of this state.

Provides mechanism by which local [*health departments*] **public health authorities** may implement provisions of Act separately and at different times.

Becomes operative January 1, 2016.

Declares emergency, effective on passage.

Be It Enacted by the People of the State of Oregon:

FINDINGS

SECTION 1. The Legislative Assembly of the State of Oregon finds and declares that:

(1) Each resident of this state is entitled to the basic public health services that are necessary to preserve life and health;

(2) A framework for public health services provided by the government is necessary for applying the foundational capabilities and implementing the foundational programs by which the state or a local government may assess, protect or improve the health of the residents of this state; and

(3) The purpose of sections 9 to 24 of this 2015 Act is to provide the framework described in subsection (2) of this section.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

DEFINITIONS

SECTION 2. As used in sections 9 to 24 of this 2015 Act:

(1) “Foundational capability” means the knowledge, skill or ability that is necessary to carry out a public health activity.

(2) “Foundational program” means a public health program that is necessary to assess, protect or improve the health of the residents of this state.

(3) “Governing body of a local public health authority” means:

(a) The governing body of a county;

(b) A board described in ORS 431.414 (2);

(c) A board established under ORS 431.414 (3); or

(d) The board of an intergovernmental entity created by an agreement pursuant to ORS 190.010 (5) for the purpose of providing public health services.

(4) “Local health department” means the agency established by the local public health authority that is responsible for administering public health programs and public health activities within the local public health authority’s jurisdiction.

(5) “Local health officer” means:

(a) A local public health administrator appointed under ORS 431.418; or

(b) If the local public health administrator appointed under ORS 431.418 is not a physician licensed by the Oregon Medical Board, the physician who is employed by or who enters a contract with a local public health administrator under ORS 431.418.

(6) “Local public health administrator” means an individual appointed under ORS 431.418 to supervise the public health programs and public health activities of a local health department.

(7) “Local public health authority” means:

(a) A county government;

(b) A health district formed under ORS 431.414; or

(c) An intergovernmental entity that provides public health services pursuant to an agreement entered into under ORS 190.010 (5).

DUTIES OF THE OREGON HEALTH AUTHORITY

SECTION 3. ORS 431.110 is amended to read:

431.110. *[Subject to ORS 417.300 and 417.305,]* The Oregon Health Authority shall:

(1) Have direct supervision of all matters relating to the preservation of life and health of the people of *[the]* this state.

[(2) Keep the vital statistics and other health related statistics of the state.]

(2) Ensure the statewide and local application of the foundational capabilities established under section 9 of this 2015 Act and described in sections 10, 11, 12, 13, 14, 15 and 16 of this 2015 Act.

(3) At the state level of governance, administer the foundational programs established under section 17 of this 2015 Act and described in sections 18, 19, 20 and 21 of this 2015 Act.

(4) At the local level of governance, oversee and provide support for the implementation of the foundational programs established under section 17 of this 2015 Act and described in sections 18, 19, 20 and 21 of this 2015 Act.

1 [(3)] (5) *[Make]* **Conduct** sanitary surveys **about** and investigations *[and inquiries respecting]* **on**
2 the causes and prevention of diseases, *especially of epidemics*].

3 [(4)] (6) Investigate, conduct hearings and issue findings in connection with annexations pro-
4 posed by cities as provided in ORS 222.840 to 222.915 **and 431.705 to 431.760**.

5 [(5)] (7) Have full power in the control of all communicable diseases.

6 [(6)] (8) Have **the** authority to send a representative of the authority to any part of the state
7 *[when deemed necessary]*.

8 [(7)] (9) From time to time, publish and distribute to the public *[in such form as the authority*
9 *determines, such information as in its judgment may be useful in carrying on the work or purposes for*
10 *which the authority was established]* **information related to the functions and duties of the au-**
11 **thority.**

12 **SECTION 4. (1) For the purpose of fulfilling its duties under ORS 431.110 (2), (3) and (4),**
13 **the Oregon Health Authority shall:**

14 (a) **Adopt and update as necessary a statewide public health modernization assessment;**

15 (b) **In consideration of the statewide public health modernization assessment, develop and**
16 **modify as necessary a statewide public health modernization plan;**

17 (c) **Implement the statewide public health modernization plan;**

18 (d) **Subject to the provisions of ORS 431.380, develop and modify as necessary plans for**
19 **the distribution of funds to local public health authorities;**

20 (e) **Implement plans for the distribution of funds to local public health authorities;**

21 (f) **Coordinate state and local administration of the foundational programs established**
22 **under section 17 of this 2015 Act;**

23 (g) **Approve local plans for applying the foundational capabilities established under sec-**
24 **tion 9 of this 2015 Act and implementing the foundational programs established under section**
25 **17 of this 2015 Act as required by ORS 431.385;**

26 (h) **Monitor the progress of local public health authorities in meeting statewide public**
27 **health goals, including applying the foundational capabilities established under section 9 of**
28 **this 2015 Act and implementing the foundational programs established under section 17 of**
29 **this 2015 Act;**

30 (i) **For the purpose of making distributions under ORS 431.380, consult with and consider**
31 **the recommendations of local public health authorities on the total cost to local public health**
32 **authorities of applying the foundational capabilities established under section 9 of this 2015**
33 **Act and implementing the foundational programs established under section 17 of this 2015**
34 **as identified by local public health authorities in community modernization assessments**
35 **adopted under ORS 431.416;**

36 (j) **Use incentives adopted under ORS 431.380 to encourage the effective and equitable**
37 **provision of public health services by local public health authorities;**

38 (k) **Seek funding, including in the form of federal grants, for sections 9 to 24 of this 2015**
39 **Act; and**

40 (L) **Coordinate and collaborate with federal agencies in implementing sections 9 to 24 of**
41 **this 2015 Act.**

42 (2) **The Oregon Health Authority shall solicit input from the Conference of Local Health**
43 **Officials and local public health authorities in:**

44 (a) **Establishing the foundational capabilities under section 9 of this 2015 Act and the**
45 **foundational programs under section 17 of this 2015 Act;**

1 (C) A local public health administrator who supervises public health programs and public
2 health activities in Coos, Douglas, Josephine, Klamath, Linn, Polk, Umatilla or Yamhill
3 County;

4 (D) A local public health administrator who supervises public health programs and public
5 health activities in Clatsop, Columbia, Crook, Curry, Hood River, Jefferson, Lincoln,
6 Tillamook, Union or Wasco County;

7 (E) A local public health administrator who supervises public health programs and public
8 health activities in Baker, Gilliam, Grant, Harney, Lake, Malheur, Morrow, Sherman,
9 Wallowa or Wheeler County;

10 (F) A local health officer who is not a local public health administrator;

11 (G) An individual who represents the Conference of Local Health Officials created under
12 ORS 431.330;

13 (H) An individual who represents coordinated care organizations;

14 (I) An individual who represents health care organizations that are not coordinated care
15 organizations;

16 (J) An individual who represents individuals who provide public health services directly
17 to the public;

18 (K) An expert in the field of public health who has a background in academia;

19 (L) An expert in population health metrics; and

20 (M) An at-large member.

21 (2)(a) The term of office for a board member appointed under this section is four years,
22 but a member serves at the pleasure of the Governor. Before the expiration of the term of
23 a member, the Governor shall appoint a successor whose term begins on January 1 next
24 following. A member is eligible for reappointment. If there is a vacancy for any cause, the
25 Governor shall make an appointment to become immediately effective for the unexpired
26 term.

27 (b) Members of the board described in subsection (1)(a)(B) to (E) of this section are
28 nonvoting ex officio members of the board.

29 (3) A majority of the voting members of the board constitutes a quorum for the trans-
30 action of business.

31 (4) Official action by the board requires the approval of a majority of the voting members
32 of the board.

33 (5) The board shall elect one of its voting members to serve as chairperson.

34 (6) The board shall meet at times and places specified by the call of the chairperson or
35 of a majority of the voting members of the board.

36 (7) The board may adopt rules necessary for the operation of the board.

37 (8) The board may establish committees and subcommittees necessary for the operation
38 of the board.

39 (9) Voting members of the board are entitled to compensation and expenses as provided
40 in ORS 292.495.

41 **SECTION 6.** The term of membership for a person who is a member of the Oregon Public
42 Health Advisory Board immediately before the operative date specified in section 114 of this
43 2015 Act expires on the operative date specified in section 114 of this 2015 Act. A member
44 whose term expires under this section is eligible for reappointment. Of the members first
45 appointed to the board on or after the operative date specified in section 114 of this 2015 Act:

1 (1) Four shall serve for terms ending January 1, 2017.

2 (2) Three shall serve for terms ending January 1, 2018.

3 (3) Three shall serve for terms ending January 1, 2019.

4 (4) Three shall serve for terms ending January 1, 2020.

5 **SECTION 7.** The Oregon Public Health Advisory Board shall:

6 (1) Make recommendations to the Oregon Health Policy Board on the development of
7 statewide public health policies and goals;

8 (2) Make recommendations to the Oregon Health Policy Board on how other statewide
9 priorities, such as the provision of early learning services and the delivery of health care
10 services, affect and are affected by statewide public health policies and goals;

11 (3) Make recommendations to the Oregon Health Policy Board on the establishment of
12 the foundational capabilities under section 9 of this 2015 Act, the foundational programs un-
13 der section 17 of this 2015 Act and any other public health program or activity under section
14 22 of this 2015 Act;

15 (4) Make recommendations to the Oregon Health Policy Board on the adoption and up-
16 dating of the statewide public health modernization assessment under section 4 of this 2015
17 Act;

18 (5) Make recommendations to the Oregon Health Policy Board on the development of and
19 any modification to the statewide public health modernization plan developed under section
20 4 of this 2015 Act;

21 (6) Make recommendations to the Oregon Health Authority and the Oregon Health Policy
22 Board on:

23 (a) The development of and any modification to plans developed under section 4 of this
24 2015 Act for the distribution of funds to local public health authorities; and

25 (b) The total cost to local public health authorities of applying the foundational capabili-
26 ties established under section 9 of this 2015 Act and implementing the foundational programs
27 established under section 17 of this 2015 Act;

28 (7) Make recommendations to the Oregon Health Policy Board on the use of incentives
29 by the Oregon Health Authority under ORS 431.380 to encourage the effective and equitable
30 provision of public health services by local public health authorities;

31 (8) Provide support to local public health authorities in developing local plans to apply the
32 foundational capabilities established under section 9 of this 2015 Act and implement the
33 foundational programs established under section 17 of this 2015 Act as required by ORS
34 431.385;

35 (9) Monitor the progress of local public health authorities in meeting statewide public
36 health goals, including employing the foundational capabilities established under section 9 of
37 this 2015 Act and implementing the foundational programs established under section 17 of
38 this 2015 Act;

39 (10) Assist the Oregon Health Authority in seeking funding, including in the form of
40 federal grants, for sections 9 to 24 of this 2015 Act; and

41 (11) Assist the Oregon Health Authority in coordinating and collaborating with federal
42 agencies.

1 **(2) For purposes of this section, the Oregon Health Authority may adopt rules differen-**
2 **tiating between the knowledge, skills and abilities that are necessary for state governance**
3 **and that are necessary for local governance.**

4 **SECTION 11. (1) For the purpose of establishing the foundational capabilities under sec-**
5 **tion 9 of this 2015 Act, emergency preparedness and response include, but are not limited to,**
6 **the knowledge, skills and abilities necessary to:**

7 **(a) Develop, exercise, improve and maintain preparedness and response plans in the event**
8 **that either a natural or man-made disaster or an emergency occurs;**

9 **(b) Communicate and coordinate with health care providers, emergency service providers**
10 **and other agencies and organizations that respond to disasters and emergencies;**

11 **(c) Activate emergency response personnel during a disaster or emergency, and recognize**
12 **if public health has a primary, secondary or ancillary role in response activities;**

13 **(d) Use communications systems effectively and efficiently during a disaster or emer-**
14 **gency;**

15 **(e) Maintain and execute a plan providing for continuity of operations during a disaster**
16 **or emergency, including a plan for accessing resources necessary to recover from or respond**
17 **to a disaster or emergency;**

18 **(f) Issue and enforce emergency health orders;**

19 **(g) Be notified of and respond to potential disasters and emergencies; and**

20 **(h) Address the needs of vulnerable populations during a disaster or emergency.**

21 **(2) For purposes of this section, the Oregon Health Authority may adopt rules differen-**
22 **tiating between the knowledge, skills and abilities that are necessary for state governance**
23 **and that are necessary for local governance.**

24 **SECTION 12. (1) For the purpose of establishing the foundational capabilities under sec-**
25 **tion 9 of this 2015 Act, communications include, but are not limited to, the knowledge, skills**
26 **and abilities necessary to:**

27 **(a) Engage in two-way communications with the public through the use of a variety of**
28 **accessible methods of communication;**

29 **(b) Effectively use mass media and social media to transmit communications to and re-**
30 **ceive communications from the public;**

31 **(c) Communicate with specific populations in a manner that is culturally and linguis-**
32 **tically appropriate;**

33 **(d) Develop and implement educational programs and preventive strategies; and**

34 **(e) During a disease outbreak or other disaster or emergency, provide accurate, timely**
35 **and understandable information, recommendations and instructions to the public.**

36 **(2) For purposes of this section, the Oregon Health Authority may adopt rules differen-**
37 **tiating between the knowledge, skills and abilities that are necessary for state governance**
38 **and that are necessary for local governance.**

39 **SECTION 13. (1) For the purpose of establishing the foundational capabilities under sec-**
40 **tion 9 of this 2015 Act, policy and planning include, but are not limited to, the knowledge,**
41 **skills and abilities necessary to:**

42 **(a) Enable the Oregon Health Authority and local public health authorities to serve as a**
43 **primary and expert resource for using science and evidence-based best practices to inform**
44 **the development and implementation of public health policies;**

45 **(b) Provide guidance and coordinate planning for the purpose of developing, adopting and**

1 **implementing public health policies;**

2 **(c) Develop public health policy options necessary to protect and improve the health of**
3 **the public and specific adversely impacted populations;**

4 **(d) Understand and use the principles of public health law to improve and protect the**
5 **health of the public;**

6 **(e) Analyze and disseminate findings on the intended and unintended impacts of public**
7 **health policies; and**

8 **(f) Implement, monitor, evaluate and modify state health improvement plans or commu-**
9 **nity health improvement plans.**

10 **(2) For purposes of this section, the Oregon Health Authority may adopt rules differen-**
11 **tiating between the knowledge, skills and abilities that are necessary for state governance**
12 **and that are necessary for local governance.**

13 **SECTION 14. (1) For the purpose of establishing the foundational capabilities under sec-**
14 **tion 9 of this 2015 Act, leadership and organizational competencies include, but are not lim-**
15 **ited to, the knowledge, skills and abilities necessary to:**

16 **(a) Define the strategic direction necessary to achieve public health goals and align and**
17 **lead stakeholders in achieving those goals;**

18 **(b) Use the principles of public health law, including relevant agency rules and the con-**
19 **stitutional guarantee of due process, in planning, implementing and enforcing public health**
20 **initiatives;**

21 **(c) Promote and monitor organizational objectives while sustaining a culture of quality**
22 **of service;**

23 **(d) Maintain a competent workforce necessary to ensure the effective and equitable pro-**
24 **vision of public health services;**

25 **(e) Provide continuing education and other training opportunities necessary to maintain**
26 **a competent workforce;**

27 **(f) Develop partnerships with institutions of higher education necessary to maintain a**
28 **competent workforce;**

29 **(g) To the extent practicable, ensure that local public health administrators, local health**
30 **officers and individuals who work in the field of public health reflect the demographics of the**
31 **community being served and the changing demographics of this state;**

32 **(h) Implement and maintain the technology needed to support public health operations**
33 **while simultaneously protecting personally identifiable information and other confidential**
34 **health information; and**

35 **(i) Use accounting and business best practices in budgeting, tracking finances, billing,**
36 **auditing, securing grants and other sources of funding and distributing moneys to govern-**
37 **mental and nongovernmental partners.**

38 **(2) For purposes of this section, the Oregon Health Authority may adopt rules differen-**
39 **tiating between the knowledge, skills and abilities that are necessary for state governance**
40 **and that are necessary for local governance.**

41 **SECTION 15. (1) For the purpose of establishing the foundational capabilities under sec-**
42 **tion 9 of this 2015 Act, health equity and cultural responsiveness include, but are not limited**
43 **to, the knowledge, skills and abilities necessary to:**

44 **(a) Support public health policies that promote health equity;**

45 **(b) Implement processes within public health programs that create health equity;**

1 (c) Recognize and address health inequities that are specific to certain populations, in-
2 cluding populations specific to sex, race, ethnicity and socioeconomic status;

3 (d) Communicate with the public and stakeholders in a transparent and inclusive manner;

4 (e) When appropriate, provide the public and stakeholders with access to the data and
5 findings described in section 10 of this 2015 Act; and

6 (f) Engage diverse populations in community health planning.

7 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-
8 tiating between the knowledge, skills and abilities that are necessary for state governance
9 and that are necessary for local governance.

10 **SECTION 16.** (1) For the purpose of establishing the foundational capabilities under sec-
11 tion 9 of this 2015 Act, community partnership development includes, but is not limited to,
12 the knowledge, skills and abilities necessary to:

13 (a) Convene and sustain relationships with traditional and nontraditional governmental
14 partners and stakeholders and traditional and nontraditional nongovernmental partners and
15 stakeholders;

16 (b) Foster and support community involvement and partnerships in developing, adopting
17 and implementing public health policies;

18 (c) Engage members of the community in implementing, monitoring, evaluating and
19 modifying state health improvement plans or community health improvement plans; and

20 (d) Develop, strengthen and expand connections across disciplines, such as education and
21 health care, and with members of the community who work in those disciplines.

22 (2) For purposes of this section, the Oregon Health Authority may adopt rules differen-
23 tiating between the knowledge, skills and abilities that are necessary for state governance
24 and that are necessary for local governance.

25 **SECTION 17.** (1) The Oregon Health Authority, in consideration of any advice provided
26 by the Oregon Health Policy Board under section 8 of this 2015 Act, shall establish by rule
27 the foundational programs through which the authority and local public health authorities
28 administer public health services in this state.

29 (2) At a minimum, the authority shall establish the following foundational programs:

30 (a) Communicable disease control programs, as described in section 18 of this 2015 Act;

31 (b) Environmental public health programs, as described in section 19 of this 2015 Act;

32 (c) Prevention of injury and disease and promotion of health programs, as described in
33 section 20 of this 2015 Act; and

34 (d) Clinical preventive services, as described in section 21 of this 2015 Act.

35 **SECTION 18.** Communicable disease control programs established under section 9 of this
36 2015 Act must identify, prevent and control infectious diseases that pose a threat to the
37 health of the public and must include, but are not limited to:

38 (1) Recognizing, identifying and responding to communicable disease outbreaks;

39 (2) Maintaining a list of communicable diseases;

40 (3) Conducting, receiving and analyzing laboratory results and physician reports related
41 to communicable diseases;

42 (4) Providing the support necessary for individuals to recognize communicable diseases
43 and other illnesses of public health importance; and

44 (5) Conducting community-based programs for the purpose of preventing communicable
45 diseases.

1 **SECTION 19.** Environmental public health programs established under section 9 of this
2 2015 Act must protect the public from illness, injury, disability and death caused by exposure
3 to physical, chemical or biological factors in the environment and must include, but are not
4 limited to:

5 (1) Testing and analysis for purposes related to environmental health;

6 (2) Preventing and investigating environmental health hazards, including radioactive
7 materials, animal bites and vector-borne diseases;

8 (3) Inspecting and educating the operators of:

9 (a) Restaurants and other food service establishments;

10 (b) Recreation sites, lodges and swimming pools;

11 (c) Septic systems;

12 (d) Potable water systems;

13 (e) Radiological equipment; and

14 (f) Hospitals and other health care facilities; and

15 (4) Promoting land use planning and sustainable development activities that create posi-
16 tive health outcomes.

17 **SECTION 20.** (1) Prevention of injury and disease and promotion of health programs es-
18 tablished under section 9 of this 2015 Act must include, but are not limited to:

19 (a) Prevention and control of tobacco use;

20 (b) Improving nutrition;

21 (c) Improving oral health;

22 (d) Improving prenatal, natal and postnatal care, maternal health and the health of
23 children;

24 (e) Incentivizing increased physical activity; and

25 (f) Decreasing the occurrence and impacts of both unintentional and intentional injuries,
26 such as motor vehicle accidents and suicide.

27 (2) Prevention of injury and disease and promotion of health programs must be based on
28 evidence-based or emerging best practices designed to improve health outcomes for all pop-
29 ulations.

30 **SECTION 21.** Clinical preventive services established under section 9 of this 2015 Act
31 must provide for the assessment of public access to:

32 (1) Immunizations;

33 (2) Prenatal care;

34 (3) Screening for preventable cancers and other diseases;

35 (4) Screening for sexually transmitted infections;

36 (5) Evaluation of and treatment for tuberculosis and related latent tuberculosis in-
37 fections;

38 (6) Cost-effective preventive care; and

39 (7) Laboratory services.

40 **SECTION 22.** In addition to the foundational programs established under section 17 of
41 this 2015 Act, the Oregon Health Authority may establish by rule other public health pro-
42 grams, or by rule or order other public health activities, that address specific public health
43 problems or needs. Programs and activities may be established under this section for the
44 purpose of enhancing or expanding a foundational program or for the purpose of addressing
45 a need not addressed by a foundational program. Additional programs and activities may be

1 established under this section in consideration of any advice provided by the Oregon Public
2 Health Advisory Board or upon the authority's own initiative.

3 **SECTION 23.** The Oregon Health Authority may adopt by rule evidence-based best prac-
4 tices for the purpose of assisting local public health authorities implement the foundational
5 programs established under section 17 of this 2015 Act and any other public health program
6 or activity established under section 22 of this 2015 Act. Rules adopted under this section are
7 only for the purpose of assisting local public health authorities and are not mandatory
8 guidelines for the implementation of the programs or activities.

12 **SECTION 24.** The Oregon Health Authority may adopt rules to implement sections 9 to
13 24 of this 2015 Act.

15 **DUTIES OF LOCAL PUBLIC HEALTH AUTHORITIES**

16
17 **SECTION 25.** ORS 431.416 is amended to read:

18 431.416. *[The local public health authority or health district shall:]*

19 *[(1) Administer and enforce the rules of the local public health authority or the health district and*
20 *public health laws and rules of the Oregon Health Authority.]*

21 *[(2) Assure activities necessary for the preservation of health or prevention of disease in the area*

10 treatment, or is brought under ORS 30.260 to 30.300 and involves the Department of Corrections or
11 an institution operated by the department, nothing in this section prohibits the disclosure of any
12 written account referred to in subsection (2) of this section to the Department of Justice, Oregon
13 Department of Administrative Services, or their agents, upon request, or the subsequent disclosure
14 to a court, administrative hearings officer, arbitrator or other administrative decision maker.

15 (8)(a) When an action, suit, claim, arbitration or proceeding involves the Oregon Health Au-
16 thority or an institution operated by the authority, nothing in this section prohibits the disclosure

 16 duction of marijuana or any other criminal offense in which possession, delivery or production of
 17 marijuana is an element if the following conditions have been satisfied:

18 (a)(A) The person holds a registry identification card issued pursuant to this section, has applied
 19 for a registry identification card pursuant to subsection (9) of this section, is the designated primary
 20 caregiver of the cardholder or applicant, or is the person responsible for a marijuana grow site that
 21 is producing marijuana for the cardholder and is registered under ORS 475.304; and

22 (B) The person who has a debilitating medical condition, the person's primary caregiver and the
 23 person responsible for a marijuana grow site that is producing marijuana for the cardholder and is
 24 registered under ORS 475.304 are collectively in possession of, delivering or producing marijuana for
 25 medical use in amounts allowed under ORS 475.320; or

26 (b) The person is responsible for or employed by a medical marijuana facility registered under
 27 ORS 475.314 and does not commit any of the acts described in this subsection anywhere other than
 28 at the medical marijuana facility.

29 (2) The Oregon Health Authority shall establish and maintain a program for the issuance of
 30 registry identification cards to persons who meet the requirements of this section. Except as pro-
 31 vided in subsection (3) of this section, the authority shall issue a registry identification card to any
 32 person who pays a fee in the amount established by the authority and provides the following:

33 (a) Valid, written documentation from the person's attending physician stating that the person
 34 has been diagnosed with a debilitating medical condition and that the medical use of marijuana may
 35 mitigate the symptoms or effects of the person's debilitating medical condition;

37 (c) The name, address and telephone number of the person's attending physician;

43 (3) The authority shall issue a registry identification card to a person who is under 18 years of
 44 age if the person submits the materials required under subsection (2) of this section, and the custo-
 45 dial parent or legal guardian with responsibility for health care decisions for the person under 18

1 years of age signs a written statement that:

2 (a) The attending physician of the person under 18 years of age has explained to that person
3 and to the custodial parent or legal guardian with responsibility for health care decisions for the
4 person under 18 years of age the possible risks and benefits of the medical use of marijuana;

5 (b) The custodial parent or legal guardian with responsibility for health care decisions for the
6 person under 18 years of age consents to the use of marijuana by the person under 18 years of age
7 for medical purposes;

8 (c) The custodial parent or legal guardian with responsibility for health care decisions for the
9 person under 18 years of age agrees to serve as the designated primary caregiver for the person
10 under 18 years of age; and

11 (d) The custodial parent or legal guardian with responsibility for health care decisions for the
12 person under 18 years of age agrees to control the acquisition of marijuana and the dosage and
13 frequency of use by the person under 18 years of age.

14 (4) A person applying for a registry identification card pursuant to this section may submit the
15 information required in this section to a [county] **local** health department for transmittal to the au-
16 thority. A [county] **local** health department that receives the information pursuant to this subsection
17 shall transmit the information to the authority within five days of receipt of the information. Infor-
18 mation received by a [county] **local** health department pursuant to this subsection shall be confi-
19 dential and not subject to disclosure, except as required to transmit the information to the authority.

20 (5)(a) The authority shall verify the information contained in an application submitted pursuant
21 to this section and shall approve or deny an application within thirty days of receipt of the appli-
22 cation.

23 (b) In addition to the authority granted to the authority under ORS 475.316 to deny an applica-
24 tion, the authority may deny an application for the following reasons:

25 (A) The applicant did not provide the information required pursuant to this section to establish
26 the applicant's debilitating medical condition and to document the applicant's consultation with an
27 attending physician regarding the medical use of marijuana in connection with such condition, as
28 provided in subsections (2) and (3) of this section;

29 (B) The authority determines that the information provided was falsified; or

30 (C) The applicant has been prohibited by a court order from obtaining a registry identification
31 card.

32 (c) Denial of a registry identification card shall be considered a final authority action, subject
33 to judicial review. Only the person whose application has been denied, or, in the case of a person
34 under the age of 18 years of age whose application has been denied, the person's parent or legal
35 guardian, shall have standing to contest the authority's action.

36 (d) Any person whose application has been denied may not reapply for six months from the date
37 of the denial, unless so authorized by the authority or a court of competent jurisdiction.

38 (6)(a) If the authority has verified the information submitted pursuant to subsections (2) and (3)
39 of this section and none of the reasons for denial listed in subsection (5)(b) of this section is appli-
40 cable, the authority shall issue a serially numbered registry identification card within five days of
41 verification of the information. The registry identification card shall state:

42 (A) The cardholder's name, address and date of birth;

3 (b) When the person to whom the authority has issued a registry identification card pursuant
4 to this section has specified a designated primary caregiver, the authority shall issue an identifica-
5 tion card to the designated primary caregiver. The primary caregiver's registry identification card
6 shall contain the information provided in paragraph (a) of this subsection.

7 (7)(a) A person who possesses a registry identification card shall:

8 (A) Notify the authority of any change in the person's name, address, attending physician or
9 designated primary caregiver.

10 (B) If applicable, notify the designated primary caregiver of the cardholder, the person respon-
11 sible for the marijuana grow site that produces marijuana for the cardholder and any person re-
12 sponsible for a medical marijuana facility that transfers usable marijuana or immature marijuana
13 plants to the cardholder under ORS 475.314 of any change in status including, but not limited to:

14 (i) The assignment of another individual as the designated primary caregiver of the cardholder;

15 (ii) The assignment of another individual as the person responsible for a marijuana grow site
16 producing marijuana for the cardholder; or

17 (iii) The end of the eligibility of the cardholder to hold a valid registry identification card.

18 (C) Annually submit to the authority:

19 (i) Updated written documentation from the cardholder's attending physician of the person's
20 debilitating medical condition and that the medical use of marijuana may mitigate the symptoms or
21 effects of the person's debilitating medical condition; and

22 (ii) The name of the person's designated primary caregiver if a primary caregiver has been
23 designated for the upcoming year.

24 (b) If a person who possesses a registry identification card fails to comply with this subsection,
25 the card shall be deemed expired. If a registry identification card expires, the identification card of
26 any designated primary caregiver of the cardholder shall also expire.

27 (8)(a) A person who possesses a registry identification card pursuant to this section and who
28 has been diagnosed by the person's attending physician as no longer having a debilitating medical
29 condition or whose attending physician has determined that the medical use of marijuana is
30 contraindicated for the person's debilitating medical condition shall return the registry identification
31 card and any other associated Oregon Medical Marijuana Program cards to the authority within 30
32 calendar days of notification of the diagnosis or notification of the contraindication.

33 (b) If, due to circumstances beyond the control of the registry identification cardholder, a
34 cardholder is unable to obtain a second medical opinion about the cardholder's continuing eligibility
35 to use medical marijuana before the 30-day period specified in paragraph (a) of this subsection has
36 expired, the authority may grant the cardholder additional time to obtain a second opinion before
37 requiring the cardholder to return the registry identification card and any associated cards.

38 (9) A person who has applied for a registry identification card pursuant to this section but
39 whose application has not yet been approved or denied, and who is contacted by any law enforce-
40 ment officer in connection with the person's administration, possession, delivery or production of
41 marijuana for medical use may provide to the law enforcement officer a copy of the written doc-
42 umentation submitted to the authority pursuant to subsection (2) or (3) of this section and proof of
43 the date of mailing or other transmission of the documentation to the authority. This documentation
44 shall have the same legal effect as a registry identification card until such time as the person re-

1 (10)(a) A registry identification cardholder has the primary responsibility of notifying the des-

5 any change in status of the cardholder.

21 (13) The authority and employees and agents of the authority acting within the course and scope
22 of their employment are immune from any civil liability that might be incurred or imposed for the
