

# House Bill 3132

Sponsored by Representatives SMITH WARNER, HELM

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Expands definition of "hospital facility" to include behavioral treatment facilities and family safety facilities in regard to local public authorities created to finance hospital facilities.

## A BILL FOR AN ACT

2 Relating to public authority created to finance health-related facilities; amending ORS 441.525.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 441.525 is amended to read:

5 441.525. As used in ORS 441.525 to 441.595, unless the context requires otherwise:

6 (1) "Adult congregate living facility" means any institution, building or buildings, residential  
7 facility for elderly [*persons and persons*] **individuals or individuals** with disabilities, or other place,  
8 operated as a nonprofit corporation [*which*] **that** undertakes through its ownership or management  
9 to provide housing, meals and the availability of other supportive services.

10 (2) "Authority" means any public authority organized or existing pursuant to ORS 441.525 to  
11 441.595.

12 (3) **"Behavioral treatment facility" means any institution, building or buildings or resi-**  
13 **dential facility operated as a nonprofit corporation that provides services, which may include**  
14 **residential services to individuals for a period of 72 hours to 12 months, to individuals**  
15 **struggling with addiction or another mental health issue.**

16 (4) **"Family safety facility" means an institution, building or buildings or residential fa-**  
17 **cility operated as a nonprofit corporation that provides services, which may include resi-**  
18 **dential services to individuals for a period of 72 hours to 12 months, to individuals seeking**  
19 **relief from domestic violence issues.**

20 [(3)] (5) "Governing body" means the county court, board of county commissioners, council or  
21 other legislative body of any municipality.

22 [(4)] (6) "Hospital facility" means any structure, system, machinery, equipment or other real or  
23 personal property useful for or incidental to inpatient or outpatient care or administration, service  
24 or support for such care or any combination thereof [*which*] **that** is provided by a political subdivi-  
25 sion of this state or any private nonprofit corporation, [*which is operating or proposes to operate*  
26 *an adult congregate living facility, or a health care facility as defined by ORS 442.015.*] **including:**

27 (a) **An adult congregate living facility;**

28 (b) **A behavioral treatment facility;**

29 (c) **A family safety facility; or**

30 (d) **A health care facility, as defined in ORS 442.015.**

31 [(5)] (7) "Municipality" means any health district, [*city or county and further means any munic-*
