

House Bill 3139

Sponsored by Representative HAYDEN

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Task Force on Mobile Medical Clinics. Specifies membership and duties.
Sunsets task force on December 31, 2016.
Declares emergency, effective on passage.

A BILL FOR AN ACT

1
2 Relating to mobile medical clinics; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Task Force on Mobile Medical Clinics is established, consisting of six**
5 **members appointed as follows:**

6 (a) **The President of the Senate shall appoint three members from among members of the**
7 **Senate.**

8 (b) **The Speaker of the House of Representatives shall appoint three members from**
9 **among members of the House of Representatives.**

10 (2) **The task force shall study how to facilitate the use of mobile medical clinics in med-**
11 **ically underserved communities in this state and make recommendations for legislative**
12 **changes.**

13 (3) **A majority of the members of the task force constitutes a quorum for the transaction**
14 **of business.**

15 (4) **Official action by the task force requires the approval of a majority of the members**
16 **of the task force.**

17 (5) **The task force shall elect one of its members from the Senate and one of its members**
18 **from the House of Representatives to serve as cochairpersons.**

19 (6) **If there is a vacancy for any cause, the appointing authority shall make an appoint-**
20 **ment to become immediately effective.**

21 (7) **The task force shall meet at times and places specified by the call of the**
22 **cochairpersons or of a majority of the members of the task force.**

23 (8) **The task force may adopt rules necessary for the operation of the task force.**

24 (9) **The task force may pre-session file legislation in the manner provided in ORS 171.130**
25 **for interim committees. All legislation recommended by official action of the task force must**
26 **indicate that it is introduced at the request of the task force.**

27 (10) **The task force shall report to the Legislative Assembly in the manner provided in**
28 **ORS 192.245 no later than September 15, 2016.**

29 (11) **The Legislative Administrator may employ persons necessary for the performance**
30 **of the functions of the task force. The Legislative Administrator shall fix the duties and**
31 **amounts of compensation of these employees. The task force shall use the services of con-**

1 **tinuing legislative staff, without employing additional persons, to the greatest extent practi-**
2 **cable.**

3 **(12) All agencies of state government, as defined in ORS 174.111, are directed to assist**
4 **the task force in the performance of its duties and, to the extent permitted by laws relating**
5 **to confidentiality, to furnish such information and advice as the members of the task force**
6 **consider necessary to perform their duties.**

7 **SECTION 2. Section 1 of this 2015 Act is repealed on December 31, 2016.**

8 **SECTION 3. This 2015 Act being necessary for the immediate preservation of the public**
9 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
10 **on its passage.**
