

# House Bill 3141

Sponsored by COMMITTEE ON BUSINESS AND LABOR

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Expands retail pet store law to include establishment providing or offering to provide dog by lease or rental.

## A BILL FOR AN ACT

2 Relating to retail pet stores; amending ORS 646A.075.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 646A.075 is amended to read:

5 646A.075. (1) As used in this section:

6 (a) "Dog" means a member of the subspecies *Canis lupus familiaris* or a hybrid of that subspe-  
7 cies.

8 (b) "Litter" means one or more dogs, sold individually or together, that are all or part of a group  
9 of dogs born to the same mother at the same time.

10 (c) "Retail pet store" means a retail establishment open to the public that:

11 (A) Sells or offers to sell dogs[.]; **or**

12 (B) **Provides or offers to provide dogs on a lease or rental basis.**

13 (d) "Retail pet store" does not mean a person that sells [*or offers to sell*], **provides by lease or**  
14 **rental, offers to sell or offers to provide by lease or rental** only dogs:

15 (A) That were bred or raised by the person; or

16 (B) That are kept primarily for the purpose of reproduction.

17 (2) A retail pet store that offers a dog for sale, **lease or rental** shall, prior to accepting an offer  
18 to purchase, **lease or rent** the dog, provide the person making the offer with the following infor-  
19 mation, in writing, regarding the dog:

20 (a) If known, the breed, age and date of birth for the dog.

21 (b) The sex and color of the dog.

22 (c) A list, and accompanying proof, of all inoculations that have been given to the dog by any  
23 person, and the date of those inoculations.

24 (d) A list of all medical treatment provided to the dog by any person, the date or treatment and  
25 the reasons for the treatment.

26 (e) The name and business address of the breeder and of the facility where the dog was born.

27 (f) If the breeder holds a license issued by the United States Department of Agriculture, the  
28 breeder's federal identification number.

29 (g) The retail price [*of*], **lease rate or rental rate for** the dog.

30 (h) Any congenital disorder or hereditary diseases in the parents of the dog known to the pet  
31 dealer.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (i) If the dog is being provided by lease or rental, a statement that the person obtaining  
2 possession is not the owner of the dog.

3 (j) If the dog is being provided by lease or rental, a statement that the retail pet store  
4 retains ultimate authority to determine the level and source of veterinary care for the dog.

5 [(i)] (k) If the dog is being sold with the representation that the dog qualifies for registration  
6 with a pedigree organization:

7 (A) The name and registration numbers of the parents of the dog; and

8 (B) The name and address of the pedigree organization with which the parents of the dog are  
9 registered.

10 [(j)] (L) If the dog has previously been sold by the retail pet store and returned by the pur-  
11 chaser, the reason for the return.

12 [(k)] (m) A statement in substantially the following form, with the applicable provision number  
13 circled:

16 The facility in which this dog was born has produced:

- 17 1. 0 to 2 litters during the one-year period preceding the day this dog was born.
- 18 2. 3 to 10 litters during the one-year period preceding the day this dog was born.
- 19 3. 11 to 39 litters during the one-year period preceding the day this dog was born.
- 20 4. 40 or more litters during the one-year period preceding the day this dog was born.
