SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Permits any person convicted of [offense] aggravated murder or felony with relevant DNA evidence to file motion for DNA testing.

Changes requirements for prima facie showing and standard for court to order DNA testing. Removes mandatory sentence enhancement as basis for filing motion. Requires state to an-swer motion. Authorizes court to allow witness testimony. Prohibits testimony of victim without victim's consent. Requires court to [state reasons on record for denial of motion] make findings when issuing order for DNA testing. Provides that person filing motion for DNA testing is entitled to counsel at all stages of pro-

ceedings concerning DNA testing.

5	SECTION 1. ORS 138.690 is amended to read:
6	138.690. A person may file in the circuit court in which the judgment of conviction was entered
7	a motion requesting the performance of DNA (deoxyribonucleic acid) testing on specific evidence if

sulted in the conviction of the person; and 3

(C) Include the results of any previous DNA test of the evidence if a previous DNA test was 4 conducted by either the prosecution or the defense. 5

(b) Consistent with the statement of innocence described in subparagraph (a)(A) of this 6 subsection, the person must present a prima facie showing that DNA testing of the [specified] evi-7 dence would, assuming exculpatory results, [establish the actual innocence of the person of:] 8

[(A) The offense for which the person was convicted; or] [(B) Conduct, if the exoneration of the person of the conduct would result in a mandatory reduction 10

in the person's sentence] lead to a finding that the person is actually innocent of the offense for 11 12 which the person was convicted.

13 (2) The state shall answer the motion requesting the performance of DNA testing and may refute the basis for the motion. 14

15 (3) Upon the motion of a party or the court's own motion, the court may allow the testimony of witnesses if the testimony will assist the court in making its determination to 16 grant or deny the motion requesting the performance of DNA testing. The court may not 17 allow testimony from the victim of the offense without the consent of the victim. 18

[(2)] (4) The court shall order the DNA testing requested in a motion under subsection (1) of this 19 section if the court finds that: 20

(a) The requirements of subsection (1) of this section have been met; 21

22(b) Unless the parties stipulate otherwise, the evidence to be tested [is in the possession of a city, county, state or the court and] has been subject to a chain of custody sufficient to establish that the 23evidence has not been altered in any material aspect; 24

(c) The motion is made [in a timely manner and] for the purpose of demonstrating the innocence 25of the person of the offense or of the conduct and not to delay the execution of the sentence or 2627administration of justice; and

(d) There is a reasonable possibility, assuming exculpatory results, that the testing [will 28produce exculpatory evidence that would establish the innocence of the person of:] 29

[(A) The offense for which the person was convicted; or]

31 [(B) Conduct, if the exoneration of the person of the conduct would result in a mandatory reduction in the person's sentence] would lead to a finding that the person is actually innocent of the of-32fense for which the person was convicted. 33

34 [(3)] (5) In granting a motion under this section, the court may impose reasonable conditions 35designed to protect the interests of the state in the integrity of the evidence and the testing process. [(4)] (6) Unless both parties agree or the court finds compelling circumstances otherwise, the 36

37 court shall order the Department of State Police to conduct the DNA testing. The court may order a second test upon a showing that the state police failed to follow appropriate DNA protocols and 38 that failure reasonably affected the accuracy of the DNA test. 39

[(5)] (7) The costs of DNA tests ordered under this section must be paid by:

(a) The person making the motion for DNA testing if the person is not incarcerated or, if the 41 person is incarcerated, if the person is financially able to pay; or 42

(b) The state if counsel at state expense has been appointed under ORS 138.694. 43

[(6)] (8) The [results of a DNA test ordered under this section must be disclosed] laboratory 44 conducting the DNA test shall provide a copy of the results of the test to the person filing the 45

1 motion and to the state.

[(7)] (9) Notwithstanding the fact that an appeal of the conviction or a petition for postconviction relief in the underlying case is pending at the time a motion is filed under ORS 138.690, the circuit court shall consider the motion. If the court grants the motion, the court shall notify the court considering the appeal or post-conviction petition of that fact. When a court receives notice under this subsection, the court shall stay the appeal or post-conviction proceedings pending the outcome of the motion filed under ORS 138.690 and any further proceedings resulting from the motion.

11 138.694. (1) A person described in ORS 138.690 is entitled to counsel during all stages of
 12 the proceedings described in ORS 138.692, 138.696 and 138.697.

[(1)] (2) A person described in ORS 138.690 [(1)] may file a petition in the circuit court in which the judgment of conviction was entered requesting the appointment of counsel at state expense to assist the person in determining whether to file a motion under ORS 138.690. The petition must be accompanied by:

17 (a) A completed affidavit of eligibility for appointment of counsel at state expense; and

18 (b) An affidavit stating that:

19 (A) The person meets the criteria in ORS 138.690 [(1)];

SECTION 3. ORS 138.694 is amended to read:

(B) The person is innocent of the charge for which the person was convicted [or of the conduct

(a) The court shall forward the results to the State Board of Parole and Post-Prison Supervision;and

45 (b) The Department of State Police shall compare the evidence to DNA evidence from unsolved

1 crimes in the Combined DNA Index System.

2 (2) If DNA testing ordered under ORS 138.692 produces exculpatory evidence, the person who 3 requested the testing may file in the court that ordered the testing a motion for a new trial based 4 on newly discovered evidence. Notwithstanding the time limit established in ORCP 64 F, a person 5 may file a motion under this subsection at any time during the 60-day period that begins on the date 6 the person receives the test results.

(3) Upon receipt of a motion filed under subsection (2) of this section and notwithstanding the
time limits in ORCP 64 F, the court shall hear the motion pursuant to ORCP 64.

138.697. (1) A person described in ORS 138.690 may appeal to the Court of Appeals from a circuit
court's final order or judgment denying or limiting DNA (deoxyribonucleic acid) testing under ORS
138.692, denying appointment of counsel under ORS 138.694 or denying a motion for a new trial
under ORS 138.696.

(2) The state may appeal to the Court of Appeals from a circuit court's final order or judgment
 granting a motion for DNA testing under ORS 138.692 or granting a motion for a new trial under
 ORS 138.696.

(3) The time limits described in ORS 138.071, the notice requirements described in ORS 138.081
and 138.090 and the provisions of ORS 138.225, 138.227, 138.240, 138.250[,] and 138.255 [and 138.261]
apply to appeals under this section unless the context requires otherwise.

(4) A circuit court shall appoint counsel to represent a person described in ORS 138.690 on appeal in the same manner as for criminal defendants under ORS 138.500.
