House Bill 3216

Sponsored by COMMITTEE ON RURAL COMMUNITIES, LAND USE, AND WATER

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Establishes farm vehicle operator permit. Prescribes fees.

Expands use of slow-moving vehicle emblems to include farm vehicles operated by persons who hold farm vehicle operator permit.

Creates offense of violation of farm vehicle operator permit restrictions. Punishes by maximum fine of \$500.

A BILL FOR AN ACT

- 2 Relating to farm vehicle operator permit; creating new provisions; and amending ORS 801.250, 807.370 and 815.110.
- 4 Be It Enacted by the People of the State of Oregon:
 - SECTION 1. Sections 2 and 3 of this 2015 Act are added to and made a part of the Oregon Vehicle Code.
 - **SECTION 2.** (1) As used in this section:
 - (a) "Family member" means any individual who is related to a person by blood, marriage, adoption or domestic partnership as defined in ORS 106.310.
 - (b) "Farm vehicle" means a vehicle registered as a farm vehicle under ORS 805.300.
 - (2) A farm vehicle operator permit authorizes a person who otherwise does not have driving privileges to operate a farm vehicle in the scope of the person's employment or while the person is working on a farm owned by a family member. Except as otherwise provided in this section, a farm vehicle operator permit is subject to the provisions, conditions, prohibitions and penalties applicable to a Class C license.
 - (3) The Department of Transportation shall issue a farm vehicle operator permit to a person to operate farm vehicles if:
 - (a) The person is 12 years of age or older;
 - (b) The person is an employee or a family member of a farmer;
 - (c) The department determines that the person has sufficient experience in the operation of motor vehicles to operate the type of farm vehicle authorized by the permit without endangering the safety of the public; and
 - (d) The person does not possess driving privileges under the laws of this state or another jurisdiction.
 - (4) The department may require an applicant for a farm vehicle operator permit to demonstrate that the applicant is qualified to safely exercise the driving privileges granted under a farm vehicle operator permit.
 - (5) A person who holds a farm vehicle operator permit issued under this section may operate a farm vehicle only at a speed of 35 miles per hour or less on highways:
 - (a) Within 10 miles of a farm where the person is employed or on highways within 10

miles of a farm owned by a family member; and

- (b) With a speed limit not greater than 50 miles per hour or in an area with a speed designation not greater than 50 miles per hour.
- (6) The department shall place restrictions on a farm vehicle operator permit that designate the types of farm vehicles the holder of the permit is authorized to operate.
- (7) The department may establish an application form for the permit that differs from the form required for a driver license.
- (8) The fees required for issuance or renewal of a farm vehicle operator permit are the farm vehicle operator permit fees under ORS 807.370.
- (9) The department shall cancel a farm vehicle operator permit if the department determines that the holder of the permit has:
 - (a) Operated a farm vehicle in violation of this section; or
- (b) Operated a type of farm vehicle not designated under the permit as described in subsection (6) of this section.
- (10)(a) If the department cancels a farm vehicle operator permit, the person issued the permit is ineligible to be issued another farm vehicle operator permit for a period of 90 days.
- (b) If the department cancels a farm vehicle operator permit within 90 days after the department reissued a permit, the person issued the permit is ineligible to be issued another farm vehicle operator permit for a period of one year.
- SECTION 3. (1) A person commits the offense of violation of farm vehicle operator permit restrictions if the person:
 - (a) Operates a farm vehicle in violation of section 2 of this 2015 Act; or
- (b) Operates a type of farm vehicle not designated under the permit as described in section 2 (6) of this 2015 Act.
- (2) The offense described in this section, violation of farm vehicle operator permit restrictions, is a Class D traffic violation.
 - SECTION 4. ORS 815.110 is amended to read:
- 815.110. This section establishes requirements for ORS 815.115. The requirements under this section are in addition to any other requirements for lighting equipment provided by law. Except as specifically provided by an exemption under ORS 815.120, a person violates ORS 815.115 if the person does not comply with any of the following requirements:
- (1) The following types of vehicles must display slow-moving vehicle emblems described under ORS 815.060:
- (a) Vehicles or combinations of vehicles designed for customary use at speeds of less than 25 miles per hour.
 - (b) Golf carts or similar vehicles when operated by a person with a disability.
- (c) Class I, Class II and Class IV all-terrain vehicles operated on a highway under ORS 821.191 (1).
- (d) Vehicles registered as farm vehicles under ORS 805.300 that are operated on a highway by a person who holds a farm vehicle operator permit issued under section 2 of this 2015 Act.
 - (2) Slow-moving vehicle emblems must meet the requirements for such emblems established by the Department of Transportation by rule under ORS 815.060.
 - (3) Slow-moving vehicle emblems shall be displayed on the rear of the power unit. When a combination of vehicles is being operated in a manner that obscures the emblem mounted on the

- power unit, an additional emblem shall be displayed on the rear of the rearmost vehicle in the combination.
