## A-Engrossed House Bill 3301

## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires insurer to permit naturopathic physician to [determine whether naturopathic physician is] apply to be primary care provider or specialty care provider for purposes of insurer credentials. [Adds primary care to definition of "naturopathic medicine."] Permits naturopathic physician to represent that naturopathic physician is medical specialist or practices medical specialty.

- 5 SECTION 1. Section 2 of this 2015 Act is added to and made a part of the Insurance Code.

- care incident thereto of superficial lacerations and abrasions, benign superficial lesions[,] and the removal of foreign bodies located in the superficial structures; and the use of antiseptics and local anesthetics in connection therewith.
- (4) "Naturopathic medicine" means the discipline that includes physiotherapy, natural healing processes and minor surgery and has as its objective the maintaining of the body in, or of restoring it to, a state of normal health.
- (5) "Naturopathic physician" means a person who holds a degree of Doctor of Naturopathic Medicine and is licensed under this chapter.
