

House Bill 3357

Sponsored by Representative LIVELY; Representative SPRENGER

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires hospital that does not offer family medicine residency program to make payment to Area Health Education Center program in order to defray costs of family medicine residency network created by Area Health Education Center program.

A BILL FOR AN ACT

2 Relating to family medicine residency programs; creating new provisions; amending ORS 353.455.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 353.455 is amended to read:

5 353.455. (1) The Area Health Education Center program created in ORS 353.450 is encouraged
6 to create a family medicine residency network that:

7 (a) Facilitates an increase in the number of family medicine residency positions in this state in
8 order to train more highly qualified family physicians who are likely to practice in this state.

9 (b) Supports and assists hospital systems in this state to work collaboratively with existing
10 family medicine residency programs to develop new family medicine residency programs throughout
11 this state.

12 (c) Helps family medicine residency programs in this state share resources through the creation
13 of standardized curriculum, a common faculty development center, initiation of physician training
14 in quality improvement, medical home development, chronic disease management, interprofessional
15 team-based care and population care management, facilitation of primary care research projects
16 through joint regulatory monitoring and other support and provision of grant writing resources for
17 outside funding.

18 **(2) Any hospital licensed in this state that does not offer a family medicine residency**
19 **program shall pay to the Area Health Education Center program \$250,000 for each year that**
20 **the hospital does not offer such a program.**

21 [(2)] **(3) The Area Health Education Center program may accept gifts, grants or contributions**
22 **from any public or private source for the purpose of carrying out this section.**

23 **(4) Moneys received under subsections (2) and (3) of this section are continuously ap-**
24 **propriated to the Higher Education Coordinating Commission for distribution to the Oregon**
25 **Health and Science University for the purpose of creating and maintaining a family medicine**
26 **residency network in accordance with this section.**

27 **SECTION 2. The Area Health Education Center program created in ORS 353.450 and the**
28 **Oregon Health and Science University shall consult with the College of Osteopathic Medicine**
29 **of the Pacific-Northwest of the Western University of Health Sciences in creating and**
30 **maintaining a family medicine residency network under ORS 353.455.**

31 **SECTION 3. Section 2 of this 2015 Act is repealed January 2, 2017.**
