## **A-Engrossed** House Bill 3406

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Requires law enforcement agency that employs police officer involved in use of deadly force, or officer who is victim of violence, to provide officer with paid leave, mental health support resources and other care after incident.]

[Requires felony charge against involved officer to be first heard in preliminary hearing rather than grand jury proceeding.] Expands primary purposes of Oregon Center for Policing Excellence to include assisting with recruiting and community outreach.

Declares emergency, effective on passage.

in ORS 174.116, are directed to cooperate with the center in achieving the purposes described in
subsection (2) of this section.

9 (5) The Director of the Department of Public Safety Standards and Training may adopt rules 10 necessary to implement the provisions of this section.

11 <u>SECTION 2.</u> This 2015 Act being necessary for the immediate preservation of the public 12 peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect 13 on its passage.
