House Bill 3432

Sponsored by Representative CLEM

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Prohibits vision-only insurance policy from providing coverage for only those services provided by specified network of vision care providers.

A BILL FOR AN ACT

- (2) An insurer offering a policy of vision-only insurance in this state may not require a beneficiary of the policy to use any specified network of vision care providers in order to receive benefits under the policy.
