

House Bill 3543

Sponsored by Representative KENNEMER (at the request of Boring Community Planning Organization)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits electors of areas within urban growth boundary, urban reserve, rural reserve or metropolitan service district to petition county board for withdrawal.

A BILL FOR AN ACT

2 Relating to metropolitan service districts.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS chapter 268.**

5 **SECTION 2. (1)(a) The electors of an area within an urban growth boundary established**
6 **by rule or by metropolitan service district action plan may petition the county board pursu-**
7 **ant to ORS 198.755 and 198.760 to withdraw from the urban growth boundary.**

8 **(b) The county board shall:**

9 **(A) Direct an agent of the county board to verify the signatures on the petition;**

10 **(B) Conduct a hearing for the petition as filed; and**

11 **(C)(i) Approve the petition; or**

12 **(ii) Adjust the urban growth boundary.**

13 **(c) The county board may deny the petition if the area described in the petition is subject**
14 **to the jurisdiction of a city.**

15 **(d) The county board shall adopt an ordinance reflecting the county board's determi-**
16 **nation and, if the county board does not deny the petition and if appropriate, submit the**
17 **ordinance to the metropolitan service district to remove the area from the urban growth**
18 **boundary.**

19 **(2)(a) The electors of an area within an urban reserve or rural reserve established by rule**
20 **or by metropolitan service district action plan may petition the county board pursuant to**
21 **ORS 198.755 and 198.760 to withdraw from the urban reserve or rural reserve.**

22 **(b) The county board shall:**

23 **(A) Direct an agent of the county board to verify the signatures on the petition;**

24 **(B) Conduct a hearing for the petition as filed; and**

25 **(C)(i) Approve the petition;**

26 **(ii) Adjust the urban reserve or rural reserve boundaries; or**

27 **(iii) Deny the petition.**

28 **(c) The county board shall adopt an ordinance reflecting the county board's determi-**
29 **nation and, if the county board does not deny the petition and if appropriate, submit the**
30 **ordinance to the metropolitan service district to remove the area from the urban reserve**
31 **or rural reserve boundaries.**

1 **(3)(a) The electors of an area within a metropolitan service district may petition the**
2 **county board pursuant to ORS 198.755 and 198.760 to withdraw from the metropolitan service**
3 **district.**

4 **(b) The county board shall:**

5 **(A) Direct the agent of the county board to verify the signatures on the petition;**

6 **(B) Conduct a hearing for the petition as filed; and**

7 **(C)(i) Approve the petition; or**

8 **(ii) Adjust the metropolitan service district boundaries.**

9 **(c) The county board may deny the petition if the area described in the petition is subject**
10 **to the jurisdiction of a city.**

11 **(d) The county board shall adopt an ordinance reflecting the county board's determi-**
12 **nation and, if the county board does not deny the petition, submit the ordinance to the**
13 **metropolitan service district to remove the area from the district boundaries.**
