

# House Bill 5025

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Approves certain new or increased fees adopted by Higher Education Coordinating Commission.  
Declares emergency, effective July 1, 2015.

### A BILL FOR AN ACT

Relating to the financial administration of the Higher Education Coordinating Commission; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** For purposes of carrying out the provisions of ORS 291.055 (1)(e), the following fees for application by an Oregon post-secondary institution to operate under an interstate agreement regarding the provision of post-secondary distance education, adopted by the Higher Education Coordinating Commission and approved by the Oregon Department of Administrative Services, are approved:

- (1) Less than 2,500 student FTE .... \$ 7,000
- (2) 2,500 to 9,999 student FTE..... \$ 5,000
- (3) 10,000 or more student FTE .... \$ 3,000

**SECTION 2.** For purposes of carrying out the provisions of ORS 291.055 (1)(e), the following fees adopted by the Higher Education Coordinating Commission and approved by the Oregon Department of Administrative Services, are approved:

- (1) Search of closed private career school student transcript:
  - (a) Up to four copies ..... \$ 12
  - (b) Additional copies..... \$ 2
- (2) Private career school teacher registration, all teachers:
  - (a) Initial three-year registration ..... \$ 75
  - (b) Three-year renewals ..... \$ 75
- (3) Private career school teacher trainee, application..... \$ 7
- (4) Eligibility review, cosmetology teachers, out-of-state application..... \$ 25
- (5) Private career school
