SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Department of State Lands for certain purposes.

Limits certain biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2015.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other law limiting expenditures, the following amounts**
6 **are established for the biennium beginning July 1, 2015, as the maximum limits for payment**
7 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
8 **cluding lottery funds and federal funds, collected or received by the Department of State**
9 **Lands, for the following purposes:**

10 (1) **Common School Fund**
11 **programs..... \$ 31,291,047**

12 (2) **Oregon Removal-Fill**
13 **Mitigation Fund \$ 1,821,439**

14 (3) **South Slough National**
15 **Estuarine Research**
16 **Reserve operations..... \$ 1,962,130**

17 (4) **Capital improvements \$ 1,026,250**

18 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
19 **are established for the biennium beginning July 1, 2015, as the maximum limits for payment**
20 **of expenses from federal funds collected or received by the Department of State Lands, for**
21 **the following purposes:**

22 (1) **Common School Fund**
23 **programs..... \$ 16,829**

24 (2) **South Slough National**
25 **Estuarine Research**

1 **Reserve operations..... \$ 1,617,600**

2 **SECTION 3. For the biennium beginning July 1, 2015, expenditures by the Department**
3 **of State Lands for tenant-incurred utility charges, unclaimed property finders fees and State**
4 **Treasurer charges for investment-related transactions are not limited.**

5 **SECTION 4. This 2015 Act being necessary for the immediate preservation of the public**
6 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
7 **July 1, 2015.**
