SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Appropriates moneys from General Fund to Water Resources Department for biennial expenses. Limits biennial expenditures by department from certain lottery moneys.

Limits biennial expenditures for certain purposes from fees, moneys or other revenues, including Miscellaneous Receipts and specified federal funds, but excluding lottery funds and other federal funds, collected or received by department.

Limits biennial expenditures by department from other federal funds. Declares emergency, effective July 1, 2015.

A BILL FOR AN ACT

Relating to the financial administration of the Water Resources Department; and declaring an 2 3 emergency.

Be It Enacted by the People of the State of Oregon: 4

SECTION 1. There is appropriated to the Water Resources Department, for the biennium 5 6 beginning July 1, 2015, out of the General Fund, the amount of \$29,821,168 for water resources programs. 7

SECTION 2. Notwithstanding any other law limiting expenditures, the amount of 8 9 \$2,511,482 is established for the biennium beginning July 1, 2015, as the maximum limit for 10 payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the Water Resources Department for debt service. 11

12SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2015, as the maximum limits for payment 13 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and in-14 cluding federal funds received under cooperative agreements with or contracts from the 15 Bureau of Reclamation of the United States Department of the Interior, the United States 16 Army Corps of Engineers, the United States Geological Survey, the Bonneville Power Ad-17ministration and the National Fish and Wildlife Foundation, but excluding lottery funds and 18 federal funds not described in this section, collected or received by the Water Resources 19 Department, for the following purposes: 20
