SUMMARY

 $Honors \ Ron \ Post \ for \ establishing \ Medical \ Teams \ International \ and \ improving \ lives \ of \ Oregonians \ and \ millions \ of \ others \ worldwide.$

CONCURRENT RESOLUTION

2	Whereas Ron Post founded Northwest Medical Teams in Oregon; and
3	Whereas Ron Post learned of the humanitarian disaster in Cambodia in 1979, and in just one
4	month organized Northwest Medical Teams and arrived in Thailand with 28 medical volunteers; and
5	Whereas Northwest Medical Teams served thousands of starving and sick people during the
6	1980s Ethiopian famine; and
7	Whereas Northwest Medical Teams was the first American medical team to arrive in Mexico
8	City after the earthquake there in 1985; and
9	Whereas Northwest Medical Teams was the first American medical team to arrive in what was
10	then Soviet Armenia after the earthquake there in 1988; and
11	Whereas Northwest Medical Teams, now known as Medical Teams International, continues to
12	provide medical relief to this day; and
13	Whereas Medical Teams International is a humanitarian relief and development organization
14	committed to helping people affected by disaster, conflict and poverty around the world; and
15	Whereas Medical Teams International has been honored for its rapid response to the 2014 Ebola
16	outbreak in West Africa; and
17	Whereas Medical Teams International has deployed more than 1,900 volunteer teams and
18	shipped over \$1 billion in antibiotics, surgical kits and lifesaving medicines to care for 34 million
19	people in 100 countries; and
20	Whereas Medical Teams International routinely provides dental care to thousands of people in
21	the Pacific Northwest; and
22	Whereas the international headquarters for Medical Teams International is located in Tigard
23	Oregon, with offices in four other states and nine other countries; and
24	Whereas former Oregon Senator and Governor Mark O. Hatfield wrote that "Ron Post exem
25	plifies the very heart of a caring and loving God"; and
26	Whereas Ron Post had no medical background but established one of the world's most esteemed
27	medical disaster response teams; and
28	Whereas Ron Post was honored with the Jefferson Award for Public Service, the country's
29	long-standing and most prestigious celebration of public service; and
30	Whereas all of this occurred because Ron Post saw a need, had an idea, made it happen and
