Whereas Shirley Kalkhoven served as chairperson of the Tillamook County Futures Council, the Northwest Oregon Area Commission on Transportation, the League of Oregon Cities Water and Wastewater Policy Committee, the Tillamook County Emergency Warning Task Force and the Beaverton School District School Board, and served as cochairperson of the Tillamook County Transient Lodging Tax Advisory Committee; and

Whereas Shirley Kalkhoven served as Director of the Oregon Coastal Zone Management Association for 19 years and as President of the Women's Club of Manzanita, President of the Beaverton School District Parent Teacher Association, Treasurer of the North County Food Bank and Treasurer and Fiscal Agent of the Lower Nehalem Watershed Council; and

Whereas Shirley Kalkhoven was a member of the League of Oregon Cities Transportation Committee, board member of the Columbia-Pacific Economic Development District, member of the Department of Transportation Stakeholder Advisory Committee, member of the Department of Transportation Freight Advisory Committee, member of the Final Review Committee for ConnectOregon II, III, IV and V, member of the Northwest Oregon Economic Alliance for 16 years and member of the Tillamook County Budget Committee for 11 years; and

Whereas Shirley Kalkhoven passed away on March 16, 2015, and will be greatly missed; now, therefore,
