# Senate Bill 1

Sponsored by Senator MONNES ANDERSON, Representative GREENLICK (at the request of Joint Interim Committee on Health Insurance Transition)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Abolishes Oregon Health Insurance Exchange Corporation and board of directors of corporation and transfers functions and duties to Department of Consumer and Business Services. Creates Health Insurance Exchange Advisory Committee and specifies duties. Declares emergency, effective on passage.

(1) The Oregon Health Insurance Exchange Corporation board of directors 14 is abolished. On the effective date of this 2015 Act, the tenure of office of the members of 15 the board ceases. 16 (2) All the duties, functions and powers of the board are imposed upon, transferred to 17 and vested in the Director of the Department of Consumer and Business Services. 18 SECTION 2. (1) The Oregon Health Insurance Exchange Corporation is abolished. On the 19 20 operative date of this section, the tenure of the executive director of the Oregon Health In-21 surance Exchange Corporation ceases. 22(2) All the duties, functions and powers of the corporation are imposed upon, transferred to and vested in the Department of Consumer and Business Services. 2324 (3) Employees of the corporation are not public employees for purposes of ORS 236.605 to 236.640. 2526 27 **RECORDS AND PROPERTY** 28 SECTION 3. The executive director of the Oregon Health Insurance Exchange Corpo-29 ration shall deliver to the Department of Consumer and Business Services all records and 30

property within the jurisdiction of the executive director that relate to the duties, functions and powers transferred by section 2 of this 2015 Act. The Director of the Department of Consumer and Business Services shall take possession of the records and property.

#### UNEXPENDED REVENUES

SECTION 4. The moneys in the accounts established under ORS 741.101 and the unex-7 pended balances of amounts authorized to be expended by the Oregon Health Insurance Ex-8 9 change Corporation for the biennium beginning July 1, 2013, from revenues dedicated, continuously appropriated, appropriated or otherwise made available for the purpose of ad-10 ministering and enforcing the duties, functions and powers transferred by section 2 of this 11 122015 Act are transferred to the Health Insurance Exchange Fund established in section 14 of this 2015 Act and are available for expenditure by the Department of Consumer and 13 Business Services for the biennium beginning July 1, 2013, for the purpose of administering 14 15 and enforcing the duties, functions and powers transferred by section 2 of this 2015 Act.

# LIABILITY, DUTY, OBLIGATION

(5) The committee shall provide annual reports to the Legislative Assembly, in the man-38 ner provided in ORS 192.245, of the findings and recommendations the committee considers 39 appropriate, including a report on the: 40 (a) Adequacy of assessments for reserve programs and administrative costs; 41 (b) Implementation of the Small Business Health Options Program; 42 (c) Number of qualified health plans offered through the exchange; 43 (d) Number and demographics of individuals enrolled in qualified health plans; 44 (e) Advance premium tax credits provided to enrollees in qualified health plans; and 45

(6) The members of the committee shall be appointed for a term of two years and shall
serve without compensation, but shall be entitled to travel expenses in accordance with ORS
292.495. The committee may hire, subject to the approval of the Director of the Department
of Consumer and Business Services, such experts as the committee may require to discharge
its duties. All expenses of the committee shall be paid out of the Health Insurance Exchange
Fund established in section 14 of this 2015 Act.

9 <u>SECTION 14.</u> The Health Insurance Exchange Fund is established in the State Treasury, 10 separate and distinct from the General Fund. Interest earned by the Health Insurance Ex-11 change Fund shall be credited to the fund. The charge must be in an amount sufficient to 8 9 cover the costs of grants to navigators, in-person assisters and application counselors certified under ORS 741.002 and to pay the administrative and operational expenses of the [corporation] de-10 partment in carrying out ORS 741.001 to 741.540. in state programs offered through the exchange. The charge may not exceed:

(a) Five percent of the premium or other monthly charge for each enrollee if the number ofenrollees receiving coverage through the exchange is at or below 175,000;

(b) Four percent of the premium or other monthly charge for each enrollee if the number of enrollees receiving coverage through the exchange is above 175,000 and at or below 300,000; and

(c) Three percent of the premium or other monthly charge for each enrollee if the number ofenrollees receiving coverage through the exchange is above 300,000.

(3)(a) If charges collected under subsection (1) of this section exceed the amounts needed for the administrative and operational expenses of the [corporation] department in administering the health insurance exchange, the excess moneys collected may be held and [invested and, with the earnings and interest,] used by the [corporation] department to offset future net losses [or reduce the administrative costs of the corporation].

30 [(A) Limited to investments described in ORS 294.035;]
