SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Revises procedures for preparation of Governor's budget.

Be It Enacted by the People of the State of Oregon:

BUDGET PROCESS

SECTION 1. ORS 173.025 is amended to read:

173.025. (1) The Legislative Fiscal Officer, with the aid of the [*Oregon Department of Administrative Services,*] Legislative Revenue Officer, state agencies and affected local governmental units, including school districts, shall prepare a fiscal impact statement on each measure reported out of a committee of the Legislative Assembly that could have an effect on expenditures of **the state or on** local governmental units, including school districts.

(2) The Legislative Revenue Officer, with aid of the Legislative Fiscal Officer, the Department of Revenue, state agencies and affected local governmental units, including school districts, shall prepare a revenue impact statement on each measure reported out of a committee of the Legislative Assembly that could have any effect on revenues of **the state or on** local governmental units, including school districts.

(3)(a) As used in this subsection, "tax expenditure" has the meaning given that term in ORS

2 (b) If a revenue impact statement is prepared pursuant to subsection (2) of this section on a
3 measure that creates a tax expenditure, the revenue impact statement must include the revenue
4 impact of the measure for at least three consecutive biennia, beginning with the current biennium.

5 (c) If a revenue impact statement is prepared pursuant to subsection (2) of this section on a
6 measure that creates or extends a tax expenditure, the revenue impact statement must include a
7 statement describing the public policy purpose of the tax expenditure. The public policy purpose
8 statement is subject to review by the committee recommending passage of the measure.

9 **SECTION 2.** ORS 173.029 is amended to read:

10 173.029. (1) For any measure reported out of a committee of the Legislative Assembly, the effect
11 of which is to create a new crime, increase the period of incarceration allowed or required for an
12 existing crime or otherwise modify sentencing or state corrections policies, the Legislative Fiscal
13 Officer, with the aid of the [*Oregon Department of Administrative Services,*] Legislative Revenue Of-
14 ficer, state agencies and affected local governmental units, shall prepare a fiscal impact statement
15 describing the fiscal impact that the measure would, if enacted, have on the state as well as on local
16 governmental units.

17 (2) In particular and to the extent practicable, the Legislative Fiscal Officer shall determine and
18 describe in the statement the following:

19 (a) The fiscal impact on state and local law enforcement agencies, including an estimate of the
20 increase in anticipated number of arrests annually;

21 (b) The fiscal impact on state and local courts, including an estimate of the increase in the an-
22 ticipated number of cases annually;

23 (c) The fiscal impact on district attorney offices, including an estimate of the increase in the
24 anticipated number of prosecutions annually;

25 (d) The fiscal impact on public defense resources, including an estimate of the increase in the
26 anticipated number of cases annually; and

27 (e) The fiscal impact on state and local corrections resources, including resources supporting
28 parole and probation supervision, and also including an estimate of the increase in the anticipated
29 number of bed-days to be used annually at both the state and local level as a result of the passage
30 of the measure.

31 (3) The fiscal impact statement required under this section must describe the fiscal impact that
32 the measure would, if enacted, have on the state as well as on local governmental units for 10 years,
33 beginning on the effective date of the measure.

34 (4) A state agency that prepares and submits to the Legislative Fiscal Officer fiscal impact
35 statements or related fiscal information applicable to a measure introduced before the Legislative
36 Assembly, the effect of which is to create a new crime, increase the period of incarceration allowed
37 or required for an existing crime or otherwise modify sentencing or state corrections policies, shall
38 describe the fiscal impact that the measure would have on the state agency for 10 years, beginning
39 on the effective date of the measure.

40 **SECTION 3.** ORS 173.035 is amended to read:

41 173.035. The Legislative Fiscal Officer and Legislative Revenue Officer shall submit the state-
42 ment prepared under ORS 173.025 or 173.029 to the Legislative Assembly at a time set by the rules
43 of the house where the measure was introduced. [*The Speaker of the House of Representatives and*
44 *the President of the Senate shall refer the statement to*] The committee to which the measure was
45 referred[. *The committee*] shall review the statement prepared under ORS 173.025 or 173.029 prior to

1 reporting the measure out.

2 **SECTION 4.** ORS 176.110 is amended to read:

3 176.110. (1) The person elected to the office of Governor may take any action prior to the date
4 the official term of office commences that is necessary to enable the Governor to exercise on such
5 date the powers and duties of the office of Governor.

6 (2) The Governor-elect shall cause the **Governor's** budget [*report*] and the tax expenditure re-
7 port for the biennium beginning July 1 of the year in which the Governor takes office to be compiled
8 and prepared for printing as required in ORS 291.222.

9 (3) All expenses of the Governor-elect incurred in carrying out the provisions of this section are
10 open to inspection and audit by the Secretary of State and must be paid from any funds appropriated
11 for this purpose in the same manner as other claims against the state are paid.

12 **SECTION 5.** ORS 184.345 is amended to read:

13 184.345. The Oregon Department of Administrative Services [*shall*] **may** provide on a
14 reimbursable basis administrative and other services, as agreed [*to*] **upon**, to[:] **a state agency as**
15 **defined in ORS 291.002.**

16 [*(1) The Department of Corrections;*]

17 [*(2) The Department of Human Services;*]

18 [*(3) The Oregon Health Authority; and*]

19 [*(4) The State Board of Education.*]

20 **SECTION 6. The Oregon Department of Administrative Services Federal Funds Account**
21 **established under ORS 184.354 is abolished. Any moneys remaining in the account on the**
22 **effective date of this 2015 Act shall be transferred to the General Fund.**

23 **SECTION 7.** ORS 291.002 is amended to read:

24 291.002. As used in ORS 291.001 to 291.034, 291.201 to 291.222, 291.232 to 291.260, 291.261,
25 291.307 and 291.990, unless the context requires otherwise:

26 (1) "Classification of expenditures" means the [*major groups or*] categories of [*expenditures*] **ex-**
27 **pendenses** for the purpose of budget-making and accounting that are [*established as*] provided in ORS
28 [*291.206*] **291.216 (6)(a).**

29 (2) "Dedicated fund" means a fund in the State Treasury, or a separate account or fund in the
30 General Fund in the State Treasury, that by law is dedicated, appropriated or set aside for a limited
31 object or purpose, but "dedicated fund" does not include a revolving fund or a trust fund.

32 (3) "Department" means the Oregon Department of Administrative Services.

33 (4) "Director" means the Director of the Oregon Department of Administrative Services.

34 (5) "Legislatively adopted budget" means the budget enacted by the Legislative Assembly during
35 an odd-numbered year regular session **for the biennium beginning July 1 of the year in which**
36 **the regular session begins.**

37 (6) "Legislatively approved budget" means the legislatively adopted budget as modified by the
38 Emergency Board meeting in an interim period or by the Legislative Assembly meeting in special
39 session or in an even-numbered year regular session.

40 (7) "Revolving fund" means a fund in the State Treasury, established by law, from which is paid
41 the cost of goods or services furnished to or by a state agency, and which is replenished through
42 charges made for such goods or services or through transfers from other accounts or funds[; *and*
43 *specifically includes funds derived from receipts by the State Board of Higher Education of tuition, fees,*
44 *dormitory earnings, student activity receipts and sales of products and services incident to education*
45 *functions*].

1 (8) "State agency" or "agency" means every state officer, board, commission, department, insti-
2 tution, branch or agency of the state government, whose costs are paid wholly or in part from funds
3 held in the State Treasury, except:

4 (a) The Legislative Assembly, the courts and their officers and committees;

5 (b) The Public Defense Services Commission; and

6 (c) The Secretary of State and the State Treasurer in the performance of the duties of their
7 constitutional offices.

8 (9) "State officer" means any elected or appointed state officer, including members of boards and
9 commissions, except the members and officers of the Legislative Assembly, the courts, the Secretary
10 of State and the State Treasurer in the performance of the duties of their constitutional offices and
11 the members of the Public Defense Services Commission.

12 (10) "Trust fund" means a fund in the State Treasury in which designated persons or classes of
13 persons have a vested beneficial interest or equitable ownership, or which was created or estab-
14 lished by a gift, grant, contribution, devise or bequest that limits the use of the fund to designated
15 objects or purposes.

16 **SECTION 8.** ORS 291.060 is amended to read:

17 291.060. The Oregon Department of Administrative Services shall, no later than January 15 of
18 each odd-numbered year, provide the Legislative Assembly with a report setting forth in detail all
19 fees charged by each state agency, the purpose for the fee or charge, the persons affected by the fee
20 or charge, the statutory authority for the fee or charge, the amounts collected in the past biennium,
21 the amounts expected to be paid during the present biennium and estimated for the next biennium
22 in the Governor's [*recommended*] budget, and any changes in the fee or charge authorized during the
23 present biennium or proposed for the next biennium in the Governor's [*recommended*] budget. The
24 department shall report to the Emergency Board and the appropriate interim committee when re-
25 quested to provide information concerning the development of the report.

26 **SECTION 9.** ORS 291.100 is amended to read:

27 291.100. (1) It is the intent of the Legislative Assembly, in funding the development and imple-
28 mentation of a new statewide financial management system, that statewide financial management
29 systems and policies support program-driven budget planning and execution, based on timely and
30 accurate statewide managerial cost accounting information and that such systems support legislative
31 program evaluation and performance auditing of statewide programs and services.

32 (2) The Oregon Department of Administrative Services shall devise and supervise statewide fi-
33 nancial management systems for all state agencies by preparing policies and procedures for imple-
34 menting and operating financial management systems for all agencies in state government and
35 measuring implementation. In order to ensure that the state's investment in a modern and complete
36 statewide financial management system is fully implemented, every agency and unit of state gov-
37 ernment shall:

38 (a) Cooperate and comply fully with policies and procedures and deadlines prepared by the
39 Oregon Department of Administrative Services for establishing a database for the financial man-
40 agement system.

41 (b) Comply fully with policies and procedures prepared by the Oregon Department of Adminis-
42 trative Services for operation of the financial management system.

43 [(3) *The Oregon Department of Administrative Services shall report to the Legislative Assembly*
44 *no later than December 1 of even-numbered years.*]

45 [(a) *Progress in implementing the financial management system as to preparation of financial*

1 *statements, nonfinancial management information and the ability of the system to support legislative*
2 *program evaluation and performance auditing.]*

3 *[(b) Compliance by each agency and unit of state government with policies and procedures of the*
4 *Oregon Department of Administrative Services for implementation of the financial management*
5 *system.]*

6 *[(4) After a review of the Oregon Department of Administrative Services report by the Legislative*
7 *Fiscal Officer, the Joint Legislative Audit Committee may schedule a hearing for any agency or unit*
8 *of state government to review compliance with this section and policies and procedures of the Oregon*
9 *Department of Administrative Services, prior to any appropriation approval by the Legislative Assem-*
10 *bly.]*

11 **SECTION 10.** ORS 291.110 is amended to read:

12 291.110. (1) The Oregon Department of Administrative Services shall ensure that state agency
13 activities and programs are directed toward achieving [*the Oregon benchmarks*] **performance out-**
14 **comes.** The department shall:

15 (a) Monitor progress, identify barriers and generate alternative approaches for attaining [*the*
16 *benchmarks*] **performance outcomes.**

17 (b) Ensure the development of a statewide system of performance measures designed to increase
18 the efficiency and effectiveness of state programs and services.

19 (c) Provide agencies with direction on the appropriate format for reporting performance meas-
20 ures to ensure consistency across agencies.

21 (d) Consult with the Legislative Assembly to assist in devising a system of performance meas-
22 ures.

23 (e) Facilitate the development of performance measures in those instances where [*benchmarks*]
24 **performance measures** involve more than one state agency.

25 (f) Prior to budget development **and adoption of a performance measurement system**, consult
26 with the legislative review agency, as defined in ORS 291.371, or other appropriate legislative com-
27 mittee, as determined by the President of the Senate and the Speaker of the House of
28 Representatives[, *prior to the formal adoption of a performance measurement system*].

29 (g) No later than October 1 of each year, submit a report to the Legislative Fiscal Officer on
30 the progress state agencies have made in meeting performance measures.

31 (2) State agencies shall develop measurable performance measures consistent with and aimed
32 at achieving [*Oregon benchmarks*] **performance outcomes.** To that end, each state agency shall:

33 (a) Identify the mission, goals and objectives of the agency and any applicable [*benchmarks*]
34 **performance measures** to which the goals are directed.

35 (b) Develop written defined performance measures that quantify desired organization intermedi-
36 ate outcomes, outputs, responsibilities, results, products and services, and, where possible, develop
37 unit cost measures for evaluating [*the*] program efficiency.

38 (c) Involve agency managers, supervisors and employees in the development of statements of
39 mission, goals, objectives and performance measures as provided in paragraphs (a) and (b) of this
40 subsection and establish teams composed of agency managers, supervisors and employees to imple-
41 ment agency goals, objectives and performance measures. Where bargaining unit employees are af-
42 fected, they shall have the right to select those employees of the agency, through their labor
43 organization, to serve on any joint committees established to develop performance measures.

44 (d) Use performance measures to work toward achievement of identified missions, goals[,] **and**
45 objectives [*and any applicable benchmarks*].

1 (e) Review agency performance measures with the appropriate legislative committee, as deter-
2 mined by the President of the Senate and the Speaker of the House of Representatives, during each
3 odd-numbered year regular session of the Legislative Assembly.

4 **SECTION 11.** ORS 291.200 is amended to read:

5 291.200. (1) It is the intent of the Legislative Assembly to require the Governor, in the prepa-
6 ration of the [*biennial*] **Governor's** budget, to state as precisely as possible what programs the
7 Governor recommends be approved for funding under estimated revenues under ORS 291.342. If es-
8 timated revenues are inadequate, the Legislative Assembly intends that it be advised by the Gover-
9 nor as precisely as possible how the Legislative Assembly might proceed to raise the additional
10 funds. It is also the intent of the Legislative Assembly, in the event that the additional funding is
11 not possible, to be informed by the Governor precisely what programs or portions thereof the Gov-
12 ernor recommends be reduced accordingly. Finally, if the Governor chooses to recommend additional
13 new programs or program enhancements, the Legislative Assembly intends that the Governor specify
14 how the additional funding might be achieved. The Legislative Assembly believes that the state
15 government must allocate its resources for effective and efficient delivery of public services by:

- 16 (a) Clearly identifying desired results;
- 17 (b) Setting priorities;
- 18 (c) Assigning accountability; and
- 19 (d) Measuring, reporting and evaluating outcomes to determine future allocation.

20 (2) In addition to the intentions of subsection (1) of this section, in preparing the [*biennial*]
21 **Governor's** budget, the Governor and the Legislative Assembly shall use an outcomes-based budg-
22 eting process described in ORS 291.217 (2) and (3).

23 (3) To achieve the intentions of subsections (1) and (2) of this section, it is the budget policy of
24 this state to create and administer programs and services designed to attain societal outcomes [*such*
25 *as the Oregon benchmarks*] and to promote the efficient and measured use of resources.

26 (4) To effect the policy stated in subsection (3) of this section, state government shall:

- 27 (a) Allocate resources to achieve desired outcomes;
- 28 (b) Express program outcomes in measurable terms;
- 29 (c) Measure progress toward desired outcomes;
- 30 (d) Encourage savings;
- 31 (e) Promote investments that reduce or avoid future costs;
- 32 (f) Plan for the short term and long term using consistent assumptions for major demographic
33 and other trends; and
- 34 (g) Require accountability at all levels for meeting program outcomes.

35 **SECTION 12.** ORS 291.202 is amended to read:

36 291.202. (1) Except as otherwise provided in ORS 291.222, the Governor shall prepare in each
37 even-numbered year for the biennium beginning July 1 of the following year:

- 38 (a) A **Governor's** budget [*report*]; and
- 39 (b) A tax expenditure report.

40 (2) The Oregon Department of Administrative Services shall advise and assist the Governor in
41 the preparation of the **Governor's** budget [*report*] and **the** tax expenditure report and shall perform
42 [*such duties in connection therewith*] **any duties connected to the budget or report** as the Gover-
43 nor requires.

44 (3) The Department of Revenue shall advise and assist the Governor in the preparation of the
45 tax expenditure report.

1 **SECTION 13.** ORS 291.203 is amended to read:

2 291.203. (1) Not later than November 10 of each even-numbered year, the Governor shall cause
3 the tax expenditure report to be compiled and prepared for printing.

4 (2) In the tax expenditure report, the Governor shall:

5 (a) List each tax expenditure;

6 (b) Identify the statutory authority for each tax expenditure;

7 (c) Describe the purpose of each tax expenditure;

8 (d) Estimate the amount of revenue loss caused by each tax expenditure for the coming
9 biennium;

10 (e) List the actual amount of revenue loss in the preceding biennium for each tax expenditure
11 or an estimate if the actual amount cannot be determined;

12 [(f) *Determine whether each tax expenditure is the most fiscally effective means of achieving each*
13 *purpose of the tax expenditure;*]

14 [(g)] (f) Determine whether each tax expenditure has successfully achieved the purpose for
15 which the tax expenditure was enacted and currently serves, including an analysis of the persons
16 that are benefited by the expenditure; and

17 [(h)] (g) Categorize each tax expenditure according to the programs or functions each tax ex-
18 penditure supports.

19 **SECTION 14.** ORS 291.204 is amended to read:

20 291.204. (1) The Oregon Department of Administrative Services, by July 1 of each even-
21 numbered year, shall furnish every state agency with [*a sufficient number of forms*] **instructions** for
22 [*its use in*] preparing for submission to the Governor the information required by the Governor in
23 the preparation of the **Governor's** budget [*report of the Governor*].

24 (2) The Governor shall prescribe the [*forms*] **instructions** to be used by the agencies in sub-
25 mitting their [*budget estimates and requests for appropriations*] **agency request budgets** as required
26 by ORS 291.208.

27 **SECTION 15.** ORS 291.206 is amended to read:

28 291.206. (1) The Governor shall [*prescribe such rules and regulations as the Governor deems*]
29 **prescribe rules the Governor considers** necessary for the guidance of agencies in the preparation
30 of [*the budget estimates and requests*] **agency request budgets**. The Governor[, *with the approval of*
31 *the Secretary of State,*] **shall use the classifications of expenditures provided in ORS 291.216**
32 **(6)(a) and** shall prepare and prescribe classifications of [*expenditures and*] revenue for the purpose
33 of budget-making and accounting.

34 (2) In so far as practicable, agency [*budget estimates and requests*] **request budgets** and appro-
35 priation measures shall be prepared in a manner that reflects state governmental organization and
36 state agency duties, functions and powers under the law in effect on January 1 of the following year.
37 The Oregon Department of Administrative Services shall maintain agency [*budget estimates and re-*
38 *quests*] **request budgets** in the form in which they are submitted.

39 (3) **As supplemental information, each agency request budget shall include options for a**
40 **10 percent reduction from the estimate of the projected costs of continuing currently au-**
41 **thorized activities or programs for the next biennium, excluding debt service. Each state**
42 **agency shall describe the 10 percent reduction in terms of the activities or programs that**
43 **the agency will not undertake. The activities or programs shall be ranked in order of im-**
44 **portance and priority on the basis of lowest cost for benefit obtained.**

45 **SECTION 16.** ORS 291.208 is amended to read:

1 291.208. Each state agency shall file with the Oregon Department of Administrative Services,
2 before September 1 in each even-numbered year, *[on the form and]* in the manner required, *[its budget*
3 *forms]* **an agency request budget** containing the information required. The department shall pre-
4 pare *[budget estimates and requests for appropriations]* **agency request budgets** for all agencies that
5 fail to file requests.

6 **SECTION 17.** ORS 291.210 is amended to read:

7 291.210. *[(1) The Oregon Department of Administrative Services, in connection with its direct*
8 *studies of the operations, plans and needs of state agencies and of the existing and prospective sources*
9 *of income, shall prepare a tentative budget plan and tentative tax expenditure report for the two fiscal*
10 *years for which a budget report and tax expenditure report are required to be prepared.]*

11 *[(2) The Department of Revenue shall advise and assist in the preparation of the tentative tax ex-*
12 *penditure report.]*

13 **The Oregon Department of Administrative Services and the Legislative Fiscal Officer**
14 **shall prepare a tentative budget for the next biennium for which the Governor's budget is**
15 **prepared. The tentative budget shall consist of the estimated revenues under ORS 291.342 for**
16 **the next biennium and a preliminary estimate of the projected costs of continuing currently**
17 **authorized programs for the next biennium.**

18 **SECTION 18.** ORS 291.214 is amended to read:

19 291.214. (1) The Governor, during the preparation of the **Governor's** budget *[report]* and before
20 its submission to the Legislative Assembly, shall[:]

21 *[(1)(a) Examine the budget forms filed by the various agencies and may make or cause to be made*
22 *such further investigations by the Oregon Department of Administrative Services, with such hearings*
23 *before the Governor or any state agency, as the Governor deems advisable, and may make such changes*
24 *or revisions in policy and program and in specific details of the tentative budget report or tentative tax*
25 *expenditure report as the Governor finds warranted; and]*

26 *[(b)]* identify each tax expenditure that has a full or partial sunset that, if allowed to take effect,
27 will have a fiscal impact on the state or on school districts for the next biennium, and shall prepare
28 a recommendation as to each tax expenditure identified under this paragraph that indicates the
29 Governor's opinion on whether the full or partial sunset of the tax expenditure should be allowed
30 to take effect as scheduled or should be revised to a different date.

31 (2) As used in this section:

32 (a) "Full sunset" means any provision that completely eliminates an existing tax expenditure on
33 a specified date.

34 (b) "Partial sunset" means any provision that reduces the amount of an existing tax expenditure
35 or that alters the eligibility requirements for the expenditure as of a specified date.

36 **SECTION 19.** ORS 291.216 is amended to read:

37 291.216. *[(1) Not later than November 10 of each even-numbered year the Governor shall cause the*
38 *budget report to be compiled and prepared for printing.]*

39 *[(2)]* (1) The *[budget report]* **Governor's budget** shall include a budget message prepared by the
40 Governor, including recommendations of the Governor with reference to the fiscal policy of the state
41 government for the coming biennium, describing the important features of the budget *[plan]*, em-
42 bracing a general budget summary setting forth the aggregate figures of the budget *[report]* so as
43 to show a balanced relation between the total proposed expenditures and the total anticipated in-
44 come, with the basis and factors on which the estimates are made, the amount to be borrowed, and
45 other means of financing the estimated expenditures for the ensuing biennium, compared with the

1 corresponding figures for at least the last completed biennium and the current biennium.

2 [(3)] (2) The **Governor's** budget [*plan*] shall be supported by explanatory schedules or state-
3 ments, classifying the expenditures reported [*therein*] **in the budget**, both past and proposed, by or-
4 ganization units, objects and funds, and the income by organization units, sources and funds, and the
5 proposed amount of new borrowing as well as proposed new tax or revenue sources, including a
6 single comprehensive list of all proposed increases in fees, licenses and assessments assumed in the
7 budget [*plan*].

8 [(4)] (3) The **Governor's** budget [*plan*] shall be submitted for all dedicated funds, as well as the

14 (c) The **state** agency's use of temporary employees; and

15 (d) Employee workload.

16 [(5) *It is declared to be the policy of this state that the total personal services, budget and full-time*
17 *equivalent positions approved for any state agency shall be the maximum amount necessary to meet the*
18 *requirements of the agency for the biennium. Notwithstanding ORS 291.232 to 291.260, the Governor*
19 *and the Oregon Department of Administrative Services may transfer vacant position authority among*
20 *and within state agencies to achieve maximum utilization of authorized positions within agencies.*]
