

SENATE AMENDMENTS TO SENATE BILL 217

1 On page 1 of the printed bill, line 2, after “327.800” delete the rest of the line and line 3 and
2 insert “, 327.810, 327.815 and 327.820; repealing sections 30, 31, 32 and 33, chapter 27, Oregon Laws
3 2015 (Enrolled Senate Bill 342); and declaring an emergency.”.

4 Delete lines 5 through 30 and delete pages 2 and 3 and insert:

5 “**SECTION 1.** ORS 327.800 is amended to read:

6 “327.800. (1) The Oregon Education Investment Board shall [*design and implement*] **identify and**
7 **make recommendations to the Legislative Assembly about** programs that make strategic in-
8 vestments to:

9 “(a) Advance the educational goals of this state, as described in ORS 351.009;

10 “(b) Improve the employability of graduates from Oregon public schools;

11 “(c) Close the achievement gap that exists between historically underserved student groups, as
12 defined by the board by rule;

13 “(d) Assist public education in all regions of this state;

14 “(e) Promote collaboration and alignment among early childhood service providers, school dis-
15 tricts, community colleges, public universities and employers;

16 “(f) Leverage private, public and community resources;

17 “(g) Engage parents and child care providers, support families and motivate students;

18 “(h) Develop and disseminate evidence-based models and best practices that are likely to im-
19 prove student outcomes;

20 “(i) Collect data to monitor student progress; and

21 “(j) Establish networks that allow for the replication of successful practices across this state.

22 “[*2) The distribution and administration of all moneys that are used for strategic investments*
23 *made as provided by this section and ORS 327.810, 327.815 and 327.820 must be guided by the pur-*
24 *poses described in subsection (1) of this section.*]

25 “**(2) The Department of Education shall distribute any moneys received for strategic in-**
26 **vestments under this section. Distributions may be made to school districts, education ser-**
27 **vice districts, post-secondary institutions of education, nonprofit organizations, providers of**
28 **early childhood services, tribes of this state and other entities. Distributions of moneys must**
29 **advance the purposes set forth in ORS 327.810, 327.815 and 327.820 or other purposes that**
30 **meet the goals specified in subsection (1) of this section.**

31 “(3) Any recipient of moneys distributed as a strategic investment must provide separate ac-
32 counting for the moneys and may use the moneys only for the purpose for which the moneys are
33 provided.

34 “(4)(a) The **Oregon Education Investment** Board shall establish requirements for the programs
35 implemented under this section that are consistent with this section and with ORS 327.810, 327.815

1 and 327.820.

2 “(b) The board shall develop timelines, performance measures and other requirements related to
3 the accumulation and evaluation of data collected in relation to a program that receives moneys as
4 a strategic investment. The performance measures shall include progress toward the goals estab-
5 lished in ORS 351.009 and other key student education outcomes established by the board.

6 “(5) The State Board of Education, [*the Oregon Student Access Commission, the Oregon Arts*
7 *Commission*] **the Early Learning Council** and the Oregon Education Investment Board may adopt
8 any rules necessary for the agencies they oversee to perform any of the duties assigned to them
9 under this section. Any rules adopted by the State Board of Education[, *the Oregon Student Access*
10 *Commission or the Oregon Arts Commission*] **or the Early Learning Council** must be consistent
11 with this section and actions taken by the Oregon Education Investment Board to implement this
12 section.

13 “**SECTION 2.** ORS 327.800, as amended by section 5, chapter 660, Oregon Laws 2013, is
14 amended to read:

15 “327.800. (1) The State Board of Education shall [*design and implement*] **identify and make**

19 “(b) Improve the employability of graduates from Oregon public schools;

20 “(c) Close the achievement gap that exists between historically underserved student groups, as
21 defined by the board by rule;

22 “(d) Assist public education in all regions of this state;

23 “(e) Promote collaboration and alignment among early childhood service providers, school dis-
24 tricts, community colleges, public universities and employers;

40 “(3) Any recipient of moneys distributed as a strategic investment must provide separate ac-
41 counting for the moneys and may use the moneys only for the purpose for which the moneys are
42 provided.

43 “(4)(a) The [*board*] **State Board of Education** shall establish requirements for the programs
44 implemented under this section that are consistent with this section and with ORS 327.810, 327.815
45 and 327.820.

1 “(b) The board shall develop timelines, performance measures and other requirements related to
2 the accumulation and evaluation of data collected in relation to a program that receives moneys as
3 a strategic investment. The performance measures shall include progress toward the goals estab-
4 lished in ORS 351.009 and other key student education outcomes established by the board.

5 “(5) The State Board of Education[, *the Oregon Student Access Commission and the Oregon Arts*
6 *Commission*] **and the Early Learning Council** may adopt any rules necessary for the agencies they

8 [*Oregon Student Access Commission or the Oregon Arts Commission*] **Early Learning Council** must

37 *creased access to technology; and*]

38 “[*(B)*] **(c)** Increasing the number of school districts that participate in a network in this state
39 that is designed to support school districts in implementing high-quality reading instruction and
40 protocols that identify, support and serve students who are at risk for not reading at grade level
41 early and effectively;[.]

42 “[*(c) To the Oregon Education Investment Board to develop a statewide approach to early reading*
43 *awareness.*]

44 “[*(d) To the State Library to expand the Ready to Read program.*]

45 “**(d) Increasing the number of students who receive free lunches; or**

1 “(e) **Reducing rates of chronic absenteeism among historically underserved students who**
2 **have an achievement gap as compared to other student groups.**

3 “**SECTION 4.** ORS 327.810, as amended by section 6, chapter 660, Oregon Laws 2013, is
4 amended to read:

6 Reading Program to:

7 “(a) Improve the readiness of children preparing to enter into kindergarten; and

8 “(b) Improve the reading proficiency of students by the time the students complete the third
9 grade.

10 “(2) To accomplish the purposes of the Oregon Early Reading Program, [*moneys shall be dis-*
11 *tributed*] **the State Board of Education shall identify programs for the distribution of moneys**

45 toward a high school diploma, a modified diploma or an extended diploma; and

1 “(b) Increase the number of students who earn a high school diploma, a modified diploma or an
2 extended diploma and who enroll in a post-secondary institution of higher education.

3 “(2) To accomplish the purposes of the Guidance and Support for Post-Secondary Aspirations
4 Program, [*moneys shall be distributed*] **the Oregon Education Investment Board shall identify**
5 **programs and make recommendations for the distribution of moneys by the Department of**
6 **Education** for strategic investments that advance at least one of the following missions:

7 “(a) Supporting comprehensive systems of monitoring and support for struggling students.

21 tory progress toward a high school diploma, a modified diploma or an extended diploma[.]; **or**

22 “[*(B)*] **(b)** [*Creating a scholarship fund aimed at increasing*] **To increase** access for underserved
23 students to post-secondary institutions by paying for first-year college courses or accelerated college
24 credit programs.

25 “[*(c) To the Department of Community Colleges and Workforce Development for the purpose of*
26 *distributing moneys to school districts, public schools, post-secondary institutions and nonprofit organ-*
27 *izations to educate and engage underserved or first-generation college-bound students and their families*
28 *through counseling programs, parent advocacy, parent education, college visits, college initiatives and*
29 *assistance with obtaining financial aid.*]

35 toward a high school diploma, a modified diploma or an extended diploma; and

36 “(b) Increase the number of students who earn a high school diploma, a modified diploma or an
37 extended diploma and who enroll in a post-secondary institution of higher education.

38 “(2) To accomplish the purposes of the Guidance and Support for Post-Secondary Aspirations
39 Program, [*moneys shall be distributed*] **the State Board of Education shall identify programs for**
40 **the distribution of moneys by the Department of Education** for strategic investments that ad-
41 vance at least one of the following missions:

15 “[*(c) To the Department of Community Colleges and Workforce Development for the purpose of*
16 *distributing moneys to school districts, public schools, post-secondary institutions and nonprofit organ-*

18 *through counseling programs, parent advocacy, parent education, college visits, college initiatives and*

22 World of Work Program to:

23 “(a) Increase students’ proficiency in science, technology, engineering and mathematics; and

24 “(b) Connect students to the world of work.

25 “(2) To accomplish the purposes of the Connecting to the World of Work Program, [*moneys shall*
26 *be distributed*] **the Oregon Education Investment Board shall identify programs and make**
27 **recommendations for the distribution of moneys by the Department of Education** for strategic
28 investments that advance the following missions:

29 “(a) Collaborating with other public entities to develop and implement a long-term strategy that
30 advances state educational goals related to science, technology, engineering and mathematics.

31 “(b) Providing investments in programs that engage underserved students in science, technology,
32 engineering or mathematics or in career and technical education.

33 “(c) Developing consortiums of school districts, **education service districts** and post-secondary
34 institutions of higher education committed to developing innovative and flexible pathways for stu-
35 dents in grades 6 through 12 and in community colleges.

36 “(3) **In addition to moneys distributed as provided by subsection (2) of this section, the**
37 **Department of Education may distribute** strategic investment moneys [*distributed as provided by*
38 *this section shall be as follows*] **for any of the following purposes:**

39 “[*(a) To the Department of Education for the purposes of:*]

40 “[*(A) Distributing moneys to school districts, post-secondary institutions and nonprofit organiza-*
41 *tions to create regional networks, or expand upon existing regional networks, to support science, tech-*
42 *nology, engineering and mathematics and career and technical education.*]

43 “[*(B) Distributing moneys to school districts, public schools, post-secondary institutions and*
44 *nonprofit organizations to develop public schools focused on science, technology, engineering and*
45 *mathematics and arts-related industries to serve middle school, high school and community college*

1 *students.]*

2 “[(C)] (a) [*Distributing moneys to school districts, public schools, post-secondary institutions and*
3 *nonprofit organizations to increase]* **Increasing** learning opportunities in science, technology, engi-
4 neering and mathematics, the arts and career and technical education[.];

5 “[(D)] (b) [*Distributing moneys to consortiums that include at least three school districts, at least*
6 *one education service district, at least one community college and at least one public or private post-*
7 *secondary institution to design and deliver]* **Designing and delivering** individualized, innovative and
8 flexible ways of delivering content, awarding high school and college credit and providing develop-
9 ment education for students in high school or in the first two years of post-secondary education[.];
10 **or**

11 “[(b) *To the Oregon Arts Commission for the purpose of distributing moneys to school districts,*
12 *public schools, post-secondary institutions and nonprofit organizations to increase opportunities for*
13 *students to connect with the arts and arts-related industries.]*

14 “(c) **Increasing the number of students who receive a General Educational Development**
15 **(GED) certificate.**

16 “**SECTION 8.** ORS 327.820, as amended by section 8, chapter 660, Oregon Laws 2013, is
17 amended to read:

18 “327.820. (1) The State Board of Education shall establish the Connecting to the World of Work
19 Program to:

20 “(a) Increase students’ proficiency in science, technology, engineering and mathematics; and

21 “(b) Connect students to the world of work.

22 “(2) To accomplish the purposes of the Connecting to the World of Work Program, [*moneys shall*
23 *be distributed]* **the State Board of Education shall identify programs for the distribution of**
24 **moneys by the Department of Education** for strategic investments that advance the following
25 missions:

26 “(a) Collaborating with other public entities to develop and implement a long-term strategy that
27 advances state educational goals related to science, technology, engineering and mathematics.

28 “(b) Providing investments in programs that engage underserved students in science, technology,
29 engineering or mathematics or in career and technical education.

30 “(c) Developing consortiums of school districts, **education service districts** and post-secondary
31 institutions of higher education committed to developing innovative and flexible pathways for stu-
32 dents in grades 6 through 12 and in community colleges.

33 “(3) **In addition to moneys distributed as provided by subsection (2) of this section, the**
34 **Department of Education may distribute** strategic investment moneys [*distributed as provided by*
35 *this section shall be as follows]* **for any of the following purposes:**

36 “[(a) *To the Department of Education for the purposes of:]*

37 “[(A) *Distributing moneys to school districts, post-secondary institutions and nonprofit organiza-*
38 *tions to create regional networks, or expand upon existing regional networks, to support science, tech-*
39 *nology, engineering and mathematics and career and technical education.]*

40 “[(B) *Distributing moneys to school districts, public schools, post-secondary institutions and*
41 *nonprofit organizations to develop public schools focused on science, technology, engineering and*
42 *mathematics and arts-related industries to serve middle school, high school and community college*
43 *students.]*

44 “[(C)] (a) [*Distributing moneys to school districts, public schools, post-secondary institutions and*
45 *nonprofit organizations to increase]* **Increasing** learning opportunities in science, technology, engi-

1 neering and mathematics, the arts and career and technical education[.];

2 “[D)] (b) [*Distributing moneys to consortiums that include at least three school districts, at least*
3 *one education service district, at least one community college and at least one public or private post-*
4 *secondary institution to design and deliver*] **Designing and delivering** individualized, innovative and
5 flexible ways of delivering content, awarding high school and college credit and providing develop-
6 ment education for students in high school or in the first two years of post-secondary education[.];

7 **or**

8 “[*b) To the Oregon Arts Commission for the purpose of distributing moneys to school districts,*
9 *public schools, post-secondary institutions and nonprofit organizations to increase opportunities for*
10 *students to connect with the arts and arts-related industries.*]

11 **“(c) Increasing the number of students who receive a General Educational Development**
12 **(GED) certificate.**

13 **“SECTION 9. If Senate Bill 342 becomes law, sections 30, 31, 32 and 33 (amending ORS**
14 **327.800 and 327.815), chapter 27, Oregon Laws 2015 (Enrolled Senate Bill 342), are repealed.**

15 **“SECTION 10. This 2015 Act being necessary for the immediate preservation of the public**
16 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
17 **July 1, 2015.”.**
