7 “**SECTION 51.** Sections 2, 21 and 22 of this 2015 Act and the amendments to ORS 496.146,
8 496.232, 496.283, 496.289, 496.303, 496.550, 496.555, 496.562, 496.566, 497.022, 497.032, 497.075,
9 497.102, 497.112, 497.121, 497.124, 497.132, 497.138, 497.142, 497.151, 497.153, 497.156, 497.158,
10 497.258, 497.325, 498.166, 498.418, 508.116, 508.285, 508.505, 508.550, 508.760, 508.790, 508.816,

20 rolled House Bill 3012), is amended to read:

21 “**Sec. 3.** *[(1) In addition to the fees otherwise prescribed by law, the issuer of each of the following*
22 *licenses shall charge and collect each time the license is issued, during the period beginning January*
23 *1, 2016, and ending December 31, 2026, the following surcharges]* **Notwithstanding any other pro-**
24 **vision of the wildlife laws and during the period beginning January 1, 2016, and ending De-**
25 **cember 31, 2026, of the moneys received from the sale of the following licenses, the following**
26 **amounts shall be deposited in the Oregon Hatchery Research Center Fund:**

27 “[*a*] (1) Resident **annual** combination license issued under ORS 497.132, \$1.

28 “[*b*] (2) Resident annual angling license issued under ORS 497.121 (1)(a), \$1.

29 “[*c*] (3) Angling license to angle for one day issued under ORS 497.121 (1)(d), \$0.50.

30 “[*d*] (4) Nonresident annual angling license issued under ORS 497.121 (1)(b), \$1.50.

31 “[*e*] (5) Nonresident angling license to angle for seven consecutive days issued under ORS
32 497.121 (1)(c), \$1.50.

33 “[*2*] *All moneys received by the State Fish and Wildlife Commission under subsection (1) of this*
34 *section shall be deposited in the Oregon Hatchery Research Center Fund.]*

35 “**SECTION 53.** If House Bill 3012 becomes law, section 8, chapter ___, Oregon Laws 2015 (En-

rolled House Bill 3012), is amended to read:

“**Sec. 8.** (1)(a) Sections 1 [to], 2, 4 and 7 [of this 2015 Act], **chapter __, Oregon Laws 2015 (Enrolled House Bill 3012)**, are repealed on January 2, [2026] **2027.**

“(b) **Section 3, chapter __, Oregon Laws 2015 (Enrolled House Bill 3012)**, as amended by **section 52 of this 2015 Act, is repealed on January 2, 2027.**

“(2) Any balance in the Oregon Hatchery Research Center Fund that is unexpended and unobligated on the date of the repeal of section 1 [of this 2015 Act], **chapter __, Oregon Laws 2015 (Enrolled House Bill 3012)**, and all moneys that would have been deposited in the Oregon Hatchery Research Center Fund had section 1 [of this 2015 Act], **chapter __, Oregon Laws 2015 (Enrolled House Bill 3012)**, remained in effect, shall be transferred to and deposited in the Fish Endowment Subaccount in the Fish and Wildlife Account, and are appropriated for expenditure as in the case of other moneys in the Fish Endowment Subaccount.

“(3) Any balance in the Hatchery Construction Fund that is unexpended and unobligated on the date of the repeal of section 2 [of this 2015 Act], **chapter __, Oregon Laws 2015 (Enrolled House Bill 3012)**, and all moneys that would have been deposited in the Hatchery Construction Fund had section 2 [of this 2015 Act], **chapter __, Oregon Laws 2015 (Enrolled House Bill 3012)**, remained in effect, shall be transferred to and deposited in the Fish Endowment Subaccount in the Fish and Wildlife Account, and are appropriated for expenditure as in the case of other moneys in the Fish Endowment Subaccount.

“**SECTION 54.** (1) **If House Bill 3012 becomes law, sections 3 and 5 of this 2015 Act (both amending section 2 of this 2015 Act) are repealed.**

“(2) **If House Bill 3012 becomes law, sections 4 and 6 of this 2015 Act are repealed.**

“**SECTION 55.** If House Bill 3012 becomes law, section 2 of this 2015 Act is amended to read:

“**Sec. 2.** (1) Except as otherwise provided for by law, the State Fish and Wildlife Commission shall charge the fees listed in the fee schedule under this section for the issuance of the specified licenses, tags and permits.
