

# Senate Bill 263

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor John A. Kitzhaber, M.D., for Department of Environmental Quality)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Adds program elements to opportunity to recycle. Modifies program elements and program element requirements.

Updates statewide goals for recovery of materials from general solid waste stream for calendar years 2020 and 2025 and subsequent years. Establishes specific statewide recovery goals for certain materials. Updates waste generation goals for calendar years 2025 and 2050 and subsequent years. Updates washed recovery goals. Allows Environmental Quality Commission to revise goals under certain conditions.

Directs commission to develop and adopt alternative method for calculating recovery rates based on rate of energy savings achieved through recovery of materials. Authorizes commission to adopt other alternative calculation methods under certain conditions. Authorizes washeds to base recovery rate calculations on weight-based or alternative methods adopted by commission.

Eliminates two percent recovery credits on washed recovery rates.

Reduces required frequency of statewide solid waste composition study to once every three biennia.

Requires Department of Environmental Quality to conduct statewide survey of recovery rates for certain materials for calendar year 2020. Requires department to report to interim committee of Legislative Assembly by September 15, 2022, if goals are not being achieved.

9 **SECTION 1.** ORS 459A.005 is amended to read:

10 459A.005. (1) As used in ORS 459.015, 459.250 and 459A.005 to 459A.665, the "opportunity to  
11 recycle" means at least that the city, county or metropolitan service district responsible for solid  
12 waste management:

13 (a)(A) Provides a place for collecting source separated recyclable material located either at a  
14 disposal site or at another location more convenient to the population being served and, if a city  
15 has a population of 4,000 or more, collection at least once a month of source separated recyclable  
16 material from collection service customers within the city's urban growth boundary or, where ap-  
17 plicable, within the urban growth boundary established by a metropolitan service district; or

18 (B) Provides an alternative method [*which*] **that** complies with rules of the Environmental  
19 Quality Commission; and

20 (b) Complies with the [*rates and program elements required under ORS 459A.010*] **program ele-**  
21 **ment requirements described in section 5 of this 2015 Act.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (2) The “opportunity to recycle” defined in subsection (1) of this section also includes a public  
2 education and promotion program that:

- 3 (a) Gives notice to each person of the opportunity to recycle; and
- 4 (b) Encourages source separation of recyclable material.

5 **SECTION 2.** ORS 459A.005, as amended by section 1 of this 2015 Act, is amended to read:

6 459A.005. (1) As used in ORS 459.015, 459.250 and 459A.005 to 459A.665, the “opportunity to  
7 recycle” means at least that the city, county or metropolitan service district responsible for solid  
8 waste management:

9 (a)(A) Provides a place for collecting source separated recyclable material located either at a  
10 disposal site or at another location more convenient to the population being served and, if a city  
11 has a population of 4,000 or more, collection at least once a month of source separated recyclable  
12 material from collection service customers within the city’s urban growth boundary or, where ap-  
13 plicable, within the urban growth boundary established by a metropolitan service district; or

14 (B) Provides an alternative method that complies with rules of the Environmental Quality  
15 Commission; and

- 16 (b) Complies with the program element requirements described in section 5 of this 2015 Act.

17 (2) The “opportunity to recycle” defined in subsection (1) of this section also includes a public  
18 education and promotion program that:

- 19 (a) Gives notice to each person of the opportunity to recycle; and
- 20 (b) Encourages source separation of recyclable material.

21 **(3) As used in this section, “collection service customers” includes:**

22 **(a) Customers of a collection service as defined in ORS 459.005; and**

23 **(b) The residential and commercial tenants of landlords or property managers that are**  
24 **customers of a collection service for the benefit of their tenants.**

25 **SECTION 3.** The amendments to ORS 459A.005 by section 2 of this 2015 Act become op-  
26 erative on July 1, 2022.

27 **SECTION 4.** Sections 5 and 6 of this 2015 Act are added to and made a part of ORS  
28 459A.005 to 459A.665.

29 **SECTION 5.** (1) A person providing the opportunity to recycle shall fulfill the require-  
30 ments of subsection (3) of this section using the following recycling program elements:

31 **(a) Provision of at least one durable recycling container to each residential service cus-**  
32 **tomer.**

33 **(b) On-route collection at least once each week of source separated recyclable material**  
34 **from residential collection service customers, provided on the same day that solid waste is**  
35 **collected from each customer.**

36 **(c) An expanded education and promotion program as described in section 6 of this 2015**  
37 **Act.**

38 **(d) A multifamily collection program that includes:**

39 **(A) Collection of at least four principal recyclable materials or the number of materials**  
40 **required to be collected under the residential on-route collection program, whichever is less,**  
41 **from each multifamily dwelling complex that has five or more units; and**

42 **(B) Education and promotion directed to the residents of the multifamily dwelling com-**  
43 **plex.**

44 **(e) An effective residential yard debris collection and composting program that includes**  
45 **the promotion of home composting of yard debris, and that also includes either:**

1 (A) Monthly or more frequent on-route collection of yard debris from residential col-  
2 lection service customers for production of compost or other marketable products; or

3 (B) A system of yard debris collection depots conveniently located and open to the public  
4 at least once a week.

5 (f) A commercial recycling program that includes:

6 (A) Weekly, or on a more appropriate regular schedule, onsite collection of source sepa-  
7 rated principal recyclable materials from, at a minimum, commercial generators of solid  
8 waste employing 10 or more persons and occupying 1,000 square feet or more in a single lo-  
9 cation.

10 (B) An education and promotion program conducted to inform all commercial generators  
11 of solid waste of the manner and benefits of the commercial recycling program that provides  
12 effective promotion of the program to the generators.

13 (C) Other elements including but not limited to waste assessments and recycling recog-  
14 nition programs. A wasteshed is encouraged to involve local business organizations in pub-  
15 licly recognizing outstanding recycling efforts by commercial generators of solid waste. The  
16 recognition may include awards designed to provide additional incentives to increase recycl-  
17 ing efforts.

18 (D) Each commercial generator of solid waste shall strive to achieve 55 percent recovery  
19 from its solid waste stream by the year 2025.

20 (g) Expanded depots for recycling of at least all principal recyclable materials and pro-  
21 visions for promotion and education to maximize the use of the depots. The depots must:

22 (A) Have regular and convenient hours;

23 (B) Be open on the weekend days; and

24 (C) When feasible, collect additional recyclable materials.

25 (h) Solid waste residential collection rates that encourage waste reduction, reuse and  
26 recycling through reduced rates for smaller containers, including at least one rate for a  
27 container that is 21 gallons or less in size. Based on the average weight of solid waste dis-  
28 posed per container for containers of different sizes, the rate on a per pound disposed basis  
29 may not decrease with increasing size of containers, and the rates per container service may  
30 not be less with additional containers serviced.

31 (i) A collection and composting system for food and other compostable waste from com-  
32 mercial and institutional entities that generate large amounts of such wastes.

33 (j) A commercial recycling program that requires commercial generators of solid waste  
34 that generate large amounts of recyclable materials to source separate recyclable materials.

35 (k) A program for monthly or more frequent on-route collection and composting for food  
36 and other compostable waste from residential collection service customers. The program  
37 described in this paragraph must include education and promotion to maximize the use of  
38 compost produced through the program.

39 (L) A recovery program for construction and demolition debris that:

40 (A) Requires construction and demolition debris to be source separated at the generation  
41 site or sent to a material recovery facility for processing and recovery; and

42 (B) Includes an education and promotion program for developers, contractors and resi-  
43 dential owners that provides strategies to:

44 (i) Reduce waste during preconstruction planning and in building construction, reno-  
45 vation and demolition phases; and

1 (ii) Direct waste to reuse and material recovery facilities.

2 (m) A food waste collection program requiring nonresidential generators that generate  
3 large amounts of food waste to source separate the food waste for recovery.

4 (2) A person providing the opportunity to recycle shall fulfill the requirements of sub-  
5 section (3) of this section using the following waste prevention education program elements:

6 (a) A city- or county-wide education and promotion program about the environmental  
7 benefits of, and opportunities to reduce the generation of waste through, waste prevention  
8 and reuse.

9 (b) A waste prevention promotion campaign targeting residential generators of waste and  
10 focused on one or more toxic or energy intensive materials or consumer purchasing prac-  
11 tices.

12 (c) A waste prevention promotion campaign targeting commercial or institutional gen-  
13 erators of waste and focused on one or more toxic or energy intensive materials or consumer  
14 purchasing practices.

15 (d) A waste prevention and reuse education program in elementary and secondary  
16 schools.

17 (e) A program for the provision of city or watershed funding or infrastructure support  
18 to promote and sustain reuse, repair, leasing or sharing efforts.

19 (f) A program for the provision of city or watershed technical assistance to promote and  
20 sustain the reuse, repair or leasing of materials or other sharing of efforts to reduce waste.

21 (g) City or watershed support for a food rescue program that diverts to residents food  
22 that would otherwise be composted or disposed.

23 (3) Each city with a population of at least 4,000 and each county that is responsible for  
24 the area between city limits and the urban growth boundary of a city or the area within the  
25 metropolitan service district for the city shall implement either:

26 (a) The applicable number of program elements for the size and location of the city as  
27 provided in subsection (4) of this section; or

28 (b) An alternative program designed to achieve recovery levels comparable to similar  
29 communities and that complies with the rules of the Environmental Quality Commission.

30 (4) The number of program elements that cities and counties must implement to comply  
31 with subsection (3) of this section are as follows:

32 (a) For cities within a metropolitan service district:

33 (A) The waste prevention education program element set forth under subsection (2)(a)  
34 of this section, and at least four additional elements set forth under subsection (2) of this  
35 section; and

36 (B) A program that includes either:

37 (i) Recycling program elements set forth under subsection (1)(a), (b) and (c) of this sec-  
38 tion and at least four additional elements set forth under subsection (1) of this section; or

39 (ii) At least eight recycling program elements set forth under subsection (1) of this sec-  
40 tion.

41 (b) For cities with a population of at least 4,000 but not more than 10,000 that are located  
42 120 miles or less from the City of Portland, a program that includes at least four recycling  
43 program elements set forth under subsection (1) of this section.

44 (c) For cities with a population of at least 4,000 but not more than 10,000 that are more  
45 than 120 miles from the City of Portland, a program that includes at least three recycling

1 **program elements set forth under subsection (1) of this section.**

2 **(d) For cities with a population of more than 10,000 but not more than 50,000 that are**  
3 **located 150 miles or less from the City of Portland:**

4 **(A) The waste prevention education program element set forth under subsection (2)(a)**  
5 **of this section and at least two additional elements set forth under subsection (2) of this**  
6 **section; and**

7 **(B) A program that includes either:**

8 **(i) Recycling program elements set forth under subsection (1)(a), (b) and (c) of this sec-**  
9 **tion and at least two additional elements set forth under subsection (1) of this section; or**

10 **(ii) At least six recycling program elements set forth under subsection (1) of this section.**

11 **(e) For cities with a population of more than 10,000 but not more than 50,000 that are**  
12 **located more than 150 miles from the City of Portland, a program that includes either:**

13 **(A) The waste prevention education program element set forth under subsection (2)(a)**  
14 **of this section and at least two additional elements set forth under subsection (2) of this**  
15 **section; and**

16 **(B) A program that includes either:**

17 **(i) Recycling program elements set forth under subsection (1)(a), (b) and (c) of this sec-**  
18 **tion and at least one additional elements set forth under subsection (1) of this section; or**

19 **(ii) At least five recycling program elements set forth under subsection (1) of this sec-**  
20 **tion.**

21 **(f) For cities with a population of more than 50,000 that are located 180 miles or less from**  
22 **the City of Portland:**

23 **(A) The waste prevention education program element set forth under subsection (2)(a)**  
24 **of this section and at least four additional elements set forth under subsection (2) of this**  
25 **section; and**

26 **(B) A program that includes either:**

27 **(i) Recycling program elements set forth under subsections (1)(a), (b) and (c) of this**  
28 **section and at least three additional recycling program elements set forth under subsection**  
29 **(1) of this section; or**

30 **(ii) At least seven recycling program elements set forth under subsection (1) of this**  
31 **section.**

32 **(g) For cities with a population of more than 50,000 that are located more than 180 miles**  
33 **from the City of Portland:**

34 **(A) The waste prevention education program element set forth under subsection (2)(a)**  
35 **of this section, and at least four additional elements set forth under subsection (2) of this**  
36 **section; and**

37 **(B) A program that includes either:**

38 **(i) Recycling program elements set forth under subsections (1)(a), (b) and (c) of this**  
39 **section and at least one additional recycling program element set forth under subsection (1)**  
40 **of this section; or**

41 **(ii) At least five recycling program elements set forth under subsection (1) of this sec-**  
42 **tion.**

43 **(5) A city or county subject to subsection (4)(b) or (c) of this section may substitute the**  
44 **waste prevention education program element set forth in subsection (2)(a) of this section and**  
45 **at least two additional elements set forth in subsection (2) of this section for one recycling**

1 program element set forth under subsection (1) of this section.

2 (6) A waste prevention education program element required for a county under sub-  
3 sections (3) and (4) of this section may be provided on behalf of the county by the metro-  
4 politan service district where the county is located. If the metropolitan service district  
5 provides a waste prevention education program element under this subsection, the metro-  
6 politan service district must make the program available to all areas between the city limits  
7 and the urban growth boundaries of all cities within both the county for which the metro-  
8 politan service district is providing the element and the metropolitan service district.

9 (7)(a) Each local government that franchises or licenses the collection of solid waste and  
10 establishes the rates to be charged for collection service shall:

11 (A) Include in those rates all net costs incurred by the local government, franchisee or  
12 licensee for providing the opportunity to recycle and for implementing the requirements of  
13 subsection (2) of this section; or

14 (B) Fund implementation of the opportunity to recycle through an alternative source of  
15 funding that may include but is not limited to disposal fees.

16 (b) As used in this subsection, "net costs" includes but is not limited to the reasonable  
17 costs for collecting, handling, processing, storing, transporting and delivering to market  
18 recyclable material and for providing any required education and promotion or data col-  
19 lection services adjusted by a factor to account for proceeds from the sale of recyclable  
20 material.

21 **SECTION 6.** An expanded education and promotion program to satisfy the requirements  
22 of section 5 of this 2015 Act must carry out the policy set forth in ORS 459.015, inform gen-  
23 erators of solid waste of the manner and benefits of reducing, reusing, recycling and  
24 composting material, promote use of recycling services and reduce contamination in col-  
25 lected recyclables. The city, county or metropolitan service district responsible for providing  
26 an opportunity to recycle shall provide the education and promotion program in one of the  
27 following ways:

28 (1)(a) Preparing and implementing an education and promotion plan that includes actions  
29 to effectively reach solid waste generators and all new and existing collection service cus-  
30 tomers as necessary to fulfill the intent of this section.

31 (b) The plan described in paragraph (a) of this subsection must be submitted to the De-  
32 partment of Environmental Quality during the first year that the plan is in effect. There-  
33 after, the watershed shall submit a summary of activities in the plan to the department at  
34 the same time the county submits the periodic report required under ORS 459A.050 (1)(a).  
35 The summary must cover at least the time period until the next periodic report is due to the  
36 department.

37 (2) Implementing all of the following:

38 (a)(A) Provision of recycling notification and education packets to all new residential,  
39 commercial and institutional collection service customers that include, at a minimum, in-  
40 formation about the materials collected, the schedule for collection, the way to prepare ma-  
41 terials for collection, why separating material for recycling is necessary and how to reduce  
42 contamination of the materials set out for collection.

43 (B) In addition to the requirements of subparagraph (A) of this paragraph, the educa-  
44 tional and promotional materials provided to commercial collection customers must:

45 (i) Be targeted to meet the needs of various types of businesses;

1 (ii) Include information on the economic and other benefits of recycling, common barriers to recycling and solutions to the barriers, additional resources for commercial generators of solid waste and other information designed to assist and encourage recycling efforts and reduce contamination; and

5 (iii) Encourage each commercial collection customer to have a goal to achieve 55 percent recovery from the customer's solid waste stream by 2025.

7 (b) Provision of recycling information to collection service customers, in a variety of formats and materials at least four times per calendar year, that includes, at a minimum, the materials collected and the schedule for collection.

10 (c) Provision, at least annually, of the information described in paragraph (a) of this subsection to all residential, commercial and institutional collection service customers.

12 (d) Targeting of community and media events to promote recycling and reduce contamination in collected recyclables.

14 (e) A program to determine the levels of contamination of materials set out for collection and to take action to reduce contamination in collected recyclables.

16 **SECTION 7.** ORS 459A.010 is amended to read:

17 459A.010. [(1) It is the goal of the State of Oregon that:]

18 [(a) For the calendar year 2005, the amount of recovery from the general solid waste stream shall be at least 45 percent;]

20 [(b) For the calendar year 2009, the amount of recovery from the general solid waste stream shall be at least 50 percent;]

22 [(c) For the calendar year 2005 and subsequent years, that there be no annual increase in per capita municipal solid waste generation; and]

24 [(d) For the calendar year 2009 and subsequent years, that there be no annual increase in total municipal solid waste generation.]

26 [(2) In addition to the requirements of ORS 459A.005, the "opportunity to recycle" shall include the requirements of subsection (3) of this section using the following program elements:]

28 [(a) Provision of at least one durable recycling container to each residential service customer.]

29 [(b) On-route collection at least once each week of source separated recyclable material to residential customers, provided on the same day that solid waste is collected from each customer.]

31 [(c) An expanded education and promotion program conducted to carry out the policy set forth in ORS 459.015, to inform solid waste generators of the manner and benefits of reducing, reusing, recycling and composting material and to promote use of recycling services. The city, county or metropolitan service district responsible for providing an opportunity to recycle under ORS 459A.005 and this section shall provide the education and promotion program in either of the following two ways:]

36 [(A) Preparing and implementing an education and promotion plan that includes actions to effectively reach solid waste generators and all new and existing collection service customers, as necessary to fulfill the intent of this paragraph. The plan shall be submitted to the Department of Environmental Quality the first year that the plan is in effect. Thereafter, the watershed shall submit a summary of activities in the plan to the Department of Environmental Quality at the same time the county submits the periodic report required under ORS 459A.050 (1)(a). The summary shall cover at least the time period until the next periodic report is due to the department.]

43 [(B) Implementing all of the following:]

44 [(i) Provision of recycling notification and education packets to all new residential, commercial and institutional collection service customers that include at a minimum the materials collected, the schedule

1 for collection, the way to prepare materials for collection and the reasons persons should separate their  
2 material for recycling. The educational and promotional materials provided to commercial collection  
3 customers should be targeted to meet the needs of various types of businesses and should include rea-  
4 sons to recycle, including economic benefits, common barriers to recycling and solutions, additional  
5 resources for commercial generators of solid waste and other information designed to assist and en-  
6 courage recycling efforts. The educational and promotional materials provided to commercial collection  
7 customers shall encourage each commercial collection customer to have a goal to achieve 50 percent  
8 recovery from its solid waste stream by the year 2009.]

9 [(ii) Provision of recycling information in a variety of formats and materials at least four times a  
10 calendar year to collection service customers that includes at a minimum the materials collected and  
11 the schedule for collection.]

12 [(iii) Provision at least annually to all residential, commercial and institutional collection service  
13 customers, of the information under sub-subparagraph (i) of this subparagraph.]

14 [(iv) Targeting of community and media events to promote recycling.]

15 [(d) Collection of at least four principal recyclable materials or the number of materials required  
16 to be collected under the residential on-route collection program, whichever is less, from each multi-  
17 family dwelling complex having five or more units. The multifamily collection program shall include  
18 promotion and education directed to the residents of the multifamily dwelling units.]

19 [(e) An effective residential yard debris collection and composting program that includes the pro-  
20 motion of home composting of yard debris, and that also includes either:]

21 [(A) Monthly or more frequent on-route collection of yard debris from residences for production of  
22 compost or other marketable products; or]

23 [(B) A system of yard debris collection depots conveniently located and open to the public at least  
24 once a week.]

25 [(f) A commercial recycling program that includes:]

26 [(A) Weekly, or on a more appropriate regular schedule, onsite collection of source separated  
27 principal recyclable materials from, at a minimum, commercial solid waste generators employing 10 or  
28 more persons and occupying 1,000 square feet or more in a single location.]

29 [(B) An education and promotion program conducted to inform all commercial generators of solid  
30 waste of the manner and benefits of the commercial recycling program that provides effective promotion  
31 of the program to the generators.]

32 [(C) In addition to the requirements of subparagraphs (A) and (B) of this paragraph, a commercial  
33 recycling program may also consist of other elements including but not limited to waste assessments  
34 and recycling recognition programs. A watershed is encouraged to involve local business organizations  
35 in publicly recognizing outstanding recycling efforts by commercial generators of solid waste. The re-  
36 cognition may include awards designed to provide additional incentives to increase recycling efforts.]

37 [(D) Each commercial generator of solid waste shall strive to achieve 50 percent recovery from its  
38 solid waste stream by the year 2009.]

39 [(g) Expanded depots for recycling of at least all principal recyclable materials and provisions for  
40 promotion and education to maximize the use of the depots. The depots shall have regular and con-  
41 venient hours and shall be open on the weekend days and, when feasible, shall collect additional  
42 recyclable materials.]

43 [(h) Solid waste residential collection rates that encourage waste reduction, reuse and recycling  
44 through reduced rates for smaller containers, including at least one rate for a container that is 21  
45 gallons or less in size. Based on the average weight of solid waste disposed per container for con-



1 *tainers of different sizes, the rate on a per pound disposed basis shall not decrease with increasing size*  
 2 *of containers, nor shall the rates per container service be less with additional containers serviced.]*

3 *[(i) A collection and composting system for food, paper that is not recyclable because of contam-*  
 4 *ination and other compostable waste from commercial and institutional entities that generate large*  
 5 *amounts of such wastes.]*

6 *[(3)(a) Each city with a population of at least 4,000 but not more than 10,000 that is not within a*  
 7 *metropolitan service district and any county responsible for the area between the city limits and the*  
 8 *urban growth boundary of such city shall implement one of the following:]*

9 *[(A) The program elements set forth in subsection (2)(a), (b) and (c) of this section;]*

10 *[(B) A program that includes at least three elements set forth in subsection (2) of this section; or]*

11 *[(C) An alternative method of achieving recovery rates that complies with rules of the Environ-*  
 12 *mental Quality Commission.]*

13 *[(b) Each city that is within a metropolitan service district or that has a population of more than*  
 14 *10,000 and any county responsible for the area within a metropolitan service district or the area be-*  
 15 *tween the city limits and the urban growth boundary of such city shall implement one of the*  
 16 *following:]*

17 *[(A) Program elements set forth under subsection (2)(a), (b) and (c) of this section and one addi-*  
 18 *tional element set forth under subsection (2) of this section;]*

19 *[(B) A program that includes at least five elements set forth under subsection (2) of this section;*  
 20 *or]*

21 *[(C) An alternative method of achieving recovery rates that complies with rules of the Environ-*  
 22 *mental Quality Commission.]*

23 *[(4)(a) Recovery rates shall be determined by dividing the total weight of material recovered by the*  
 24 *sum of the total weight of the material recovered plus the total weight of solid waste disposed that was*  
 25 *generated in each watershed. It is the policy of the State of Oregon that recovery of material shall be*  
 26 *consistent with the priority of solid waste management in ORS 459.015 (2).]*

27 *[(b) Each watershed implementing a waste prevention program shall receive a two percent credit*  
 28 *on the watershed's recovery rate. A waste prevention program shall include:]*

29 *[(A) A watershed-wide program to provide general educational materials to residents about waste*  
 30 *prevention and examples of things residents can do to prevent generation of waste; and]*

31 *[(B) Two of the following:]*

32 *[(i) Reduce the watershed annual per capita waste generation by two percent each year;]*

33 *[(ii) Conduct a waste prevention media promotion campaign targeted at residential generators;]*

 38 *waste prevention assessments for businesses and institutions and document any waste prevention*  
 39 *measures implemented;]*

40 *[(vi) Conduct a material specific waste prevention campaign for businesses throughout the*  
 41 *watershed;]*

42 *[(vii) Implement a Resource Efficiency Model City program;]*

43 *[(viii) Conduct a material-specific waste prevention education campaign that focuses on a toxic or*  
 44 *energy-intensive material;]*

45 *[(ix) Local governments will implement programs to buy recycled-content products for their oper-*

1 ations, consistent with procurement guidelines issued by the United States Environmental Protection  
2 Agency; or]

3 [(x) Local governments will implement programs for new construction and remodeling of local  
4 government buildings that incorporate recycled-content materials, energy conservation features, water  
5 conservation and stormwater management features and other elements to increase the resource effi-  
6 ciency and lower the environmental impact of these buildings.]

7 [(c) Each wasteshed implementing a reuse program shall receive a two percent credit on the  
8 wasteshed's recovery rate. A reuse program shall include:]

9 [(A) A promotion and education campaign on the benefits and opportunities for reuse available to  
10 the public in the wasteshed; and]

11 [(B) Two of the following:]

12 [(i) Operate construction and demolition debris salvage programs with depots;]

13 [(ii) Promote reuse programs offered by local resale businesses, thrift stores and equipment vendors,  
14 such as computer and photocopier refurbishers, to the public and businesses;]

15 [(iii) Identify and promote local businesses that will take back white goods for refurbishing and  
16 resale to the public;]

17 [(iv) Develop and promote use of waste exchange programs for the public and private sectors;]

18 [(v) Site accommodation for recovery of reusable material at transfer stations and landfills; or]

19 [(vi) Sidewalk pickup or community fair program in cities over 4,000 population in the  
20 wasteshed.]

21 [(d) Each wasteshed implementing a residential composting program shall receive a two percent  
22 credit on the wasteshed's recovery rate. A residential composting program shall include:]

23 [(A) Promotion of the residential composting program through public information and demon-  
24 stration sites or sites; and]

25 [(B) Two of the following:]

26 [(i) A program to encourage leaving grass clippings generated by lawn mowing on-site rather than  
27 bagging the clippings for disposal or composting;]

28 [(ii) A composting program for local schools;]

29 [(iii) An increase in availability of compost bins for residents; or]

30 [(iv) Another program increasing a household's ability to manage yard trimmings or food

32 [(e) A wasteshed may receive, upon application to the Department of Environmental Quality, a re-  
33 covery credit greater than two percent for a residential composting program. To receive the recovery  
34 credit under this paragraph, the wasteshed must provide quantitatively verifiable documentation of  
35 residential composting tonnage to the department. The documentation must show that more than two

6 (C) Industrial waste, ash, inert rock, dirt, plaster, asphalt and similar material if deliv-  
7 ered to a municipal solid waste disposal site or demolition disposal site and if a record is kept  
8 of such deliveries and submitted as part of the annual report submitted under ORS 459A.050;

9 (D) Waste received at an ash monofill from an energy recovery facility; and

10 (E) Solid waste not generated within this state.

11 (4)(a) If there is not a viable market for recycling a material, the composting or burning  
12 of the material for energy recovery may be included in the recovery rate for the wasteshed  
13 calculated under subsection (3) of this subsection.

14 (b) If the material is burned for energy recovery and then included in the recovery rate  
15 for Clackamas, Multnomah or Washington Counties in aggregate or for Benton, Lane, Linn,  
16 Marion, Polk or Yamhill County wastesheds, the same material, when burned as part of  
17 mixed solid waste, may be included in the recovery rate for a wasteshed that burns mixed  
18 solid waste for energy recovery. The amount of the material within the mixed solid waste  
19 that may be included in the recovery rate for energy recovery shall be determined by a waste  
20 composition study performed by the wasteshed at least every six years.

21 (c) Mixtures of materials that are composted or burned for energy recovery may not be  
22 included in the recovery rate if more than half of the mixed materials by weight could have  
23 been recycled if properly source separated.

24 (d) In its annual report to the department, the county or metropolitan service district  
25 shall state how much composting or energy recovery under this subsection is included as  
26 recovery and state the basis for the determination that there was not a viable market for  
27 recycling the material.

28 (e) As used in this subsection, “viable market” means a person located within a  
29 wasteshed that will pay for the material or accept the material free of charge or a person  
30 located outside a wasteshed that will pay a price for the material that, at minimum, covers  
31 the cost of transportation of the material.

32 (5) As an alternative to achieving the weight-based recovery goals described in this sec-  
33 tion, wastesheds may achieve outcome-based recovery goals as adopted by the Environmental  
34 Quality Commission in accordance with section 9 of this 2015 Act.

35 **SECTION 8.** Section 9 of this 2015 Act is added to and made a part of ORS 459A.005 to  
36 459A.665.

37 **SECTION 9.** (1)(a) The Environmental Quality Commission shall develop and adopt by  
38 rule a method for calculating recovery rates based on the rate of energy savings achieved  
39 by recovering materials from the general solid waste stream. The calculation method must  
40 account for:

41 (A) The energy savings achieved from material recovery, as opposed to material disposal;

42 (B) Recovery of energy from waste; and

43 (C) Energy saving practices implemented as part of local solid waste reduction, reuse and

7 (3)(a) The commission may develop and adopt by rule other methods for calculating re-  
 8 covery rates from the general solid waste stream that are based on achieving outcomes that  
 9 result from waste recovery and management, and may include but are not limited to the  
 10 following:

11 (A) Reductions in greenhouse gas emissions.

12 (B) Reductions in the emissions of toxic or potentially toxic chemicals.

13 (C) Water conservation.

14 (b) The commission may adopt by rule other outcome-based recovery goals consistent  
 15 with the goals under ORS 459A.010 (1) and (2) using outcome-based calculation methods de-  
 16 veloped under this subsection.

44 (iii) **Any other method adopted by the commission under section 9 of this 2015 Act;** and

45 (C) The amount of each type of material recovered annually statewide and, based on available

1 information, the amount of each type of material recycled annually statewide;

2 (b) Compliance with and implementation of the provisions of ORS 459.015, 459.035, 459.055,  
3 459.992 (1) and (2) and 459.995;

4 (c) **The** status of the metropolitan service district's waste reduction program as submitted to the  
5 commission under ORS 459.345 and its compliance with the criteria in ORS 459.350; and

6 (d) Recommendations for improvements in waste prevention, reuse, recycling and composting  
7 programs.

8 (3) The commission shall revise the plan at regular intervals in order to allow local government  
9 units to take advantage of the data and analysis in the state plan.

10 **SECTION 11.** ORS 459A.035 is amended to read:

11 459A.035. The Department of Environmental Quality shall conduct a solid waste composition  
12 study **to determine the quantities and sources of different materials disposed of in the waste**  
13 **stream** at least once [*a biennium*] **every three biennia** for all areas of the state not covered by  
14 other solid waste composition studies. The study may include:

15 [*(1) A measurement of the per capita waste disposal rate; or*]

16 [*(2) A statewide survey of the amount of waste reduced through material and energy recovery.*]

17 (1) **A measurement and composition of wastes disposed of through nonstandard methods**  
18 **such as litter; and**

19 (2) **The composition of commingled and other recovered materials collected or processed**  
20 **in Oregon.**

21 **SECTION 12.** (1) **For the calendar year 2020, the Department of Environmental Quality**  
22 **shall conduct a statewide survey of recovery rates for food waste, plastic waste and carpet**  
23 **waste.**

24 (2) **If the study reveals that the statewide waste recovery goals for food waste, plastic**  
25 **waste and carpet waste under ORS 459A.010 are not being met, the department shall submit**  
26 **a report to the interim committees of the Legislative Assembly related to solid waste, as**  
27 **appropriate, no later than September 15, 2022. The report must include:**

28 (a) **An evaluation of options to improve recovery; and**

29 (b) **Recommendations for meeting or modifying the recovery goals for food waste, plastic**  
30 **waste and carpet waste under ORS 459A.010.**

31 **SECTION 13.** Section 12 of this 2015 Act is repealed on the date of the convening of the  
32 **2023 regular session of the Legislative Assembly as specified in ORS 171.010.**

36 **SECTION 14.** ORS 459.055 is amended to read:

37 459.055. (1) Before issuing a permit for a landfill established after October 3, 1979, in any area  
38 zoned for exclusive farm use, the Department of Environmental Quality shall determine that the site  
39 can and will be reclaimed for uses permissible in the exclusive farm use zone. A permit issued for  
40 a landfill in an exclusive farm use zone [*shall*] **must** contain requirements that:

41 (a) Ensure rehabilitation of the site at the termination of the use for solid waste disposal to a  
42 condition comparable to its original use;

43 (b) Protect the public health and safety and the environment;

44 (c) Minimize the impact of the landfill on adjacent property;

45 (d) Minimize traffic; and

1 (e) Minimize rodent and vector production and sustenance.

2 (2) Before issuing a permit for any disposal site, including a landfill established under ORS  
3 459.047 or 459.049, the department shall require:

4 (a) Any person who sends more than 75,000 tons of solid waste a year to the disposal site to  
5 prepare a waste reduction program accepted by the department; and

6 (b) That any contract or agreement to dispose of more than 75,000 tons of out-of-state solid  
7 waste a year in an Oregon disposal site established under ORS 459.047 or 459.049 provides for a  
8 waste reduction program accepted by the department.

9 (3) A disposal site subject to the requirements of subsection (2) of this section may not accept  
10 solid waste from any person disposing of solid waste originating in any local government unit that  
11 does not have a waste reduction program or a contract accepted by the department. The department  
12 shall review the local government programs and the contract programs in the manner provided in  
13 subsection (5) of this section. A waste reduction program shall provide for:

14 (a) A commitment by the local government unit to reduce the volume of waste that would oth-  
15 erwise be disposed of in a landfill through techniques such as waste prevention, recycling, reuse,  
16 composting and energy recovery;

17 (b) An opportunity to recycle that:

18 (A) Includes a program for recycling that achieves the applicable recovery rate in ORS 459A.010  
19 [(6)] (2) for waste originating in Oregon, or as demonstrated by the disposal site operator for waste  
20 originating outside Oregon, either a recovery rate equivalent to that achieved in a comparable  
21 county in Oregon or a recycling program equivalent to the opportunity to recycle in ORS 459A.005  
22 (1)(a) and (2) and the program elements in [ORS 459A.010 (2) and (3)] **section 5 of this 2015 Act**;  
23 and

24 (B) For waste originating inside Oregon, meets or exceeds the requirements of ORS 459.250 and  
25 459A.005 to 459A.085;

26 (c) A timetable for implementing each portion of the waste reduction program;

27 (d) Energy efficient, cost-effective approaches for waste reduction;

28 (e) Procedures commensurate with the type and volume of solid waste generated in the area; and

29 (f) Legal, technical and [economical] **economic** feasibility.

30 (4) For each area outside the state from which a disposal site receives solid waste, the disposal  
31 site [shall have] **has** two years after first accepting solid waste from the area to demonstrate how  
32 the area complies with the requirements of subsection (3) of this section. If[,] after two years the  
33 waste reduction program required under subsection (3) of this section is not implemented, the En-  
34 vironmental Quality Commission may, by order, direct such implementation, or may prohibit the  
35 disposal site from accepting waste from the person responsible for preparing the waste reduction  
36 program. The disposal site operator shall provide written notice to the department prior to first  
37 accepting solid waste from outside the state. The requirements of this subsection [shall] apply only  
38 to contracts entered into after September 9, 1995.

39 (5) **The department shall review** a waste reduction program prepared under subsection (2) of  
40 this section [shall be reviewed by the department] and shall [be accepted by the department] **accept**  
41 **the program** if it meets the criteria prescribed in subsection (3) of this section.

42 (6) Notwithstanding ORS 459.245 (1), if the department fails to act on an application subject to  
43 the requirements of this section within 60 days, the application [shall not be] **is not** considered  
44 granted.

45 (7) [No] **A** contract or agreement for the disposal of solid waste made between an owner or op-

1 erator of a disposal site and a person [*shall*] **does not** affect the authority of the commission to es-  
 2 tablish or modify the requirements of an acceptable waste reduction program under subsection (2)  
 3 of this section.

4 (8) Notwithstanding any other provision of law relating to solid waste disposal, if the state of  
 5 origin prohibits or restricts the disposal of any kind of solid waste within the state of origin,  
 6 [*such*] **the** prohibition or restriction also [*shall apply*] **applies** to the disposal of [*such*] **the** solid  
 7 waste in Oregon.

8 **SECTION 15.** ORS 459.305 is amended to read:

9 459.305. (1) Except as otherwise provided by rules adopted by the Environmental Quality Com-  
 10 mission under subsection (4) of this section, a disposal site may not accept solid waste generated  
 11 outside the county in which the disposal site is located unless the Department of Environmental  
 12 Quality certifies or, for waste that originates outside Oregon in an amount exceeding 75,000 tons  
 13 annually from a single source generator or wasteshed, the disposal site operator demonstrates to the  
 14 department, that the person responsible for solid waste management in the area from which the solid  
 15 waste originates has implemented an opportunity to recycle that:

16 (a) Includes a program for recycling that achieves the applicable recovery rate in ORS 459A.010  
 17 [(6)] **(2)** for waste originating in Oregon, or for waste originating outside Oregon, either a recovery  
 18 rate equivalent to that achieved in a comparable county in Oregon or a recycling program equiv-  
 19 alent to the opportunity to recycle in ORS 459A.005 (1)(a) and (2) and the program elements in [*ORS*  
 20 *459A.010 (2) and (3)*] **section 5 of this 2015 Act**; and

21 (b) For waste originating inside Oregon, meets the requirements of ORS 459.250 and 459A.005  
 22 to 459A.085.

23 (2) The [*Environmental Quality*] commission shall adopt rules to establish a program for certi-  
 24 fication of recycling programs established by a person in order to comply with the requirement of  
 25 subsection (1) of this section. [*No*] **A** contract or agreement for the disposal of solid waste made  
 26 between an owner or operator of a disposal site and a person [*shall*] **does not** affect the authority  
 27 of the commission to establish or modify the requirements established under subsection (1) of this  
 28 section.

29 (3) For each area outside the state from which a disposal site receives solid waste, the disposal  
 30 site [*shall have*] **has** two years after first accepting solid waste from the area to demonstrate how  
 31 the area complies with the requirements of subsection (1) of this section. The disposal site operator  
 32 shall provide written notice to the department [*of Environmental Quality*] prior to first accepting  
 33 solid waste from outside the state. The requirements of this subsection [*shall*] apply only to con-  
 34 tracts entered into after September 9, 1995.

35 (4) The commission shall establish by rule the amount of solid waste that may be accepted from  
 36 outside the county in which the disposal site is located before the person must comply with the re-  
 37 quirements set forth in subsection (1) of this section.

38 (5) Subject to prior approval of the Oregon Department of Administrative Services and a report  
 39 to the Emergency Board prior to adopting the fee, and within the budget authorized by the Legis-  
 40 lative Assembly as that budget may be modified by the Emergency Board, the Department of Envi-  
 41 ronmental Quality may establish a certification fee in accordance with ORS 468.065. The fees  
 42 [*shall*] **may** not exceed the cost of the program.

43 (6) The certification requirement under subsection (1) of this section [*shall*] **does** not apply to  
 44 a person implementing a waste reduction program under ORS 459.055.

45 (7) Notwithstanding any other provision of law relating to solid waste disposal, if the laws of

1 the state of origin prohibit or restrict the disposal of any kind of solid waste within the state of  
 2 origin, [such] **the** prohibition or restriction [shall] also [apply] **applies** to the disposal of [such] **the**  
 3 solid waste in Oregon.

4 **SECTION 16.** ORS 459A.029 is amended to read:

5 459A.029. (1) The Department of Environmental Quality shall work with local government units  
 6 to provide educational and promotional materials that local government units may distribute to  
 7 commercial generators of solid waste. The educational and promotional materials should be targeted  
 8 to businesses[,] and include reasons to recycle, including economic benefits, common barriers to re-  
 9 cycling and solutions **to the barriers**, additional resources for commercial generators and other  
 10 information designed to assist and encourage meeting the state's [50] **55** percent recovery rate.

11 (2) Each wasteshed is encouraged to involve local business organizations in publicly recognizing  
 12 outstanding recycling efforts by commercial generators of solid waste. The recognition may include  
 13 awards designed to provide additional incentives to increase recycling efforts.

14 (3) Each commercial generator of solid waste shall strive to achieve [50] **55** percent recovery  
 15 from its solid waste stream by [*the year 2000*] **2025**.

16 (4) The Legislative Assembly encourages local government units that have chosen to implement  
 17 commercial recycling programs to evaluate the effectiveness of those programs. The effectiveness  
 18 of a program may be determined by measuring solid waste diverted by programs, by participation  
 19 in programs or **by** some other method.

20 **SECTION 17.** ORS 459A.050 is amended to read:

21 459A.050. (1) On behalf of each wasteshed and the cities within each wasteshed, each county  
 22 shall submit to the Department of Environmental Quality:

23 (a) A periodic report, as required by the department, but not more frequently than annually, that  
 24 documents how the wasteshed and the cities within the wasteshed are implementing the opportunity  
 25 to recycle, including the requirements of **section 5 of this 2015 Act and** ORS 459A.010. A  
 26 wasteshed is encouraged to report the results of the wasteshed's commercial recycling program  
 27 evaluations in the wasteshed's periodic report to the department [*of Environmental Quality*].

28 (b) An annual report that states for the wasteshed the type of material and the weight of each  
 29 type of material collected through the following means:

30 (A) On-route collection;

31 (B) Collection from commercial customers; and

32 (C) Collection at disposal site recycling depots.

33 (c) If solid waste generated in the wasteshed is disposed of outside of the state, the total weight  
 34 of the solid waste disposed of outside the state, which shall be included in the annual report.

35 (2) The metropolitan service district for Multnomah, Washington and Clackamas counties and  
 36 the cities therein in aggregate shall submit to the department annual reports that include the in-  
 37 formation required under subsection (1) of this section.

38 (3) Except as provided in subsection (4) of this section and subject to the exclusions of ORS  
 39 459A.010 [(4)(h)] **(3)(d)**, each solid waste disposal site that receives solid waste, except transfer  
 40 stations, shall report, for each wasteshed, the weight of in-state solid waste disposed of at the solid  
 41 waste disposal site that was generated in each wasteshed.

42 (4) The metropolitan service district for Multnomah, Washington and Clackamas counties and  
 43 the cities therein in aggregate shall submit to the department the weight of solid waste disposed of  
 44 through the following facilities:

45 (a) Metropolitan service district central transfer station;

1 (b) Metropolitan service district south transfer station;

2 (c) Municipal solid waste compost facility; and

3 (d) Any disposal facility or transfer facility owned, operated or under contract by the metro-  
4 politan service district.

5 (5) The cities and counties within each watershed shall share proportionally in the costs in-  
6 curred for the preparation and submission of the annual report required under this section.

7 (6) At least annually, the department shall survey privately operated recycling and material re-  
8 covery facilities, including but not limited to buy back centers, drop off centers, recycling depots  
9 other than those at permitted land disposal facilities, manufacturers and distributors. The depart-  
10 ment shall collect the following information:

11 (a) By type of material for each watershed, the weight of in-state material collected from other  
12 than on-route collection programs, both residential and commercial.

13 (b) Any other information necessary to prevent double counting of material recovered or to de-  
14 termine if a material is recyclable.

15 (7) Information collected under subsection (6) of this section, as it relates specifically to the  
16 entity's customer lists or specific amounts and types of materials collected or marketed, [*shall be*  
17 *maintained as*] **is** confidential [*by the department*] and exempt from disclosure under ORS 192.410 to  
18 192.505. The department may use and disclose such information in aggregated form.

19 (8) The information in subsections (1)(b) to (4) and (6) of this section shall be collected and re-  
20 ported annually on a form provided by the department.

21 (9) Unless extended by the Environmental Quality Commission upon application under ORS  
22 459A.055 after the affected persons show good cause for an extension, the affected persons within  
23 the watershed shall implement the opportunity to recycle and submit the recycling report to the  
24 department.
