

SENATE AMENDMENTS TO SENATE BILL 460

By JOINT COMMITTEE ON IMPLEMENTING MEASURE 91

1 Delete lines 4 through 19 of the printed bill and insert:

2 **“SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS 475.300 to**
3 **475.346.**

4 **“SECTION 2. (1) As used in this section:**

5 **“(a) ‘Limited marijuana retail product’ means:**

6 **“(A) The seeds of marijuana;**

7 **“(B) The dried leaves and flowers of marijuana; and**

8 **“(C) A marijuana plant that is not flowering.**

9 **“(b) ‘Marijuana’ means the plant Cannabis family Cannabaceae, any part of the plant**
10 **Cannabis family Cannabaceae and the seeds of the plant Cannabis family Cannabaceae.**

11 **“(c) ‘Medical marijuana dispensary’ means an entity registered with the Oregon Health**
12 **Authority under ORS 475.314.**

13 **“(2) Notwithstanding any other provision of law, on and after October 1, 2015, a medical**
14 **marijuana dispensary may sell limited marijuana retail product to a person who is 21 years**
15 **of age or older if:**

16 **“(a) The person presents proof of age to the medical marijuana dispensary before enter-**
17 **ing into the medical marijuana dispensary;**

18 **“(b) The medical marijuana dispensary verifies that the person is 21 years of age or older**
19 **at the time of the sale;**

20 **“(c) The medical marijuana dispensary sells no more than one-quarter ounce of limited**
21 **marijuana retail product to the person per day if the person is purchasing the dried leaves**
22 **and flowers of marijuana; and**

23 **“(d) The medical marijuana dispensary sells no more than four units of limited marijuana**
24 **retail product to the person if the person is purchasing a marijuana plant that is not flow-**
25 **ering.**

26 **“(3) A city or county may adopt ordinances prohibiting the sale of limited marijuana re-**
27 **tail product as described in this section in the area subject to the jurisdiction of the city or**
28 **the unincorporated area subject to the jurisdiction of the county.**

29 **“(4) The authority shall adopt rules to implement this section, including rules that:**

30 **“(a) Are necessary to ensure the public health and safety; and**

31 **“(b) Ensure that a medical marijuana dispensary complies with this section.**

32 **“(5) The authority may prohibit a medical marijuana dispensary from selling limited**
33 **marijuana retail product as described in this section if the medical marijuana dispensary vi-**
34 **olates this section.**

35 **“SECTION 3. Section 2 of this 2015 Act is repealed on December 31, 2016.**

1 **“SECTION 4. This 2015 Act being necessary for the immediate preservation of the public**
2 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
3 **on its passage.”.**
