

# A-Engrossed Senate Bill 5512

Ordered by the Senate June 22  
Including Senate Amendments dated June 22

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to State Department of Geology and Mineral Industries for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and specified federal funds, but excluding lottery funds and other federal funds, collected or received by department.

Limits biennial expenditures by department from other federal funds.

**Increases General Fund appropriation made to department for current biennium.**

Declares emergency, effective *[July 1, 2015]* on passage.

## A BILL FOR AN ACT

1  
2 Relating to the financial administration of the State Department of Geology and Mineral Industries;  
3 and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the State Department of Geology and Mineral In-**  
6 **dustry, for the biennium beginning July 1, 2015, out of the General Fund, the amount of**  
7 **\$4,133,992 for operations of the department.**

8 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**  
9 **are established for the biennium beginning July 1, 2015, as the maximum limits for payment**  
10 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and fed-**  
11 **eral funds for contract services, but excluding lottery funds and federal funds not described**  
12 **in this section, collected or received by the State Department of Geology and Mineral In-**  
13 **dustry, for the following purposes:**

14 (1) Geologic survey..... \$ 3,539,777

15 (2) Mined land reclamation ..... \$ 2,567,085

16 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**  
17 **\$5,360,944 is established for the biennium beginning July 1, 2015, as the maximum limit for**  
18 **payment of expenses from federal funds, other than those described in section 2 of this 2015**  
19 **Act, collected or received by the State Department of Geology and Mineral Industries.**

20 **SECTION 4. Notwithstanding any other provision of law, the General Fund appropriation**  
21 **made to the State Department of Geology and Mineral Industries by section 1, chapter 394,**  
22 **Oregon Laws 2013, for the biennium beginning July 1, 2013, as modified by legislative or**  
23 **Emergency Board action, is increased by \$800,000.**

1        **SECTION 5. This 2015 Act being necessary for the immediate preservation of the public**  
2        **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**  
3        **on its passage.**
