SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Oregon Liquor Control Commission.

Authorizes specified nonlimited expenditures.

Increases authorized expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by commission in 2013-2015 biennium for agents' compensation.

Declares emergency, effective [*July 1, 2015*] **on passage.**

A BILL FOR AN ACT

2 Relating to the financial administration of the Oregon Liquor Control Commission; and declaring
3 an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other law limiting expenditures, the following amounts**
6 **are established for the biennium beginning July 1, 2015, as the maximum limits for payment**
7 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
8 **cluding lottery funds and federal funds, collected or received by the Oregon Liquor Control**
9 **Commission, for the following purposes:**

- 10 (1) **Administrative expenses..... \$ 63,652,074**
- 11 (2) **Agents' compensation..... \$102,570,335**
- 12 (3) **Capital improvements..... \$ 4,391,810**

13 **SECTION 2. For the biennium beginning July 1, 2015, expenditures by the Oregon Liquor**
14 **Control Commission for liquor purchases and bank card fees are not limited.**

15 **SECTION 3. Notwithstanding any other law limiting expenditures, the limitation on**
16 **expenditures established by section 1 (2), chapter 667, Oregon Laws 2013, as modified by leg-**
17 **islative or Emergency Board action, for the biennium beginning July 1, 2013, as the maximum**
18 **limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous**
19 **Receipts, but excluding lottery funds and federal funds, collected or received by the Oregon**
20 **Liquor Control Commission, is increased by \$350,000 for agents' compensation.**

21 **SECTION 4. This 2015 Act being necessary for the immediate preservation of the public**
22 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
23 **on its passage.**
