SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Appropriates moneys from General Fund to Oregon Business Development Department for Oregon Arts Commission and debt service.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department for certain purposes.

Limits biennial expenditures by department from lottery moneys for certain purposes.

Limits biennial expenditures by department from federal funds for certain purposes.

Authorizes certain nonlimited expenditures.

Declares emergency, effective July 1, 2015.

- SECTION 1. There are appropriated to the Oregon Business Development Department, for the biennium beginning July 1, 2015, out of the General Fund, the following amounts, for the following purposes:

- 9 **(2)** Debt service \$ 14,936,863

SECTION 4. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2015, as the maximum limits for payment of expenses from federal funds collected or received by the Oregon Business Development Department, for the following purposes:

<u>SECTION 5.</u> For the biennium beginning July 1, 2015, expenditures by the Oregon Business Development Department are not limited for:

- (1) Loans from the following funds:
- (a) Oregon Business Development Fund (ORS 285B.092), Oregon Entrepreneurial Development Loan Fund (ORS 285B.758), Credit Enhancement Fund (ORS 285B.215) and Brownfields Redevelopment Fund (ORS 285A.188); and
- (b) Special Public Works Fund (ORS 285B.455), Water Fund (ORS 285B.563), Marine Navigation Improvement Fund (ORS 777.267), Oregon Port Revolving Fund (ORS 285A.708), Safe Drinking Water Revolving Loan Fund (ORS 285A.213), Oregon Infrastructure Opportunity Program Fund, Working Forest and Farm Credit Enhancement Fund and Working Forest and Farm Revolving Loan Fund.
- (2) Debt service, excluding debt service on lottery revenue bonds and general obligation bonds.

<u>SECTION 6.</u> This 2015 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect July 1, 2015.
