CHAPTER

AN ACT

Relating to the financial administration of the State Parks and Recreation Department; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2015, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the State Parks and Recreation Department, for the following purposes:

- (1) Director's office..... \$ 2,893,764
- (2) Central services..... \$ 15,782,675
- (3) Park development..... \$ 3,675,630
- (4) Direct services..... \$ 61,484,347
- (5) Community support and grants \$ 13,244,786

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2015, as the maximum limits for payment of expenses from lottery moneys allocated from the Parks and Natural Resources Fund to the State Parks and Recreation Department, for the following purposes:

- (1) Director's office..... \$ 1,904,572
- (2) Central services..... \$ 10,216,400
- (3) Park development..... \$ 16,970,607
- (4) Direct services..... \$ 35,291,495
- (5) Community support and grants \$ 13,497,704
- (6) Central services debt service.... \$ 1,682,356

SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$912,494 is established for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the State Parks and Recreation Department for the payment of debt service for the Willamette Falls development project.

SECTION 4. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2015, as the maximum limits for payment of expenses from federal funds collected or received by the State Parks and Recreation Department for the following purposes:

- (1) Park development \$ 3,629,158
- (2) Direct services..... \$ 2,226,540
- (3) Community support and grants \$ 7,350,687

SECTION 5. This 2015 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect July 1, 2015.
