## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Oregon Youth Authority for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by authority.

Limits biennial expenditures by authority from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2015.

- 2 Relating to the financial administration of the Oregon Youth Authority; and declaring an emergency.
- 3 Be It Enacted by the People of the State of Oregon:
- SECTION 1. There are appropriated to the Oregon Youth Authority, for the biennium beginning July 1, 2015, out of the General Fund, the following amounts, for the following purposes:
- 7 (1) Operations...... \$262,774,369
  - (2) Juvenile crime
- 9 prevention/diversion ...... \$ 17,849,069
- 10 (3) Multnomah County
- 11 gang services ...... \$ 3,426,221
- 12 (4) East Metro Gang
- 13 **Enforcement Team ...... \$ 1,862,062**
- 14 (5) **Debt service...... \$ 3,328,941**
- 15 (6) Capital improvements ...... \$ 745,131
  - <u>SECTION 2.</u> Notwithstanding any other law limiting expenditures, the amount of \$13,250,954 is established for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Oregon Youth

- SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$36,131,918 is established for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses from federal funds, other than federal funds described in section 4 of
- 24 this 2015 Act, collected or received by the Oregon Youth Authority.
